Born on July 3rd, 1912, Justice Khanna was a judge of impeccable values, who preserved the rightful tenets of the Constitution of India through his judgments by faithfully and selflessly discharging the duties vested in him. His courage and virtues are venerated even today and he is treated as an example for all judges that followed him in the Constitutional Courts. His brave dissent in the face of great personal loss cemented his reputation as a prophet of the rule of law, human rights, and constitutionalism. As a tribute to his visions, we at CAN Foundation are taking a step further in trying to keep his legacy of values alive, by bringing the second edition of our Annual symposium.

The First edition of the Symposium saw the august presence of Hon'ble Mr. Justice U U Lalit as the Chief Guest, Hon'ble Mr. Justice V. FUNDAMENTAL DUTIES vis-à-vis FUNDAMENTAL RIGHTS UNDER OUR CONSTITUTION - A Brief Insight

According to Rusell Kirk, 'Every right is married to a duty, every freedom owes a corresponding responsibility.' The building blocks of a society are the rights and duties given by society to its members. For a functioning democracy, these two need to exist in harmony. However, over time, an imbalance has emerged between them, primarily because a 'rights-centric' approach has been adopted recently whilst the importance of duties has been downplayed.

The rights are not absolute and the freedoms that an individual enjoys are subject to certain restrictions which include respecting the rights of others. These restrictions are further justified by way of the duty of one individual to respect and acknowledge the rights and freedoms of others and to not practice his/her individual rights in a manner which prejudices the rights and freedoms of others. It is only with the practice of one's duties that a balance in society can be brought about. Democracy cannot establish deep roots in society unless fundamental rights are complemented by fundamental duties. We are privileged to host Hon'ble Mr. Justice Vikram Nath, Mr. N.K. Kaul and Mr. Sidharth Luthra (Senior Advocates) on this topic and we look forward to their thoughts on how rights and the corresponding duties may be balanced.

VOX POPULI vs. RULE OF LAW: SUPREME COURT OF INDIA - A Brief Insight

The conflict between Vox Populi and the Rule of Law is not a recent phenomenon. The role of the majority opinion in a democracy has long been discussed and deliberated. A number of jurists have given their opinion on whether Vox Populi should have a role in a constitutional democracy. Some have argued that it has no role in a democracy and the rule of law must remain supreme. Others such as Justice Cardozo of the US Supreme Court have opined that it would be impractical to say that Judges are not affected by external happenings, but they must strive to reduce it to the greatest extent practicable.

The judiciary in its wisdom has however been extremely cautious of the fact that the public morality and popular opinion must not override constitutional morality. The issue is much more relevant today because of the access and reach that social media enjoys. A narrative is created by the aggrieved section to influence judges and to intimidate them to deliver a judgement in favour of theirs. To counter this phenomenon, there have been numerous discussions which have led to brilliant recommendations. We are proud to host Hon'ble Mr. Justice J.B. Pardiwala, Mr. Nidhesh Gupta and Mr. Siddharth Bhatnagar (Senior Advocates) on this topic which has recently come to the fore owing to a variety of socio-legal challenges that confront this dispute.

"I would just like to say that our institution is based on upholding the trust and as guardians of this institution. I would only like to conclude by saying, truth is the highest Dharma."

These were the words of Hon'ble Mr. Justice Vikram Nath, while he was addressing the full court and lawyers of the Gujarat High Court, highlighting why it is important for the judiciary to uphold the trust of people, as he bid farewell to the High Court after his appointment to the Supreme Court in August 2021. He was born on 24th September 1962 in the Kaushambi district of Uttar Pradesh and followed the footsteps of his paternal ancestry by pursuing law. He graduated from the University of Lucknow and enrolled as an advocate in March 1987 and primarily practised before the Allahabad High Court.

He was elevated as an Additional Judge of the Allahabad High Court on September 24th, 2004. He took oath as Permanent Judge on February 27th, 2006, and was appointed as Chief Justice of the Gujarat High Court on September 10th, 2019. During his tenure as a Chief Justice of the High Court of Gujarat, he dealt with several matters of immense public importance. Justice Vikram Nath had taken up suo moto cognizance of the Government's response to COVID 19 and passed a slew of directions to ensure equitable distribution of resources to deal with the COVID crisis. Further while hearing a challenge to a preventive detention order in the case of Haidarsha Abdulsha Pir v. State of Gujarat (2020), Justice Nath made some crucial observations on personal liberty vis-a-vis preventive detention by stating that, *"the Courts should always lean in favour of upholding personal liberty, for it is one of the essential pillars of democracy."* In yet another important ruling in his tenure, in the context of the Right to Education, he directed the State Government to ensure that a parent's inability to pay the fees should not be any hindrance in the education of the child.

His colossal persona and his work reflect his immense experience as an integral part of the institution. Being a firm believer in the accountability of all organs of a working democracy, he holds the distinction of being the first Chief Justice of a High Court in India to live-stream the proceedings of his Courtroom. His steps taken to ensure the common person's belief in the judiciary is reinforced, are truly remarkable and we look forward to learning from such a virtuous leader.

Hon'ble Mr. Justice J.B. Pardiwala Judge, Supreme Court of India

Justice Jamshed Burjor Pardiwala, was born in Mumbai on August 12th, 1965 to a family of lawyers rooted in South Gujarat's Valsad. He obtained his degree of law from K.M.Law College, Valsad in 1988 and began his legal practice at Valsad in 1989. He shifted his practice to the Gujarat High Court in September 1990. In 2002, he was appointed as Standing Counsel for the High Court of Gujarat and subordinate courts. He was well regarded for his legal prowess as a lawyer.On February 17th , 2011, he was appointed as an Additional Judge of the Gujarat High Court. On January 28th, 2013 he was elevated as a Permanent Judge. During his tenure as a judge at the Gujarat High Court, he presided over numerous criminal, civil, taxation, commercial and environmental matters of national importance. On May 9th, 2022, he assumed office as a Judge of the Supreme Court. He is also in-line to be the Chief Justice of India in May 2028.

He is well regarded for having authored various judgments that have been instrumental for the constitutional progress of the rights of the citizenry during his tenure at the Gujarat High Court. Justice Pardiwala has been a champion of the marginalised and downtrodden and this has been reflected in his judgments. In a suo moto case relating to the pandemic in 2020 and response of the government, he held the Gujarat government accountable and took cognizance for its poor management of the crisis.

In the case of Nimeshbhai Bharatbhai Desai v State Of Gujarat decided in 2018, he opined that reform must be brought to the law and marital rape "ought to be a crime and not a concept. It has long been overdue to jettison the notion of "implied consent" in marriage. The law must uphold the bodily autonomy of all women, irrespective of their marital status." We are honoured to host such a luminary at our Symposium.
