

Most Impact Madison grants focus in the areas of: health and human services that support families, women, and children; education programs; arts, culture, and history; as well as a thriving community (animal welfare, recreation parks, and so on). DONOR ADVISED FUNDS



A **Donor Advised Fund (DAF)** is a flexible fund that allows a donor to actively participate in the grantmaking process. Donors can make immediate tax-deductible charitable contributions without needing to identify nonprofit beneficiaries or commit to an annual distribution. Instead, gifts are invested so that they may grow. When ready, fund donors recommend grants to eligible nonprofits. DAFs provide simplicity in managing charitable giving, delivering current tax benefits while enhancing future impact. MCCF currently manages over 40 Donor Advised Funds established through the generosity of local donors.

FIELD OF INTEREST FUNDS

Unlike an agency endowment, which names a single organization as beneficiary, a Field of Interest (FOI) fund allows for discretion in grantmaking to a range of nonprofits within a specified area of focus.

Donors can make contributions in any amount to an existing FOI fund managed by the Madison County Community Foundation. Existing FOI's include: Hecht Family Fund (Mental Health Awareness and Suicide Prevention) Humanities Fund Rosemary B. Sigler Education Fund Downtown Anderson Fund Larry "The Can Man" VanNess Memorial Community Services Fund Women's Endowment Fund Jimmy Fund (Accessibility, Inclusiveness, er Disability Services) New FOI funds can be established for any category of nonprofit agencies (*a minimum fund balance may apply*). FOI's might focus within a variety of areas of need, such as Veterans Services, Pets & Animals, Historic Preservation, and more. Use your imagination and fuel your passion!
