• Today there are about 120 vessels in our pools\*, all of which are operated on the spot market




In 2023 we had 50 vessels in the pool on average and managed a total of 71 vessels over the year





# HOW THE RSA WORKS

- Income generated from the pool vessels are distributed to the members according to the revenue earning capabilities of their vessels
  - Vessels are assessed on tradability and performances (dwt, cubic capacity, service and eco speed & consumption, draft, etc) and a Revenue Sharing Key is established
  - Vessel performances are monitored
  - Working capital of \$400,000 (in bunkers and cash) is required to cover the day-to-day expenses of the vessel (bunkering, port agent fees etc) and is returned to the member when the vessel exits







Delivering great results is at the top of our agenda and our performance is testament to this. Over the past 12 months, the Supramax RSA has outperformed the market by 5%.






