VOICE

Advocacy, campaigns

We influence policy by responding to consultations and offering practical, evidence-based recommendations.

We run campaigns that inform, mobilise and push decision-makers to act in support of mothers.

KNOWLEDGE

Data, Monitoring

We amplify the lived experiences of mothers by conducting surveys and participating in research to gather data. Staying alert to policy shifts, we monitor legislative drafts and issues that shape our evidence-based advocacy.

MOBILISATION

Partnerships, grassroots

We build power from the ground up, partnering with our grassroots network and allies to amplify mothers' voices, spark collective action, and drive systemic change.

A historic UN resolution in February 2024 recognises the importance of care work for the well-being and development of societies.

A major victory for MMM reflecting our commitment to elevating the voices of mothers who are the world's primary caregivers and pushing for policies that value and support care work worldwide.

RESEARCH FOR POLICY CHANGE

Our major Europe-wide *State of Motherhood* report based on what almost 10,000 mothers told us, is a powerful tool that amplifies mothers' lived realities and serves as a guide for evidence-based advocacy, policy change and action.
