SPONSOR & EXHIBITOR AGREEMENT

The following rules and regulations become binding upon the signing of this contract between the applicant and their employees and Xccelerator.

XCCCELERATOR SPONSORSHIP

Xccelerator has a zero-tolerance policy for false certification of individuals as sponsor's representatives, office personnel of a physician's office, misuse of an attendee registration badge, or any other method used to assist unregistered/registered persons to gain admission to the event, workshops or general sessions. Violation of this policy may result in the immediate removal or other actions as deemed appropriate by event management.

PAYMENTS & REFUNDS

A 50% deposit of the total fees, to include sponsorship packages and/or add-on sponsorship opportunities, is due upon the signing of the agreement contract, payable upon signature. No opportunities will be considered reserved until a deposit is received. All contracts must be paid in full no later than 30 days prior to the event, or the package may be canceled and/or reassigned without notification or refund of payments.

CANCELLATION OR REDUCTION

Requests for cancellation or reduction of the sponsor package must be sent in writing to Aesthetic Record. The cancellation and refund policy is as follows:

- Before April 15, 2024: 50% refund of total agreement fees if deposit has been paid.

- After April 15, 2024: NO refund. There are no cancellations or refunds on sponsorship contracts.

SECURITY

Providing security for property and sponsors themselves, as well as for their employees, agents, representatives, and guests, shall be the sole responsibility of the sponsor.

LIABILITY AND INSURANCE

The hotel management and Xccelerator Team will take all reasonable precautions to avoid loss of property by theft or fire, but under no circumstances shall the hotel management or Xccelerator Team be responsible for such losses, and it is recommended that exhibitors cover their property with suitable insurance. In the enforcement and interpretation of these rules and regulations, the decision of Aesthetic Record is final.

DAMAGE TO PROPERTY

You are liable for any damage caused to the building, floor, walls, columns, or to standard booth equipment or to other exhibitors' property. Exhibitors must not apply paint, lacquer, adhesive, or any other coating to buildings, columns, or floors.

PUBLIC POLICY

Sponsors are charged with knowledge of all ordinances and regulations pertaining to taxes, health, fire prevention, customs, and public safety while participating in this show. Compliance with such laws is mandatory for exhibitors and the responsibility of the sponsor.

COMMITMENT PROTOCOL

Sponsors shall reflect their company's highest standards of professionalism during event hours. Any reserved space deemed abandoned will be considered forfeited and removed. No sponsor shall assign, sublet, or share space or sponsorship benefits without express permission from Xccelerator Show Management. Sponsors commit to actively engaging in all scheduled events and activities throughout the duration of the program. You are required for attending all events which you sponsor without exception. Show management request all sponsors are available from May 17, 2024 to May 19, 2024, for the entirety of the program. Failure to meet the agreed-upon commitments may result in dismissal from the program without a refund.

INDEMNIFICATION

Exhibitor agrees to indemnify, defend, save and hold harmless Aesthetic Next, Aesthetic Next Productions, Aesthetic Record, Juvly Aesthetics, Xccelerator and its officers, employees and agents from and against any and all third-party claims, liabilities, losses, damages, costs, claims, awards, judgments, sanctions, expenses, including but without limitation, reasonable attorney's fees and costs, resulting from or arising from any negligence, acts or omissions, or willful misconduct of the Exhibitor, its directors, members, managers, officers, employees, representatives, agents, servants, contractors, patrons, invitees, or guests, in connection with the sponsor's use of the space.

GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles. In the event any action is commenced by either party against the other arising out of, or connected with the Agreement shall be awarded its costs and expenses incurred in such action, including without limitation reasonable attorney's fees and costs.

MEETINGS, ACTIVITIES AND SOCIAL FUNCTIONS

Personal Sponsored events (including those for company personnel only), workshops, sessions, and activities are strictly prohibited during Xccelerator show hours, including exhibit hall hours, social functions, educational sessions, and any other show activities without prior written approval from show management. Contact show management for questions, to request a meeting space, or to sponsor a satellite event or reception.

PROFESSIONAL FILMING AND PHOTOGRAPHY

No professional still image or video recording is permitted at Xccelerator or the event property during Xccelerator under any circumstances without a specific license agreement or approval from show management. Violation of this condition will result in legal action for financial loss and brand damages. Contact show management for

questions or to request a filming and photography.

ADVERTISING, BRANDING, AND PRODUCT DISTRIBUTION

The distribution of pamphlets and product samples are limited strictly within the confines of the Xccelerator event assigned hotel space/aera. Placement of signage, products, or promotional items in meeting hallways, tables and seats, rooms, and other areas outside the designated area is strictly prohibited without prior written approval from show management. For any advertising and branding initiatives beyond the booth space, exhibitors must contact show management for approval and available options. Failure to adhere to these guidelines may result in penalties, removal of materials, and other actions deemed necessary by the event organizers. Sponsors are expected to comply with these regulations to maintain a cohesive and professional event environment.

ATTENDEE LISTS

Xccelerator attendee lists are distributed only to select sponsoring companies, are not sold separately, and should be kept confidential. The selling or distribution of the list and included information with any other persons is strictly prohibited. Mass emails or carbon copying (cc:) multiple recipients on the same email is strongly discouraged. Communications must be in accordance with anti-spam and email marketing laws and regulations in the countries where you do business. Communications must also provide a clear and conspicuous option or explanation of how the recipient can opt out from receiving future messages. The full contact information for your company should be included. Please note that Aesthetic Record does not sell nor share attendee lists or exhibitor lists with or through any third parties.
