

Longboat hires Police Chief from Delray Beach to lead force

More than 76 applicants from across the country wanted to work as a Police chief on Longboat Key.

It's not all hurricanes, library fundraising and road construction on Longboat Key, there is also important police activity that happens on the scenes and behind the scenes, all led by the Chief of Police.

And Longboat Key Town Manager Howard Tipton excitedly announced that Russ Mager, who recently served as Chief of Police of Delray Beach, is taking the helm at the top spot in the Longboat Key police department on August 4.

Longboat holds a certain cachet as a pinnacle endnote for police leaders nationwide desirous to bring their skill sets for a final act to our toney shores.

There were more than 76 applicants from across the country who wanted to work as a chief on Longboat Key. Frank Rubino, one of the applicants, has been serving as Longboat's Interim Chief since George Turner resigned as Chief earlier this year.

Tipton said Rubino was an extremely strong candidate, but that Mager's experience running Delray Beach brought a perfect skill set of community policing, storm preparedness and next generation practices that he wants to



see expanded and implemented on Longboat.

"I wanted someone who had a 21st-century policing attitude. Delray gave him a background in storm events, and Delray is also an accredited department, which is important. Chief Mager has an impressive set of skills, leadership

Baltimore Orioles minor league player dies in Jet Ski crash off Lido Key

The Baltimore Orioles are mourning the loss of one of their minor league players after he died in a Jet Ski accident Sunday off Lido Key in Sarasota County, according to the Florida Fish and Wildlife Commission (FWC).

FWC confirmed 19-year-old Luis Guevara, a player in the Orioles minor league system, died Sunday after the Jet Ski accident on June 15.

Investigators said two personal watercraft collided in the water off Lido Key. Four people were thrown into the water and rescued by good Samaritans. Two people on the first Jet Ski sustained minor injuries, and two others, including Guevara, were taken to the hospital for treatment

Guevara later died of his injuries, according to FWC investigators.

"Luis was a beloved member of our organization, and we are devastated following his tragic passing. Our thoughts and prayers are with

and a track record as a team player," Said Tipton

Rubino will return to his role as Deputy Chief when major starts in August and Tipton went out of his way to complement Rubino for stepping up as needed.

"Rubino was a strong finalist. He did a good job bridging the gap and provided consistency and strong management and service levels went on interrupted," Said Tipton.

Russ Mager spent 29 years with the Delray Beach Police Department – his entire policing career. He was appointed as chief in August 2022.

Mager's resignation came after about a year of contract negotiations between city officials and the Palm Beach County Police Benevolent Association. The union declared an impasse in February; a day after the city's commission did not reach an agreement with the group on matters such as wages, retirement benefits and take-home vehicles.

In a May 15 letter to city officials, Mager warned that the city's failure to approve a new union contract was fueling critical staffing shortages.

"As you all are aware we are presently losing officers," the letter stated — 15 to be exact. "With our current shortages, I have been forced to temporarily reassign officers from specialty units to include pulling from the Detective Bureau, Criminal Intelligence Unit, Motors/Traffic Unit, Problem Oriented Policing Unit and Community Policing Unit."

Mager was appointed as the city's police chief in 2022. He replaced Chief Javaro Sims, who retired after serving for 30 years.

Mager, born in Tallahassee, grew up in South Florida. He was raised in Pompano Beach and Coconut Creek, before leaving for Florida State University in 1987.

As an officer, Mager served on the TACT Team, as an auto theft detective, SWAT Team member and Community Patrol Division member.

In 2015, Mager was promoted to lieutenant of the Community Patrol Division. He later became the special operations lieutenant of the Community Response Division. And, in 2019, he was promoted to captain as the Investigative Division commander — a role he held until December 2020, when he became assistant chief.

limits. With St. Armands being one of the county's top tourist destinations, the gateway to the city's only beach and the only way to reach the Town of Longboat Key from mainland Sarasota, we look to the county to approve the St. Armands Resiliency & Flood Mitigation Project to make us more resilient and able to more quickly bounce back from future storm events.

St. Armands Circle Park and Adjacent Medians

The St. Armands Circle Merchants Association (SACA) is reporting that the city has been planning a landscape refresh project for St. Armands Circle Park and the adjacent medians which is now approved and the work has already begun. All compromised vegetation and trees have been removed. Electrical contractors have been repairing and replacing lighting. And in the next week or two, irrigation work will begin in anticipation of the new plants and trees. There are drawings which show plans for new, lush, and full plantings throughout. By August, there should be a transformation underway. One caveat: the area between storefronts and the curb remains the responsibility of the commercial landowners and/or their merchant tenants.

Overhead Lines Taken Down Between Ringling Bridge and St. Armands

The power lines and poles have been removed from the medians along John Ringling Boulevard. This project was announced during planning to build the St. Armands Parking Garage (pre-2018), and has finally been completed. Goglia reports that he was told that land-scape updates to these medians are not immediately planned, but are a conversation within the City Parks and Recreation Department.

his family, friends, and teammates, and we ask for their continued privacy during this difficult time," Orioles Executive Vice President and General Manager Mike Elias said.

Guevara was signed by the Orioles as an international free agent out of Tinaco, Venezuela, in January 2023. He appeared in 30 games this year, his first season in the United States, playing in 24 games with Single-A Delmarva, four with the FCL Orioles, and two with Double-A Chesapeake. He spent his first two professional seasons from 2023-24 with the DSL Orioles.





Mote Leads Seagrass Restoration plan makes critical impact

Seagrasses play a crucial role in the health and resilience of Florida's coastal ecosystems. They provide nursery habitats for keystone species and stabilize shorelines and sediments. Seagrasses contribute significantly to environmental health by filtering excess nutrients from the water (which improves water quality and reduces harmful algal blooms), capturing and storing carbon dioxide (a process known as carbon sequestration that helps mitigate climate threats), and stabilizing coastal ecosystems (enhancing overall resilience to storms and erosion). Yet, these underwater meadows are vanishing at an alarming rate—approximately 7% per year—due to human activities, natural stressors, and impacts of a changing climate.

Recognizing the urgency for innovative solutions to seagrass meadows depleting globally at alarming rates, the Florida Legislature and Governor established the Seagrass Restoration Technology Development Initiative in 2023 through the Florida Department of Environmental Protection (DEP), with Mote Marine Laboratory leading this effort.

The goal of this Initiative is to develop, test and implement innovative, effective, cost-efficient, and environmentally sustainable technologies and approaches for restoring coastal seagrass ecosystems. The Initiative is a partnership between Mote, the DEP Aquatic Preserve Program, and the University of Florida. Mote serves as the lead administrative component to achieve the goals of the Initiative and create a 10-year Florida Seagrass Restoration Plan.

The Seagrass Restoration Technology Development Initiative is a collaborative and coordinated effort among public and private research entities to develop restoration technologies. It aims to address the loss of seagrass and the cascading ecological and economic impacts of that loss on communities across Florida. As part of this effort, Mote is constructing and managing Florida's primary seagrass genetic library, serving as a hub for statewide collaboration.

In 2024, Mote completed construction on a state-of-theart greenhouse, which will serve as a cornerstone for seagrass

research efforts, enabling scientists, from across florida and around the world, to conduct experiments that replicate real-world stressors such as warming temperatures, reduced salinity, turbidity, grazing, and sulfides. By identifying and cultivating seagrass genotypes resilient to these challenges, Mote is laying the groundwork for long-term restoration success.

Mote postdoctoral research fellow, Dr. Dominique Gallery, is playing a lead role in Mote's Seagrass Ecosystem Restoration Research Program (SERRP), which is designed to tackle these challenges head-on by blending advanced genetic science with practical restoration techniques, a similar approach to Mote's groundbreaking coral restoration strategies.

Dr. Gallery is a researcher specializing in genetic and genomic approaches to marine conservation, will generate genetically resilient seagrass capable of natural reproduction in land-based nurseries, in-water nurseries, and large-scale gene

banks. Dr. Gallery brings expertise in applying population genetics techniques—previously utilized in coral research—to the emerging field of seagrass restoration.

Since the Initiative's inception, Mote has successfully leveraged funding from federal grants and philanthropic support to drive critical advancements in seagrass restoration. Mote contracted eight groundbreaking projects in summer 2024 and released a second competitive Request for Proposals (RFP) in December

Mote Aquarium preparing for a big move to its new facility

Mote Marine Laboratory & Aquarium says it is getting closer to the move from its current location to the new Mote Science Education Aquarium at Nathan Benderson Park.

According to the current timeline, the aquarium on City Island is set to close to visitors on July 6 as staff prepare to move to the new facility.

An opening date for the new facility, Mote says, is dependent on two critical factors: getting water chemistry and essential life support dynamics of the exhibits just right, as well as the quarantine, transfer and acclimation of the animals to the new facility.

According to Mote's website, the artificial aquatic environment in the new aquarium must maintain a delicate balance. "Part of this exercise is simply waiting for the water chemistry to stabilize," the website says.

"Once that occurs, critical life support microbial communities are inoculated into exhibit life support systems and must become stabilized before multi-cellular animal inhabitants of the exhibits are introduced."

Once the animals' new home is ready, the animals themselves must go through quarantine, then be moved to the new aquarium, and acclimation.

Mote SEA will open only after all animals have fully acclimated to their new habitats, Mote said.



Unusual, in that most of the elevated values were along the barrier island (LBK boat ramp, LBK bayfront park, SRQ Sailing squadron) rather than along the mainland shoreline. The mainland shoreline has a much bigger watershed, and more wastewater infrastructure (no WWTPs on the barrier islands anymore) and the barrier island sites are closer to passes, with higher salinity and greater flushing. So a bit odd. Was wind out of the east?



How common are the results from Sarasota Bay

To: Longboat Key Commission, Sarasota City Commission

As you are (hopefully) aware, we have seen some really good news about the bay's health the last few years. Dating back to 2023, we'd been informing our stakeholders about the accumulating evidence that our bay's water quality was starting to turn around - Director's Note: Report card update & meetings in Washington, DC.

By the fall of 2023, FDEP staff in Tallahassee came down to meet with us to confirm and convey the good news that water quality had improved sufficiently in Sarasota Bay that none of the open waters of the bay were out of compliance with the SBEP-developed Numeric Nutrient Concentration (NNC) criteria - Director's Note: FDEP determinations of water quality trends/.

We were fairly certain that the improvements were going to result in a substantial increase in seagrass coverage, which we discussed in both 2023 - Director's Note: Good news on bay recovery, and also in 2024 - Director's Note: Reasons for optimism - with a few caveats

The basis for the water quality improvements was covered in depth in prior Director's Notes, and also is used in great detail in the development of the SBEP-led Water Quality Protection Plan, which is due to be completed this summer - Director's Note: Honing in on the basis for recent trends.... And the improving condition in the bay are not just something that a statistician and/or chemist would be able to determine, my regular communications with recreational fishing guides has led to me being more confident that our findings are reflecting the reality of a cleaner bay - Director's Note: Recreational fishing guide feedback on bay health.

And then, earlier this year, the culmination of all our hard work came about: the wastewater upgrades and large regional stormwater retrofit projects and public education about living a more bay-friendly lifestyle seem to have paid off by us having a 19% increase in seagrass coverage the last two years, an increase likely large enough to provide habitat for over 70 million fish, and providing more food for manatees and sea turtles - Director's Note: 2024 Seagrass results - further good news on the bay's recovery.

There is a lot to be proud of – our local elected officials and partners have funded over \$300 million worth of efforts that have turned this bay around. To be sure, this recovery could slip away from us, like it did before. And the threats of climate change - higher rates of sea level rise, warmer air and water temperatures, the risk of more dangerous hurricanes - all these could set us back again. But for now, let's just enjoy the moment, maybe?

And let's take pride in the uniqueness of our recovery. Just last year, FDEP released its "Integrated Water Quality Assessment for Florida: Sections 303(d), 305(b) and 314 Report and Listing Update". In that report, there is a summary of results from monitoring sites located across the state, where data were analyzed to look for any trends over time in water quality. Of those sites, only 32% showed evidence of improving conditions for Total Nitrogen (TN) and only 15% showed evidence of declining levels of chlorophyll a, the indicator of phytoplankton biomass that FDEP and the US EPA use. While many locations showed lots of variability but no trends, 46% of those stations had a trend of increasing chlorophyll-a.

Basically, in a state where it is much more likely that water quality (as far as nutrients) is



getting worse, not better, we are an outlier - and in a good way. Oh yeah, none of those sites showed a decrease in water temperature, but half showed an increase. Climate change is happening, folks, the data are clear and accumulating.

But this begs the question: Is the success of Sarasota Bay only possible because our watershed is so small? Well, I don't think so. And the reason why is because of what the stakeholders have pulled off in the Chesapeake Bay, where the Chesapeake Bay Program is the example upon which the National Estuary Program was designed.

This plot shows "flow-adjusted" trends over a 30-to-40-year period (varies depending on location) of the concentration of nitrogen in the bay itself, and also in its main tributaries, rivers as large as the Susquehanna, whose watershed includes much of Pennsylvania and even a bit of New York, to the Potomac (where I grew up), and then down to the James. The symbols with a downward-facing green triangle represent statistically significant downward trends (which is good) in the amount of nitrogen in the water column, after adjusting for the influence of wet and/or dry conditions.

Of the dozens of stations shown, well over 95% of them had decreasing TN concentrations. In Florida's latest 305(b) report, the number of monitored stations with decreasing TN values was about 32%. But you know what's really interesting here? The Chesapeake Bay's water shed is almost exactly the same size as the entire state of Florida! Which means, a bay which drains a landmass almost as large as the entire state of Florida (and which houses over 18 million people) has been able to implement a pollutant load reduction strategy that has been able to improve water quality at more than 95% of its stations. That's proof that you don't have to be small to pull off water quality recovery.

One of the reasons why the Chesapeake Bay focused so much on reducing TN values was (similar to us) their desire to increase the amount of underwater grass beds (aka seagrass, or submerged aquatic vegetation). This graph, also from the Chesapeake Bay Program (and using data from the Virginia Institute of Marine Science), shows the plot of seagrass over the past 20 years.

After large rain events, seagrass coverage across the bay drops, but in doesn't collapse the way it did in much of the Indian River Lagoon about a decade ago. And then it starts to increase again in a year or two. That's what resilience is about - not a system that never changes, but a system that can bounce back quickly. That's what we now have in Sarasota Bay, I believe, and that's what the Chesapeake Bay has become. Also, check out the lower yellow line; that's evidence that not only is the Chesapeake Bay cleaner than it was 30 to 40 years ago, but it also has a lot more seagrass habitat than it had 30 to 40 years ago.

Just like us. And maybe, one day in the future, the state as a whole might be able to see the trends we now have in both Sarasota and Chesapeake Bays.

Could be. The important thing about these "fecal indicator bacteria" is that they are not specific to humans, mammals or even animals as a source. You can get high levels of these bacteria from sewage or dog poop or rain washing bird poop off of docks.

But you can also get high levels of these "fecal" bacteria from decomposing grass blades from a neighborhood that blows grass clippings into the storm drain system, or from decomposing seaweed, or from the sloughed off seagrass blades. All those 12,000 acres of seagrass - those blades are replaced every month or so in the summertime, and when they decay/decompose, they can be the source of the bacteria as well as sewage.

Ohanna like I used to, but there is still a very good amount of beach to walk north of Ohanna and I think the vocal minority has gone through their "grieving process" and unhappily accepts the laws regarding beachfront property ownership.

In a candid conversation with the coastal engineer who had input on the enclosed Power Point, he mentioned on a phone call that he did not know how successful the groins would be in holding the sand. He was confident that this area would be a challenge given how far the groins would jet out from Ohanna wall (200' ++) creating a very unnatural peninsula. He also questioned whether FDEP would actually allow such a project that would extend out that far into the gulf.

If the groins are installed taxpayers will be strapped with maintaining the renourishment at a potentially steep and unknown cost. Note – All of the cost estimates were done prior to recent inflation spikes.

Now that Hurricane Idalia has exposed seawalls and other hard structure – I believe LBK code requires property owners to maintain seawalls (Seawalls shall be maintained plumb and in good repair, without visible deterioration, spalling of concrete, exposed reinforcements, ground holes, or other damage). Why not enforce current municipal code? This would also give property owners an opportunity to protect their properties and exhibit their willingness to do so without relying on others (taxpayers) to bail them out.

Casey Key Example:

Use Casey Key as a guideline. Very exclusive beachfront homes protected by natural rocks at homeowner expense. It does not seem to influence property values nor a desire to build beachfront. In fact, new home construction is built to withstand sea rise and as time goes on, people will build with the expectation of erosion and storm surge. I believe that LBK can make an investment and effort to help the 16 property owners with getting the necessary clearance to reinforce their properties. This might not be a perfect solution, but it does not strap taxpayers to a very questionable and expensive project. Here is an example of a Casey Key home:

In summary – Gulfside erosion is not a new problem as is evident with half century old seawalls. The owners of these properties are/were aware of the challenges in this area (or at least should have been aware with some due diligence) and LBK can empower these homeowners by getting the necessary clearance to reinforce their properties, enhance the aesthetics, and help maintain property values. Taxpayers should not be asked to bail out 16 homeowners that have current property values of \$4 million (land only) to as much as \$17 million (i.e. spec home currently being built at 6489 Gulfside Rd) for an expensive experimental project that will require constant funding. In the best interest of the majority of LBK homeowners, wouldn't it make sense to at least explore and try this approach first before committing to such a large investment – what do we have to lose? Thank You for reading this.



St Armands – Lido Key Food & Beverage Sector Resilience Part 2

While far from complete, the recovery of the St. Armand's Circle and Lido Key area has moved beyond its critical first stages.

Last week's Wine Times column surveyed the St. Armand's - Lido Key food and bever-

age sector beginning on City Island and moving south on Boulevard of the Presidents along the west side of the circle to Lido Beach and back north toward the Circle.

Continuing the survey past Kilwin's and River Street Sweets on John Ringling approaching the Circle, we see Rico's Pizzeria and Le Macaron open to walk in customers. Many of the stores on the south side of the Circle have closed. Ben & Jerry's has opened and serves ice cream until 10PM. Big Olaf's Creamery (serving Yoder's Ice Cream) on west Washington Street stays open to 10PM as well. Two locations of Ephesus Mediterranean Delights have reopened on the Circle. Settimi's Gelato, as one would expect, serves tasty gelato.

The Meaney's Mini-Donut shop at the intersection of the Circle and Boulevard of the Presidents has closed. Going south away from the Circle along the hard-hit area on the right side of Boulevard of the Presidents, all food venues have

right side of Boulevard of the Presidents, all food venues have closed. The Italian ristorante Le Colonne, famous for Mama Graziella's handmade pasta, has a "temporarily closed" sign out front. We are hoping that this landmark restaurant makes a comeback soon.

Across the Boulevard of the Presidents from Le Colonne, the trattoria 15 South by Napulè, offers a full bar, a wood-fired Neopolitan pizzas, and handmade pasta. Continuing north and east on the Circle, the Crab and Fin restaurant (craft cocktails and fresh shell and fin fish dishes) is serving a steady stream of customers. Going east on John Ringling toward the Ringling Bridge, a new I Love Candy and Ice Cream location is opening just before the large Alvin's Alley store. In the middle of that block, the Blue Dolphin Café opens early for coffee and breakfast. Past the Blue Dolphin, the Green Zebra (vegetarian) has opened for takeout orders.

Continuing north across John Ringling and circling back west toward the Circle, Tommy Bahamas Restaurant has staked out an expanse of storefronts below the former location of the Shore Restaurant on the level above. Tommy Bahamas plans to open both the lower and upper levels of restaurant space this summer.

Starbucks on the Circle has closed temporarily. The Café at Soliel nearby has stepped in to serve cappuccino and other brunch specialties. The adjoining Café at St. Armands serves drinks and Mediterranean lunch and dinner selections. The Cha Cha Coconuts tropical bar and café, owned by the Columbia restaurant group, occupies a space between the Café on St. Armand and the Columbia. The Cilantro Café on the level above the Columbia opened shortly after the Circle opened shortly after Hurricane Milton.

In the area immediately west and north of the Columbia, the Madison Café has closed. That block of N Boulevard of the Presidents remains open for development.

While far from complete, the recovery of the St. Armand's Circle and Lido Key area has moved beyond its critical first stages. The commercial and residential tax base of the area has inspired federal, state, county, and city agencies to help improve resiliency to storm surges in particular and flooding in general. The future of St. Armand's Circle and Lido Key depends on public and private efforts that rely on one another: so far, so good, but still uncertain.
