Record number of 'disoriented' turtles hatch in 2025 says Mote

5,735 sea turtle nests were counted along the 35 miles of Sarasota County beaches, stretching from Longboat Key to Venice

Mote Marine Laboratory & Aquarium has announced a historic sea turtle nesting season in 2025, documenting the highest number of nests in its 43-year monitoring history, even as researchers sound the alarm over a dramatic increase in hatchling disorientations.

Mote's Sea Turtle Conservation and Research Program (STCRP) recorded a total of 5,735 sea turtle nests along the 35 miles of Sarasota County beaches, stretching from Longboat Key to Venice. This record far surpasses the 4,369 nests documented in 2024.

Nesting Success: A Conservation Triumph

The vast majority of nests were laid by Loggerhead turtles (*Caretta caretta*), a threatened species, accounting for 5,384 nests. Green sea turtles (*Chelonia mydas*) contributed 351 nests, with occasional rare nests from Kemp's ridley and leatherback turtles also observed.

Dr. Jake Lasala, Manager of Mote's STCRP, celebrated the achievement. "This year's record



numbers show that Mote's conservation measures are working," Dr. Lasala stated. The program's success

County to Create 'No Wake Zone' at South Lido Beach

Sarasota County leaders have backed away from a proposed ordinance that would have banned motorboats near the shore of South Lido Beach and Ted Sperling Park, opting instead to pursue the creation of an Idle Speed, No Wake Zone.

The decision, finalized after a public hearing and input from law enforcement and legal teams, reflects the complexity of regulating Florida waterways. A full motorboat ban would have required lengthy and rigorous approval from the Florida Fish and Wildlife Conservation Commission (FWC), whereas the creation of an idle speed zone is a more immediately achievable action under local authority.

Safety Concerns Drive the Change

The push for new water restrictions follows years of escalating public safety concerns and complaints

18-Story Waldorf Astoria Tower to Replace Zenith Building at Five Points Intersection

Developers emphasized that the design is intended to correct the Zenith Building's isolation from street-level activity.

The long-discussed redevelopment of a key downtown parcel is moving forward.

Local development group Jebcore Companies and WMG Development, in partnership with Hilton, have announced plans for the Waldorf Astoria Residences Sarasota, an 18-story luxury residential tower slated for the prominent Five Points site.

The project, located at 1390 Main Street and 40 South Pineapple Avenue, will involve the demolition of the 12-story Zenith Building—a structure built in 1972 that has long drawn criticism for its bulky profile and deep setbacks. WMG Development acquired the 1.19-acre property, including its attached parking structure, for \$24 million in 2023.

The new tower, designed by



ODP Architecture & Design with interiors by Workshop/APD, will feature 86 private residences, spanning one- to five-bedroom units and penthouses. It will introduce the Waldorf Astoria brand to the Sarasota market for the first time.

Focus on Streetscape and Commercial Use

Developers emphasized that the design is intended to correct the

Zenith Building's isolation from street-level activity.

"That Five Points site deserves a stronger presence," said Sadek Omar, Partner at Jebcore Companies. "We've worked with the Downtown Sarasota Condominium Association and neighbors and listened. It's an opportunity to improve a key intersection and it feels like a privilege to help reshape it."

The plans dedicate substantial

space to public engagement, including:

- 42,000 square feet of Class A commercial and office space across the ground and second floors, with plans for a restaurant and bar.
- Ground-floor activation through wider sidewalks and shade trees.

The building also outlines over 50,000 square feet of exclusive resi-

conducted by the Sea Turtle Patrol, a dedicated team of STCRP staff, interns, and over 300 volunteers, who monitor and protect nests from April 15 through October 31 (with a few nests still incubating into November this season).

The New Challenge: Rising Disorientations

Despite the record nesting numbers, the data also revealed a disturbing trend: 716 disorientation events, the highest number ever documented by Mote.
Disorientations occur when artificial lighting along the shoreline misleads hatchlings or returning nesting females. Instead of heading toward the natural light over the ocean, the turtles are drawn inland, often leading to exhaustion, dehydration, or death.

Dr. Lasala emphasized the urgent need for community action to address this new challenge. “However, we’re seeing new challenges emerge, such as the rise in disorientations. It’s more important than ever for our community to turn off or shield beachfront lights, remove beach furniture at night, and keep nesting areas clear to give every hatchling the best possible chance at survival.”

Long-Term Monitoring Informs Protection

Mote’s STCRP has been a cornerstone of sea turtle protection since 1982, maintaining one of the longest continuous sea turtle monitoring datasets in the U.S. Scientists use this long-term data to study population trends, reproductive success, and how human and environmental factors affect nesting behavior. This research directly supports management decisions made by local, state, and federal conservation partners.
Mote’s sea turtle activities are conducted under multiple FWC Permits. The public can learn more about joining the Sea Turtle Patrol or how to help protect sea turtles by visiting mote.org/seaturtles.

from South Lido residents and non-motorized watercraft users (kayakers, paddleboarders, and swimmers). Residents presented the County Commission with eyewitness accounts and video showing reckless operation, particularly by personal watercraft (jet ski) users, who were frequently seen speeding dangerously close to the shore.

The issue was tragically underscored by a fatal jet ski collision in the summer that killed Luis Guevara, a 22-year-old minor league baseball player for the Baltimore Orioles, accelerating the County’s move to regulate the chaotic area.

From Ban to ‘No Wake’

Initially, the County Commission considered a full exclusion zone that would prohibit motorized vessels within 300 feet of the park’s boundary. However, during the review process, law enforcement expressed concerns about the difficulty of enforcing a total ban. Furthermore, the legal and regulatory hurdle of securing FWC approval for a motorboat exclusion zone—which requires the state to determine it is “necessary to protect public safety”—was seen as a significant potential roadblock.

- By pivoting to an Idle Speed, No Wake Zone, the County aims to:
- Reduce speed and wakes near the popular recreational area, minimizing the risk of collisions between motorized vessels and non-motorized users.
 - Implement the safety measure faster, as a No Wake designation is easier to establish locally.
 - Provide immediate relief to residents who have long called for action to restore order and safety to the popular area.
- The County has been authorized to proceed with the process of establishing the idle speed zone.

dential amenities, including a resort-style pool deck, spa, movie theater lounge, golf simulator, and unique resident services such as a house car and a private day yacht.

Cost, Pricing, and Market Uncertainty

The City’s approval of the project comes with an understanding of its position in the region’s highly competitive luxury market. The developers have included seven attainable units under the city’s bonus density program in the overall plan.
While final pricing has not been released, Waldorf Astoria-branded residences in other markets typically command substantial figures, often starting in the low millions and rising into the tens of millions for larger floor plans.
Developers acknowledged that the economic climate presents variables for the project, which is dependent on delivering a high-quality product in a cooling environment. Construction is not anticipated to begin until late 2026.
“There’s some uncertainty due to things like tariffs affecting costs, and we’re seeing a pullback in the condo market,” Omar noted.
The project is currently proceeding through the planning stages, with sales to be represented by Michael Saunders & Company.

Tax valuations

Attached you will find two letters. The first is to the Manatee County Property Appraiser regarding the valuations he certified on July 1, 2025 and what we believe are inconsistencies in how values were calculated. Changes to valuations have large implications for taxing authorities like the Town, County, and School Board, but they can also have potentially significant impacts to property owners as well when it comes to insurance and resale. The goal of the letter is to create a dialogue between the taxing authorities like the Town and the Property Appraiser's Office so that we can understand how we got to where we are and what the future holds.
The second letter is an example of a letter sent to our fellow taxing authorities alerting them to this conversation and inviting them to join the Town in this discussion. We don't yet have a date when the Property Appraiser's Office might agree to meet, and we will keep you informed of our progress to get this set up. From a timing perspective, all taxing authorities need to understand any additional valuation changes (positive or negative) as we kick off our budget

planning in early 2026. Please let me know if you have any questions.

To: Longboat Key Commission

I respectfully request that you vote against the proposed amendment that would allow the St. Regis to disregard Town regulations, this time concerning the sign on the pier. The St. Regis has repeatedly positioned itself as unaware of or exempt from established rules and then sought special accommodations. Our sign ordinances were created to apply uniformly to all parties.

I recall, for example, when Lynches operated their restaurant on Longboat Key. Their shamrock sign did not meet the Town's requirements, and they were required to modify it accordingly—ultimately cutting it in half to comply. They later relocated to St. Armands. Experiences such as this underscore the importance of applying our regulations consistently; otherwise, it is only a matter of time before the St. Regis asserts additional privileges, potentially even limiting Longboat Key residents access to walk on their beach.

Along those lines, I am also concerned that St. Regis owners appear to walk their dogs on the beach despite longstanding prohibitions. Those of us who live on the beach adhere to these rules, yet we are expected to overlook ongoing exceptions made for the St. Regis, which increasingly seems to be treated as though it is above them.

Another issue is the St. Regis's possession of water barriers intended to protect its own property during major storms. While understandable in isolation, the use of such barriers would likely redirect storm surge toward adjacent properties that sit at lower elevations, increasing the risk of greater damage to the neighboring properties. This raises serious questions about their commitment to responsible and considerate community stewardship.

For these reasons, I urge you to vote no on the amendment and to uphold the consistent and equitable application of Town laws.

Funding Secured Through SRF

The Town of Longboat Key is proud to announce that it has been awarded \$19.2 million for wastewater infrastructure improvements. Specifically, this funding will support the construction of the new Subaqueous Wastewater Force Main. These funds were received based on federal funding as part of the American Relief Act, 2025, Supplemental Appropriation for Hurricanes Helene and Milton and the Hawai'i Wildfires (SAHM). As you know, the Town was directly and significantly impacted by both Hurricanes Helene and Milton. The impacts to the Town's wastewater system enabled the town to apply for these SAHM funds in June 2025. On November

12, 2025, the FDEP State Revolving Funds (SRF) announced the results of the funding for numerous impacted utilities, with the Town of Longboat Key being one of the selected recipients.

Specifically, the Town's request included funding for the construction of the new Subaqueous Force Main, which is a critical pipeline that transmits all of the Town's wastewater to the Manatee County Wastewater Plant on the mainland. This appropriation, administered by the Florida DEP State Revolving Funds (SRF) program, provides low-interest loans to local governments and other entities for water quality and water supply projects.

The results of the appropriation are as follows:

- Loan: \$9,583,252 loan at 0% interest
- Grant: \$9,583,252 "principal forgiveness," not to be repaid
- Total: \$19,166,503

Next Steps – Although the town has already applied for and received approval for these funds, it must now initiate a formal application process with FDEP SRF to submit the required loan documents and supporting information. This process will begin immediately and is expected to be complete by March of 2026.

The Town has been in the planning and design process for the new critical Subaqueous Force Main for some time already. The receipt of these funds will enable the Town to proceed with the construction of the new force main while further solidifying the Town's financing for these facilities.

Great question and one of the things we are exploring. We may be able to, for example, begin the landside work ahead of schedule. We will cover what these funds might enable us to do in January.

Sarasota Bay Estuary Program update

To: Longboat Key Commission, Sarasota City Commission

This will be my last Director's Note, as the eminently qualified Ryan Gandy, supported by our fantastic staff, will be in charge as of next week. But I wanted to spend just a bit of time to summarize what we've done the past few years, and why we did it.

The signs that Sarasota Bay was in trouble predate me

taking the position five years ago. Back in 2013, Sarasota County started to see troubling signs in terms of the abundance and types of macroalgae in the lower bay. Between 2014 and 2018, the lower bay lost 30% of its seagrass coverage, wiping out most of the gains that arose between 1999 and 2016 in that part of the bay. In the upper bay, we suffered one of the most intense and longest-lasting red tide events in decades. Researchers at New College documented a huge impact on the bay's fish populations during that red tide, which was also the likely main cause of a seagrass loss of about 2,000 acres between 2018 and 2020. Then, in 2021, FDEP determined that the waters from Ringling Causeway down to Venice Inlet were "out of compliance" with the Numeric Nutrient Concentration (NNC) criteria that were established back in 2013.

In short, our bay was in trouble, with macroalgae blooms, elevated levels of floating microscopic algae, intense red tides, seagrass loss and widespread impacts to our fish populations.

Fast forward to 2025, and where are we? Well, we're not pristine, but we're in much better shape:

Thanks to over \$300 million worth of investments in wastewater upgrades and large stormwater retrofits, the Pollutant Load Reduction Goal (PLRG) that we set in 2021 appears to have been met already

Due to the implementation of projects that have met our PLRG, we have been seeing positive system responses the last few years:

The amount of floating microscopic algae has decreased by about 50% over the past few years.

The amount of macroalgae has declined even more, in the lower bay in particular, over the past few years.

Bay-wide, we've gained nearly 2,000 acres of seagrass since 2022, the second largest increase (19%) in the past 30 years.

Using values used by FDEP and FFWCC, that seagrass increase is likely sufficient to support over 70 million fish.

This graphical abstract, developed by Megan, illustrates how we used the combination of our Ecosystem Health Report Card and our watershed-wide pollutant loading model to develop our PLRG. We then hosted, in 2021, a Water Quality Restoration Workshop where we asked our local government partners to bring us all the projects that they could commit to implementing, which turned out to be sufficient to meet our PLRG target. And then, over the past three years, we've worked with our partners to collect, analyze and interpret the data that shows that our efforts have actually worked.

This does not mean that we've solved all our bay's problems, but it does mean that we are a healthier system than we were a few years ago. And, as we've said multiple times, a healthier bay is a more resilient bay. And we'll need to be more resilient, because the indicators of climate change are already here.

As we've discussed in the past, our air is warmer than it was a few decades ago, as is our water temperature. Warmer air holds more moisture, and as discussed previously, we have seen a big increase in the frequency of what used to be rare rainfall amounts. Using data from Bradenton, we had only a single day with more than 5" of rain in the 20 years between 1965 and 1984. Over the last 10 years alone, we've had eight

Beaujolais Nouveau Day 2025

Our experience in our search for Beaujolais Nouveau in Sarasota during its special day reminded us of the quest of Linus Van Pelt in the comic strip Peanuts

November 20th of 2025, the third Thursday in November and a week before Thanksgiving in the USA, marks the day in France that the first wine of the 2025 vintage arrives in Paris. We had announced the occasion a week earlier and scouted wine stores in the Sarasota Florida area on the big day for bottles labelled "Beaujolais Nouveau 2025". We discovered that stores such as LBK Liquors and others had missed the wholesalers cutoff date for ordering Beaujolais Nouveau and could not ask for a November 20th or earlier delivery date.

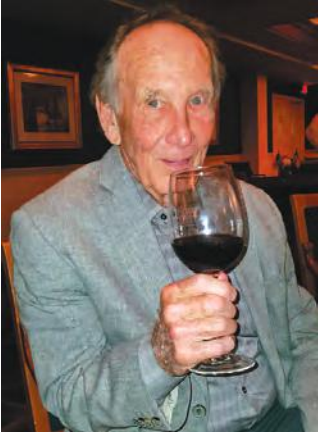
Our experience in our search for Beaujolais Nouveau in Sarasota during its special day reminded us of the quest of Linus Van Pelt in the comic strip Peanuts (circa 1966) to find the mythical Great Pumpkin during his vigil in a pumpkin patch. Cartoonist Charles Schulz penned both the episode of the Great Pumpkin in the comics and the script for a movie about Linus' obsession with the Great Pumpkin.

Our quest for Beaujolais Nouveau 2025 fared better than Linus' search for the Great Pumpkin. We found small displays at a couple of stores that we had asked a few days earlier about their plans for Beaujolais Nouveau Day: ABC Fine Wine and Spirits and Sarasota Liquors Wine. We bought a bottle of the iconic 2025 George DuBeuf Beaujolais Nouveau from Sarasota Liquors.

We also bought a bottle of the 2025 Marechal Beaujolais Nouveau from ABC. Each of the bottles sold for \$17.

Some of the 125 guests at a pre-Thanksgiving feast at CitySide, an apartment complex in the Rosemary District in Sarasota, sampled the two bottles of Beaujolais Nouveau. Both had fresh red fruit tastes and light, dry finishes. The Marechal had a deeper red hue than the DuBeuf. Each of these wines paired well with turkey and ham, dressing, cranberries, squash, and root vegetables traditionally part of a Thanksgiving feast.

We echo the recommendations of wine experts. Serve Beaujolais with harvest feasts. It has the light tastes that enhance bird, pork, and vegetarian dishes. While Beaujolais has usually



made lighter wines, the region also produces natural Cru Beaujolais wines from the Gamay grape that rival the Pinot Noir of neighboring Burgandy.

S. W. Hermansen has used his expertise in econometrics, data science and epidemiology to help develop research databases for the Pentagon, the National Institutes of Health, the Department of Agriculture, and Health Resources and Services. Officer Troyer was dispatched to the Police Department to a walk in complaint. The complainant and her husband walked into the police department lobby and they requested to make a police report regarding suspicious incidents occurring at their residence at Bogey Lane. The complainants said they go back and forth traveling but have lived on Longboat Key for three years. Approximately one and a half years ago, the complainants noticed every time they leave for vacation, personal items were missing upon their return. The complainants believed someone was breaking into their house and were taking items without permission. The complainants said the person must be close to them because she hides very personal items in specific spots where they should not be found but they are gone nonetheless. The complainant mentioned they have no house keepers and their home was not under current construction, therefore no one had access to the residence. The complainants also mentioned they keep the house very secure when they leave and they recently changed locks to the residence. The complainants reported they were missing a very sentimental ring, dishes, pillowcases and other miscellaneous items, however all of her very expensive items were all in place which was confusing to her. The complainant also said the windows to the home do not open and none of the doors had any pry or forced entry marks. Based on what the two were reporting, the items appeared to be lost. However, the complainants wished for Officer Troyer to visit their residence and see for himself. Upon Officer Troyer's arrival, he checked the front door locks which appeared to be fully operations and were free of any pry marks. Officer Troyer also observed all other doors and windows appeared to be operational as well and were not broken. such days. Increased water temperatures are adding more fuel to spin up more powerful hurricanes and also leading to increased rates of sea level rise. Sea level has been increasing for about 20,000 years, but our rates over the past 20 years (3"/decade) are not only in line with the State of Florida's expectations over the next few decades, they are about three times higher than the rates we've documented over the past 80 or so years. Our current rates of sea level rise also appear to be higher than the average rates that we've had over the past 5,000 years.

We are seeing climate change happening in front of our eyes, which has led in part to the almost complete collapse of the live coral coverage on the Florida Keys Reef Tract, as well as an increased likelihood that storms that would have been Category 1 to 3 are now more likely to be Category 4 and 5 events.

As I say to friends and family (and folks who are neither) you can ignore climate change, but it won't ignore you.

Which leads to the last element of this Director's Note - what are the likely biggest problems we'll see with our changing climate? Will we have another year like 2024? Sure we will, but nobody knows if that will happen in 2026 or maybe not for another 50 years. But we're playing Russian roulette with storms, and our lack of adequate action to address climate change is adding more rounds to the chamber.

With or without a major storm, our region will be challenged with the combination of increased sea level and the increased probability of more intense rain events. Another graphic, created by Megan (who puts my communication efforts to shame) highlights the challenges of dealing with more intense rain co-occurring with higher sea level. Basically, our low-lying areas will find it harder to drain their streets when it rains on a high tide.

Will the SBEP and its stakeholders have the foresight and wisdom to respond to climate change the same way we've responded to the issues of water quality and nutrient enrichment? I don't know, but I hope so. But I would suggest keeping this in mind as well – the vast majority of the costs of the projects that have been implemented to address our water quality problems were paid for by local residents. Neither the State nor the Federal governments have funded most of the wastewater upgrades and stormwater retrofits. They've not played NO role, but they've not played the major role either.

Don't expect much support from either Tallahassee or Washington, D.C. to respond to the stressors of climate change. They might not even want you to say those two words. So maybe you're on your own for a bit on this topic. But if I know this region, I know that you're up to the challenge – more so than any other part of Florida.

And that's the final thing I'd like to point out. This bay isn't better because of me, or the SBEP. Or because of EPA or FDEP. It's cleaner and healthier because of YOU, the local and regional governments, supported by informed and engaged local stakeholders that have funded the projects that got our pollutant loads under control, and that led to our recent improved condition.

Sarasota Bay is the healthiest urban estuary in Florida. And that is something that I, and

you, should be proud of. It's also one of the reasons why I want to go back in the private sector, to see if we can get a few more Sarasota Bay-like success stories initiated, before I shuffle off this mortal coil. It's been a privilege and an honor.

How to rest on vacation

Rest renews, rebuilds, and rewires our brains and bodies, which can make us look better, feel younger, get healthier, plus obtain the peak experiences and memories of a lifetime.

When was the last time you took a vacation and came back fully rested, renewed, and refreshed? Half of Americans come back from vacation bushed or exhausted. Yet rest should produce renewal. We see our hair and and nails grow, but we don't see our brain grow. Yet that's what happens during rest, which is when our bodies literally rebuild and remake themselves (and the process is fast. Some researchers report you essentially get a new heart in three days.) Rest can make us feel younger, look younger, and become healthier in an amazing variety of ways. Still, as Melanie Beck wrote in the June 15th Wall Street, "Relaxing Can Be Hard Work." The last thing you want is to turn vacation into a job. So for your next vacation consider these ideas:



1. Get enough sleep. Most Americans are sleep deprived, and often use vacations and weekends to pare back their sleep debt. What are you left with at the end of a vacation? For most of us, it's memories. Memories are powerfully summarized and remade during sleep, which is also the period where we grow more brain cells (more on this later.) So try to give enough time to sleep - that way you'll really remember some of the best times you have.
2. Spend time enjoying food. Food is more than fuel and materials, it's also love, pleasure, celebration, plus critical information to our body. When we travel we experience different foods with entertainingly different results. Try dining rather than feeding, enjoying food socially as well as physically, emphasizing both new tastes and the people with whom you dine. Meals often become wonderful memories.
3. Alternate physical and mental activities. Brain cell growth occurs through combining physical activity and proper rest. If you move around, strolling, hiking, walking, biking, you create conditions for the brain cell growth which occurs during sleep. One of the easiest ways to do this is described in my book "The Power of Rest" (Harper One, 2010,) by going FAR - following a daily pattern of Food, Activity, Rest, as do many of the longest lived people on earth.
4. Get outside. Studies prove that moving in nature, especially when surrounded by greenery and water, markedly and quickly improves mood. Even if you are in the most urban of environments, get to a park or waterside if you can. Nature is high, wide, vast, and deep, and moments spent in nature can make us feel better physically, mentally, and spiritually.
5. Emphasize experiences. You don't want to treat a vacation like it's a job, where you manage to run through 17 palaces, 24 museums and 11 amusement parks in 8 days. Take time to look and see the unexpected. Let serendipity take its eventful course. A great advantage of travel is to experience the new.
6. Take time for people. When in Paris you may want to see the Louvre and the Eiffel Tower, but what about the people you meet, only some of whom will be the wondrously singular French? Language barriers exist, but people find astonishing ways to get around them and enjoy refreshing perspectives.
- I often talk to people at the end of their lives. Their most powerful and enjoyable memories frequently involve relationships and vacations.
7. Make your days rhythmic and musical. Ever wonder why people enjoy music so much? It's because we are inherently musical. Try to make your vacation days (actually all your days) rhythmic. FAR is one easy way to do this, as is to alternate physical with mental activities. Yet there are many different rhythms in the human body, varying from milliseconds to ninety minutes to the 24 hour day and the year. Every human enjoyment, whether it's conversation, hiking, dining or dancing, has its own rhythm.
8. Use active rest techniques. Rest is not a passive, slow process but quick and active. Using active rest techniques, like following a memorable meal with a pleasant ramble in a park, can aid far more than your waistline. It also allows you to do something truly powerful, giving the right kind of directions to your body's rest and renewal.
9. Figure out your desired level of adventure and go for it.



Keep your vacation a vacation and don't turn it into a job.

Some people like bungee jumping or parachuting from airplanes, while others prefer to watch. Vacations are new experiences. Try to think up experiences you consider imaginative and self-expanding, and try at least one each vacation. Learning new things can be a wonderulf kick, and you can learn a great deal on vacations.

But please, don't forget that rest is a critical part of a healthy lifestyle. Rest renews, rebuilds, and rewires our brains and bodies, which can make us look better, feel younger, get healthier, plus obtain the peak experiences and memories of a lifetime.

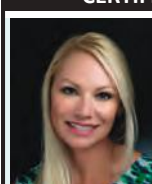

Why is hitting down the middle a good shot?

I started off with a one handed backhand, but I'm curious do you generally advise learning a two-handed? What are the advantages and disadvantages?

"Down the middle solves the riddle". If you take a doubles clinic with me you will often hear me recite these words. Hitting in the middle of the court is a great shot in doubles for a variety of reasons. It can cause confusion and a delayed reaction between partners because they are unsure whose ball it is. From the baseline it is a high percentage shot because you are hitting over the lowest part of the net and in the middle of the court, so your chance of an unforced error is lower. As the net player your highest percentage shot is a volley to the middle of the court. The angle of this shot is very hard to cover unless your opponents follow the ball perfectly. For example, if the returner hits the return to the opposing net player 8 out of 10 of their volleys should go down the middle and the other 2 can be angled off the court. The key to being a successful tennis player is playing high percentage tennis. I encourage you all to work on your ball placement next time you hit the court!

What is a swinging volley? And when should I use it?

A swinging volley is one of the most aggressive shots in tennis, and is typically used when taking high loopy balls out of the air from the baseline. The swinging volley can be used as a great transition shot from the baseline to the net. The swinging volley is basically a forehand that doesn't bounce. It should be hit low to high with a forehand grip usually above the waist and below the shoulders. You still want to follow through like you are hitting a traditional forehand. The swinging volley should be used to take time away from your opponent. For example, if you hit a nice deep shot and your opponent is in trouble, and they lob the ball up to allow themselves more time, you should come forward and take the ball out of the air. The swinging volley can also be helpful if your opponent has heavy topspin and is hitting shots that are bouncing over your head. Instead of backing up and being extremely defensive, move forward and take it out of the air. The swinging volley can also be used as an alternative to an overhead if the sun is in your eyes or you have a shoulder injury.

Who can call a double bounce?

Only the player or players on the side of the court hitting the ball can call a double bounce. You and/or your partner can only call the double bounce on yourselves. If you think your opponent did not get to the ball but they keep playing you must keep playing too. If you stop play to call a double bounce on your opponent and they disagree then you lose the point. The best option is to continue playing and at the end of the point ask them if they thought it double bounced. Again, it is their call so always keep playing until your opponent calls it on themselves.

Who can call a let?

Anyone on the court playing can call a let.

Can I take a serve out of the air?

No. The serve must bounce first. If you are serving and hit the receiver or the receiver's partner with the ball before it bounces it is your point. Even if your serve would have been out.

Can I serve underhand?

Yes! As long as the ball is hit out of the air the serve can be hit many different ways.
