# 2025 Impact Highlights



## Celebrating Philanthropy

The Community Foundation partnered with the Association for Fundraising Professionals to combine two previously separate events together and co-hosted National Philanthropy Day.

The event highlighted the partnerships that drive meaningful change across northwest Ohio, bringing together donors, nonprofit leaders and volunteers to recognize the collective power of giving.



## Building Permanent Arts and Culture Support

Sparked by declining national funding, the inaugural Arts and Culture Fund kicked off and awarded grants to 15 organizations spanning the entire region.

These investments support creative projects that strengthen community identity and expand access to cultural experiences throughout northwest Ohio.



## Breaking New Ground

The Community Foundation set records in both funds raised and grants distributed, reflecting a growing movement in collaborative philanthropy.

These milestones demonstrate the region’s commitment to strategic community investment and shared impact. See page 16 for a detailed look.

## Solar Energy. Community Impact.

After two years and 14,668 students served, the Community Foundation closed its \$1.1 million U.S. Department of Energy-funded Sustainable Communities Educational Initiative — demonstrating how renewable energy can power both classrooms and communities.

Energy from the Overland Solar Array is sold to Dana, Inc., with proceeds of the energy sale invested directly into neighborhoods around the Overland site. In 2025, through the Toledo Neighborhoods Foundation, eight area nonprofits were awarded funding for transformative community building projects.

# Building Pathways

## Investing in Our Region's Future Workforce

The question facing thousands of young adults across northwest Ohio isn't whether they have potential — it's whether they'll have the chance to discover it.

For many ages 18-24, the gap between education and meaningful employment feels impossible to bridge. Traditional pathways don't fit everyone's circumstances. And for too many young people, economic barriers prevent them from exploring careers that could change their trajectory.

That's why The Community Foundation is investing in a different approach: paid work experience that simultaneously builds skills, confidence and economic stability.

At Junior Achievement, President and CEO Jim Pollock recognized a critical blind spot in how we measure high

school success. "High schools are scored in three categories: whether their graduates are enrolled in university, enlisted in the military or employed. I want to give high school seniors an explore option."

The Fifth Year Program is providing high school seniors with a much-needed explore option. Recent graduates unsure of their next step move onto campus for a structured year of discovery — attending a 40-hour-per-week program that demystifies personal finance and professional skills while working three-day-per-week paid internships with local businesses. Each week brings exposure to a new company, a new industry, a new possibility.

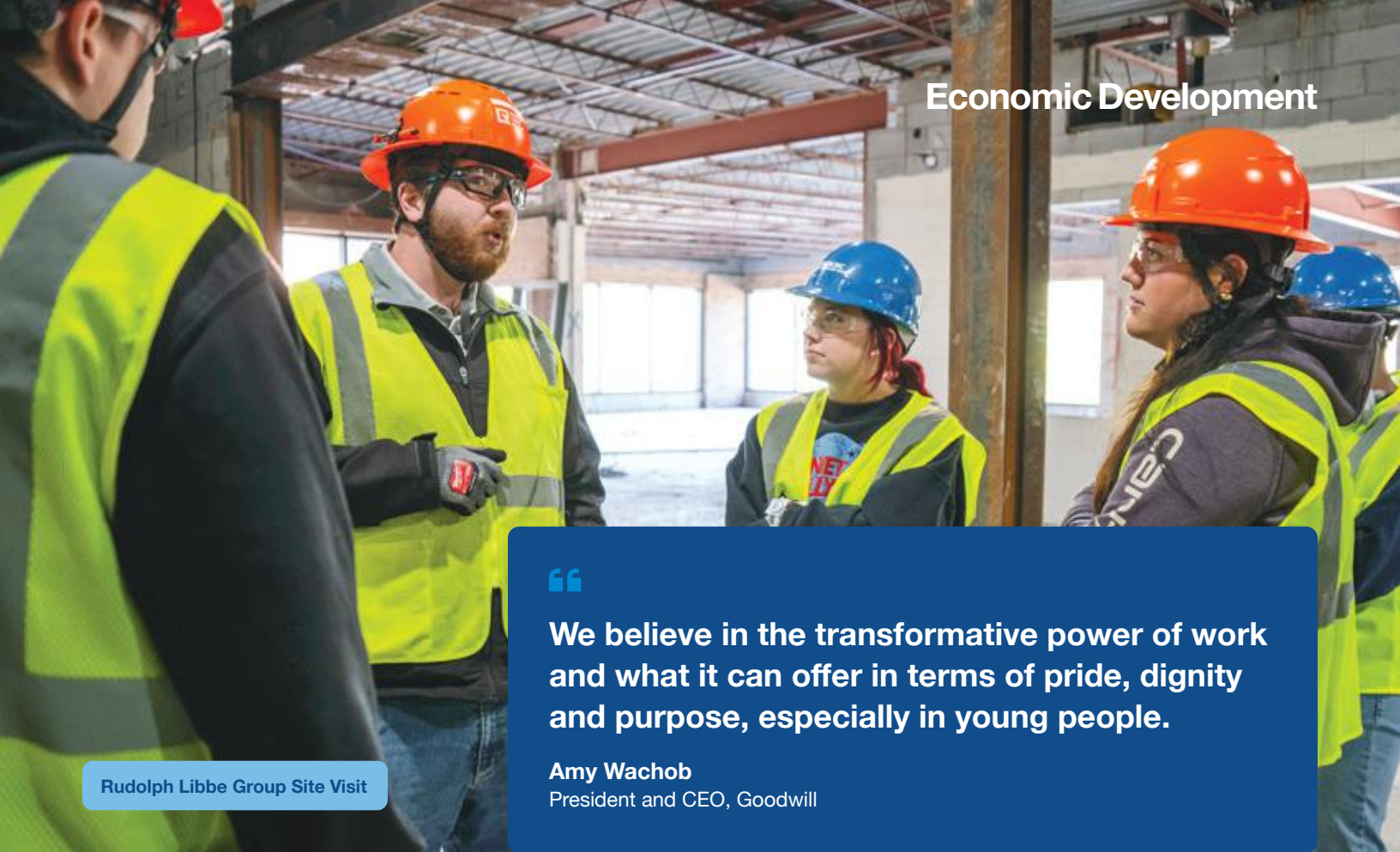
Heading into its third year, the program continues to grow and impact the lives of young people in northwest Ohio.

When the city of Toledo's Mayor's Office of Neighborhood Safety and Engagement (MONSE) invited Goodwill of Northwest Ohio to help address workforce development as part of its anti-gun violence response, the organization drew on 91 years of connecting people to jobs.

The result: Mow-Bility, a program modeled after the City’s Snow Angels initiative that pairs older residents and residents with disabilities with nearby neighbors who volunteer to assist them with snow removal on their sidewalks and driveways.

In the summer of 2025, two cohorts of eight young people exposed to gun violence mowed lawns for 48 older residents and people with disabilities every other week. Homeowners, who previously faced blight citations and potential court appearances, maintained compliance. The program also dedicated two hours weekly to anger management and addressing behavioral and personal issues in new and novel ways. “It was important to provide the resources that they needed, meeting them where they were, not where we thought they should be,” said David Takats, Chief Mission Officer at Goodwill.

With 100 percent participation across both cohorts, Goodwill plans to expand to 60 lawns in 2026.

## Investment that Multiplies

What connects these programs is recognition that opportunity alone isn’t enough. Young people need income while building skills, real-world experience that translates to credentials employers value, and guidance that meets them where they are.

Since 2020, The Community Foundation has contributed more than \$1.7 million in community investments supporting paid training and employment programs across the region and helped leverage over \$3.6 million. Each young adult who builds skills, earns income and envisions a future here strengthens the economic and social fabric of northwest Ohio. This is the multiplier effect of strategic investment: one generation’s opportunity becomes the next generation’s foundation.

# Lee Koenig's Lifetime Commitment to Community

When employees stay 40 years, you're building more than a business. Lee Koenig built the foundation his hometown could stand on.

Lee Koenig never needed to leave Sandusky County to find everything he loved. Born in Fremont in 1929 during the Depression, the son of immigrant parents learned early what mattered most: creating stability for family and community.

As owner of Crown Battery, Lee built more than a successful business. He created jobs that sustained generations of workers over decades, many staying 40 or 50 years.

"A lot of people that supported him at Crown Battery were extremely grateful," his daughter Amy Koenig reflects.

Lee's path began modestly. After working as an industrial arts teacher, he and his wife lived in their basement while constructing the rest of their house, never going beyond their means. His father had taught him to approach life "one thing at a time," and that patient philosophy served him well.

For Lee, business was about people. He understood that every hiring decision affected families, every wage determined community stability. Crown Battery became a cornerstone of Fremont's economy, providing security and opportunity for countless Sandusky County families.

Despite his success, Lee's life remained simple. He swam at the YMCA, golfed at the country club and spent summers at a small Lake Erie cottage—the same pleasures he'd always enjoyed. He remained active in Rotary, supported the YMCA and engaged with the Chamber of Commerce, the UAW and the Elks.

"He lived his own life—followed his path," Amy says. "He was a happy person and didn't require much. He had hobbies and lived a really well-balanced life for being so successful."

Before his passing, Lee established a legacy fund at the Community Foundation, the largest in the organization's history—a decision consistent with who he had always been: someone who believed in and invested in Sandusky County's future.

Through grants and programs funded by his generosity, the fund will continue providing the stability and opportunity Lee knew were essential for families and communities to thrive.

"He probably loved Sandusky County and Fremont more than anyone," Amy says.

# Reinvest Toledo Visionaries Program

## Englewood Residents Lead Brownfield Transformation

Strong neighborhoods are the foundation of thriving communities.

They're where children play safely, where small businesses take root, where neighbors know each other's names. In both urban cores and rural towns across northwest Ohio, vibrant neighborhoods drive economic development, create a sense of belonging and determine whether families choose to stay or leave.

But when neighborhoods decline—when abandoned buildings become eyesores, when residents aren't connected—entire communities suffer. The exodus that often follows drains tax bases, closes schools and breaks the social fabric that holds us together.

This is why neighborhood revitalization matters, and why resident-led transformation—not top-down solutions—creates lasting change.

For decades, the abandoned Doehler-Jarvis plant has loomed over the Englewood community—a contaminated reminder of industrial decline in a neighborhood that's lost half its population since 2010. But momentum is building.

Through Reinvest Toledo's Englewood-Doehler-Jarvis Revitalization Initiative, residents are claiming their seat at the table and leading the transformation themselves.

"Englewood has been losing for so long," says Crystal Taylor, project coordinator for the Doehler Jarvis Visionaries cohort. "It is nice to see community collaboration and people gaining power and their advocacy voice. It feels like there's a change coming."

That change is intentional. Reinvest Toledo, a coalition of neighborhood groups and institutional partners, created the Visionaries program to transform residents into informed, skilled advocates for their own communities.

Executive Director Amelia Gibbon partnered with Englewood resident Tina Hall to recruit neighbors with deep roots in the community. Hall identified a dozen potential leaders who could envision a different future for the blighted site.

"I am encouraged," Hall says, "that we as a group will be able to do something with Doehler-Jarvis so that it is not an eyesore in our community anymore."

The cohort includes people like Danny Hughes, a two-year Reinvest Toledo member; Monica Edwards, who grew up in Englewood in the late 1960s; and Charles Strong, whose family has worshipped in the neighborhood for more than 30 years.

Together, they're learning skills that will outlast any single project.

For Sharon Crawford, the work is personal: "I am so happy to work with the group I'm working with to improve and restore my history."

In Englewood, history isn't being abandoned. It's being reclaimed — one empowered resident at a time.

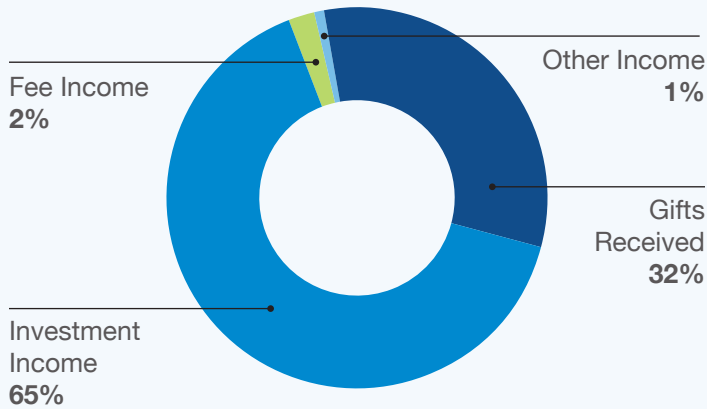

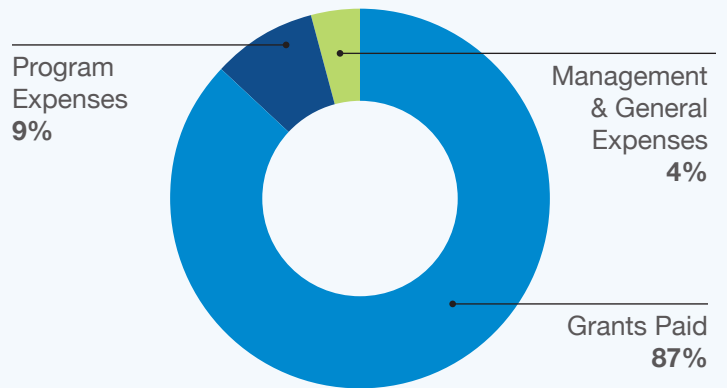

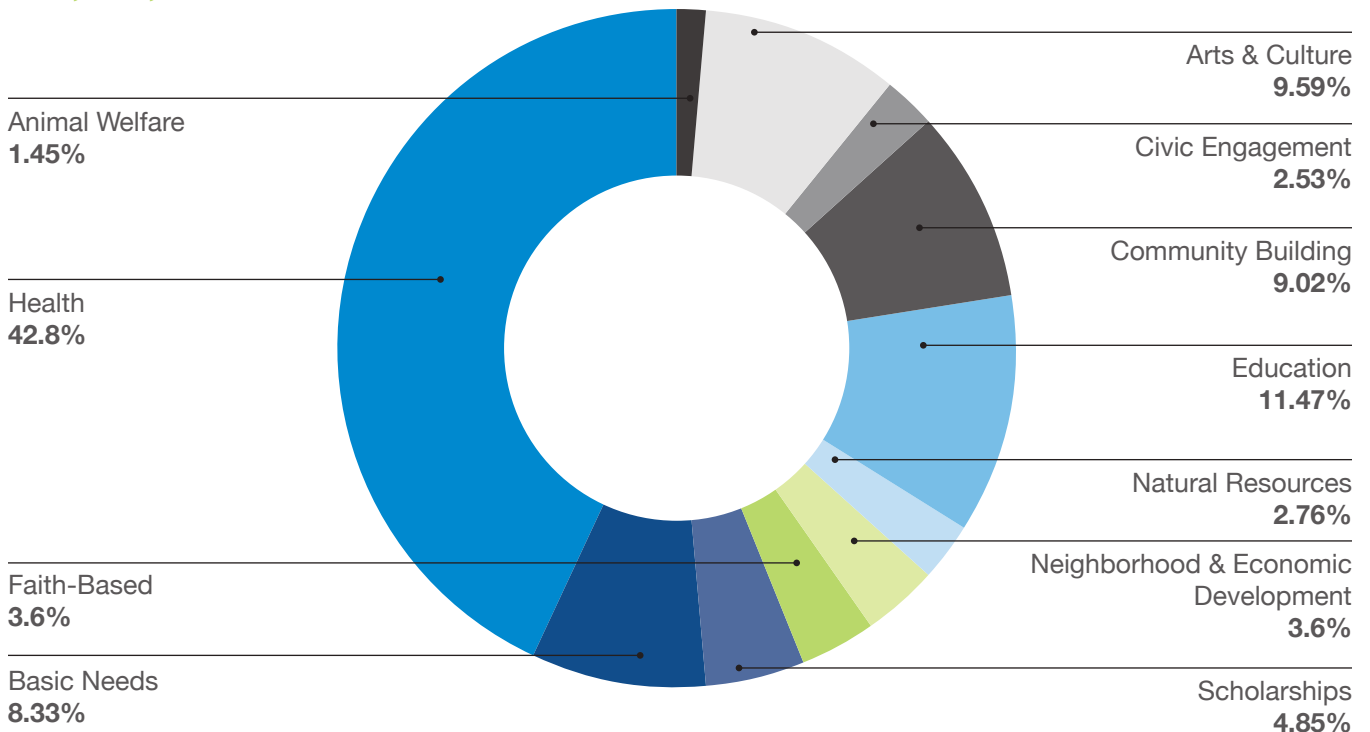
## Total Support, Revenue & Gains \$139,295,177

## Total Grants by Area \$47,315,944.08



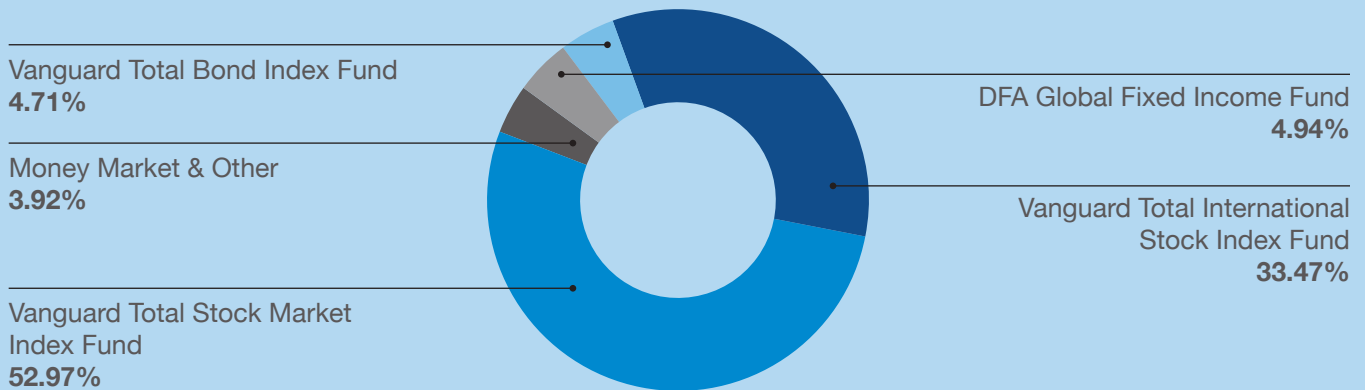

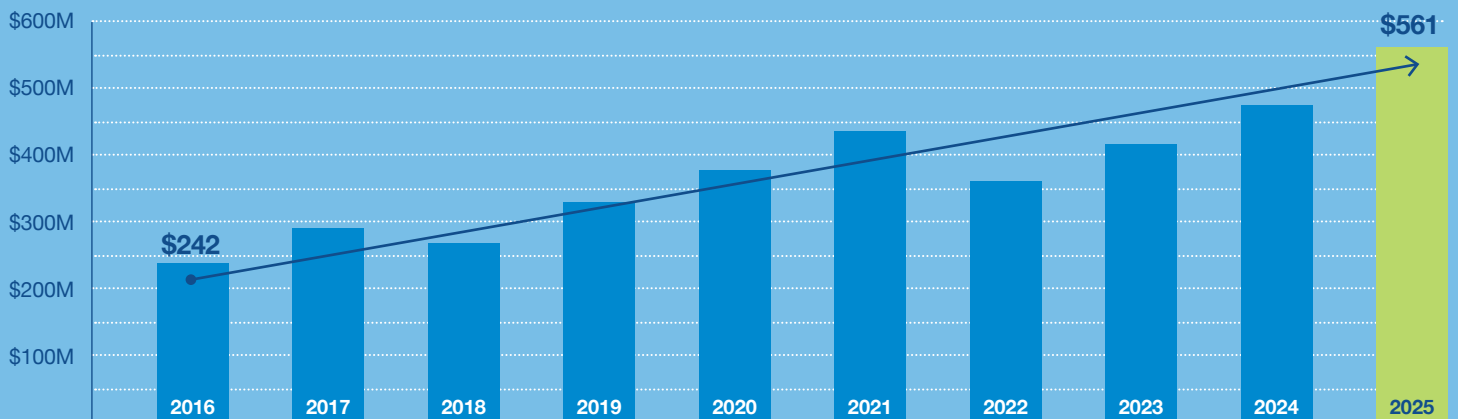
