For over a century, Inspirica has cared for those in need. Through a Depression, two World Wars, strife, conflict, natural disasters, and now a pandemic. And nothing has stopped us from our mission of helping individuals break the cycle of homelessness by achieving - and maintaining - permanent housing and stability in their lives.

And we couldn't do that without you - our individual supporters, corporate and foundation partners, and all those who donated their time, treasure, and talent during the past year. Whether you provided a meal for our Women or Family Shelters, donated items to help our clients, gave a gift to support our programs, or gave your time to beautify our campus, thank you!

Through it all, Inspirica remained unwavering in our mission to provide families and individuals with the stability and essential support services they need to rebuild their lives.

We invested in upgraded technology and equipment for our school-aged children to access their classroom remotely and for adults to stay connected to healthcare providers and support services such as our virtual job training and parenting programs. We also ensured PPE and healthy food was provided across all programs. Our youth center remained open safely providing educational and social enrichment. Finally, in partnership with Community Health Center, we've provided on-site COVID-19 testing and vaccinations.

We also stayed committed to our community. Our Harvest for Hope program distributed over 950 Thanksgiving dinners to our clients and those in need in lower Fairfield County and our Holiday Wishes program provided 2,000 children with 4,000 toys, bringing smiles to those children during this holiday season.

Thank you for your commitment to the community's most vulnerable. Your benevolence makes a significant difference in the lives of those we care for.


