#### 2. Is this recognized legally?

Yes — with two distinct layers:

**Internal Sovereign Recognition:** ICCACK Embassy documents, diplomatic IDs, Laissez-Passer, and Blockchain Dynasty Trust instruments are issued under the jurisdiction of ICCACK and the World Arbitration Court (WAC).

**External State Recognition:** Residency permits and Embassy mission registration with Ministries of Foreign Affairs (MOFAs) are granted by host nations, beginning with the Dominican Republic.

Together, these provide a dual shield of sovereign protection and state recognition.

# 3. Do you follow compliance rules?

Yes — but always with **balance and sovereignty**:

**Residency & Immigration:** Members must appear personally at Dominican Immigration to activate their residence permit (CEDULA).

The exclusive issuer of the **WBB Token (WBBT)** — pegged to the Kuwaiti Dinar, tradeable worldwide under a closed loop system, which cannot be shut down by any Government.

## 5. How is my information and investment protected?

**Technology:** Blockchain-based identity (ISO-aligned) + Dynasty Trust registry.


Legal: All assets are shielded in an Irrevocable Blockchain Dynasty Family Trust, enforceable under World Arbitration Court jurisdiction.
