



Miss Cindy's Doodles: Puppy Reservation Agreement

This agreement (**Agreement**), dated _____ (**Effective Date**), is between _____ (**Breeder**) and _____ (**Buyer**). The subject of this **Agreement** is for the below-described **Puppy or Litter** and the obligations defined herein.

The Breeder and Buyer agree as follows:

1. **Reservation Fee.** A Reservation Fee of \$500 shall be due and paid to Breeder upon execution of this Agreement. This Reservation Fee shall be applied to the final Purchase Price of \$4,500.
2. **Reservation.** Upon receipt of Reservation Fee, Breeder will secure for Buyer either a) the next available spot on the Priority Waitlist from the above designated litter or b) an available puppy selected by Buyer from the above designated litter.
3. **Preferences.** If a puppy/dog that meets Buyer's identified preferences is not available when it becomes Buyer's turn to pick a puppy/dog from the selected litter, Buyer may elect to have the Reservation Fee transferred to the next litter ONE time ONLY.
4. **Purchase Price and Payment Schedule.** The full purchase price of \$4,500 is agreed upon by both parties and is divided into three payments:

- a. **\$500 Reservation Fee** is due upon signing the **Puppy Reservation Agreement** to reserve a waitlist spot or specific available puppy.
 - b. **\$1,500 Payment** is due by 30 days after the puppy is born.
 - c. **\$2,500 Final Payment** is due by the day the puppy/dog is transferred from the Breeder to the Buyer. All transportation expenses are the responsibility of and shall be paid by Buyer.
 - d. All payments due under this Agreement shall be made in US Dollars and paid to Breeder via Payments through Good Dog, Cash or Zelle. (Personal checks are not accepted for final payment unless received 1 week prior to puppy pick up to allow for bank processing.) Zelle is our preferred method of payment.
5. **Puppy/Dog Purchase Agreement.** Both parties have read and agree to all elements of the **Miss Cindy's Doodles Puppy/Dog Purchase Agreement** and further agree to execute the Puppy/Dog Purchase Agreement one week prior to taking possession of the puppy.

IN WITNESS WHEREOF, Breeder and Buyer have executed this Agreement effective as of the Effective Date.
