





The Third Revolution team secured planning consent for a 19.8MWp solar farm near Upper Tean in Staffordshire, on behalf of RE Projects Development.

The site is located on lower grade pasture land and will generate enough renewable energy to supply over 5,200 homes and businesses in the area.

The team worked with ecologists and landscape specialists to create a scheme that will benefit wildlife, enable continued grazing of livestock as well as generating energy.

A long term management plan has been agreed which will ensure the proposed meadows, trees and hedges will be maintained for the duration of the project. An offsite mitigation area has also been included to allow space for birds to nest and to forage in the newly created habitats.

The scheme was approved by Staffordshire Moorlands planning committee and the team is now discharging planning conditions.

Solar farm consent secured to power 5,700 homes

The proposed development in Sandhurst near Gloucester will extend across 25 hectares and will generate enough energy to power almost 6,000 homes.

Third Revolution Projects worked with Sonnedix Bengrove Ltd to secure planning permission via planning committee for a 25-hectare solar farm located in Tewkesbury Borough in October 2024. The proposed development is located near the village of Sandhurst near Gloucester and is expected to export 15MW of solar power – enough to power around 5,700 homes.

The proposals faced considerable planning challenges, including flood risk, ecology, heritage assets and cumulative impacts with an adjacent solar farm. Any of these could have resulted in refusal of the application and so the TRP team worked closely with the design team, officers and stakeholders to minimise impacts and to demonstrate that the development's benefits outweighed any remaining harms.

With the site being located in Flood Zones 2 and 3, TRP worked closely with flood risk consultants and the Environment Agency to achieve a design that placed all sensitive electrical equipment outside of the flood plain and ensured that the development would not increase flood risk elsewhere in a locality where flooding is a significant concern for the community.









Three Bridges Solar and Battery Storage, Breckland

Third Revolution worked with Pathfinder Clean Energy (PACE) to deliver a consent for a 25MW solar and battery storage project near Norwich.

We worked closely with the local community, officers and specialist consultees to create a project that received considerable support.

The scheme was one of the first to use solar panels that track the daily movement of the sun and will also include batteries. The site is very close to two settlements and we worked with the Parish Council and residents to address their concerns. Measures including additional screening, ecological enhancements and a permissive footpath were enough to gain their support.

The development has commenced on site and will be energised in 2024. The TRP team has gained further consents with PACE.

Officers at South Gloucestershire Council have approved a 100MW battery project adjacent to the Iron Acton substation.

Working with client RE Projects Development, the Third Revolution team led the planning application process, including pre-application discussions with officers and specialist consultees, community engagement, preparation of application documents and submission of the application.

The Lower Larks site is in green belt and so the team had to present very special circumstances to justify the location of the project and to develop a landscaping strategy that would ensure the development would not be visible from the surrounding area.
