GAL/CASA PROGRAM

The Guardian ad Litem/Court Appointed Special Advocate (GAL/CASA) Program amplifies the voices of children involved in the Marion County family court system. These children have experienced abuse and neglect or they are involved in high conflict custody, guardianship and adoption cases. Many of these children are placed with caregivers other than their parents and may be living in foster care. Our staff and volunteers advocate for their best interests with a mission of preventing further abuse and neglect as well as helping them to thrive. This program includes two special initiatives: Educational Liaisons and Older Youth.

GAL/CASA PROGRAM OLDER YOUTH INITIATIVES

The Older Youth Initiatives (OYI) team meets the unique needs of youth ages 16 and older who are aging out of the foster care system. Providing intensive advocacy and support for these youth put them on a path to self-sufficiency and fulfillment of their individual potential.

OYI served **266 youth ages 16-22** in 2023 and 2024, including **111** in 2023 and **115** in 2024.

- ✓ **93%** of eligible youth graduated from high school in 2023, and **100%** graduated in 2024.
- ✓ In 2023 & 2024, over **99%** of youth were neither expelled nor suspended from school and had no juvenile court record.



GAL/CASA PROGRAM

EDUCATIONAL LIAISONS

Each Kids' Voice GAL/CASA team includes an Educational Liaison (EL) to support the academic success of the children we serve. ELs are an extremely valuable resource. They provide individualized support by facilitating open communication between caregivers and school staff, attending children's educational meetings, monitoring educational data, and more, all while considering the social-emotional learning and health of each child. The EL Program was supported by ten staff ELs and eight volunteer ELs.

Educational Liaisons served 2,374 youth in 2023 and 2024.

IMPACT STORY

GAL Volunteer

A volunteer Guardian ad Litem (GAL) played a pivotal role in resolving a complex custody case and supporting the wellbeing of a young boy named Levi. Following his parents' divorce, Levi's mother moved him to a different town without court approval or notice to his father. This move coincided with a significant increase in behavioral challenges for Levi at school. Levi's mother also limited his father's access to Levi, his school records, and other important information.

The GAL recognized that increased involvement from Levi's father was crucial. As Levi spent more time with his father, his behavior at school began to improve. The GAL also suggested that Levi participate in extracurricular activities, including soccer, where he thrived.

Based on these observations, the GAL further recommended that Levi remain in his current school district and that his parents share joint custody. The court agreed with these recommendations and ordered co-parenting counseling as well as therapy for Levi. The judge specifically praised the GAL's efforts, acknowledging her ability to identify the underlying issues affecting Levi and recommending appropriate solutions in Levi's best interests.

THE CHILDREN'S LAW CENTER OF INDIANA (CLCI)

The Children's Law Center of Indiana (CLCI), Kids' Voice longest running program, is an integral part of the child and family law system in Indiana. CLCI has a statewide reputation for providing a wealth of knowledge, a network of collaborations, and varied partnerships among Indiana's family law, child welfare, and juvenile justice systems.

Staff attorneys provide guidance on case law, statutes, and legal issues for attorneys, judges, youth-serving professionals, and other GAL/CASA agencies. CLCI also offers professional development, training, technical assistance and hosts our one-of-a-kind Parenting Coordination Clinic.

2023

- ✓ 29 new PC cases were opened and added to 27 existing cases. Of the new cases, 22 were from Marion County, 2 from Hamilton County, and the remainder from Kosciusko, Johnson, Delaware, Hancock, and Hendricks Counties.
- ✓ Provided legal support for 7 cases involving 14 children from other CASA programs across the state.
- ✓ Created 41 new case law summaries, added 2 new legal articles, and developed dozens of trainings on a wide range of topics.
- ✓ Continued development of the new CHINS Deskbook.

2024

- ✓ 33 new PC cases were opened and added to 29 existing cases. Of the new cases, 23 were from Marion County, 2 from Johnson County, 2 from Kosciusko County, and the remainder from Boone, Clinton, Hamilton, Hendricks, Madison, and Shelby Counties.
- ✓ Provided legal support for 6 cases involving 12 children from other CASA programs across the state.
- ✓ Launched the new Statewide Guardian ad Litem Training reaching attendees from 18 Indiana counties.
- ✓ Created 37 new case law summaries.
- ✓ Distributed 300 copies of the CHINS Deskbook to judges, DCS, and CASA offices across Indiana.

THE PARENTING COORDINATION (PC) CLINIC

The Parenting Coordination (PC) Clinic offers modest means and pro bono services helping resolve parental conflicts out of court and reducing stress placed on children by contentious co-parenting relationships. By minimizing tension and shifting the focus to the children's well-being and best interests, the PC Clinic seeks to improve lifelong health and wellness outcomes for the children served and improve co-parenting skills for the parents involved. The PC Clinic is the only one of its kind in Indiana. Its reach continues to grow, serving more than 56 families in 2023, double the number served in 2022. In 2024, 150 to 200 children received support.

Protect.

SUPERVISED PARENTING TIME (SPT) PROGRAM

The Supervised Parenting Time (SPT) Program allows children to safely visit with a parent to maintain a healthy relationship with their parents while reducing the sense of loss and/or abandonment that children often experience. The top priority is the physical and emotional safety of the children served. SPT gets to know and form personal relationships with the parents and children in the program and strives to provide a family-friendly, safe, and universal environment for the families served.

In 2023, there were **545** safe visits supervised for a total of **1,010.5** hours of visiting time.

- ✓ Provided service for **86** children and **65** families.
- ✓ Served families from **10** Indiana counties.
- ✓ Experienced rising demand for services and increased the number of families served by **22%**
- ✓ Delivered services in multiple languages including Spanish, ASL, and Punjabi.

In 2024, there were **742** safe visits supervised for a total of **1,332** hours of visiting time.

- ✓ Provided service for **107** children and **70** families.
- ✓ Served families from **11** Indiana counties, plus **1** out of state.



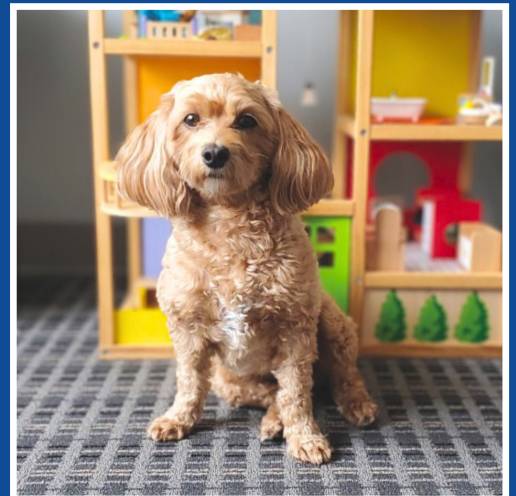

IMPACT STORY

Supervised Parenting Time Program

Clover, our therapy dog, has been a positive addition to the Supervised Parenting Time Program. She played an important role in helping Alicia and her 8-year-old son, Mason, to reconnect after she had been absent from his life for nearly three years.

Clover's presence helped both Alicia and Mason feel at ease, creating a positive shared experience during their reintroduction at Kids' Voice. Sitting on the floor together, they petted and played with Clover, which naturally encouraged conversation between the two. Laughter filled the room when Clover rolled onto her back "asking" for a belly rub, allowing Alicia and Mason to share a joyful moment together.

2023 Ages of Children Served

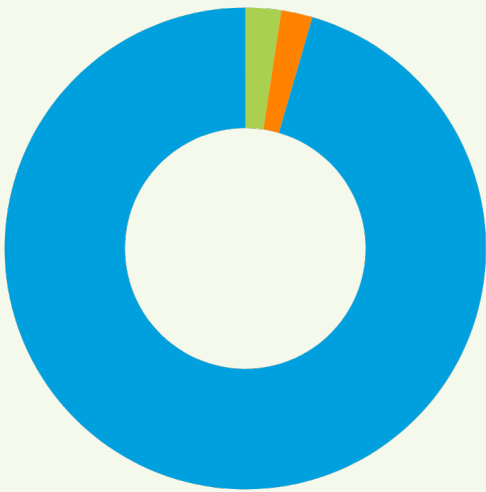

Youth Impact Board

Kids' Voice established the Youth Impact Board (YIB) to amplify the voices of older foster youth and young adults who have aged out of foster care. The YIB creates a space where lived experience shapes advocacy, ensuring youth perspectives inform programs, policies, and outreach efforts at Kids' Voice. Members meet monthly to build community, connect with stakeholders, and develop leadership and professional skills.

In 2023 and 2024, YIB members attended community events, including Monday Night Madness with the Indianapolis Colts, and spoke at events to amplify the impact Kids' Voice has on foster youth and older youth aging out of foster care. Through these opportunities, YIB members strengthened their confidence, leadership, and sense of belonging, while helping the broader community better understand the needs and strengths of youth with lived experience.
