


How does it work?

Healthcare is defined as any service or treatment provided to a person to improve health which is defined as a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity.

Healthcare Definitions

Letsbuyhealthcare criteria 'requirements checklist' for healthcare providers. Letsbuyhealthcare reserve the right to amend or add to the following checklist:

Providers (or contracted/employed providers delivering services through legal entities) must be registered in the Republic of Ireland

(A) In the register established under section 43 of the Medical Practitioners Act 2007

OR

- (B) In the register established under section 26 of the Dentists Act 1985
 OR
- (C) With CORU under the Health and Social Care Professionals Act 2005 (as amended).

In relation to any health care provided outside the Republic of Ireland, that the provider is entitled under the laws of the country in which the care is provided to practice medicine or dentistry there.

Complimentary Medicine

Complimentary medicine will not be displayed on the Letsbuyhealthcare portal, unless provided by a registered provider under (A), (B) or (C) above. Examples include:

- Acupuncture
- Herbal therapy
- Homeopathy
- Therapeutic massage
- Oriental medicine

Memo of Understanding

- 1. Letsbuyhealthcare will promote & publish a defined list of the providers procedures and services typically directed at uninsured 'self-payers'. A provider may add, delete or amend their published list by notifying Letsbuyhealthcare.
- 2. All prices are set and maintained by the provider (there is no 'negotiation' of prices). Any changes to be notified by the provider to Letsbuyhealthcare.
- 3. Information for the customer/self-payer, for each procedure or service, as to whether a provider price is fixed and 'all-inclusive' (or not), preferred normal setting (inpatient/ daycase), waiting times, other patient and treatment information and a policy on deposit refunds will be determined and maintained by the provider. Any changes to be notified to Letsbuyhealthcare.
- 4. All customer payments via the Letsbuyhealthcare website will be paid directly to the provider.
- 5. Provider agrees to nominate at least one person authorised to act on the provider's behalf to notify Letsbuyhealthcare of changes to published provider prices & provider information.
- 6. It is acknowledged by Letsbuyhealthcare and the provider that Letsbuyhealthcare has no hand, act or part in the provision of healthcare or in communicating with patients on matters relating to healthcare other than to help arrange a referral and/or assist with information provided on the Letsbuyhealthcare website.
- 7. Provider agrees to follow up with all referred customers within a defined timeline and provide Letsbuyhealthcare with a single contact point for any Letsbuyhealthcare customer service matters.
- 8. While it will not affect any provider, the provider acknowledges the Letsbuyhealthcare Healthcare Coins voucher scheme that facilitates self-funding of healthcare for customers.
- 9. A Letsbuyhealthcare referral commission wil be separately agreed with the Provider.
