SHENANGO LAUNCHBOX

About Us

The Shenango LaunchBox powered by the Greater Sharon Community was created in 2022. Community leaders in the City of Sharon had a unique opportunity to grant \$14.7 million in American Rescue Plan Act money to support COVID-19 response efforts. replace lost revenue, and support economic stabilization for households and businesses. Their vision was to invest a portion of the funds to fuel entrepreneurs and economic development for the future.

Through trusted relationships and collaboration, the City placed \$2 million into two distinct endowments of \$1 million each at the Shenango Valley Foundation, an affiliate of the Community Foundation of Western PA and Eastern OH. Penn State University agreed to match those \$2 million funds. One endowment exists to support Shenango LaunchBox and the other is intended to support economic development grants in the City of Sharon. Both endowments create a culture of innovation and drive economic development by leveraging the regional

ecosystem and resources throughout the statewide LaunchBox network.

LaunchBox is a signature program of the Invent Penn State Initiative, a commonwealth-wide system to spur economic development, job creation, and student career success. Thanks to collaborative community relationships and a desire to impact the greater good, generations of entrepreneurs will benefit from the combined creative investment and vision that brought this project together.

Services We Offer

The Shenango LaunchBox powered by the Greater Sharon Community blends entrepreneurship-focused programming, business startup training, and community collaborations to facilitate the process of turning ideas into viable products and services. We offer programs such as:

By the end of 2023, 71.22% of Entrepreneurs Forever member businesses grew their revenue by an average of 83.9%.

FAQs

Q: What is "peer-to-peer" learning?

A: Unlike a teacher-student classroom setting, peer-topeer learning allows members to freely share their small business challenges with each other so that the group can create collective solutions and, in the process, learn critical small business fundamentals.

Q: What does it take to qualify for Entrepreneurs Forever?

A: We have three simple qualifications to join a group. Members must:

- 1. Be in business for at least one year.
- 2. Have a minimum of \$30K in annual gross revenue.
- 3. Work in their businesses full time.

Q: How much does Entrepreneurs Forever cost?

A: Thanks to the funding of partners dedicated to the growth of small businesses, our program is free for members.

Q: What are some of the intangible benefits of a peer group?

A: Running a small business can be lonely. And that loneliness can erode confidence, hinder learning and damage results. Sharing and bonding over their experiences doesn't just help owners learn about business, it provides them with a critical safety net to share their thoughts and concerns with others who deeply understand what they're going through.

E+I Fellows Program

The Center for Entrepreneurship + Innovation at Grove City College provides a unique opportunity for nonprofits, startups, and small businesses in the Western Pennsylvania area to receive much needed help without the financial burden of hiring traditional interns or employees by placing highly driven students at internships with local organizations. Students are paid by (and are employees of) the Center for E+I during their internship, meaning there is no cost to the host organization! Host Organizations determine their areas of need, and E+I Fellows are placed at the organization to help in those areas. The number of E+I Fellows placed will depend on the size of the Host Organization.

Special consideration will be given to nonprofit and commercial entities that are deemed to have a positive impact on the local region through social innovation or economic opportunity. A limited number of host organizations will be selected to participate in the program.

For an organization to receive consideration for acceptance as a host for the E+I Fellows program, they must be located within two hours of Pittsburgh, PA. Due to restrictions related to insurance, hybrid or in-person formats can only visit one work site.

To increase the likelihood of acceptance into the program, organizations with a need for remote roles are strongly encouraged to apply, as there is significant student interest in remote opportunities.

HERMITAGE COMMUNITY & ECONOMIC DEVELOPMENT

About Us

The Hermitage Community and Economic Development Commission offers two Revolving Loan Fund (RLF) programs to assist new and growing small businesses in the city. The Landscape & Façade/ Small Business Improvement Program was expanded to cover small business improvement, equipment and renovation projects, in addition to exterior landscaping, façade and site improvement projects. It provides up to \$40,000 or 90% of eligible project costs and carries an interest rate of 50% of the prime rate for 5-year loans or 50% of prime plus .5% for 7-year loans. The streamlined application requires no application fee and legal fees of \$200 are only reguired upon disbursement of loan proceeds.

Services We Offer

The Business & Industry Revolving Loan Fund is for larger projects that are designed to create jobs that benefit the public and must create (or retain) at least one job for each \$50,000 in loan proceeds. Employment must be verified within 90 days of project completion. Projects must have a significant community revitalization benefit. It provides up to \$150,000 or 50% of the total project cost and carries an interest rate of 60% of prime for 5-year loans, 60% of prime plus .5% for 7-year loans, or 60% of prime plus 1% for 10year loans. Cash equity of at least 10% of the project cost is required. A \$100 upfront application fee is charged and up to \$750 in legal fees is required upon loan approval.

In addition, the City of Hermitage has teamed up with the City of Sharon to offer a Façade Improvement Program for eligible businesses and projects. The program offers up to \$5,000 in a reimbursable grant for eligible businesses and projects, on a dollar-for-dollar match basis. Business must be located within the target are which is E. State Street from the Sharon border to Keel Ridge Road, and Route 18 from Lamor Road to Longview Road. Projects must address exterior needs such as signage, awning/canopies, windows and doors, exterior lighting, exterior painting and cleaning, masonry, woodwork, metals, architectural finishes. and restoration of original architectural features. Interior work, work on outbuildings. landscaping, sidewalks and paved areas, projects begun or completed before an award are all ineligible.

The city also has a First-Time Homebuyers Assistance Program which may provide \$5,000, payable to and disbursed by the closing agent, for qualified first-time homebuyers. Applicants must not have owned a principal residence in the city for the past three years (if either spouse meets this requirement, the

applicant is eligible). The program is for the purchase of single- family homes that will be used as the applicant's principal residence. Only individuals qualify. The purchase must be a bona fide, arm's length transaction upon which Realty Transfer Tax is assessed. It is available on a first-come, first-served basis for the first 15 applicants.
