1. Purpose

This Addendum establishes the legal and sovereign framework for Fractional Ownership of a GeniusCube Embassy Home under ICCACK Embassy jurisdiction, within the Blockchain DigitalCity® (Puerto Plata, Dominican Republic).

It enables up to **ten (10) fractional co-owners** to collectively acquire one (1) GeniusCube Embassy Home valued at \$99,000, each contributing \$10,000 under the World Blockchain Bank Land Trust.
