Pfizer, Moderna, and Johnson & Johnson secured contracts worth billions, guaranteeing profits irrespective of demand or efficacy. This public investment reduced financial risk for the companies, allowing them to capitalize on a crisis without bearing the traditional costs and risks associated with drug development.
- **Commitment to Mass Distribution:** Governments worldwide committed to buying billions of vaccine doses from pharmaceutical companies, often requiring entire populations to be vaccinated or face restrictions. These guaranteed contracts created a nearly unlimited revenue stream for companies, removing the traditional need to compete or justify costs.

**Emergency Use Authorization (EUA) and Limited Liability:**

Across these crises, a clear pattern emerges: public health emergencies become profitable opportunities for pharmaceutical companies, whose products are promoted by influential figures within public health. By focusing on high-cost treatments and patent-protected solutions, these companies leverage crises to maximize revenue while limiting affordable options.

The cycle of profit-driven responses to health crises reveals a disturbing trend in modern medicine, where pharmaceutical companies and influential health figures prioritize revenue over comprehensive patient care.
