## Will & Estate Planning

An Effort to resolve the issues of Peace Full Distribution of Wealth amassed during the Life Time.

We all know that we are not immortal. Also, it is not that we do not understand the importance of making Will or the consequences of not making Will but then what are the reasons that we see many people die intestate i.e. without Will. Well, there are few obvious reasons of which first and foremost reason is nobody likes to think



of death and do planning of wealth for family; secondly nobody can anticipate the time of death or rather have an assumption about “no possibility of death in near future” and such assumption is 'renewed' repeatedly. So, there is no due date before which one should have his or her Will. There are people who also believe that, only people with huge wealth are supposed to make Will.

If you are reading this article then surely you have witnessed and survived one of the biggest threat to the mankind i.e. COVID-19 which changed many assumptions, perceptions and thought process about life and living. It undoubtedly taught the lesson of how and why planning of Money and Wealth is very important and do remember any wealth planning without having any idea as to what would happen to the wealth after death which is earned and amassed during life time – is a bad planning.

This article is a small attempt to bring awareness about the consequences of not making Will, importance of Will vis-à-vis the issues associated with preparing of Will, its execution, and some wrong assumptions about Will

Why Succession planning through Will is Important –

- Uncertainty of Life
- Smooth Transition of wealth in the form of Properties, Investments
- Continuation of Family Owned Business run by Members of Large Family
- Controlling the end use of wealth
- Avoid Litigation
- Complicate and Difficult to Understand or Interpret Succession Law

So, for smooth transition of assets without any litigation, Will is necessary.

What happens when one dies intestate i.e. without a Will –

In India for Hindus, The Hindu Succession Act, 1956 is applicable. It is also important to note that as per the said act Hindu covers – Jain, Sikh and Buddhist also. So, if a Hindu dies without making a Will then it will be treated as he died intestate and accordingly The Hindu Succession Act will decide which family member will get what from the assets of the deceased Hindu, which may and may not be as per the intension or wish of the deceased person.

If a person being Hindu makes a Will then The Indian Succession Act, 1925 will be applicable instead of The Hindu Succession Act, 1956. To communities other than Hindu like - Christian, Parsi or Jew, whether or not Will is made, The Indian Succession Act, 1925 applies. All Muslims in India are governed by Sharia Law which also covers succession and inheritance.

Quick Glance on Hindu Succession Act, 1956 :

Distribution of Properties as per Hindu Succession Act, 1956

As per Section 8 of Hindu Succession Act, 1956, in case of Males, the property shall be divided among the heirs in Class-I and only in the absence of no heirs of Class-I, the property shall be divided among the heirs specified in Class-II.

Order of Succession among heir in case of Males as per Hindu Succession Act, 1956

Among the heirs specified in Class I, they shall be considered simultaneously and to the exclusion of all other heirs; whereas

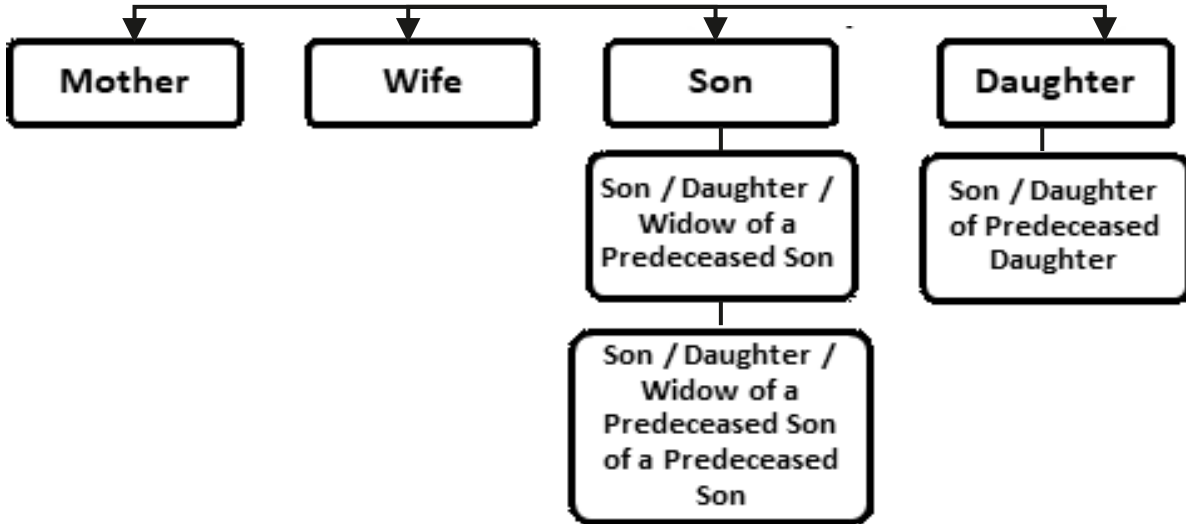
Among the heirs specified in Class II, those in the first entry shall be preferred to those in the second entry; those in the second entry shall be preferred to those in the third entry; and so on in succession.



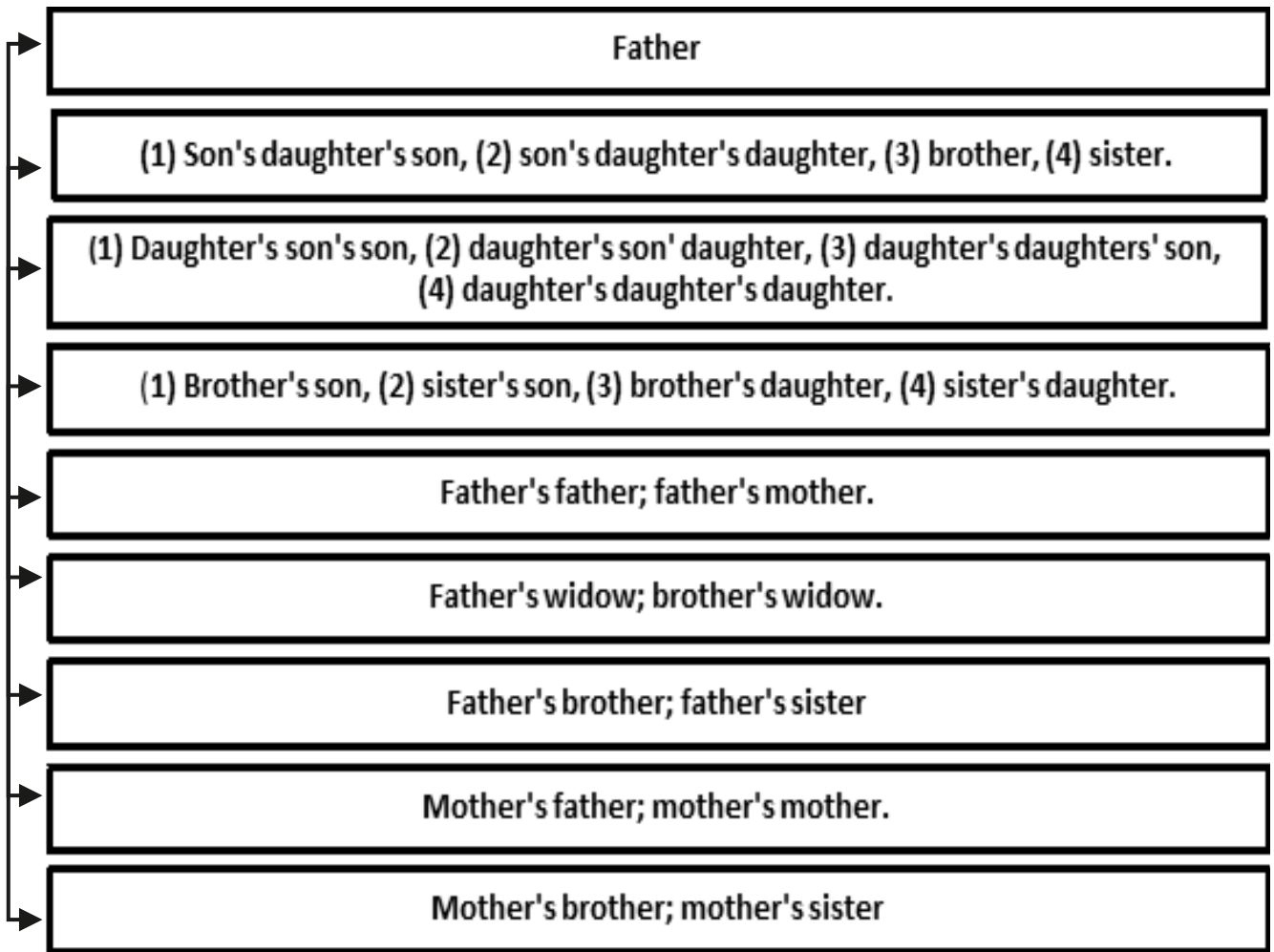
A graphical representation is given below for Hindu Male for easy understanding –

## HINDU MALE

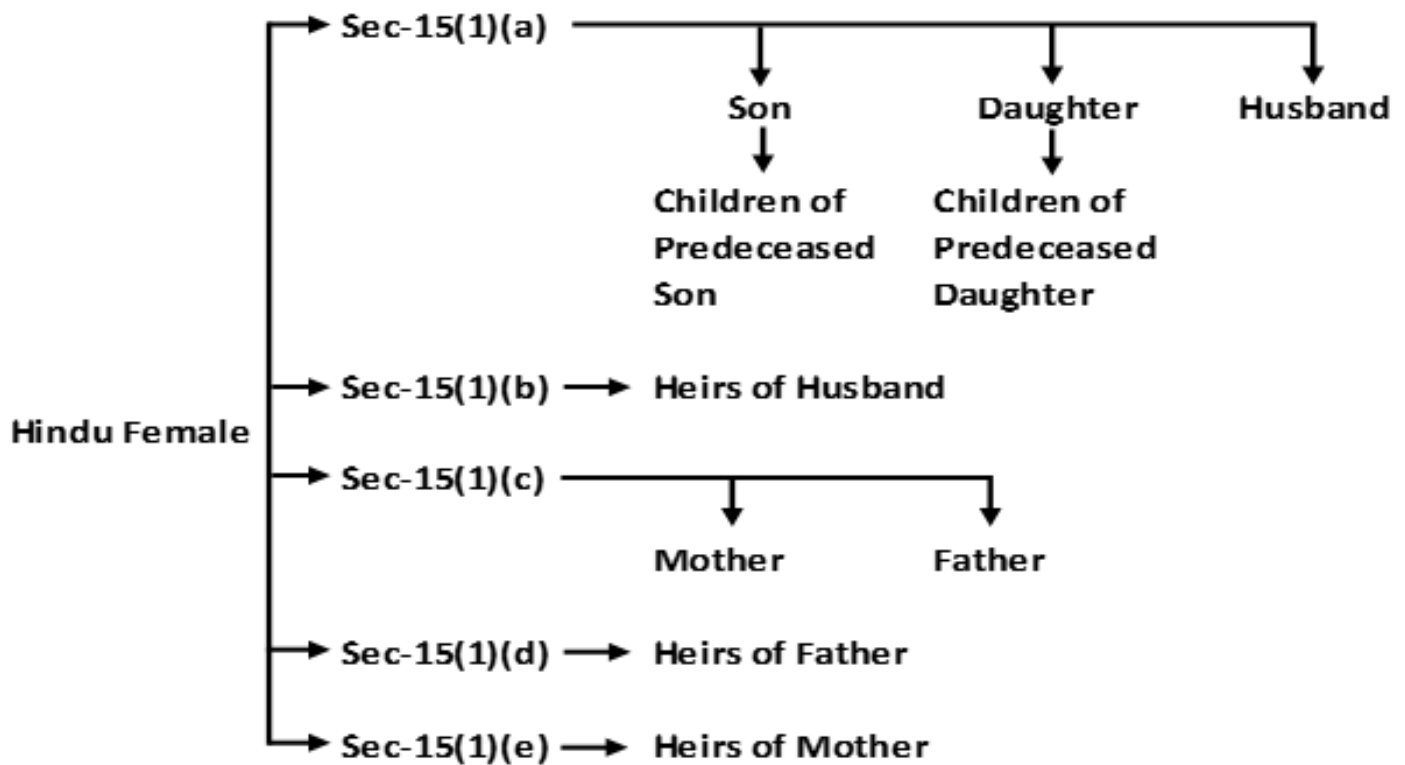
as per Class - I

As per Section 15 of Hindu Succession Act, 1956, in case of Females, the property shall be divided among the heirs specified in graphical presentation.



## Order of Succession among heir in case of Females as per Hindu Succession Act, 1956

Among the heirs specified at Section 15(1)(a) i.e. first entry will be preferred to those specified at Section 15(1)(b) i.e. second entry and so on so forth. Heirs specified at same entry shall be considered simultaneously. Devolution of Property to Heirs of Husband or Heirs of Father or the Heirs of Mother would be in same order as if the Husband or Father or Mother had died intestate.

In case of property inherited by female from her Father or Mother shall devolve on the Son and Daughter including children of predeceased Son or Daughter and in their absence the property shall directly devolve upon the heirs of father.

In case of property inherited by female from her husband or from her father-in-law shall devolve on the Son and Daughter including children of predeceased Son or Daughter and in their absence the property shall directly devolve upon the heirs of husband.

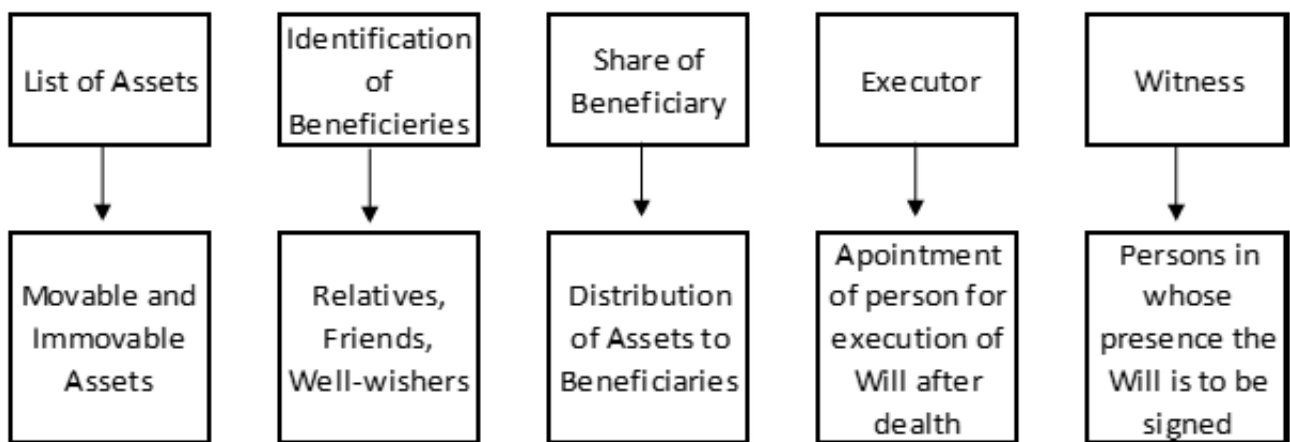
So, there are many limitations and rigidity in the provisions of the act for distribution of assets. Nonetheless, it also appears that due to complexity in the act, there may arise disputes at the time of distribution of the assets specifically in case deceased has left behind huge wealth and or large family.



To avoid the applicability of Hindu Succession Act, the only route available for distribution of property after death is through *Will*. Some of the limitations of Hindu Succession Act and key features of *Will* are given below –

Limitations of Hindu Succession Act	Key Features of <i>Will</i>
Father is not included in Class – I heir	Any share in the property can be given to father
The proportion and share in property to heirs is determined by the act	Any Property or any share in the property can be given to any heir as per the wish and will of the owner
Only relatives are covered	Any property or share in the property can be given to Friend, Care takers, well wishers
No Scope of Money being used for Charity or any noble cause	One can earmark property or share in the property for Charitable Purpose

### Important Aspects of Will



There is no specific format in which the *Will* is to be prepared, however there are some features and important aspects which one should take care while preparing the *Will* which are listed below -

- Only a person with Sound Mind can prepare a *Will*. So, it is advisable to have necessary certificate from a Doctor about Mental State of Health at the time of preparation of *Will*.
- The wordings be such that the intentions of the testator can be known therefrom .
- All the assets as on the date of signing of *Will* should be included in the *Will*.
- *Will* should contain list of heirs, who are made beneficiaries in the *Will* or are excluded from any share in any property . A share of each beneficiary should be clearly mentioned in the *Will*.





- *Will* not expressive of any definite intention is void.
- It is not necessary to prepare the *Will* on Non-judicial Stamp Paper. However, to ascertain the time period, *Will* on stamp paper is advisable.
- *Will* must contain the name and relation of Executor appointed for execution of *Will*. Any known person (may or may not be in relation) with sound mind can be appointed as an executor.
- Two or more executors can be appointed for execution of *Will*.
- Separate Executors can also be appointed for separate purposes in the *Will*.
- *Will* can be modified any number of times.
- In case of multiple *Wills*, the latest will be prevailed.
- *Will* can be prepared in any language. In case it is prepared in regional language, it is advisable to have certified English translation (preferably from Translator of the Court) annexed to the *Will*.
- It is compulsory to get the Probate of *Will* (only in case of Immovable Property) if it falls within the Jurisdiction of Mumbai, Madras and Bangalore High Court
- It is not compulsory to get the *Will* registered, however a registered *Will* enjoys more authenticity than unregistered *Will*.
- *Will* should be signed in the presence of at least Two Witnesses and both the Witnesses shall also sign on the *Will*.

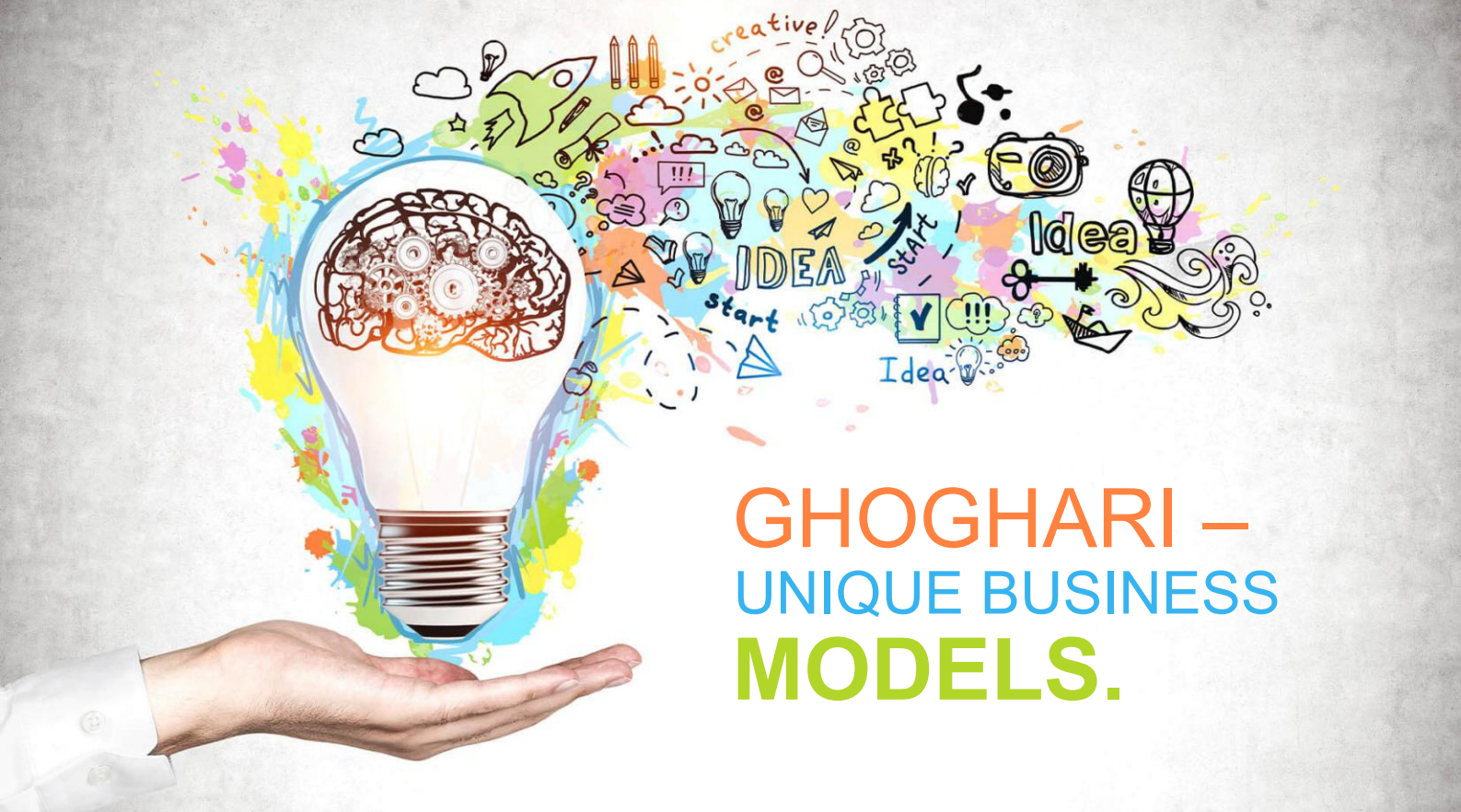

### ભાવનગર-જિલ્લો-તાલુકો-તળાજા

ભાવનગરથી તળાજા રૂટ પર વચ્ચે રાજપરા રોડ થી અંદર ૭ કિ. મિ. બે ડુંગર વચ્ચે નાજુક અને રળિયામણું દિહોર ગામ આવેલ છે. દિહોર ગામમાં પચરંગી વસ્તી હતી એ અરસામાં અંદાજે આપણા જેનોના ઘર ૨૦ થી ૨૫ હતા. ત્યારે એ અરસામાં ૧૯૬૪ ની સાલમાં ઘર દેરાસર બનાવ્યું ત્યારે અભિનંદન સ્વામિ મુળનાયક તરીકે તથા આજુબાજુમાં શાંતિનાથ દાદા તથા પાર્શ્વનાથ દાદાની આરસ પહાણ ની મુર્તિ લઈ આવ્યા હતા. આ પ્રણેય પ્રતિમાજીને ખંભાતથી વહાણ મારફતે લાવેલ હતા.

આ પ્રણેય પ્રતિમાજીની પ્રતિષ્ઠા - ૧૯૬૪ માં કરાવી. ત્યારે આપણી વસ્તી અંદાજે ૨૦-૨૫ કુટુંબ વચ્ચે હતી. તથા ગામની વસ્તી ૨૫૦૦-૩૦૦૦ ની હતી. આ પ્રતિષ્ઠા યતિ મ.સા. કરાવેલ હતી.

દિહોર ગામમાં પ્રવેશ કરતા સાસુ તથા વહુ નદીનું મિલન થાય છે. એ આપણા ગામની ખાસિયત છે. આગળ જતા આ નદી શેત્રુંજી નદી ને મળવાની આતુરતાથી ઉતાવળી થાય છે. એથી આ નદીનું હુલામણું નામ “ઉતાવળી” નદી પણ છે.

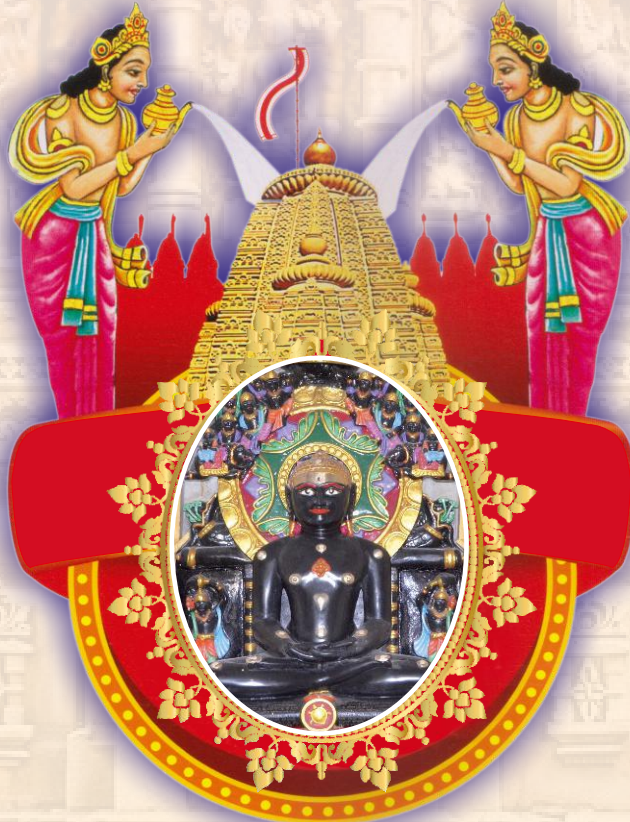

Internet safety is every one's responsibility. It's all about being able to have fun online – to be able to chat with your friends, to post a video that you've made or a song that you've written, to be free to find out more about information you're interested in and check out the latest trends – without being bullied, annoyed or scammed, or having your ideas stolen including identity theft.

Internet safety is a lot more than just about ensuring that your computer has the latest anti-virus and firewall software installed. It's about being smart about how you handle yourself online and savvy about how you deal with other people (especially strangers who you meet online), and not falling prey to an online scam artist who takes advantage of your ignorance.

### **Why is it important to stay safe online?**

Most of us are 'connected' via our laptops, mobile phones, tablets or personal computer. The potential for the internet to be a valuable and a fun resource for entertainment, making friends, keeping in touch and learning is huge. But if you use the internet without safety awareness, you could be at risk of illegal activity or abuse – be it bullying, fraud or something more serious. Unlike seeing someone face to face, on the net, people aren't the same as they are first seen.

The way you learn about safety when you leave the house, the same way it is important to learn how to stay safe online. These are skills that will stay with you for life time.

Some Golden Rules to follow when you're online

- Don't give out personal information such as your address or phone number.
- Don't send pictures of yourself to anyone, especially indecent pictures.
- Don't open emails or attachments from people you don't know.
- Don't become online 'friends' with people you don't know.
- Never arrange to meet someone in person whom you've met online.
- If anything you see or read online worries you, tell someone/inform your parents about it.

#### **Step 1: Using a Web Browser**

Internet is a way to stay connected with friends and family. For many Students, it's also a way to stay current on news, research information, shop online and download books, online applications etc. Internet has also become a popular method for banking, paying bills and completing and submitting applications and forms.

Using web browser to do things online is easy, but there can be some hidden dangers to you and your computer. These risks can include exposure of sensitive personal information and infection by malware, which includes viruses, spyware, and adware. Safe browsing means being aware of these online threats and taking the necessary precautions to avoid them.



It only takes a little bit of effort, a few tools, and some basic information to be safe as you browse the internet. Follow these guidelines to protect your personal information and your computer online.

- Install and maintain up to date anti-virus software on your computer or device.
- Keep your internet browser up-to-date.
- Be alert to unusual computer activity or problems.
- Install and maintain a firewall on your computer.
- Use a modern browser with features such as a pop-up blocker.
- Avoid storing sensitive material indefinitely on your computer.
- Change your passwords often.

## Tips to stay safe on social networking sites

- Make sure you're old enough to join.
- Maybe use a made up name or nickname on your profile.
- Do not make friends you don't already know personally.
- Maybe use an email address that does not include your name.
- Use the strongest privacy setting when you set up your profile. This means that only your friends will be able to view your information.
- Pictures and videos can be shared very carefully when uploading -even if you only share it with friends, it can easily be spread much further.

## What risk does it pose?

- Device loss or theft. Losing a device to mishap or theft can cause lost productivity, data loss, and potential liability under data-protection laws.
- Loss of sensitive data. Many mobile devices may contain sensitive or confidential information, for example, personal photographs and videos, email messages, text messages and files.
- Unauthorised network penetration. Because many mobile devices provide a variety of network connectivity options, they could potentially be used to attack protected corporate systems.
- Intercepted or corrupted data. With so many business transactions taking place over mobile devices, there is always a concern that critical data could be intercepted via tapped phone lines or intercepted microwave transmissions.
- Malicious software. Viruses, Trojan Horses, and Worms are familiar threats to mobile devices that has become a significant target.

## How can I avoid it from happening?

- When choosing a mobile device, consider its security features and ensure they are enabled.
- Install and maintain an Anti-Virus application on your smart device.
- Do not follow links sent in suspicious email or text messages.
- Carefully consider what information you want to store on the device.
- Be cautious when selecting and installing applications.
- Avoid joining unknown Wi-Fi networks and using unsecured Wi-Fi hotspots.
- Disable interfaces that are not in use, such as Bluetooth, infrared, or Wi-Fi.
- Delete all information stored in a device prior to discarding it.

જૈન શાસન માં અનેક પર્વો છે પણ પર્યુષણપર્વ માં કર્મ ના મર્મ ને ભેદવાની જેવી તાકાત છે એવી બીજા કોઇ પર્વો માં નથી માટેજ પર્યુષણપર્વ ને પર્વાધિરાજ તરીકે બિરદાવવામાં આવે છે. આ શબ્દ ની આપણે શાબ્દિક વ્યાખ્યા કરીએ તો તેનો અર્થ છે પરિ + ઉષણ = પર્યુષણ, પરિ એટલે ચારે બાજુથી અને ઉષણ એટલે કે એક સ્થાને આવી ને વસવું. જે દિવસો માં ચારે બાજુ ભટકતો આત્મા એક જગ્યાએ આવી ને વસે છે તેનું નામ પર્યુષણ મહાપર્વ. આત્મ નિરીક્ષણ આત્મ સાધના અને આત્મ સાક્ષાત્કાર નું અનુપમ પર્વ એટલે પર્વાધિરાજ પર્યુષણ પણ કોઇ દિવસ એવો વિચાર આવ્યો છે કે આ પર્વ આ આઠ દિવસ જ કેમ? કેમ વધારે કે ઓછા નહી? આનું કારણ આપણને જ્યોતિષશાસ્ત્ર ના માધ્યમ દ્વારા મળે છે. તે કઇ રીતે? તે આજે આપણે જોઇએ.

૧) સૂર્ય : સૂર્ય આપણો આત્મા, આપણું ચૈતન્ય, આપણો પ્રાણ છે. સમગ્ર જીવસૃષ્ટિ નો તે પાલનહાર, પોષક અને સર્જનહાર છે. સર્વ ઋતુઓ, પંચ તત્વ મતલબ અગ્નિ, પૃથ્વી, વાયુ, જલ, અને આકાશ, વગેરે ની ઉત્પત્તિ નું કારણ પણ સૂર્ય છે. આવો સૂર્ય મેષ થી મીન આ બાર રાશી માં ભ્રમણ કરતા કરતા જ્યારે પોતાની રાશી સિંહમાં (તા. ૨૦ ઓગષ્ટ થી ૧૯ સપ્ટેમ્બર) એક માસ માટે આવે છે. ત્યારે અત્યંત બળવાન બને છે. સૂર્ય વર્ષ માં ફક્ત એકજ વાર સિંહરાશી માં, પોતાના ઘરમાં આવે છે હવે આપણા આત્મા પર સૂર્ય નું આધિપત્ય હોવાથી આપણી ચેતના પણ બળવાન બને છે. તેથી આપણો આત્મા બળવાન બનતા આ દિવસો માં

૪) નક્ષત્રો : આ અતિખાસ એવા આઠ દિવસો દરમ્યાન સૂર્ય લગભગ મહા નક્ષત્ર માં હોય છે. તા.૧૬ ઓગષ્ટ થી ૨૯ ઓગષ્ટ આ ૧૪ દિવસ સૂર્ય આ નક્ષત્રમાં હોય છે. આ મધ્ય નક્ષત્રકેતુ નું નક્ષત્ર છે. તેથી એમ કહેવાય કે સૂર્ય કેતુ ના નક્ષત્ર માં છે. કેતુ તડપ નો, મહત્વકાંક્ષા મોક્ષ નો ગ્રહ છે. મોક્ષ, તેથી આ મિલન પણ મોક્ષ માર્ગ માટે આત્મા ને ઉન્નત, ઉજ્જવળ ઉર્ધ્વગામી બનાવવામાં સહાયક ભૂમિકા ભજવે છે. આજ રીતે ચંદ્ર કર્કરાશિમાં હોવાથી તેના નક્ષત્રો પુનર્વસુ નક્ષત્ર નો સ્વામી ગુરૂ છે. ગુરૂ એટલે ધર્મ, જ્ઞાન, તો પુષ્પ નક્ષત્ર નો સ્વામી શનિ છે. આ શનિ વૈરાગ્ય, અધ્યાત્મ, તપ, સંયમ પર



આધિપત્ય ધરાવે છે. તો આશ્રલેષા નક્ષત્ર નો સ્વામી બુધગ્રહ છે. બુધ એટલે વાણી, વિદ્યા અને બુદ્ધિ, આમ ચંદ્ર નું આ નક્ષત્રો માં ભ્રમણ ત્યાગ, તપ માં આપણા મન ને સ્થિર બનાવી શકે છે. અને સોના માં સુગંધ રૂપે બુધ નું આ નક્ષત્ર શ્રુતજ્ઞાન ની દરેક બાબત ને સરળતાથી સમજવા માટે મદદ રૂપ થાય છે.

૫) સંધિકાળ : પર્યુષણ માટે આઠ દિવસ જે પસંદ કરવામાં આવયા છે.

તેમાં ચાર દિવસ શ્રાવણ ના અને ચાર દિવસ ભાદરવા ના લેવા માં આવ્યા છે. મતલબ બન્ને મહિના ની જ્યાં સંધિ થાય છે, જોડાણ છે એ દિવસો અંતિમ અને શરૂઆત ના લીધા છે આ ને કહેવાય સંધિકાળ. જ્યાં બે વસ્તુ નું જોડાણ થતુ હોય છે. આ રીતે જ વર્ષ ના પણ બે ભાગ છે ઉતરાયણ અને દક્ષિણાયન મહિના ના બે ભાગ સુદપક્ષ અને વદ પક્ષ આ જ રીતે વધુ ઉડાણ માં ઉતરીએ તો મહિના માં પણ ચાર સંધિકાળ છે. જેમ કે એકમ થી આઠમ, નોમ થી પુનમ વદ પક્ષ માં પણ એકમ થી અમાસ. આ સર્વે સંધિકાળ સૂર્ય અને ચંદ્ર ની ગતિ ને કારણે રચાય છે. આ સંધિકાળ નું આરાધના, ઉપાસના માટે વિશેષ મહત્વ છે કેમ કે સૂર્ય થી જ્યારે ચંદ્ર બારઅંશ દૂર જાય છે ત્યારે એક તિથી બને છે. ૩૬૦ અંશ નું આપણું ભયક માનવા માં આવ્યું છે. એને કાંતિવૃત પણ કહેવામાં આવે છે. હવે જ્યારે ચંદ્ર ૪૫ અંશ સૂર્ય થી દૂર જાય છે ત્યારે ચોથે આવે છે. ૯૦ અંશ દૂર જાય ત્યારે આઠમ આવે છે. આમ ચંદ્ર સૂર્ય વિશિષ્ટ અંતર કે દૂરી ને કારણે વિશિષ્ટ શુભ અને અશુભ યોગ ઉત્પન્ન થાય છે. આવા સમયે શુભ યોગ નિર્ણય લેવામાં મદદરૂપ બને છે. મનની શાંતિ અનુભવાય છે. શુભ અંતઃપ્રેરણા મળે છે. આ પ્રેરણાસ્તોત્ર, પુંજ સ્વયં ને, આત્માને પારસમણી બનાવવાની સોનેરી તક આપે છે. આજ રીતે દિવસ નો પણ સંધિકાળ એટલે રાત અને દિવસ, દિવસ અને રાત. જેમા આપણે રાઇપ્રતિકમણ અને દેવસિ પ્રતિકમણ કરીએ છીએ.

વગેરે ના ત્રિવેણી સંગમ દ્વારા આપણા જીવન ને શુધ્ધ, વિશુધ્ધ, અને પ્રબુધ્ધ બનાવવાનો કલ્યાણકારી માર્ગ બતાવ્યો. આમ આ અદ્ભૂત દિવસો ની આરાધના આપણા આત્મા ને પરમ સમીપે લઇ જવા માટે શ્રેષ્ઠતમ ફળ નો આસ્વાદ ના ચખાડે તો જ નવાઇ !

# Mexican Vada Pav



## Ingredients:

- Raw bananas, boiled, peeled and grated.....2 medium
- Burger buns.....4
- French beans, boiled and finely chopped..5-6
- Boiled green peas.....2 tbsp
- Finely chopped mixed capsicum (red, yellow and green)..... $\frac{1}{3}$  cup
- chopped fresh coriander leaves.....1 tsp
- Turmeric powder..... $\frac{1}{4}$  tsp
- Garam masala powder..... $\frac{1}{2}$  tsp
- Salt to taste
- Mexican sauce + as required.....1 tbsp
- oil + for deep-frying.....1 tbsp
- Split black gram (urad dal).....1 tsp
- Mustard seeds.....1 tsp
- Green chillies, finely chopped.....1-2
- Curry leaves.....6-7
- Oil for deep-frying
- Gram flour (besan)..... $\frac{1}{2}$  cup
- Butter as required
- Cheese slices.....4
- Cabbage, shredded..... $\frac{1}{2}$  medium
- Red chilli powder..... $\frac{1}{2}$  tsp
- Chaat masala..... $\frac{1}{2}$  tsp
- Lemon juice.....2 tsp
- Iceberg lettuce leaf.....1

## Method:

1. Mix together raw bananas, French beans, green peas, mixed capsicum and coriander leaves in a bowl. Add turmeric powder, garam masala powder, salt and 1 tablespoon Jainisha Mexican sauce.
2. Heat 1 tablespoon oil in a small non-stick tempering pan. Add black gram and sauté till golden brown. Add mustard seeds and let the seeds splutter.
3. Add green chillies and curry leaves, sauté for 30 seconds and add the tempering to the bowl. Mix well.
4. Divide the raw banana-vegetable mixture into equal portions and shape into vadas.
5. Heat sufficient oil in a kadai.
6. Mix together gram flour, salt and sufficient water in a bowl to make a smooth batter. Add 1 tablespoon hot oil and mix well.
7. Dip each vada in the batter and deep-fry in hot oil till golden brown and crisp. Drain on absorbent paper.
8. Halve the buns vertically. Apply some butter and Jainisha Mexican sauce on the halved side of the buns.
9. To prepare one vada pav, place one vada and cheese slice on the base of the bun, cover with the top bun and apply some butter on top.
10. Heat an electric griller and grease with some butter. Place the vada pav, cover and cook till grill marks appear.
11. To prepare salad, mix together cabbage, chilli powder, chaat masala, salt and lemon juice in a bowl.
12. Brush some Mexican sauce on a serving platter. Place iceberg lettuce leaf in the center and place Mexican vada pav on top and serve hot with salad.

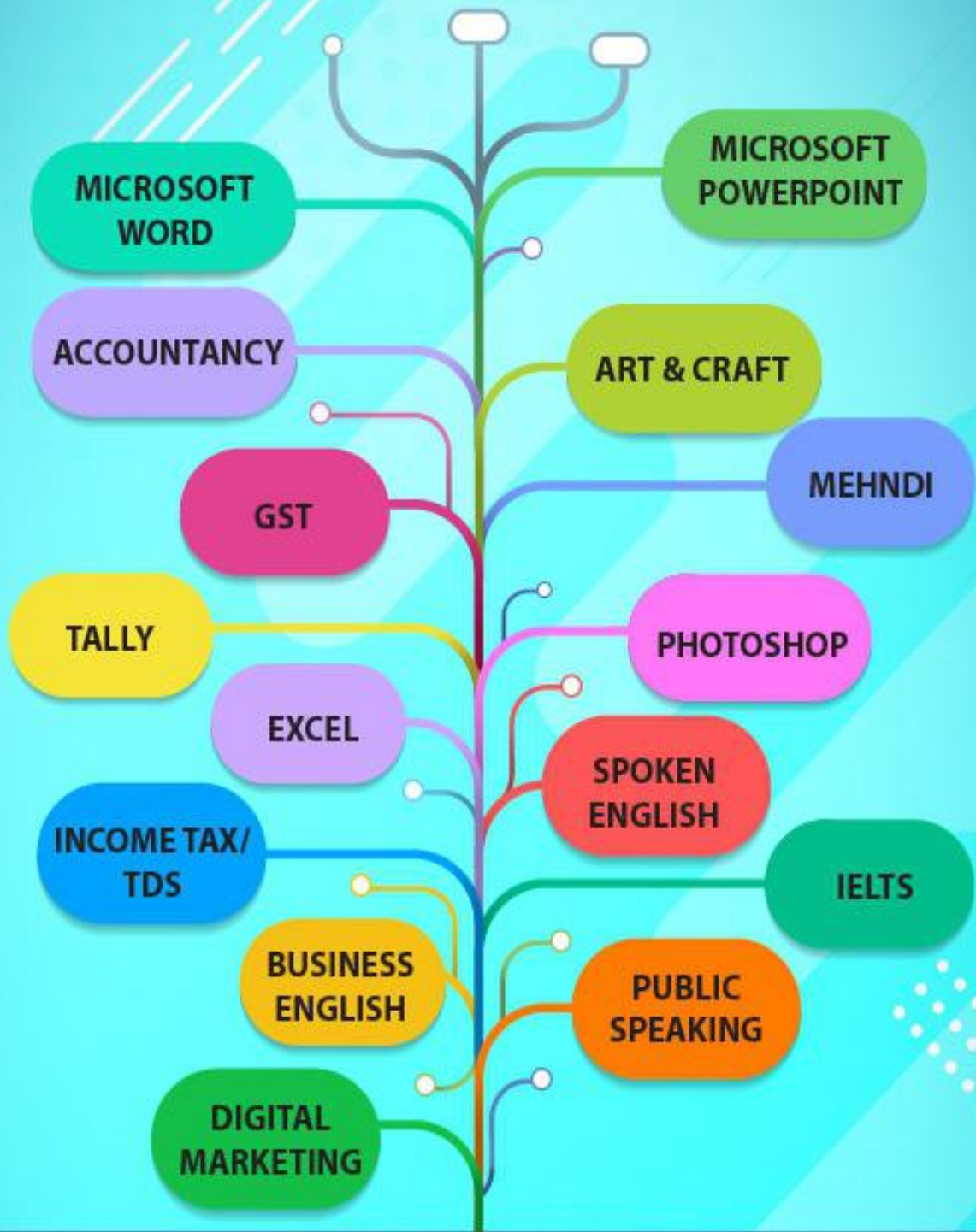
