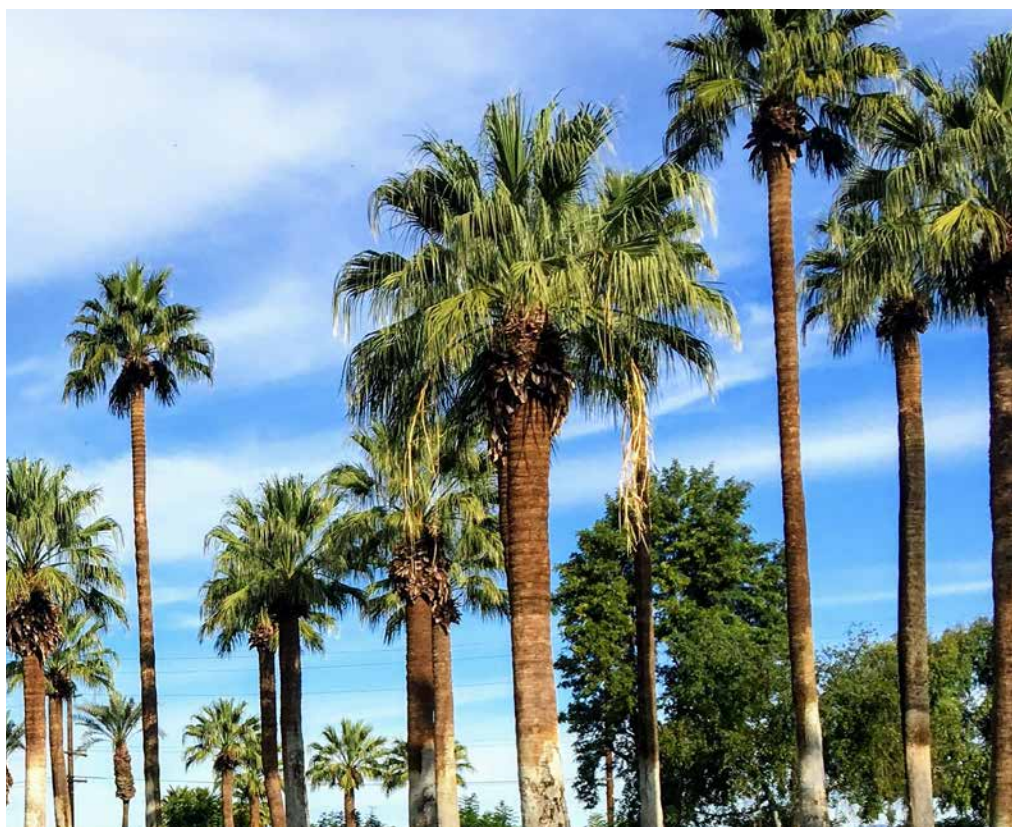

The Cat Island Club (the "Club") is owned and operated by Linx of Beaufort, LLC, a Virginia limited liability company duly registered to conduct business in the State of South Carolina. The Club is offering a limited number of membership reservations to access accommodations owned by the Club and access to a collection of services, benefits and privileges offered by the Club from time to time.



MEMBERSHIP BENEFITS

Membership at the Club will provide access to the amenities and other services provided at the newly renovated Cat Island Club. Members also have access to clubs located in Florida, North Carolina, Pennsylvania, Indiana and Virginia. Members will have exclusive access to all Club amenities. The Club plans to offer golf, pool, dining, and tennis.

CLUB MEMBERSHIP

The Club will offer a non-equity membership to persons who desire an unparalleled private club and social experience and are approved for membership on a first-come, first-served basis.
