³ **Government Delegate** – Applies to government issuing authorities such as passport agencies, immigration authorities and central banks responsible for the issue of banknotes, passports, ID cards and documents, revenue stamps, health cards or vehicle registration documents etc, as well as customs, immigration and law enforcement agencies. It does not apply to state-owned production enterprises (who instead qualify for the state enterprise rate).
