At Camp Garrett, we introduced a specialized Agriculture Education Track, giving children eager for more hands-on farm experiences a chance to dig deeper, care for animals, and nurture our gardens.



We also strengthened our role as environmental stewards. As proud members of the Sustainable Newtown Square – Green Business Coalition, we continue using our campus as a model for place-based learning. We hosted bird walks, nature hikes, and our signature Harvest Festival. Looking ahead, we are honored to host the Green Business Coalition's 2026 gathering right here on our campus.

Behind the scenes, we invested in the infrastructure that sustains our work. We modernized payroll, tuition, and accounting processing systems. We also expanded employee benefits to include short-term disability insurance as **another way of caring for the talented, mission-driven staff who bring our programs to life every day.**

2024 also brought new opportunities to connect. **We proudly participated in the first annual Delco Gives Campaign, celebrating the spirit of philanthropy county-wide.** And we welcomed Sedona Taphouse as a new community partner, strengthening the network of organizations that stand beside us.

None of this would have been possible without you. Every milestone we celebrated is rooted in your generosity and belief in our mission: to nurture loving and respectful connections between people and nature by using our extraordinary property as a dynamic canvas for learning.

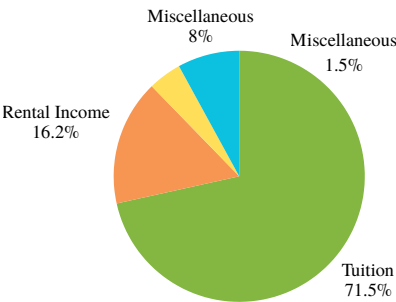

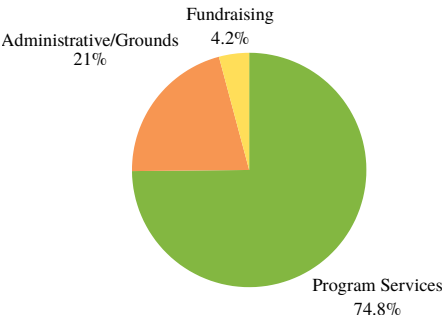
