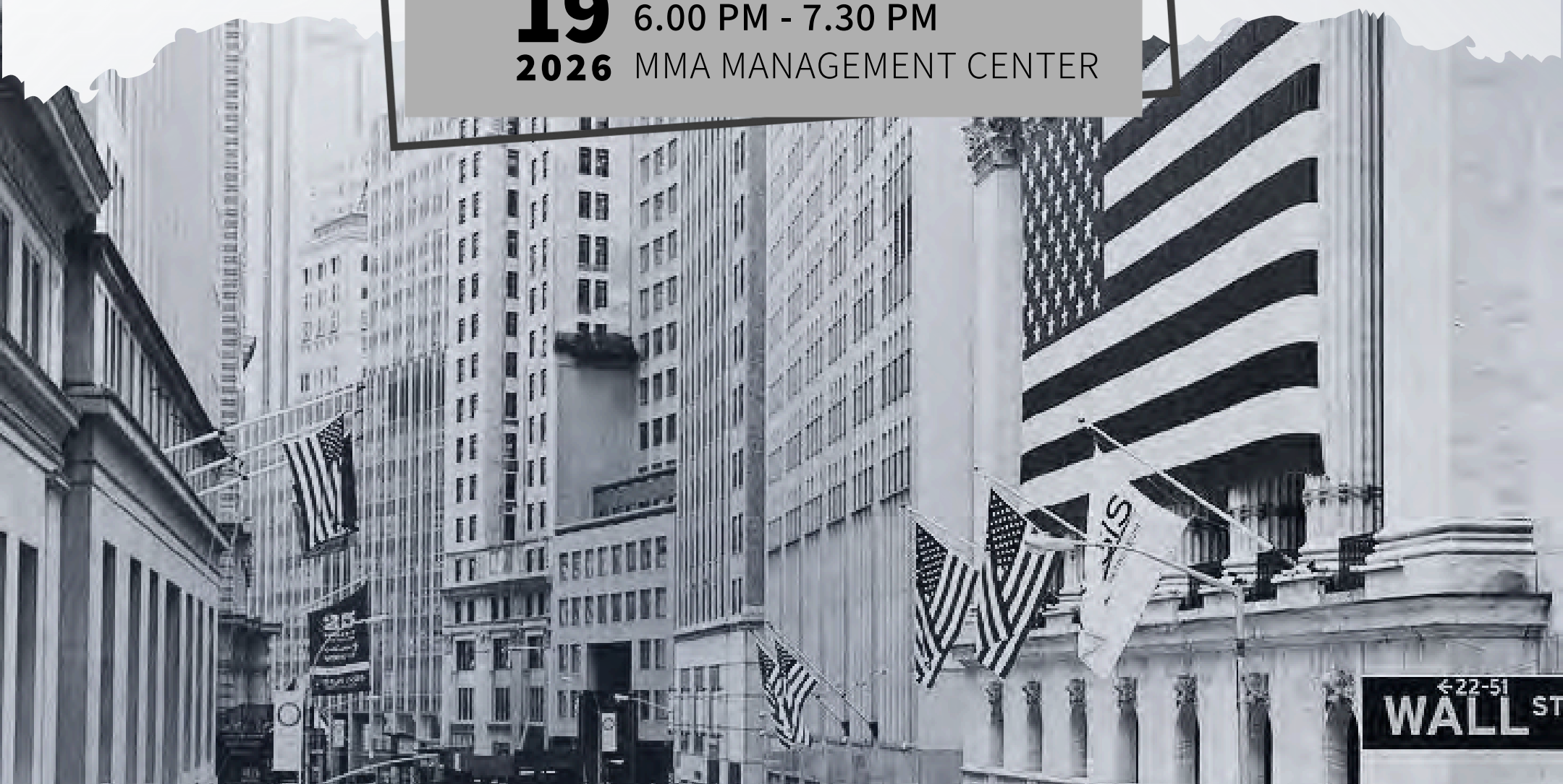

She spearheaded First Global's globalisation 25 years ago, making First Global the first Asian (ex-Japan) firm to become a member of the London Stock Exchange in 1999 and then the NASD.

First Global is now a Global Asset Management firm managing over USD 700 million in assets in India & Globally using a unique Human + Machine (Artificial intelligence and machine learning) model.

She has been quoted widely on Global as well as Indian markets by global financial media like Wall Street Journal, Business Week, Fortune, Forbes, CNBC, Financial Times etc.

She has been featured among the 50 Most Powerful Women in Business by Fortune magazine in 2025 and 2022. She has been featured as one of India's leading entrepreneurs by Outlook Business and Entrepreneur magazines.

She has been a prolific writer in various newspapers & magazines.
