



1. While Moderna and Pfizer/BioNTech were able to quickly develop their untested "vaccines", this rapid progress was made possible through substantial public funding. Moderna, in particular, received nearly \$1 billion from the U.S. government for research and development, along with an additional \$1.5 billion for the purchase of 100 million doses. Pfizer/BioNTech did not receive direct R&D funding from the U.S. government but secured a nearly \$2 billion purchase agreement.

- 2. This disagreement over recognition and potential royalties highlighted the complexities of public-private collaborations. If the NIH scientists were recognized as co-inventors, the NIH could claim a share of the intellectual property rights and potentially receive royalties from the sale of the vaccine. This would not only have financial implications but could also give the U.S. government more leverage in controlling pricing and access terms, especially during public health emergencies.

# The Implications of Patent Ownership: Who Benefits, Who Pays?

The case of the COVID-19 vaccines illustrates the broader implications of patent ownership and the commercialization of publicly funded research. The question is not just about who holds the patents, but who ultimately benefits from them.

### **Private Companies Reaping Profits:**

1. Moderna and Pfizer/BioNTech, despite leveraging public funding and public research, retained significant control over the pricing and distribution of their vaccines. 

### The War on Terror:






