- We'll also delve into how the pandemic illuminated the vital need for <u>vaccine</u> <u>administration data and timely reporting for real-time data</u> and trend monitoring to identify areas of need and ensure high vaccination coverage rates among NH individuals at highest risk of severe disease. To this end, we'll look at the NH Immunization Information System (NHIIS) that was launched in April 2021 during the peak of COVID-19 vaccine roll-out.



Vaccination is an essential component of adult healthcare, however, most adults are not up-to-date with vaccines. This session will review the standards for adult immunization practice, current adult vaccine recommendations and strategies for increasing adult vaccination rates. It will highlight the importance of all healthcare professionals taking steps to help ensure that their adult patients are fully immunized. This presentation will provide an overview of the current ACIP-recommended schedule for adults and review the most updated guidance for pneumococcal, hepatitis B, zoster and influenza vaccination. It will provide best practices and strategies for healthcare providers to increase adult vaccination rates and will offer tools and resources to support up-to-date adult immunizations.

Dr. Wolynn's is CEO of Kids Plus Pediatrics in Pittsburgh, PA. His work with vaccines extends over 27 years as a: Clinical Vaccine researcher (14yrs), Immunizing Pediatrician (27yrs), Vaccination Communication and Disinformation Researcher (5yrs) and Vaccination Advocate (27 yrs). In 2017 his practice was the victim of a global coordinated online attack triggered by a 90sec HPV PSA the practice posted on Social Media. The attack resulted in >10,000 attack posts to their Facebook page and a decimation of their online Reviews. Rather than retreat and take the post down Kids Plus fought back with: 1) Research 2) a Toolkit 3) a Digital Cavalry & 4) an Awareness Campaign. This work resulted in the founding of -Shots Heard Round the World - a nonprofit created to defend online vaccination advocates and to promote vaccinations.


