## Dear Friends,

As we close out the past year, we are proud to share a year marked by resilience, innovation, and measurable impact. At Gateway Foundation, our mission to save lives through evidence-based addiction and mental health services have never been more urgent—or more effective.

This year, we served over 10% more clients than in FY24 across our residential and outpatient programs, expanding access to care in both urban and rural communities. Our client engagement scores reached a new high, averaging 91.5%, reflecting the trust and satisfaction of those we serve. We also achieved a 1.2-point increase in successful discharge rates across multiple sites, a testament to the dedication of our clinical teams.

Operationally, we maintained expenses within 5% of our FY25 budget, while driving year-over-year revenue growth—a critical balance that ensures both sustainability and scalability. And we made substantial capital investments to prepare our organization for an evolving future landscape.

Our Patient Satisfaction or Performance Management Review (PMR) scores across 30+ indicators remained strong, with top marks in patient satisfaction, safety, and clinical compliance.

More importantly, our long-term recovery outcomes outpaced national data showing our people are more likely to sustain recovery 90 days post treatment.

We also made strategic investments in workforce development, launching individualized staff development plans and expanding training programs across all divisions. These efforts are helping us build a learning organization that supports both our mission and our people.

As you read through this year's Annual Report, we hope you'll see not just the numbers, but the lives behind them. Every data point represents a person who found hope, healing, and a path forward.










### **Our Reach**

## Year in Review FY25 Highlights

This year, Gateway Foundation strengthened its role as a leader in expanding access to treatment, building recovery communities, and advancing innovative approaches to care. These highlights showcase some of the areas where Gateway's impact was most strongly felt by our patients and in our communities.

## **Expanding Access to Care**

Gateway continued to grow its capacity to meet rising demand for substance use and mental health treatment.

Construction began on the Aurora Recovery Home, a \$9.2 million investment that will soon provide 32 beds of safe, supportive housing with wraparound services. At the same time, withdrawal management services expanded with new residential detox units at Independence and Lake Villa, complementing the existing program in Springfield. Independence also advanced development of a Level 3.7 medically monitored detox unit, filling a critical service gap in Cook County.

Facility improvements kept pace with Gateway's program growth, with the Larson Family Wellness Center, reaching completion and the Kedzie site undergoing important renovations, including accessibility upgrades with a new elevator and structural improvements such as window replacements. These investments ensure that Gateway patients receive care in safe, modern, and supportive environments.

During the year, partnerships with government agencies created opportunities for critical investments and expanded services. State funding of \$1.547 million was secured to replace the roof at Independence, protecting long-term operations. A \$1 million grant through Cook County Health's Stronger Together initiative supported the expansion of integrated substance use and mental health services. Community-based outreach grew as well, with harm reduction and referral efforts extended through the Illinois Opioid Settlement Initiative in St. Clair County and the INC Board in Southern Kane County.



## Strengthening Recovery Communities

Recovery is most sustainable when individuals feel connected and supported. Gateway strengthened these networks through alumni engagement and community partnerships. More than 80 alumni events were hosted across Illinois and St. Louis, ranging from family-friendly outings to sports-based gatherings. Highlights included the Springfield Pool Party, which drew more than 300 participants, the 5th Annual Aurora Community Walk, and a White Sox game that brought together nearly 100 alumni.

The Gateway Connect app also continued to thrive, surpassing 7,000 users and hosting more than 175 online support meetings, ensuring that alumni and their families can access recovery support anytime and anywhere. Beyond alumnispecific efforts, Gateway maintained a visible community presence at local events such as Heap's Big Pumpkin, SIU football games, Zero Fest, and the National Rally for Recovery. Peer-led recovery communities at Kedzie House and in Carbondale provided consistency of support, even during times of transition or site renovation.







## Addressing Problem Gambling

Gateway advanced its leadership in addressing gambling disorder, a growing public health concern in Illinois and beyond. Outreach and awareness activities connected with thousands of people at the Illinois State Fair, university campuses, casinos, and professional sporting events. During Problem Gambling Awareness Month, Gateway partnered with Healthcare Alternative Services to engage more than 120

community members. Participation in National Screening Day at casinos further expanded the reach of prevention and support.

Education and advocacy remained a core priority. The Wager Danger podcast continued to grow, surpassing 4,400 downloads and featuring conversations with experts in research, recovery, and gambling culture. Guests included Dr. Kasra Ghaharian of the University of Nevada–Las Vegas, Christina Cook of The Broke Girl Society, and Dr. Joshua Grubbs, who shared insights on the intersections between gambling and sports.

## Advocacy and Policy Leadership

Gateway's advocacy efforts ensured that patients' needs remained visible in policy discussions at both the state and county level. Leaders traveled to Springfield to press for increased treatment funding and to call for insurance reforms, including the removal of prior authorization requirements that delay access to care. Through consistent engagement in policy forums, Gateway worked to make treatment systems more responsive and accessible to those in need.



## **Innovation in Justice and Corrections**

Gateway remained at the forefront of delivering treatment and recovery services within correctional systems. In Missouri, the Mother/Baby Program advanced to provide critical support to incarcerated mothers and their infants. New and renewed contracts in Florida, Texas, Wyoming, and Missouri expanded services that included in-prison treatment, outpatient programming, and reentry support. Florida also became the site of a new Certified Recovery Peer Specialist pilot program, made possible through legislative funding, with design and hiring well underway.

Reentry support strengthened as Day Reporting Centers in Florida expanded and community



programs in St. Louis grew. Gateway also advanced its inmate training and reentry work with the Florida Department of Corrections, equipping participants with the skills and supports needed to build stability and sustain recovery after release.
