o Please make sure your loved ones know that if their Veterans are in or will be going into a nursing home, and their house does not have an heir, then the house will be used to pay back the Medicare/Medicaid expenses once they pass.

## from Tharrel Kast (TK)

I think none of us itemize our Federal Taxes, but do contribute to charities. You may have missed that we (along with all Post members) can now deduct up to \$1000 per individual filers or \$2000 per couple filing jointly beginning for tax year 2025. It's really something to consider. That means you really should begin keeping track of all cash, item donations and even mileage you contribute. It also means that organizations should try to provide their members with statements showing contributions when they can. No one had had much use for this since about 2021, but it would go a long way now to encourage more donations (cash, items and mileage). It will reduce Federal taxes for members and even if they don't think they will owe, it could help produce a credit. May need to put an article in post newsletters, social media and websites.

For the tax year 2025, individuals who do not itemize deductions can claim a charitable deduction of up to \$1,000 for single filers and \$2,000 for married couples filing jointly. This provision is designed to encourage charitable giving among those who typically take the standard deduction instead of itemizing their deductions. I have attached a couple articles about this and other deductions like a new Senior deduction of \$6000 (until 2028), car loan interest, etc.




