Mote’s manatee died after assault injuries says report

The death of Hugh, the 38-year-old male manatee that died at Mote Marine Laboratory last April, could have been prevented according to necropsy report findings.

The death of Hugh, the 38-year-old male manatee that died at Mote Marine Laboratory last April, could have been prevented according to necropsy report findings published by the United States Department of Agriculture.

Hugh died from a 14.5-centimeter rip in his colon and injuries caused by a sexual encounter with a larger male Manatee named “Buffett” according to the report.

“The facility (Mote) failed to handle Hugh expeditiously and as carefully as possible to prevent trauma and physical harm, resulting in the death of the animal,” the report states.

Mote reported last April that Hugh had “passed away unexpectedly” at age 38, but there were no details then of the death resulting from an injury due to the sexual encounter.

St.Armands rental house shooting prompts investigation

Lido Key and surrounding residents were shocked to learn of a shooting that took place last week at a vacation rental home near the intersection of Jackson Drive and South Washington Drive just off St. Armands Circle.

The shooting took place at about 1 a.m. on Monday, July 24, during

Window to the sea comes to life

It is designed to provide guests an expansive view into the 400,000-gallon Gulf of Mexico habitat, which will feature various coral reef formations, sharks, rays, sea turtles, tarpon, snook, red drum, snapper, parrotfish, butterflyfish, and many other species.



Mote Marine Laboratory & Aquarium announced a milestone. A major component in the construction of its new Science Education Aquarium — an acrylic window — was installed into the new aquarium’s largest exhibit, the Gulf of Mexico habitat.

The acrylic window installed last week measures 26’ L x 17’ H x 11” W and weighs 27,900 pounds. It is designed to provide guests an expansive view into the 400,000-gallon Gulf of Mexico habitat, which will feature various coral reef formations, sharks, rays, sea turtles, tarpon, snook, red drum, snapper, parrotfish, butterflyfish, and many other species. It will also open up into a new large multi-purpose room that will host a vast array of educational and community programs.

This highly-anticipated exhibit will also house a second large acrylic win-

dow, which measures 26’L x 11’ H x 9” H, and weighs 22,200 pounds. This second acrylic piece, scheduled for installation later this week, will provide another vantage point into the world of Mote’s world-class research.

Construction update

In July 2022, the Board of Sarasota County Commissioners unanimously approved the transfer of land for Mote SEA from the County to Mote, and construction permits were approved in August. Vertical construction began in September, when site workers began placing 346 auger, cast-in-place pilings 80 feet deep into the ground. This tremendous effort required a towering crane, 145 tons of steel rebar and 312 truckloads of concrete. Concrete has been poured for the second and third floors.

Last week, on July 25, Mote elaborated on Facebook:
“On the day of Hugh’s passing, Hugh and Buffett engaged in natural, yet increased, mating behavior observed and documented in manatees both in managed care and in the wild.”
“...Hugh and Buffett were both observed initiating and mutually seeking interactions from each other throughout the day, and there were no obvious signs of discomfort or distress such as listing, crunching, or active avoidance that would have triggered a need for intervention.”
Mote added that its care team decided not to separate Hugh and Buffett because “separation has previously caused undue anxiety and negative effects in both manatees.”
Soon after the day of sexual encounter, on April 29, a change in Hugh’s behavior was noticed and he soon “became unresponsive in his habitat,” and died that day.
Hugh was born at the Miami Seaquarium and came to Mote in 1996 along with Buffett, who shared a tank. Hugh and Buffett participated in research projects.

According to Sarasota City Police, the shooting is still under investigation. It has been learned that surveillance cameras captured cars rapidly exiting the scene.

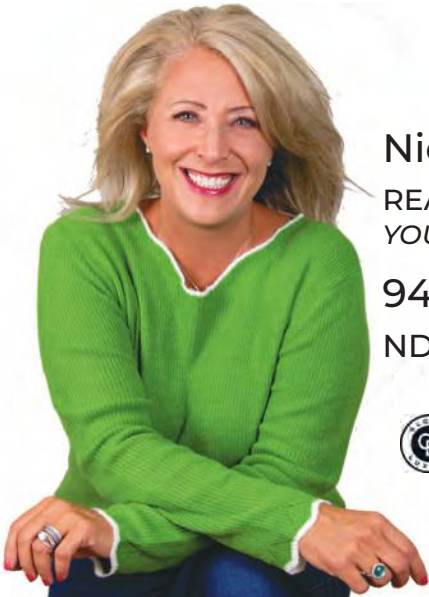

Do you know if this was approved by anyone at the City? If so, could you put me in touch with that person?
I have very mixed feelings on this and would like additional information on how it came about.
I'm a butterfly nerd (President of Sarasota County Butterfly Club, IABES, IBBA, NABA, Lepidopterist Society, etc.) So I know a little about butterflies.
This is a butterfly that has a great comeback story. I often talk about it in my butterfly presentations. I also have brought Atlas to these presentations to show participants. However, I have always made sure that if I released any, I released either a male or a female.
Intentionally starting colonies of butterflies that were not previously in Sarasota could have some unintended consequences. This was an east coast Florida butterfly. Only due to human relocation are they now on the west coast.
I'm curious as to the rationale for creating colonies of a butterfly that was not native to Sarasota.
They could have one day organically made their way to the west coast and then north, but that isn't the case here. We know what has happened with fish, birds, and other insects that

With regard to the proposed changes to the sound ordinance, my intention at this time is to propose deletion of the exemption in Section 20-7(3). However, I do not yet know with certainty the maximum decibel level that will be proposed for sound from air conditioners. Because this type of sound does not receive First Amendment protection (unlike music, which does), it is not out of the question to provide that sound generated by an AC unit is unlawful within specified nighttime hours if it would disturb a reasonable person of ordinary sensibilities.

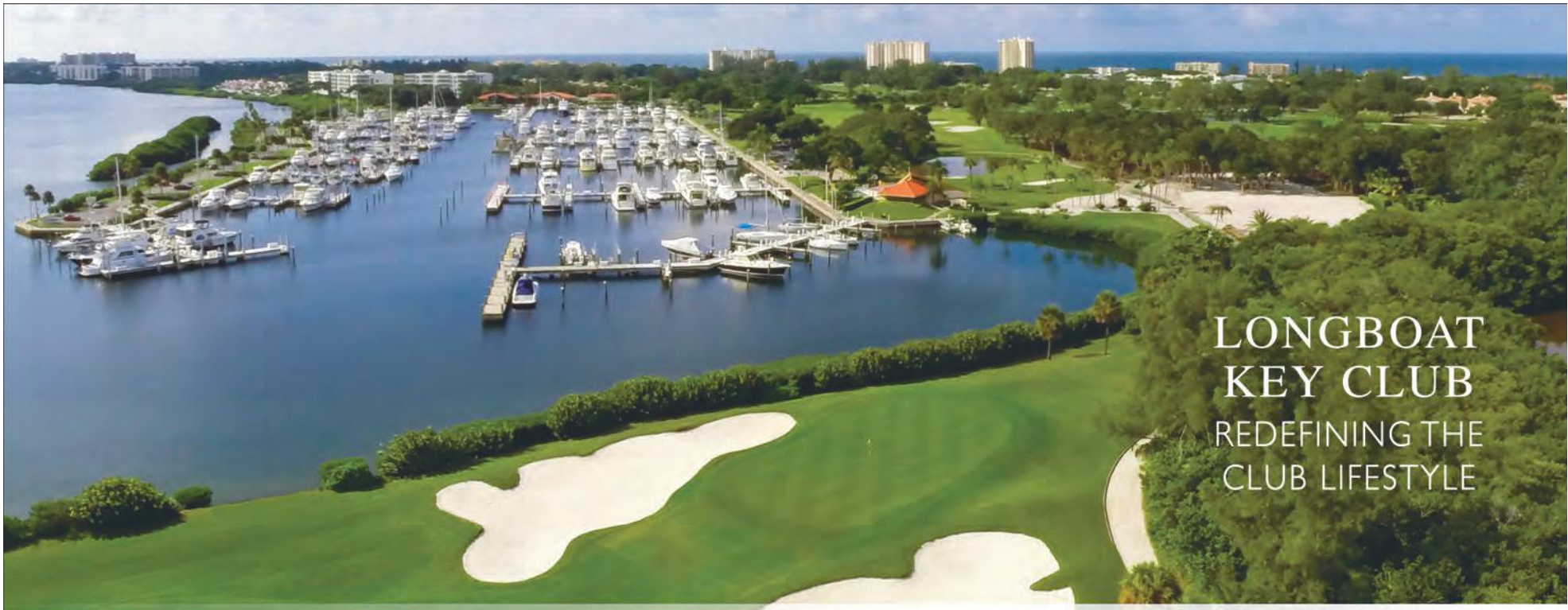

Urgent Appeal to Address Vacation Rentals in Residential Communities

To: Sarasota City Manager City of Sarasota

On behalf of my family, I humbly present this communication, seeking redress for a matter of great importance that plagues our communities - the proliferation of vacation rentals within residential zones. The issue at hand gravely impacts our quality of life and merits immediate attention from the authorities.

In the year 2007, our family made a significant investment in acquiring our residence within the serene confines of a residential neighborhood. At the time of purchase, we could not have foreseen the lamentable circumstances that would unfold years later. Unfortunately, in 2022, the tranquil sanctuary of our home was intruded upon by the establishment of a vacation rental behind our property, transforming our once peaceful abode into an inhospitable and stressful environment.

The repercussions of this vacation rental has manifested in an unending stream of disorderly and uncivilized tourists, exhibiting the most egregious anti-social behavior. Enclosed herein are links to two video recordings that vividly illustrate the distressing ordeals that our family has endured over the past year due to the uncontrolled and disruptive conduct of these transient occupants.

Regrettably, our plight has necessitated recourse to law enforcement authorities on multiple occasions, totaling four to five instances within a period of only one year, in response to the flagrant misconduct exhibited by the occupants of the aforementioned vacation rental.

Throughout our tenure in this residence, we have never before found it necessary to involve the police in addressing disruptive behavior from neighboring households.

Attempts at amicably resolving the matter through direct engagement with the vacation rental’s homeowner have proven futile. Multiple conversations and text messages with the homeowner and in-person visits to the property were made to implore the guests to exercise restraint in their activities. Regrettably, our entreaties have been met with dismissive responses from the homeowner, asserting that they are not bound by any constraints because of the noise ordinance (between 7am-11pm) and that they are entitled to raucous behavior within the premises, regardless of the impact on their neighbors.

This situation has further escalated, as the homeowner, in a written communication to me, openly threatened retaliation should we assert our civil rights by contacting the authorities again. She said in a text message, and I quote,” I don’t appreciate you calling the cops...if you call the police again, I will take action...” Such threats effectively impede our fundamental right to peace and tranquility within our own home. We have the constitutional right to peace and quiet.

Moreover, it has come to our knowledge that the deleterious effects of vacation rentals are not confined to our household alone. A sound byte from one such unruly incident from the vacation rental behind our home was shared with a hundred of our neighbors and has elicited widespread acknowledgment in the community of the negative consequences engendered by vacation rentals within our community. The pervasive sentiment among residents is a yearning for a return to the amicable and neighborly environment we once enjoyed, fostering a sense of unity and community that has since been disrupted by these vacation rentals.

In light of the prevailing circumstances, I earnestly implore this esteemed commission to undertake legislative measures to curtail the proliferation of these residential vacation rentals within residential zones. The advantages of such establishments appear limited, accruing primarily to the profit-seeking few, while the adverse effects ripple throughout the very fabric of our cherished neighborhoods.

We beseech your esteemed commission to take earnest consideration and view the linked videos as evidence, allowing yourselves to empathize with the cacophony and disruption that plagues our daily lives. Accordingly, we respectfully request that you take decisive action to amend any ordinances that permit vacation rentals within residential communities.

To restore the sanctity of our homes and foster a renewed sense of community, we advocate for the implementation of a minimum term requirement of six months for any vacation rental endeavor. Such a restriction would strike a balance between the interests of potential tourists and the preservation of residential serenity here.

In conclusion, we express our sincere gratitude for your time and consideration in addressing this pressing matter. We remain hopeful that this appeal receives the utmost attention from your esteemed commission, with a view towards safeguarding the rights and welfare of the residents instead of the tourists.

Thank you for your earnest attention to this vital concern.

Urgent Concerns Regarding Lease Non-Renewal at Hunters Glen Apartments

I hope this email finds you well. My name is Jessica Rivera, and I am a resident at Hunters Glen Apartments in Florida. I am writing to seek your advice and guidance on a matter that has recently affected my living situation.

Over the past year, my family and I have been model tenants at Hunters Glen. We have consistently paid our rent on time, maintained our apartment in good condition, and always fostered a positive relationship with the staff. However, to our surprise, we received a non-renewal letter from the apartment complex management.

When we approached the office manager, Andrea, to inquire about the reason for this non-renewal, she stated that the decision was made based on an assumption that we were not planning to renew due to our perceived mistreatment of the staff. This statement shocked us, as we have never encountered any issues or received complaints against us during our tenancy.

The Harvard University T. H. Chan School of Public Health has put a review of the Mediterranean Diet on its website. Concerning risk of death by stroke, it observes:

“The PREDIMED study, a primary prevention trial including thousands of people with diabetes or other risk factors for heart disease found that a Mediterranean diet supplemented with extra virgin olive oil or nuts and without any fat and calorie restrictions reduced the rates of death from stroke by roughly 30%. ... Most dietary fats were healthy fats, such as those from fatty fish, olive oil, and nuts, but total fat intake was generous at 39-42% of total daily calories, much higher than the 20-35% fat guideline as stated by the Institute of Medicine...Risk of type 2 diabetes was also reduced in the PREDIMED trial.”

The findings about deaths from stroke also extend to cardiovascular disease deaths in general and to cancer deaths. Lower risks of heart disease and cancer due to adherence to the Mediterranean Diet in the USA resemble lower risks of these deadly conditions in Mediterranean countries.

The Mediterranean Diet merely shifts the bulk of food consumption from red meat, starchy carbohydrates such as white potatoes and rice, foods sweetened by adding sugars, and fried foods to green, yellow, and red vegetables, whole grain breads and cereals, fresh fruit, fish, nuts, and healthier fats such as olive oil, avocados, soy, and corn. The study also reports what one would expect to find in the diet of people in France, Spain, Italy, Greece, and Portugal: generous servings of red wine.

In the USA, high proportions of calories from beef, pork, hamburgers, fried chicken, French fries, sweet soft drinks, pizza, ice cream, butter, and other dairy products show up as less healthy alternatives to the Mediterranean Diet. The NCI AARP Diet and Health Study, a very large prospective study that we helped conduct from 1995 to 2022, has found that diets heavy in processed meats and meat products increase the risk of cancers.

During recent years, heart disease and cancer figure into close to half of all deaths in the USA. Healthier diets would reduce risks of premature deaths substantially. The National Heart, Lung, and Blood Institute, the National Cancer Institute, the Centers for Disease Control and Prevention, the British National Health Service, the American Heart Association, and the American Cancer Society all recommend a Mediterranean Diet combined with exercise as a pathway to better health.

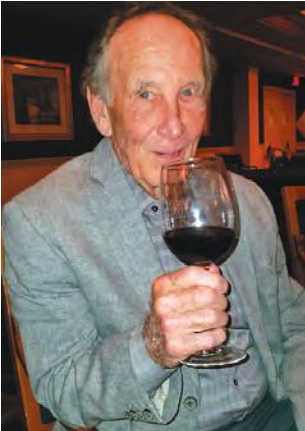
Despite the consensus of health experts on the benefits of a Mediterranean Diet, many households continue to favor unhealthy diets. Nutritionists know that people resist changing to healthy diets. After years of consuming excessive quantities of high sugar drinks, snack chips and crackers, desserts, fried fast foods, and pizzas, enchiladas, and casseroles covered with cheese, a plate of fish, brown rice, yams, greens, and an apple or peach doesn't taste the same. Making the Mediterranean Diet taste good remains a major challenge.

To learn more about alternatives to the heavyweight American diet, we turned to Amy at the Ancient Olive store on St. Armands Circle. She identified premium olive oils, aged balsamic vinegars, and wines as substitutes for less healthy American standards. Many Mediterranean restaurants serve olive oil in shallow dishes as substitutes for butter. French bread or crostini dipped in olive oil, perhaps with a dash of balsamic vinegar, serves as a tasty and healthier substitute for rolls and butter.

In vinaigrette salad dressings, infused olive oils and seasoned balsamic vinegars enhance leafy greens, ripe tomatoes, fresh and blanched vegetables, nuts, and slices of fruits such as cranberries or strawberries. Adding a splash of a wine that pairs well with the salad, say an acidic New Zealand Sauvignon Blanc or Sancerre, melds the flavors of the salad and the wine. Tuna in a niçoise salad, or white anchovies with white beans, comes alive with a light red wine such as a Pinot Noir or a young Tuscan Brunello di Montalcino in the vinaigrette and in the glass.

Olive oil, balsamic vinegar, and light red wine combine in a marinade to add savory flavors to mushrooms, salmon, and root vegetables. Add shallots, herbs, and mustard to taste.

For a substitute for a party tray of crackers, cheese, and processed meats, try serving enade



with whole grain toasts or crackers. Small dishes of hummus and of baba ghanoush will complement the tart tastes of olives, capers, parsley, and garlic in the tapenade.

A successful shift to a Mediterranean Diet often begins with gradual shifts from butter and margarine to olive oil, from red and processed meats to grilled or sauteed vegetables, from French fries to carrot sticks, and from ice cream to pieces of dark chocolate. The Mediterranean Diet generally costs more per quantity than the standard American diet, but the intense flavors of some of the healthier foods may encourage reductions in quantities consumed and encourage weight loss. Better to enjoy smaller quantities of memorable tastes than larger quantities of bland foods.

My observations and suggestions for tomorrow’s workshop:

- obtain an update on the status of 3-D efforts of the past year from staff
- discuss and confirm what priority staff and the commission wish to assign to a 3-D modeling effort in FY24 and beyond
- understand what funding is currently proposed in the FY24 budget
- ensure it is clear what department has the lead responsibility for 3-D modeling
- consider making 3-D modeling a separate line item in the budget so it has visibility.

I have written Ms. Strickland suggesting 3-D modeling be treated as a separate, line item in the budget. Thanks for considering.

Base and bonus density for purposes of Live Local

To: Sarasota City Commission

Greetings commissioners who voted in favor of last fall’s comp plan changes.

If I am interpreting Mr. Fournier’s response to Commissioner Trice’s question correctly:

it sounds like the best way forward to prevent the Live Local act from destroying neighborhoods outside of the downtown area with unsupportable density or overpowering height might be to remove the comp. plan density bonuses entirely.

Since Live Local seems intended to supersede local planning and control for affordable housing, why not allow it to - but on the basis of the current built environment and our city plan.

What I am suggesting is let Live Local handle the affordability bonus density with its 40% formula based on the existing “base” density of each zone, and let the appropriate mass, height, setback, and parking needs of a given site determine how much housing, in terms of units, can be built there.

That is how a form-based code is supposed to work inherently. And when it does work, everyone has certainty about what can be built where, avoiding lengthy and costly legal and civic battles.

I am not sure if comp plan changes can be opened for reconsideration or if a whole new comp. plan change process is required to unwind bonus density, but you didn’t know Live Local was coming when you adopted those affordability seeking density changes last fall, and the change in circumstances seems to invite a revisit. Thank you for considering this suggestion.
