We are planning to sponsor 50 more students for the year 2009/10 and to this effect we have identified the following states: **Orissa / Bihar and Chhattisgarh**

Slum Health Care Project, Aurangabad

Established in 1989 Dr Babasaheb Ambedkar Vaidyakiya Pratishthan's Slum Health Care Project is serving more than 100,000 slum dwellers of Aurangabad city through its 3 permanent health centres and a mobile clinic. The catchment area of this project is approximately 30 slum clusters. Thus, this project's outreach is almost 40% of the total slums of the city.

The trust is running 150 bedded multi speciality hospital which has as state of art Blood Bank.

2. Siddharth Madhukar Magare (Age: 19 years, B.C.S. Computer Science, First Year)

Siddharth needs to complete his Business Studies so that he can pursue his dream of starting his own business





3. Shrikant Bhaskar Salve (Age: 20 years, B.Com. First Year)

Shrikant wants to be a chartered accountant. He needs special coaching besides his regular graduation in Commerce.

4. Rajendra Prakash Rakshe

(Age: 20 Years, B.Sc. First Year)

Rajendra wants to be a Police Officer. He needs special coaching for B.Sc. as well as his preparation for the competitive examination to become a police officer.





Sewa Project Visit Report – Delhi & Mumbai

I was fortunate enough to travel to India and see projects managed by Sewa International – India. The purpose of the trip was to agree sponsorship of projects and agendas for the coming year – 2009 / 2010.

The projects that I saw and visited catered to all different aspects of service – ranging from an orphanage to visiting projects in the slums of Delhi.

DELHI SEWA PROJECTS

Ram Mandhir Project

The first project we visited was "RAM MANDIR" at Raghuvir Nagar in Delhi. This project is an Integrated Slum Development Project being run to benefit the inhabitants of the nearby slums.

We then visited "MATRICHHAYA", a child adoption centre at Miyanwali, Paschim Vihar, New Delhi. There were 19 small babies at the centre of which 17 were girls. This was a very emotional project. We had the privilege of spending some quality time with these small babies. We met with two of the board members, care workers and volunteers of the centre.

We met with Shyam Parande (general Secretary Sewa International), Navin Prasad and Arjun Lal Sharma (Vice Chair – SEWA International UK) and discussed issues relating to education aid and its functioning both in UK as well as in India. We also deliberated on the possibility of adopting projects for health, rural development and social development to be managed from the Birmingham office of Sewa International UK, in near future.

We visited - KESHAV VIHAR in East Delhi. It was our first opportunity to see a slum from such a close proximity and to have one to one interaction with the dwellers. Sewa International has a welfare centre in the slum itself. We witnessed small boys & girls attending tuition at the centre and young students being taught computer education. We also had the chance to visit a slum dwellers house where we were treated to tea and snacks. We were happy to hear from the family that their four children are now earning with the training & education they have received from Sewa International. The people were very affectionate. The lady of the house also sang Bhajans for us in their local dialect.



MUMBAISEWA PROJECTS

VATSALYA TRUST. MUMBAI MUMBAI

Bharatbhai Vadukul and I visited Vatsalya Trust accompanied by Ramesh Subramaniam Iyer of Sewa International, Mumbai.

Two trustees showed us the work of the Vatsalya Trust. We were surprised and astonished to find that the youngest trustee was 78 years old; this demonstrates the dedication of this group.

Balikashram

Balikashram is a home for 49 girls, between 7 and 17 years.

Vatsalya not only provides shelter, nourishment, medical care and education but also development facilities to these girls ensuring that they become more confident and self reliant when they return to their families.

Educational Assistance

Vatsalya Trust has also undertaken the financial responsibility of providing education to 20 students in and around Mumbai in some of the best schools in Mumbai.

Child Care And Rehabilitation Centre

Vatsalya's flagship activity 'Child Care and rehab Centre'. In the last 23 years Vatsalya Trust has reached out to 1092 children and has successfully placed 900 of these children into good families through adoption since January 2008.

At any given time there are approximately 60 children in the child care and rehabilitation unit

PERSONAL PERSPECTIVE

Having visited the Sewa Offices and seen the Sewa projects in Delhi and Mumbai, Bharat and I had the opportunity to gain an insight into the good work carried out by Sewa International.
