## Strengthening Families Through Protective Support

At All For Kids, we help families lay the building blocks that protect children from adversity and support healthy development. Through three protective factors—concrete resources, resilience-building practices, and meaningful social connections—families are better equipped to create safe, stable, and nurturing environments where children can thrive. Our prevention-focused programs continue to strengthen families today—so they are prepared for tomorrow. These insights are drawn from 757 retrospective surveys collected across All For Kids prevention programs serving diverse communities throughout Los Angeles and Orange Counties.



# BUILDING BRIGHTER FUTURES

## STORIES OF GROWTH, EMPOWERMENT & SUCCESS

At the heart of All For Kids are the children and families building brighter futures—one moment, one milestone, and one caring connection at a time. Each story reflects the power of early support, community, and compassion in action. Together, these voices show how families are growing stronger today, creating safe, supportive, and empowering environments where children can thrive now and into the future.

### *The Family I Dreamed of – And the One I Fought For* The Growth of the Bauer Williams Family

The path to motherhood was not the one Layla Bauer Williams imagined—but it was one she chose, fought for, and built with unwavering love. After years of infertility, loss, and unanswered hopes, she and her husband turned toward foster care and adoption, opening their home again and again to children who needed safety, stability, and compassion. Through moments of heartbreak and profound joy, she learned that motherhood is not defined by biology, but by presence, perseverance, and love in action. The following excerpts from a poem, written by Layla herself, reflect a journey shaped by resilience, trust, and the belief that family is built—intentionally, bravely, and one child at a time.

#### **When the right child joins your family, they become your forever child.**

I never dreamt of my wedding day.  
But I always dreamt of becoming a mom.

I come from a big family — my dad is the youngest of eight; I have twenty first cousins and forty-five second cousins. My genetics, I thought, guaranteed me an easy, straightforward road to motherhood. I'd decide I was ready, and bing-bang-boom: nine months later, I'd be woken in the middle of the night by contractions, rushed to the hospital, and handed my perfect baby. My husband, Jeremy, and I would lock eyes, tears brimming, marveling at the tiny human we'd made together.

Reality, of course, had other plans...

...

Before IVF, we'd agreed:  
only one round.

A baby didn't have to come from my body to become ours. So, while we chased IVF, we'd also signed up for an orientation at All For Kids to learn about becoming foster and adoptive parents. As a teenager, I'd imagined fostering kids once my biological kids were grown. I pictured a farmhouse — why a farm, I still don't know — filled with teens who needed help finding their way.

After IVF failed, we threw ourselves into foster parent training. We baby-proofed the house. Completed the home study. Six months later, we were approved as resource parents — the "cool kid" term for foster parents.

Seventy-two hours later, the phone rang. Two sisters needed a safe home: three months and eighteen months old. We said yes. Four hours later, they arrived wearing hospital scrubs as makeshift pajamas. I was so excited to meet them — on what was likely the worst day of their tiny lives.

I whispered to myself, *Yes, you can.*

...

After four babies came and went, my self-doubt roared back. I'll never be able to adopt. I'm not good enough. Not deserving. I told Jeremy, "*I can't keep doing this. I'm good, but I'm not saintly. When will it be my turn to be a real mom?*"

He pulled me close. "*You already are. You've been a mom to four kids who needed you. Our time will come.*"



In March 2020, the call came:  
a three-month-old baby boy.

When we adopted him a year and a half later, on September 1, 2021, I knew the old All For Kids saying was true: *When the right child joins your family, they become your forever child.* Alex was meant to be ours. He has my humor and Jeremy's tenderness. He made me a mom.

Eighteen months later, we got another call: a baby boy, born in a park in downtown LA. His mom got him to a hospital in Boyle Heights — I'm still in awe of that. His birth name was Vladimir. We called him Adam. Adam Joseph Bauer Williams. We adopted him on September 3, 2024.

Adam is independent, smart, and social — we call him the Mayor because he greets everyone and tells them his name. His favorite person on Earth is Jeremy, but on the rare occasion he chooses me for comfort, my heart spills over.

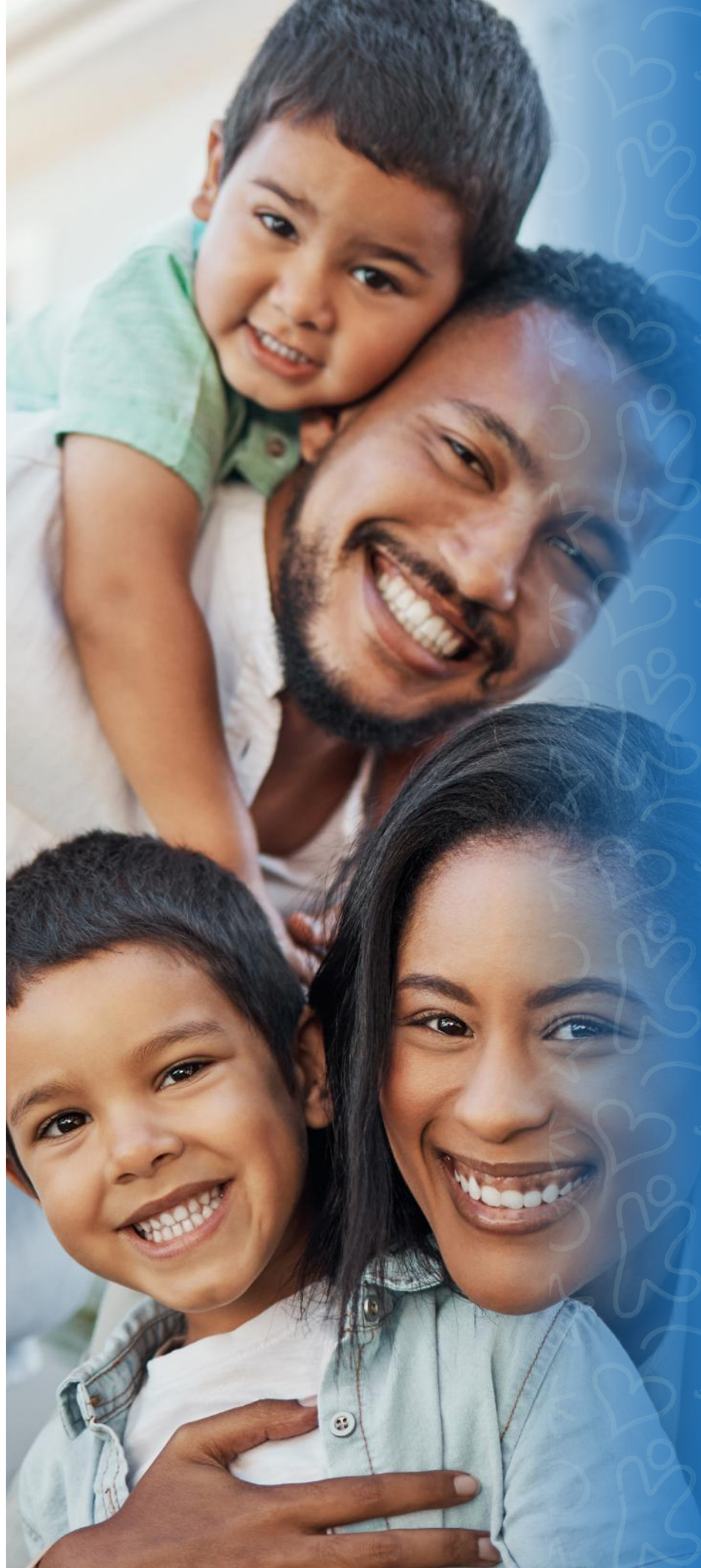
I never met Adam's biological mother. But I know she loved him — she got him somewhere safe. Somewhere we could keep him safe forever.

Each boy has heard his birth story so many times, they jump in to finish my sentences. I always end the same way, because it's the truest thing I know:

**Alex and Adam, I've been waiting for you my whole life.  
Alex, you made me a mom.  
Adam, you made us a family.**

And to myself, when doubt creeps back in, I whisper: ***You fought for this life.  
You are a good mom. A worthy mom...  
You deserve this beautiful life, more than you could have ever imagined.***

# BUILDING BRIGHTER FUTURES

## STORIES OF GROWTH, EMPOWERMENT & SUCCESS

All For Kids provides home visitation, case management, parent education classes, linkages and referrals, preschool, support groups, family enrichment classes, and father support groups. Through these services, we create opportunities for caregivers to increase protective factors shown to prevent child maltreatment, and we strengthen communities, families, and children.

### *Finding Support, Finding Hope*

#### **Emily's Story with All For Kids**

When Emily Brown first heard from All For Kids, she didn't know what to expect. Like many parents facing challenging circumstances, she was navigating a difficult season. "I had never heard of All For Kids before," Emily shared. "They came to me after I had an incident involving my daughter, who is autistic and a handful."

That unexpected outreach turned into something much greater—a source of consistent support, resources, and hope.

Emily's introduction to All For Kids was through the Prevention and Aftercare (PnA) Program. Led by a dedicated Program Manager, the team worked with Emily to help stabilize her family and ease the everyday burdens that were piling up. From emotional support to concrete assistance with bills, the team was there every step of the way.

**That's what people need to know—this program may not take away all your stress, but it takes some of it. And that makes a difference.**

"They couldn't help me with everything, but they helped me with so much," Emily said. "That's what people need to know—this program may not take away all your stress, but it takes some of it. And that makes a difference."

She described the support as a blessing, emphasizing how meaningful it was to have a team who not only listened, but followed through. "If the person I talked to couldn't help, they would find someone who could. That's powerful."

Despite recent hardships—including a job that didn't work out—Emily remains hopeful. She's actively looking for employment and leaning into the support system that All For Kids helped her build.

When asked if she would recommend All For Kids to others, her answer was enthusiastic: "Very likely. I have already referred two people, and I'll keep referring more. I appreciate the help so much."

Emily's story is a reminder that the right support at the right time can make all the difference. It also highlights the vital role community organizations like All For Kids play in helping families move from crisis to stability—and eventually, to hope.

## From New Mom to Family Support Counselor

### Chrystal's Journey with Healthy Families America

When Chrystal was in her third trimester, she was looking for more resources and support for her growing family. Through her WIC intake, she was connected to Penny Lane (a Los Angeles County non-profit providing comprehensive, therapeutic, and residential services), which ultimately referred her to All For Kids' Healthy Families America Home Visiting Program — a decision that changed her motherhood journey.

Chrystal shares, "I was pregnant and really needed extra support. WIC connected me to Penny Lane, and that's how I found All For Kids."

One of her favorite parts of the program was the family events. Chrystal recalls a special fall event where she and her children decorated picture frames and took family photos — an experience that provided much-needed bonding time when she was just four-months postpartum. "I still have that picture frame. It reminds me of that season in my life and how far I've come as a mom," she says.

Beyond the fun activities, Chrystal highlights the critical role her family support counselor played during her home visits. "Those visits were the highlight of my day. I got so much helpful information about my child's development, and the assessments really opened my eyes to my own mental health. I didn't even realize I was struggling with postpartum depression until then. My counselor helped me find resources and ways to cope."

When asked what she would tell other families considering the program, Chrystal doesn't hesitate: "Healthy Families America is amazing. You get one-on-one support, resources, and you build a strong foundation for your family to thrive." Chrystal's story comes full circle — after graduating from the program and applying what she learned, she was hired as a Family Support Counselor at All For Kids. Now, she gives back by supporting other families, just as she was once supported.

"It's really fulfilling to provide the same help I received. I'm so thankful for this journey."

Healthy Families America is the home visitation program of Prevent Child Abuse America serving our LA Metro and Antelope Valley locations. The HFA program offers weekly home visits, and services dependent on the family's needs. Services include child development programs, focused support on enhancing bonding and attachment by reading baby cues, depression screenings, developmental screenings, family/parent goal planning, and referrals to community resources.

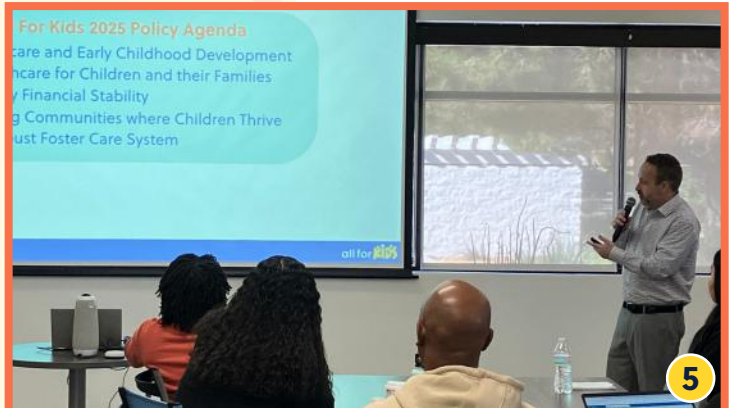

## POLICY ADVOCACY IN ACTION

This year, the All For Kids Advocacy Program advanced policies and partnerships that strengthen families and safeguard child well-being across California. By bringing together community voices, trusted leaders, and strategic coalitions, we helped shape solutions that prevent harm before it occurs and reinforce long-term support systems for families. The highlights below reflect how advocacy—grounded in compassion and informed by lived experience—is helping build more resilient communities, today and into the future.

### Community Engagement

#### ★ Presentations to Coalition Organizations

Equipped local activists with resources and information including LA County's dozen Child Abuse Prevention Councils, the SPA 2 Council for Family Well-Being, Best Start Antelope Valley, and the Antelope Valley Community Family Resource Center.

### Legislative Action

#### ★ Policy Agenda Communications

Engaged with more than a dozen legislators representing All For Kids offices, meeting with them online, in the district, and in Sacramento to push forward bills and budget positions outlined in our annual Policy Agenda.

Built relationship with newly elected Assembly Majority Whip Mark González covering our Magnolia Place Headquarters, providing input on multiple occasions to him and his staff.

#### ★ Continued Positive Impacts

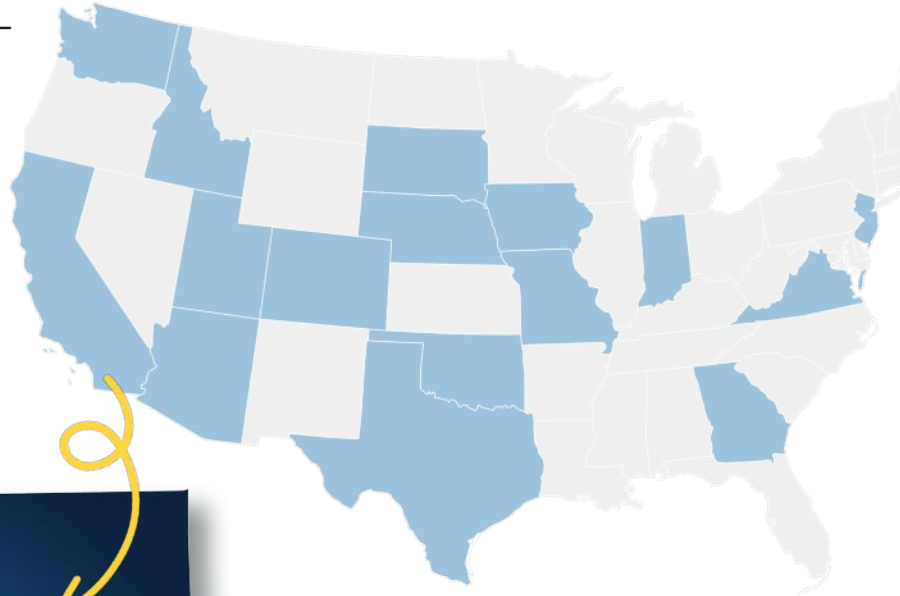

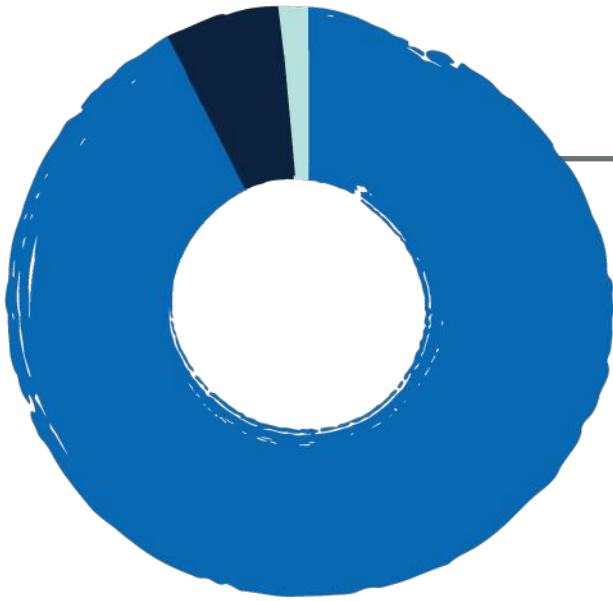

FISCAL YEAR 2024-2025

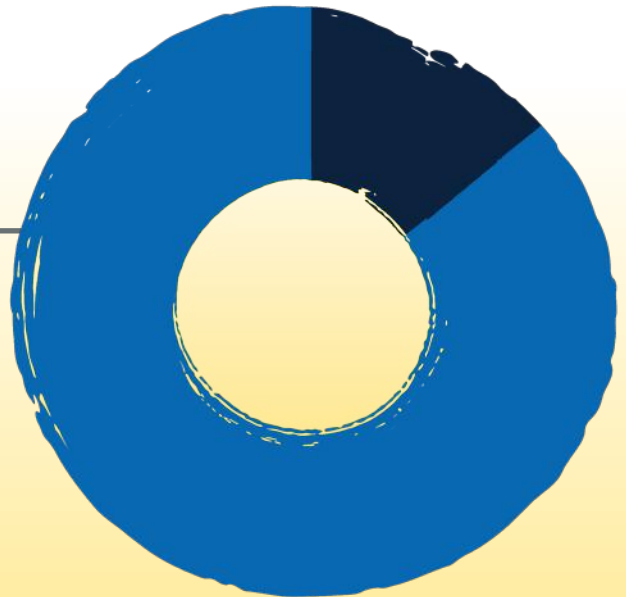

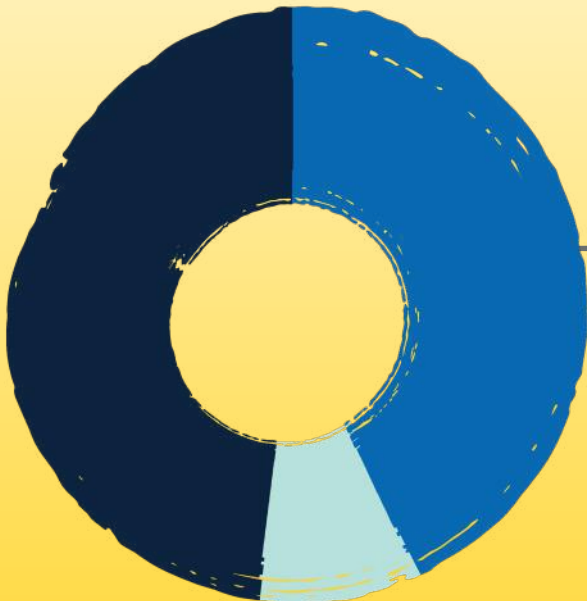

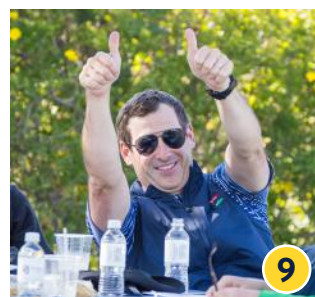
