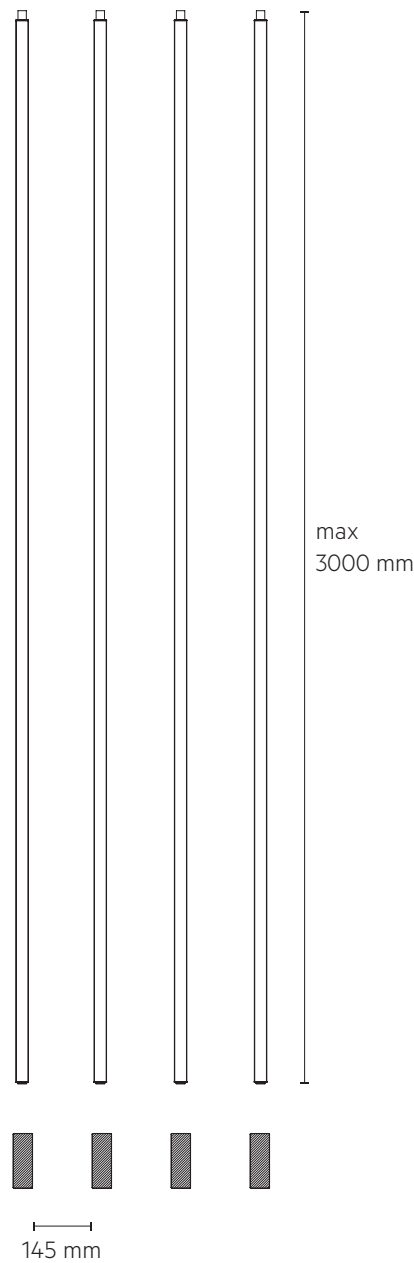

The correct sizing of the slat must be done by subtracting 19 mm from the height from ground to ceiling.

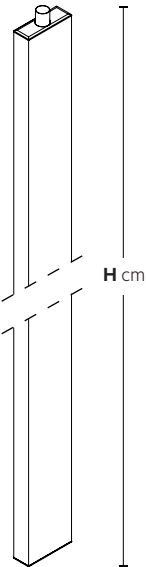
The template kit consists of 3 elements for installation with a distance between slats of 55 mm, 100 mm and a 45° inclination.

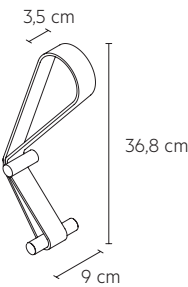

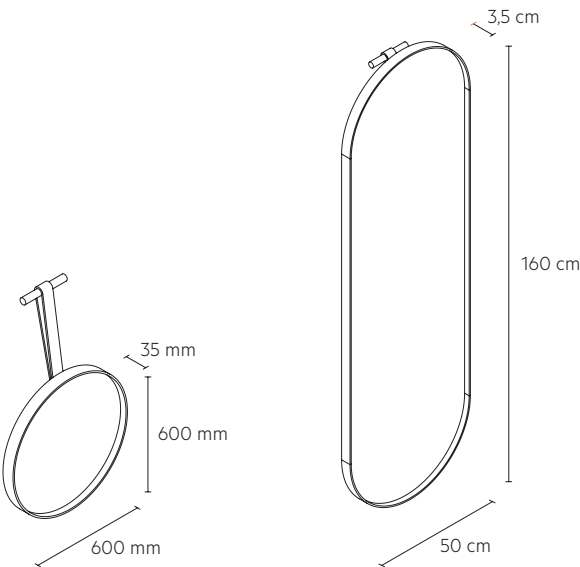

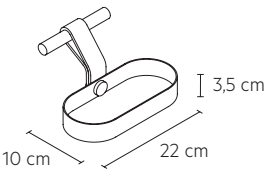

PRICE LIST

The prices in this list are in EURO, exclusive of VAT, with cardboard packaging, excluding design, surveys and installation.
The products are delivered Ex-Works, prices in the price list are in accordance with the Incoterms.

ACCEPTANCE OF THE ORDER

Each purchase order is subject to acceptance and approval by Xilia srl.
Purchase orders are considered finalized and therefore binding only after the sending of the order confirmation by Xilia srl and under the sales conditions indicated in the same order confirmation, including any acceptance signature by the Customer if required.
Xilia srl reserves the right to refuse the cancellation of an order after the receipt of the order confirmation signed.
Any modifications or additions to the order confirmation will be accepted only within 3 working days following the sending of the order confirmation. The modifications or additions will be confirmed in writing by Xilia srl by sending a new order confirmation with any adjustments to delivery times and sales price.

DELIVERY TERMS

The delivery term indicated on the order confirmation is simply indicative and not binding, referring to the date of preparation of the goods at our warehouses. Any delivery delay cannot, for any reason, lead to the total and/or partial cancellation of the order, nor to actions of redress and/or compensation against Xilia srl.
Xilia srl has the right to suspend the supply if it believes that the economic conditions of the buyer jeopardize the achievement of payment. In the case of deferred payments, the failure to meet the established deadlines legitimizes Xilia srl to request the immediate payment of the remaining amount.

TRANSPORT

It is the responsibility of the recipient to check the weight of the goods, the number of packs, and the packaging condition before collection and to make the necessary reservations to the carrier or forwarder. Xilia hasn't responsibility for the shipment.
The Customer bears all expenses, risks, and management for collecting the products from Xilia's premises and arranging the shipment to their own location.
Any special packaging (wooden boxes or others) will be priced separately according to the specific requests of the Customer.

PRODUCTS

All finishes and materials may undergo color variations over time (due, for example, to light, vapors, and aging). In the case of replacement, repairs, maintenance, differences in shades or other nature may occur.
These factors cannot constitute reasons for contestation or return of the product. The buyer accepts this tolerance with the order confirmation.
Samples, measurements, and specifications in the catalogs and price lists should be considered indicative.
Xilia srl reserves the right to make, even after sending the order confirmation, all technical-constructive changes to the products it deems appropriate without altering their essential characteristics and overall quality.
The production of non-standard products is subject to the prior written authorization of Xilia srl and subject to communicated surcharges to the Customer for prior approval.

RETURNS

They are permitted solely upon written authorization from Xilia srl and must be returned at the expense of the Customer.
The returned products must be carefully packaged by the Customer and accompanied by the transport document indicating the number of the original transport document.

COMPLAINTS

The Customer is required to carefully inspect the goods upon receipt, and any defects must be formally communicated to Xilia srl within 8 days of receipt.
Xilia srl excludes any responsibility for abnormal use of the products or for unsuitable storage of the products with reference to the assembly instructions and the cleaning and maintenance manual.
However, Xilia srl's liability is limited to the value of the potentially defective goods. Therefore, Xilia srl cannot be held responsible, among other things, for expenses incurred by the Customer or for any other (direct or indirect) damage claimed. Any goods recognized as defective will be repaired or replaced at the unquestionable judgment of Xilia srl.
Differences in wood shades and veins cannot be subject to complaints.

JURISDICTION

For any dispute, the exclusive jurisdiction will be the court of Treviso.
