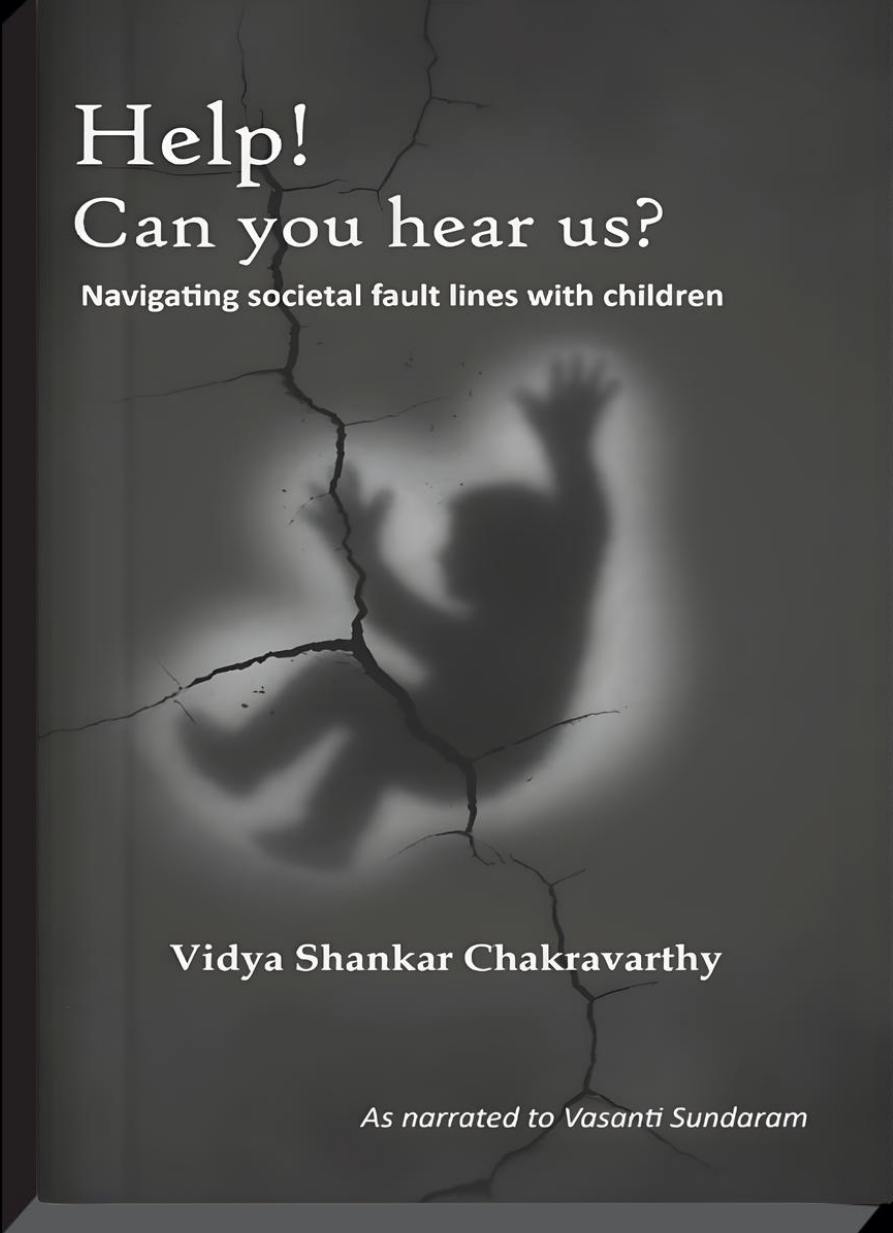

SYNOPSIS

"Help! Can You Hear Us? - Navigating Societal Fault Lines with Children" is deeply personal account of Vidya Shankar Chakravarthy's life and work with children, as narrated to biographer Vasanti Sundaram.

Founder of Relief Foundation, Vidya has worked closely with some of the most vulnerable children in our society – those in conflict with the law and those in need of care and protection. Drawing from her experience within government –run juvenile homes in Tamil Nadu, as well as her roles in the Juvenile Justice System, the book offers rare, firsthand insights into the lives of children who often slip through society's cracks.

Written from the perspective of a civilian stakeholder deeply engaged with the Juvenile Justice System, this work invites readers to look beyond labels and statistics, and to confront the human realities of childhood, vulnerability, and justice.

Dr S Muralidhar

Senior Advocate, Supreme Court

Former Chief Justice, Odisha High Court

Dr. S. Muralidhar is a distinguished Indian lawyer, former Chief Justice of the Orissa High Court, and currently a designated Senior Advocate practicing before the Supreme Court of India, known for his strong human rights stance, recently appointed Chair of a UN Commission of Inquiry investigating the Occupied Palestinian Territory. He previously served as a judge at the Delhi and Punjab & Haryana High Courts and was elevated to Chief Justice of Orissa in 2021 before retiring and being designated Senior Advocate by the Supreme Court in 2023.

Key Highlights:

- Began practice in Madras, moved to Delhi, became an Advocate-on-Record (AOR) in the Supreme Court, served as a Delhi HC Judge, then Punjab & Haryana HC Judge, and finally Chief Justice of Orissa HC.
- Designated Senior Advocate by the Supreme Court of India in October 2023.
- Appointed Chair of the UN Independent International Commission of Inquiry on the Occupied Palestinian Territory in late 2025.
- Holds an LL.M in Constitutional & Administrative Law and is known for work on human rights and constitutional law.

Dr. S. Muralidhar is a highly respected legal figure who transitioned from a prominent judicial career to continuing his impactful work as a Senior Advocate and now holds a significant international human rights role with the UN.

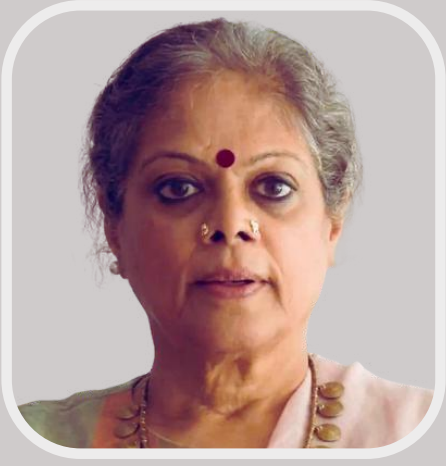

A recipient of the Manava Seva Dharma Samvardhini Award and the Rotary Vocational Service Award, she is a widely travelled speaker and writer, and the compiler of Sakhi, a premarital preparation manual for youth
