

The UK adult social care workforce is facing a significant shortage. In 2021/22, there were an estimated 165,000 vacant posts in adult social care in England, equivalent to a vacancy rate of 10.7%. This is the highest vacancy rate since records began in 2012/13.



The shortage of Level 3 Adult Care workers is particularly acute. In 2021/22, only 15% of the adult social care workforce in England held a Level 3 qualification or above. This is significantly lower than the proportion of workers in other sectors, such as the NHS (45%) and education (52%).



The demand for Level 3 Adult Care workers is expected to grow in the coming years. This is due to a number of factors, including the aging population, the increasing prevalence of chronic conditions, and the growing number of people with complex care needs.




