(What happened?)

The original working title for this manuscript was Dangerous Deception. The title seemed appropriate since the novel revolved around a series of "deceptions," including the mysterious identity of the main villain, the secret personal background of Marina, the existence of twins who presented themselves as a single person, and the tangled web of obscured information and clues that made the job of the protagonists so difficult. We found that the publishing world possessed multiple similar titles for novels, so we switched to the alternative, Survive the Day.

In the first version of the book, the action started with the rescue of the Hispanic hostages, and no epilogue existed. The author added the prologue and epilogue to better mirror how "stories" in life work. Our individual stories begin at an intersection of somebody else's ... and that other person's story continues. Sometimes they intersect again.

Teresa Adams only appeared once in the beginning of the first draft of Survive the Day. Her strong character couldn't be denied, however, and she forced her way into a much larger and more important role in the final manuscript. Appearing first in The Other Side of Good, and now Survive the Day, the popular character seems assured of other roles in future novels.

The author deleted the references to toll booths on I-95 when his wife reminded him they no longer existed.



Creme Trivia...

To the author's knowledge, no organization like the Santu exists. Many different sizes of criminal enterprises participate worldwide in the horrific crime of human trafficking.

Phil Enstice was the author's roommate at tiny Western-Maryland College (now called McDaniel), and his oldest son's name is Drew. That young man isn't the Agent-In-Charge of the FBI's field office in New York, however, and he lives in Baltimore.

Contemporary writers understand cliches aren't acceptable in good writing. The two pages devoted to them in chapter twenty was written entirely tongue-in-cheek.

Because few readers glance at the "Acknowledgments" section of books, the author and editor agreed to dispense with it in Survive the Day. By accident, the placeholder copy for the section was never deleted for the first printing of the books. Any who read these probably wondered why they related to the author's previous book, Pedaling West.

Peggy Easterly, who handles the author's social media and marketing programs, designed the cover for Survive the Day.

When Teresa and Pastor Burns cross the Susquehanna River on I-95, they pass within ten miles of the author's boyhood home. The first exits from the expressway after crossing the river going north are for Maryland communities with the colorful names, Port Deposit, Rising Sun, and North East.

Marina and Doug will appear in at least one more novel tentatively titled, The Right Side of Wrong. The book will include familiar characters from The Other Side of Good.

Have I Seen You Before?

(Characters in Survive the Day who appeared in earlier books)

The protagonists, Marina Butnari and Doug Hill helped Carrie Brinkley finish her bike trip in Pedaling West. Marina and her life partner, Tatiana, were two of the three trafficking victims saved in the opening chapter of The Other Side of Good. They were unnamed in that book.

Pastor Tom Burns was: hit by a pitch in Full Count, a high school classmate of the two protagonists in The Road Not Taken, responsible for creating an unusual enforcement coalition in The Other Side of Good, and facilitated the partnership between Hill and Butnari in Pedaling West.

Lynne Tune appeared in The Other Side of Good as a Santu torcheress. She also had a cameo appearance as Lin Song in Pedaling West when she helped the FBI from her place in Witness Protection.

Teresa Banks had a supporting role in The Other Side of Good as the primary administrative assistant to the novel's successful drug distributor. The results of her flirtation in that story with Pastor Tom Burns are evident in Survive the Day.

Readers first meet Alice Harbison in Pedaling West where she attends an FBI retreat and meets Doug Hill.

The fictitious criminal organization, Santu, first appeared in The Other Side of Good. Mei Feng, one of the criminals introduced early in Survive the Day, served as the Santu escort for the three trafficking victims rescued in the first chapter of that book.



Things to Discuss...

- 1. Several different characters must "Survive the Day" within the scope of the novel. How many can you name?
- 2. Who is the stronger female character: Marina, Alice Harbison, Teresa Banks, Dai Lu, or Henrietta?
- 3. A recurring theme in the novel is the importance of partnerships in life and several were portrayed: Marina & Doug, Marina & Tati, Mo Ren & Dai Lu, Alice Harbison & Marina, Bluntforce & the agents, Dai Lu & Ling. Which ones impacted the story the most?
- 4. In what way did this novel touch on environmental, political, and social issues that are relevant today?
- 5. The last line of the Prologue details how Carmen might one day repay Marina for rescuing her from traffickers. Did she deliver on this promise?
- 6. Even our favorite heroes in life are flawed. How did the flaws of this story's protagonists impact the plot?
- 7. Several secondary characters contribute important parts to the book. Who was your favorite and why?
- 8. Which was the more dangerous criminal: Mo Ren or Carlos?
- 9. Marina Butnari, Teresa Adams, Tom Burns, and Doug Hill are characters from earlier E. A. Coe books. Which ones from Survive the Day would you like to see in future books?
