Pipe carriers from the Thunder Clan functioned also as the guardians of peace among the membership and outside people. Families within the clan include: Baker, Bassette, Bradford, Beaver, Bigfire, Blackhawk, Grayhair, Hanken (descendent of Smoke family), Hunter, Kelsey, Payer, Raymond, Smith, and Tebo. ## CONSTRUCTION PROJECTS ROLL FORWARD

[Winnebago, NE] The construction projects that are happening in and around the community of Winnebago are numerous. With the turning seasons coming back into better weather, each of those projects continue to move forward. "There's really a lot happening in Winnebago right now.", stated Isaac Smith, Vice-Chairman of the Winnebago Tribal

In late January (2025), the Winnebago Tribal Council wanted to update the community on how the construction projects happening in our reservation home are progressing. At that event the various departments took the lead on each of their project's description, which included funding sources, completion timelines, and other vital details. At that event, which was held inside the Whirling Thunder Wellness Gym, one tribal member who attended told the WIN, "It's good to see all the activity because

our people need so much more than we have today." She continued, "[a] nd it's kind of cool to think about how our people are going to move forward in years to come."

As each of the projects was described at that morning's event, the details began to become apparent in ways that many tribal members had not heard about or realized. With the size of the construction efforts ranging from totally new buildings created from the ground up, to

## HOCAK FIGHTER IN DUBAI

[Winnebago, NE] On Friday, April 4, 2025, the hometown Winnebago crowd was treated to a mid-afternoon bout featuring one of our own, Carlos Trinidad-Snake. The young tribal member traveled to the other side of the globe landing in the grand desert city of Dubai U.A.E. This fantastic oasis-paradise city is where Trinidad-Snake took his undefeated record back into the squared-circle hoping to dethrone the reigning Welter-Weight Champion, Austin Trout.

Trinidad-Snake has been making a name for himself in the Bare Knuckle Fighting Championship (BKFC) taking on significant challenges, and each time coming away with a convincing win over each opponent. Just last year in his first Main Event match-up. Trinidad-Snake fought

in Omaha, Nebraska against a formidable opponent, Justin Pague. Trinidad-Snake won that bout in convincing fashion earning a TKO after fracturing Pague's jaw.


Training for the Skywalker 101 Club in Omaha, the 29-year-old fighter has been rising in the ranks of the BKFC for a few years now. While dabbling in other sanctioned fighting formats, it is the BKFC that seems to

interior and cosmetic renovations, the overall effort is nothing less than staggering. "We take pride in our home, and we know we have many more of our people to care for still.", said one staff member who is also a tribal member.

Of the projects, a few have been moved even closer to completion due to the better weather and previously established timing schedules. The Blackhawk Community Center (BHCC), which houses the Winnebago Tribal Council and several members of the WTN Administrative staff was closed last year, for example. To allow the building to undergo a massive interior make-over, the displaced staff members and Council moved north to the former LPTC Eagle dormitory, aka St. Augustine's Monsignor's House. The interior BHCC renovation that is taking place in that location will bring about a whole new aspect of tribal government with fully enclosed offices, additional working spaces and a whole new meeting chamber. An unidentified member of the construction crew said, "This place is coming right along. It will be done in no time."

Another major project is the new Emergency Services building. Located immediately to the north of the corporate limits for the village of Winnebago, this multimillion-dollar new construction will be a major step up for the ageing facility that currently houses the Fire Department and other Emergency Services. As the community of Winnebago continues to grow the foundational basis for these types of coverage becomes even more important. "We know

that Winnebago will continue to grow, so we're going to need more equipment that can handle a higher population.", Smith told the WIN.

Little Priest Tribal College also recently held a dedication for it's new Science Building nearing completion on that campus.

They also completed the update and renovation of the Elk Clan Auditorium that houses many classes and community events. Both stories were covered in previous issues of the WIN.

12 Clans Unity Hospital and WCHS are also in the mix, hosting a series of listening sessions in the past few months. Their staff is seeking the advice and input of the tribal membership as they move their own construction planning process forward. David Edwards, CEO for WCHS told the WIN, "We want to hear from the people." The 12 Clans campus is expected to undergo significant renovation and new construction as they hope to expand the footprint of the facility, while reaching for greater coverage of the healthcare needs of the Winnebago people.

With all the construction activity going on in our community, these listed here are but a few. The WTN Communications Department has been featuring each of the projects on its social media accounts, taking them as the figurative 'Winnebago Construction Project of the Week. have the full attention of this young hocak man. In pre-fight interviews held during press conferences in Dubai, Trinidad-Snake told the news outlets, "I think Austin has fought nothing but cans. I'm the best opponent he's fought. I'm going to bring it to him."

The overall event was scheduled to begin at 11:00 AM Central Daylight Time, a time that seemed to many, an odd occurrence. This being the timing because Dubai is a full 9-hours ahead of the United States CDT time zone. The start time, however, was for the under-card fights which were stacked up prior to the main events. Each of those fights had their bright spots and provided for much excitement as the local crowds built and the people filed in. The fight was shown at the 360 Lounge in WinnaVegas Casino Resort, and at the downtown Big Screen in Winnebago – where the WIN posted up as well. Many tribal members gathered at each location to watch. "We're so excited for this!" one tribal member told the WIN as the excitement grew along with the crowd.

Scheduled for a full five rounds, the match-up began with all the fanfare and pageantry you'd expect of a title bout. When Trinidad-Snake took the arena holding the Winnebago tribal flag above him, the now packed Winnebago crowd cheered and honked their car horns in support. "We knew there would be a great gathering of our people, and we were most certainly showing that." Garan Coons, WTN Communications Director said as the hype of the match was about to begin.

The day was a cold one, but that didn't stop the people from gathering. The downtown Winnebago Big Screen is set up for larger crowds and this kind of event fits right into the reason the area exists. People sat in their cars, on lawn chairs and on the ground, ready to watch Carlos Trinidad-Snake take on the reigning champion for the Welter-Weight crown. "A lot of people thought the fight was going to be tonight, but they forget where he is.", said another tribal member who was on hand to witness history being made.

When the bell rang, and the fight began, both contestants came out ready to battle. The people cheered, and the hype inside the arena given by the commentators helped raise everyone's spirits to incredible heights. All throughout the crowd the people chanted and cheered, "Let's go Carlos!" and other unprintable expletives.

Trinidad-Snake scored a knock down early on as Trout began the

now typical dance related to most mainstream boxing era prize fighters. Yells like, "Hit him!" and "He's scared of you! [Carlos]" rang out more and more. With only a few exchanges, none of which had any effect on either fighter, the match exhausted all five of its scheduled rounds. Trinidad-Snake retired to his corner and donned his training club t-shirt as he awaited the final results from the 3-judge panel. But after just a few moments, those judges wanted to see more — and so did the crowd. A sixth round was immediately begun.

In that short time frame, you could see that for the first time, Trout gave more effort in trying to lure Trinidad-Snake in an exchange of hits. But none of them landed anything of consequence. Trinidad-Snake was completely unscathed. Similarly, Trinidad-Snake was unable to land any of his signature hits that could end the fight outright.


As the tension mounted the final bell rang out. There was no winner by KO or TKO. But Trinidad-Snake did score his knock-down early on – but would it be enough? The Winnebago fighter stood the whole time in the ring with the reigning champion, his body and face practically untouched. With well wishes from celebrities, like Connor McGregor, who came into the squared circle as the decision was awaited, both fighters stood side by side not knowing who the judges had selected. Finally, in a split decision, Trout was awarded the win.

"Oh my god, he was robbed.", said one member of the crowd. "That's why I don't like watching regular boxing anymore. All he did [Trout] was dance around trying not to get hit.", said another. As expected, the Winnebago crowd expressed their displeasure with the unfavorable split decision. But none of the comments were of disappointment in Trinidad-Snake. Rather, they were still cheers of pride and chants of 'next time' or that the decision should have gone the other direction.

Carlos Trinidad-Snake is the son of Annabelle (Snake) Trinidad and grandson of the late, Lenore Snake. Congratulations are in order for this young fighter who is only at the beginning of his amazing career. The entire tribe cheered as you made history once more on the biggest stage in the world.

All involved in showing the day's events here in Winnebago would also like to express their sincerest gratitude and condolences to the family of the late, Pat Greyhair, for their kindness and heartfelt permission to continue with all that was shown.



He received an Air Quality Award for his work on improving air quality for Indian Country. He also served as the WTN Physical Resources Director for many years. Joseph enjoyed spending time with his family, grilling for family events, praying for his family and anyone that needed

a word of prayer.

He is survived by his parents Joby Jr. and Cheryl Painter, his siblings Miskoo and Holly Petite, Anpao, Wicahpi, Tatanka, and Wakan Petite and numerous nieces, nephews, aunts, tegas, cousins, and grandchildren.



## WCHS Celebrates National Nutrition Month with Community, Culture, and Healthy Living

We enjoyed the great reminders of ways our relatives-maintained wellness in the past" said Camilla Barajas, Director of Wa i pi nagu (Diabetes) Program. "We watched families come together to cook, share stories, walk during a chilly day and tell us how wonderful they felt. This was a reminder that we have always had these traditional medicines: food, family, movement, and cooking space, we just forgot they were medicines."


Throughout the month of March, WCHS hosted a series of events aimed at strengthening community connections through food and movement. To highlight the importance of physical activity, WCHS first hosted the Movement is Medicine

Walk, encouraging community members to step outside and embrace the benefits of fresh air and exercise. Despite the chilly weather, many participated in the 10-minute lap challenge, proving that even a short walk can boost mental wellness and physical health. The first 150 walkers received a special sweatshirt, and all participants enjoyed snacks and camaraderie.

Community members also gathered for a freezer meal workshop, "Our Cooking Space is Medicine," where they learned how to prepare healthy, homemade meals for themselves and their families. The hands-on workshop emphasized that food is more than just fuel; it is medicine that nourishes both the body and spirit. Later in the month, families took part in a Soup Cook-Off "Food, Family, & Community are Medicine," competing to create the most delicious, heartwarming soup. Community members served as judges, tasting and voting for their favorites, while participants, whether parents and children or grandparents and grandchildren, received a \$25 gift card to assist with ingredients.

As National Nutrition Month comes to a close, WCHS encourages the community to continue prioritizing healthy eating, movement, and time with loved ones. 



# Concert Review: Jelly Roll's Beautifully Broken Tour An Unforgettable Experience

Throughout my concert-going life, I've witnessed some truly memorable performances, from the raw energy of Linkin Park to the smooth harmonies of my childhood idols, Dru Hill. However, my recent experience at Jelly Roll's "Beautifully Broken" Tour has unequivocally catapulted itself to the top of my all-time favorites.

That Tuesday evening at Omaha, Nebraska's CHI Health Center Arena was buzzing with anticipation. The tour boasted impressive opening acts: Shaboozey, currently riding high with his chart-topping hit "Tipsy, A Bar Song," and ERNEST, known for his popular track "Cowgirls" featuring Morgan Wallen. Full disclosure: prior to this concert, I wasn't particularly familiar with the music of Jelly Roll, ERNEST, or Shaboozey. It was only through a fortunate turn of events – my significant other's cousin offering her unused tickets – that I found myself saying, "Let's roll, to Jelly Roll," ever the enthusiast for LIVE music.

Upon arriving at our seats, Shaboozey had just finished his set. ERNEST then took the stage for a solid 40 minutes, delivering mostly slower-paced songs before concluding with his hit single, "Cowgirls." Finally, the moment arrived for the headliner, Jelly Roll. Our seats offered an excellent vantagepoint, situated stage left and just two rows up from the floor. This meant we could enjoy the show without the need to stand for the entire duration, providing an eye-level perspective of the performers.

Jelly Roll's entrance was unique, beginning at the back of the arena. His stage setup was equally distinctive, featuring two separate stages. The main stage was a spectacle of large screens, dynamic lighting, and dramatic skull props that descended from the ceiling, all backing his talented band. In contrast, the rear stage was intentionally more understated, lacking the flash of the main setup. This design choice, it became clear, was deliberate, allowing the raw emotion and meaning of his songs to resonate without distraction.

Jelly Roll's setlist comprised 19 songs, open-

ing with the powerful and introspective "I Am Not Okay," a slower track that truly showcased his vocal ability. It was immediately apparent that every note was sung live, with no hint of overdubbing or lip-syncing – a refreshing authenticity that I deeply appreciated, having attended concerts where genuine audience engagement felt lacking. By the third song, with the high-energy "Get By," the show shifted into high gear. Flames erupted, captivating drum and guitar solos filled the arena, and stunning motion graphics danced across the background jumbotrons.

Throughout his performance, Jelly Roll encouraged numerous sing-alongs. While I wished I knew more of the lyrics, the sheer power of over 25,000 voices uniting in song was undeniably moving. I found myself completely engrossed, not wanting the concert to end as he shared his personal journey, his music, and the path that led him to that main stage. At one point, his heartfelt words resonated deeply: "This isn't a concert! It's a family reunion!"

Finally, the one song I recognized began as his encore: the widely known "Save Me." For this final performance, Jelly Roll returned to the rear stage. To my utter surprise, a suspended steel frame of a house descended around him. The frame then dramatically caught fire, and it literally began to rain. I was completely blown away by this theatrical display! He performed the entire song soaked by the artificial rain. I must admit, my focus was somewhat diverted as I marveled at the intricate rigging — Where was the water going? Would his wireless mic survive? Would he catch a cold? — but the spectacle was nonetheless captivating.

Ultimately, Jelly Roll delivered an amazing and unforgettable concert experience. I was impressed to learn that he will be touring with Post Malone later this spring, and based on this performance, I wholeheartedly recommend seeing it. 5 out of 5 stars!






