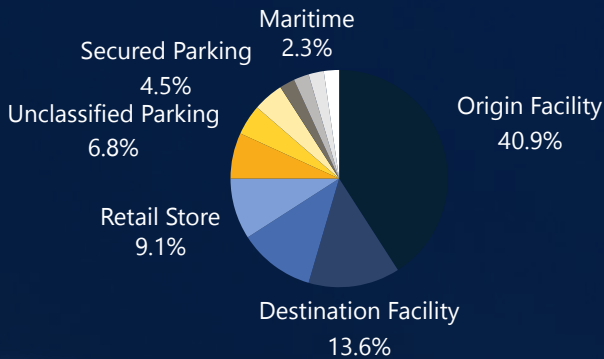

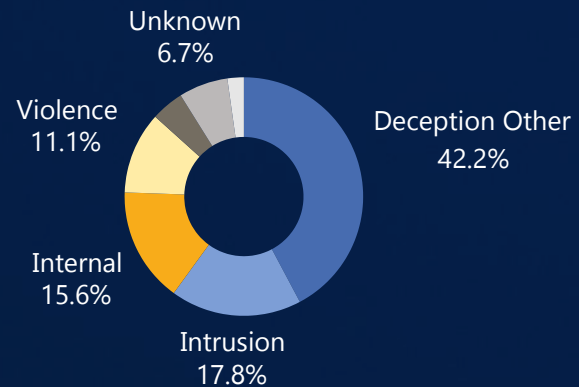

The TAPA Cyber Security Standard (CSS) 2025: A New Era for Supply Chain Cyber Security Coming Soon

In recent years, cyberattacks targeting the global supply chain have become increasingly sophisticated, and companies across industries are finding themselves in the crosshairs of cybercriminals. Cyberattacks targeting the supply chain can take many forms, from ransomware attacks that lock down critical systems to data breaches that expose proprietary information. Cyber threats are evolving at a breakneck pace, the ability to respond swiftly and effectively becomes increasingly vital for organizations striving to protect their supply chains.

In light of these growing cyber threats, it is imperative that the supply chain industry adopts a consistent, global approach to cybersecurity. One of the key challenges in addressing cyber risks in the supply chain is the lack of universal standards and frameworks. 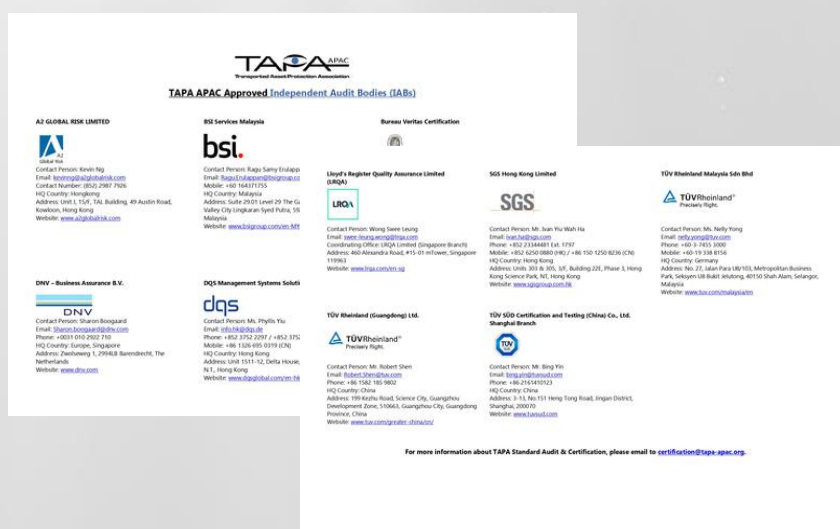

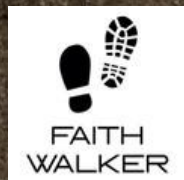

Focus Areas of the TIS Working Group

The TIS Working Group focused on three key areas:

Reporting Supply Chain Incidents

Addressing the issue of under-reporting in the APAC region, TIS provides a platform where users can anonymously submit cargo crime incidents. By enabling secure reporting, TIS supports the supply chain industry in bridging intelligence gaps and ensuring that incidents are properly documented.

- Encourage more logistics providers, manufacturers, and stakeholders to adopt the TIS platform, helping close the gap on under-reporting.

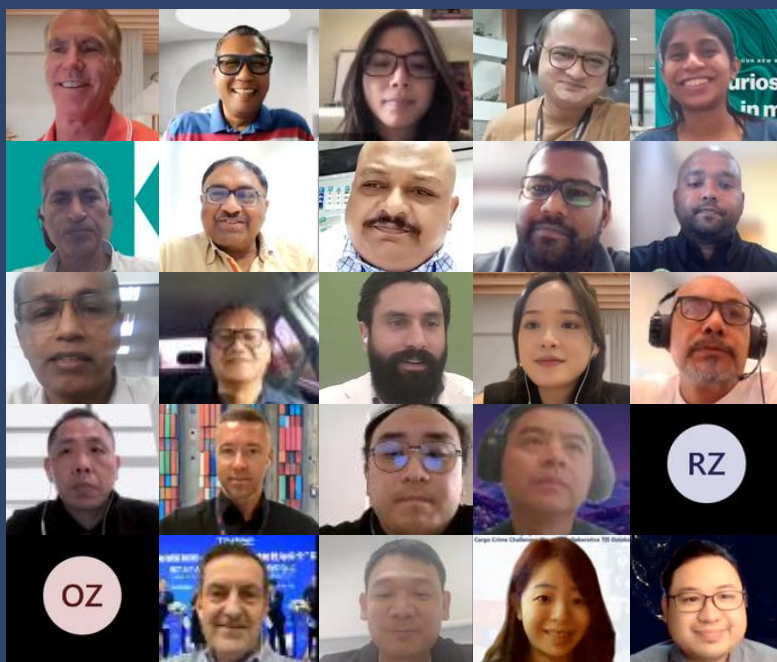
A Strong Start to the Year

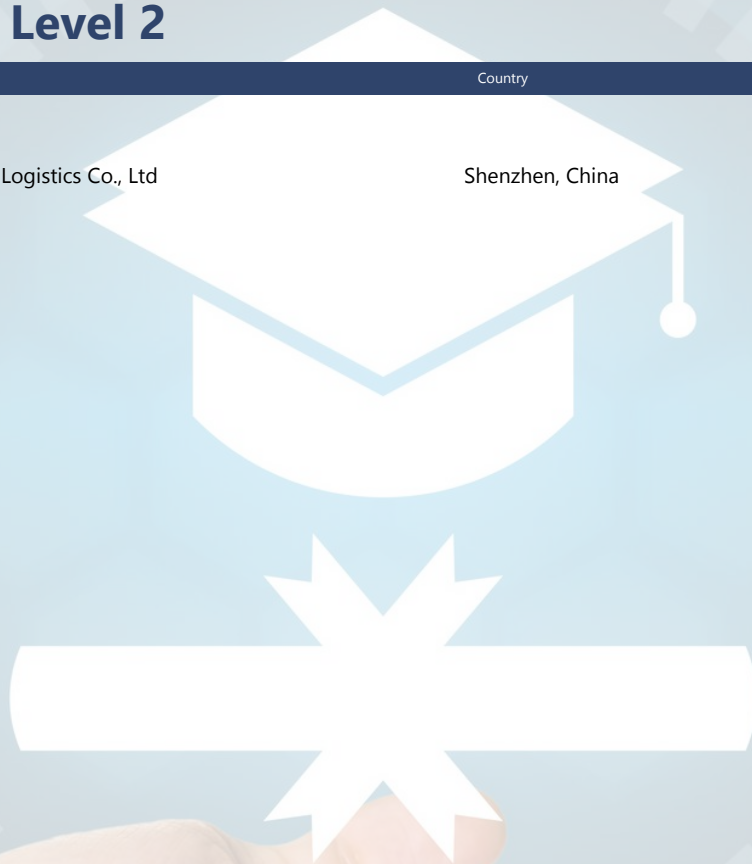
