

Government to Build By-pass Roads to Ease Leeward Highway Congestion

To address the ongoing traffic congestion on Providenciales' Leeward Highway, the government of the Turks and Caicos Islands has announced plans to create several bypass roads.

The initiative, led by the Deputy Premier and Minister of Physical Planning and Infrastructure Development, Hon. Jamell Robinson, is part of a broader strategy to improve the island's road network and reduce bottlenecks. The announcement was made during a press conference on October 16, 2024.

Minister Robinson outlined several key projects aimed at improving traffic flow and easing the daily burden on motorists using the Leeward Highway. These initiatives, he said, are rooted in recommendations from a recent transportation study, which highlighted the need for alternate routes around key bottlenecks on the island.

New By-pass Roads and Connectivity

The government's plan includes creating new roads that connect major points in Providenciales, offering alternative routes for motorists. One of the significant projects is the connection from Aviation Drive to Cooper Jack. Aviation Drive, which was recently paved, now offers smooth traffic flow, and this new connection, according to the minister, will extend that ease of movement.

"Where you would have Aviation Drive, we are connecting that to Cooper Jack. So instead of coming up and going through the bottleneck areas, drivers will be able to bypass those points entirely," he explained.

Another alternative route highlighted is Academy Way, which connects to Aviation Drive. This road provides a useful detour for drivers looking to avoid the busy downtown traffic area, offering a smoother, less congested drive. Robinson emphasized that the development of these bypasses is essential to making the island's road system more functional and efficient

Long Bay By-pass and Juba Sound Area Development

One of the most ambitious aspects of the government's road development plan is a proposed bypass connecting of Venetian Road — in the vicinity IGA Sports Complex - to Long Bay. This road, accord-

ing to Robinson, will feature multiple intersections that will allow drivers to connect back to the Leeward Highway, giving them options to avoid heavily trafficked areas. The new intersections will lead to roundabouts that either exist already or will be newly constructed as part of the project.

Robinson pointed out that this bypass not only serves as a traffic solution but also acts as a catalyst for future development in the Juba Sound area.

"There's a lot of undeveloped land in Juba Sound," said Robinson. "This road will encourage people who own land there to begin developing their properties. It's a beautiful ride across the Juba Sound area, and the new road infrastructure will make it much more accessible."

The four-lane road will be developed in phases and is expected to significantly reduce the traffic volume on Leeward Highway by providing motorists with multiple alternative routes to their destinations.

Millennium Highway Expansion

Another critical project outlined by Minister Robinson is the expansion of the Millennium Highway into a four-lane road. This project, described by Robinson as one of the "pride and joys" of the Public Works Department, is expected to ease traffic during the busy morning and evening rush hours, especially in the bottleneck area near the downtown roundabout and Bay Road.

The expansion will include the construction of two additional lanes, transforming the current two-lane road into a four-lane highway. The contract for this project has already been awarded, and while the exact start date is yet to be confirmed, negotiations with contractors have concluded, and the conceptual design has been finalized.

According to Robinson, the project will involve some disruption, as with all major roadworks. However, he reassured residents that the long-term benefits of the expanded highway would far outweigh the temporary inconveniences.

"There's no omelette without breaking a few eggs," said Robinson. "Once we get this going, it will significantly ease the traffic congestion that people face in the mornings and evenings."

The Millennium Highway expansion is part of a larger phased approach that will eventually see the four-lane road continue past the initial development phase. The new road will accommodate two buses, include bike lanes, sidewalks, streetlights, proper drainage, and vegetation.

Minister Robinson emphasized that the government's infrastructure projects are part of a long-term strategy to improve the road network across Providenciales. He pointed out that while these projects will involve temporary inconveniences, they are essential to ensuring that the island's road system can accommodate its growing population and the increasing volume of vehicles on the roads. Not An Election Stunt

The minister also took the opportunity to address any speculation that these projects were timed to coincide with the upcoming election. He clarified that the roadworks are part of the government's ongoing infrastructure development plan and will continue regardless of political timelines.

"We're just working," said Robinson. "These are the times when these projects are ready to go. And all things being considered, if we get another five-year term, we will continue to do this great work for the people of Turks and Caicos."



No Plans to Rend **Squatters** Homeless

Justice Carlos Simons, Head of the Informal Settlements Unit (ISU), has sought to reassure the public that the ISU's mission is not to displace squatters or render them homeless, but rather to regularize their situation and work toward more sustainable communities.

In an open house held on October 22, 2024, at the ISU office in Laporte Plaza, Providenciales, Simons reiterated that the government's priority is to ensure that no one, particularly families, is displaced from Crown Land without support or alternatives.

This marks an ongoing effort by the ISU to clarify its mission and goals, as fears persist among many who occupy Crown Land that their homes could be demolished without warning. Simons emphasized that while illegal structures on government land will be removed, the ISU is taking a careful, compassionate approach to avoid unnecessary hardship, especially for families.

"One of our principal policies, particularly as far as Crown Land is concerned, is that no one should remain homeless," Simons stated. He added, "We are keen to ensure that no one, particularly families, are dislocated."

The ISU's vision, he explained, is to help create more sustainable communities across the Turks and Caicos Islands (TCI), not merely by removing illegal structures but by redesigning informal settlements in a way that allows for longterm growth and development.

Simons clarified that the ISU's approach to addressing informal settlements may involve creating housing standards that differ from those in other parts of Providenciales and the Turks and Caicos Islands. These standards may be less

stringent but will still provide a level of structure and safety that is absent in many informal settlements.

"We anticipate that we shall be engaged in redesigning the informal settlements to ensure that they comply with some standard. It might be a lesser standard than the other areas of Providenciales and the Turks and Caicos Islands, which comply with codes," he said.

However, Simons pointed out that unfinished houses or vacant structures on government land will be demolished. This step, he said, is necessary to prevent further illegal occupation and misuse of land. Simons also cautioned that the ISU could not offer the same guarantees to squatters on private land, as the unit's jurisdiction focuses on Crown Land.

Simons' remarks come at a time when concerns about informal settlements are growing in the TCI, particularly in Providenciales. The housing shortage has led many to settle on Crown Land or in informal areas, raising challenges for the government as it seeks to balance the need for housing with maintaining order and land use regulations.

"We will be doing our very best to ensure that persons are not unnecessarily dislocated and that the severe housing shortage in Providenciales is not made worse," Simons added, underscoring the delicate balance the ISU must

A Data-Driven Approach to Formalization

For her part, Michelle Richardson, Logistics Lead for the ISU, also spoke at the open house, explaining the ISU's ongoing efforts to collect data that will help guide its work. Richardson

revealed that the ISU is currently conducting a comprehensive Social Needs Assessment Survey. This survey is designed to collect demographic, social, economic, and geospatial data from the 50 informal settlements identified across the Turks and Caicos Islands. The information gathered will inform the ISU's decisions about how best to approach formalizing these areas.

"We will require data, scientific data, to drive this process," Richardson stated. "This survey is supposed to provide us not only demographic data in terms of who occupies the different structures, but also geospatial and topographic

The survey aims to give the ISU a clear understanding of who is living in the settlements, as well as the environmental and logistical challenges posed by these areas.

Richardson also highlighted the importance of collaboration between the ISU and other government agencies, such as the Crown Lands Unit and the Physical Planning Unit. She stressed that the ISU is not working in isolation and that it views its efforts as part of a broader government initiative to address housing and land use challenges.

"We do have a number of sister agencies... to ensure that this exercise is a success," she said. The ISU, Richardson explained, sees the media as a key partner in spreading accurate information and ensuring the public understands the unit's objectives. Richardson encouraged the media to help disseminate the ISU's message of regularization, sustainable community development, and minimal disruption for residents.

Will Israel also doom Kamala Harris

As the nation of Israel continues its rampage in West Asia both President Joe Biden and Vice-President Kamala Harris are unwavering in their support and in the issuance of blank cheques to the Israelis.

After almost one year of a brutal bloodletting in Gaza, which has killed in excess of 40,000 Palestinians, including close to 20,000 women and children, the Israeli Defense Force has continued a bombing programme that has already sent an estimated 7,000 Lebanese into the great beyond.

Public opinion in the US has turned against the Biden Administration as millions of Americans took to the streets in protest against the unwavering support offered to the Israelis as they engaged in a textbook case of ethnic cleansing. The moniker of Genocide Joe was attributed to President Biden after his glaring displays of political tone-deafness in the face of an atrocity which increasingly resembles genocide.

President Biden's unwavering support for Israel alienated large swathes of the coalition that normally supports the Democratic Party. Muslim Americans went on record stating that they would not forget the intransigence demonstrated by President Biden even as evidence mounted implicating Israel in numerous atrocities. The Biden Administration refused to exercise any of its leverage over Israel to ensure compliance with stated American foreign policy objectives.

President of Israel Benjamin Netanyahu made it abundantly clear that he intended to pursue his own objectives even if they conflicted with American foreign policy. President Biden was made to look like the junior partner in the American-Israeli coalition on several occasions. Some political analysts, however, posited that Biden and Netanyahu were on the same page, notwithstanding the public sound bites suggesting divergence.

President Biden's political tone-deafness coupled with his lacklustre performance in the presidential debate against Donald Trump and clear evidence of age-induced mental fog eventually coalesced to produce a perfect storm of no confidence directed against him. A chorus of top-ranking Democrats, including Nancy Pelosi and Barak Obama, eventually were forced to do the needful and ask the president to withdraw from the presidential race

Ironically, as Biden's political fortunes dwindled, Netanyahu's grasp on power in Israel became stronger. The shock and awe attack against Lebanon and the assassination of Hasan Nasrallah and many of Hezbollah's top generals have resulted in a surge in popularity of Netanyahu's Likud — National Liberal Movement in Israel. President Biden has been put out to pasture while Prime Minister Netanyahu has grown in stature in Israel.

The endorsement of the assassination of Hezbollah's top brass by President Biden and Vice-President Harris indicates that the Biden-Harris Administration is continuing with the policy of "fully, fully, fully" supporting Israel. As November 4 approaches, the number one question in the minds of many Democrats who have soured on Biden is whether a Harris Administration would be willing to chart a new course vis-avis the nation of Israel.

The ascendancy of Harris to the top of the Democratic Party's presidential ticket has been greeted with great enthusiasm by Democratic Party faithful and by the Global South. The prospects of a non-Caucasian with Afro-Caribbean and Asian roots seems to have electrified the Democratic base and derailed the Trump train that accord-

ing to the polls was cruising to an electoral victory in November.

The continued popularity of the Obamas on the American political landscape suggests that Americans of goodwill are still open to new possibilities in political leadership. Caucasian supremacy and colonial settler projects have run their course and are being challenged by the global majority. The nation of Israel is, therefore, destined to go the route of apartheid South Africa.

Harris can decide to be on the right side of history and come out openly against the atrocities being committed by Israel or she can continue to be an agent in support of Caucasian supremacy and the settler colonial project that is the State of Israel. If she can preside over the dissolution of the apartheid State of Israel then history will be very kind to her. If she chooses to follow her predecessor President Biden and go all in with Israel, then her demise will be as dramatic as President Biden's and the coming collapse of the State of Israel.

TCI, A Country Under Siege - Astwood



Former Deputy Premier and Minister of Immigration, Sean Astwood, has expressed grave concerns over the alarming rise in violent crime that is plaguing the Turks and Caicos Islands (TCI).

In a statement, Astwood described the current crime wave as unprecedented, with a record 40 murders committed so far this year—a devastating milestone for a nation once celebrated for its tranquillity and safety.

Astwood, who is running as an at-large candidate in the next general elections, did not mince words when describing the perilous situation in the country. He emphasized that TCI, long regarded as a peaceful Caribbean paradise, is now under siege from organized criminal elements, leaving the community in fear and shock.

"The peaceful paradise that the Turks and Caicos Islands is known for is under siege," Astwood stated. "Our islands are facing a crime wave like nothing we have ever experienced before, and this is worrisome. As of today, we have recorded a staggering 40 murders this year—a new and devastating record for our beloved nation."

Escalating Violence in the Turks and Caicos Islands

Astwood's warning goes beyond statistics. He painted a grim picture of a society being torn apart by brutal acts of violence that are both unprecedented and horrific in nature. According to Astwood, recent years have seen a significant shift in the nature of crime on the islands, with incidents that include gang rapes, kidnappings, beheadings, and public executions in broad daylight.

"We are not just witnessing random acts of crime; we are seeing organized and brutal attacks that have never been part of our society," he explained. "Over the last three and a half years, we are now facing gang rapes, kidnappings, beheadings, and broad daylight public executions—horrors we could not have imagined just several years ago."

Astwood was adamant that this surge in violence cannot and must not be allowed to define the future of the Turks and Caicos Islands. He stressed the urgent need for comprehensive measures to tackle these rising threats to public

safety

"This level of crime CANNOT be allowed to become the norm in the Turks and Caicos Islands," Astwood declared. "Our once-peaceful shores are now being tainted by the blood of victims whose lives have been cut short by criminal elements that have no regard for human life or the law. These violent crimes are not only robbing families of their loved ones, but they are also robbing our nation of its sense of security and peace."

Root Causes and Urgent Action Needed

Astwood attributed the rise in crime to a combination of internal failures and external influences. He pointed to the infiltration of organized criminal networks, fueled by illegal immigration, drug trafficking, and the proliferation of illegal firearms, as key contributors to the escalating violence.

"Our islands have been infiltrated by organized criminal networks, fueled by illegal immigration, drug trafficking, and the spread of illegal firearms," Astwood explained. "These elements have taken root in our communities, and without urgent, decisive action, they will continue to spread their toxic influence."

Despite the grim outlook, Astwood remains resolute in his belief that the Turks and Caicos Islands can regain control and reverse the trend of violence. He called for the government to take bold and immediate action to confront the criminal elements head-on, providing law enforcement with the necessary resources, tools, and support to dismantle these criminal networks.

A Call for Bold Leadership and Crime-Fighting Strategies

As a political candidate, Astwood has committed to pushing for strong crime-fighting strategies that prioritize the safety and security of TCI's residents. He emphasized the need to empower the police force with modern forensic technologies, enhance border security to prevent illegal firearms from entering the islands, and establish a system of accountability that ensures that no criminal feels untouchable.

"With the support of you, the electorate, me along with my PDM colleagues will ensure restoring peace in our communities and make TCI safe again," Astwood said. "Safe to live, safe to work, safe to send our children to school, and safe to socialize with our family and friends."

Astwood made it clear that the Turks and Caicos Islands are at a critical turning point. Without immediate and decisive action, the future of the nation hangs in the balance. He urged the government and law enforcement to prioritize the safety and security of the people, ensuring that the wave of violence is curbed before it further destabilizes the country.

"I stand with the people of the Turks and Caicos Islands in demanding change, demanding action, and demanding justice," Astwood declared. "Together, we can overcome this crisis and reclaim the peace that has always defined our nation. The time to act is now, and I will not rest until we have restored the Turks and Caicos Islands to the safe, beautiful paradise that we all know and love."

Feeders Endangering Rock Iguana's Lives



FortisTCI, the energy provider in the Turks and Caicos Islands, is making significant strides in constructing the country's first utility-scale solar plus battery microgrid on its property in Kew, North Caicos. The project began last year and has reached a critical milestone with the installation of solar PV system now underway. This multimillion-dollar project marks FortisT-CI's single largest investment in renewable energy. Once completed, the microgrid will have

a capacity of 1.2 megawatts and is expected to meet 30% of the energy needs for North and Middle Caicos, providing savings for customers over time as utility regulations evolve. The microgrid will be a ground-mounted solar energy system and the largest solar photovoltaic installation in the TCI.

The system will produce approximately 1.9 GWh of green energy per annum. This green production is equivalent to 132,684 US gallons

of fuel avoided or 1,400 metric tons of CO2e avoided per annum. According to the project's timeline, solar PV installation is on track for completion this year. The battery energy storage system, which will support the solar PV system, is set for the completion early next year. The solar plus battery microgrid on Salt Cay will be launched next year. When completed, this system will provide 91% of the island's energy demand.

Introducing utility-scale microgrids is a significant step forward for the country, offering numerous benefits for consumers, the economy, and the environment. The continued integration of solar energy into the grid will reduce the reliance on fuel for electricity generation, lowering electricity costs over time as the regulatory framework adapts. Additionally, the shift towards low-carbon energy sources supports FortisTCI's commitment to reducing its carbon footprint.

FortisTCI President and CEO Ruth Forbes stated: "Our energy investment strategy is grounded in data from independent technical studies and focuses on achieving an optimal energy mix, with at least 33% renewable energy by 2040. The Twin Islands solar plus battery microgrid is a significant project in our energy transition, and we are proud of the progress made thus far.

As we advance this project, it is essential that renewable energy legislation advance in tandem to ensure alignment with the necessary utility-level investments to benefit customers and meet the country's renewable energy goals. The regulatory framework and supporting legislation governing the energy sector are crucial as they directly impact the scale, pace, and structure of renewable energy development in the Turks and Caicos Islands."

Four officers of the Environmental Health Department attend the 2024 Food and Drug Retail Food Protection Seminar

The Environmental Health Department is pleased to announce that four Officers attended the 2024 Food and Drug Retail Food Protection seminar of the Western Association of Food and Drug Officials from 24th- 27th September 2024. Environmental Health Officer Tiffany Murray and Port Health Officers Tinell Garland, Hattie Handfield and Rochelle Vanalstine-Nunes benefitted from the event, which was held in Sacramento, California. The event is held annually to assemble key officials from Environmental Health and Public Health Departments from western states including Hawaii, Arizona, Oregon, California, Colorado and Nevada.

The FDA Retail Food and Drug Seminar has been a forum for networking among participants and sharing challenges, successes and best practices regarding environmental health issues.

The seminar included state reports and panel discussions by member states and provided insight on areas of food safety monitoring and regulation, implementation of the FDA food

code, challenges in recruitment and retention of environmental health staff and the role of continuous professional development among environmental health professionals.

Notable areas of food safety discussed were:

- Unpermitted food vendors
- Regulation of cottage foods
- Creating meaningful metrics for food safety programs
- Shellfish distribution and controls
- The role of freeze-drying of foods in food safety
- Root cause analysis of hand washing violations
- Food poisoning
- Risk-based inspections and Environmental Assessments
- Technological advancements in food safety monitoring

In addition to the wide range of educational topics covered by state regulatory officials, the team interacted with State environmental

health managers and received vital information on food safety advancements, advanced inspection reporting and enhanced monitoring practices.

Honourable Shaun Malcolm, Minister of Health and Human Services, emphasised, "By equipping our officers with cutting-edge knowledge and tools, we are strengthening our ability to respond to food safety challenges more effectively. This training not only improves our inspection capabilities but ensures that we can protect public health more proactively."

The Environmental Health Department is committed to maintaining the highest standards of food safety and public health in the Turks and Caicos Islands by building capacity and ensuring our officers are kept up to date with public and environmental health advances.

FORTISTCI BEGINS CONSULTATION ON DRAFT RENEWABLE ENERGY AND RESOURCE PLANNING BILL



FortisTCI has conducted a comprehensive review of the provisions outlined in the draft 2023 Renewable Energy and Resource Planning Bill and a formal consultation process has commenced with the Turks and Caicos Islands Government (TCIG) and the Energy and Utilities Department on the Bill.

The consultation process on the draft Bill, which includes the energy provider FortisTCI, TCI Government, and independent consultant Mr. Abayomi

Carmichael, who was engaged by TCI Government to facilitate public consultation, started on Tuesday, October 8, 2024. This follows a kick-off meeting held on Wednesday, September 18, to discuss the consultation process. Additional meetings are planned over the next few months to continue formal discussions.

FortisTCI strongly supports renewable energy in the Turks and Caicos Islands. The Company believes the continued integration of renewable energy sources is necessary for the country's long-term sustainability, to diversify the energy mix, lower electricity rates over time, and reduce carbon emissions. This year alone, approximately 50% of the Company's capital budget was committed to clean and transitional energy projects, with ongoing commitments to invest in renewable energy and low-carbon energy sources.

The draft Renewable Energy and Resource Planning Bill, in its current form, aims to encourage the development and use of renewable energy in TCI. The Bill sets forth the licensing requirements for renewable energy producers and guidelines for connecting to the grid. It proposes an energy levy for solar energy producers, details licensing provisions for renewable energy installers, and addresses the roles of the Minister and the Energy and Utilities Commissioner. The Bill also includes a net billing arrangement, which enables solar energy producers to sell electricity back to the utility. Additionally, the Bill provides a framework for the development of an Integrated Resource Plan (IRP). The IRP is a strategic planning tool to forecast the country's future energy

demand and establishes the pathway and energy sources needed to meet those demands.

The current national roadmap for renewable energy integration, also called the Resilient National Energy Transition Strategy (RNETS), sets the country's target at 33% renewable energy by 2040.

FortisTCI, as the electricity supplier, has articulated its vision regarding provisions in the draft Bill to support a balanced, equitable and effective approach to renewable energy integration.

· Role of the Public Supplier: The Company's continued investment in renewable energy is fundamental to its obligation to serve, and to provide customers with least-cost, reliable electricity.

· Grid Integrity and Safety: The connection of independent solar systems to the grid should be done in a manner that preserves the integrity of the grid and ensures the continued safety of FortisTCI employees and the public. Proper protocols are vital to maintain a steady, safe and reliable power supply.

· An Integrated Resource Planning process should be established to determine the most cost-effective strategies for meeting customers' future energy needs. This process is key to guiding investment decisions and resource allocations.

• Equitable Benefits for All Customers: Those who do not install renewable energy systems should not cross-subsidize, that is, pay the associated costs, for those who do.

In addition, FortisTCI anticipates that incoming renewable energy legislation should follow sound regulatory principles and interact seamlessly with the Electricity Ordinance and related regulations.

Are We Doing Enough?



An OpEd by Author and Motivational Speaker Sheba Wilson

The mental health crisis in the Turks and Caicos is not just a personal struggle—it is a societal issue that impacts every corner of our community.

We live in a time marked by loss, trauma, violent crimes taking the lives of our young men, families struggling with the weight of poverty, and a collective silence that keeps us from healing.

We see the signs of distress in our neighbors, in our workplaces, in our churches, yet we must ask: are we doing enough?

The Systemic Strain

The Department of Behavioral Science, tasked with supporting mental health and substance abuse, is overburdened and underfunded. Clinicians are stretched thin, resources are scarce, and there are simply not enough hands or hours in the day to meet the growing demand. These challenges raise serious questions:

☑ Are the current resources adequate for addressing our community's mental health needs?

 $\ensuremath{\mathbb{Z}}$ Is the government providing the necessary funding

and infrastructure to truly tackle this crisis?

②Are companies paying attention to the mental wellness of their employees, offering not just lip service but meaningful support?

A Shared Responsibility

But this isn't just the government's problem—it's ours. Corporations, nonprofits, the church, and every individual have a role to play.

Employers, are you paying enough attention to the warning signs when someone isn't okay? Are you fostering a work environment where mental health is a priority?

Nonprofits, are you effectively reaching those in need with accessible resources?

And church leaders, is your role limited to offering prayers, or are you also offering tangible support to the vulnerable?

Mental health isn't just a clinical issue—it is a community issue. When someone in your circle isn't okay, do you notice the signs?

Are you asking the right questions, creating safe spaces for people to speak their truth? More importantly,

when you know someone is struggling, what are you doing about it?

Signs Someone May Not Be Okay:

- \bullet $\,\,$ Sudden withdrawal from social activities or isolation
- Consistent feelings of hopelessness or help-lessness
- Drastic changes in mood or behavior
- Difficulty maintaining daily responsibilities
- Speaking about feelings of worthlessness or burdensomeness

These signs demand action. They are calls for help, often unspoken, but clear if we pay attention. When we notice, we must act. Reach out, offer support, provide resources.

What Can Be Done?

Government must commit to a mental health strategy that matches the scale of the crisis—more funding, more trained professionals, and accessible spaces for mental health care.

Employers should take responsibility for employee well-being by offering counseling services, mental health days, and ongoing support.

The Church has a responsibility beyond spiritual care—providing emotional and mental support through community engagement, partnerships with mental health professionals, and fostering a culture of openness. What Can You Do?

As individuals, we need to educate ourselves, recognize the signs of distress in those around us, and be brave enough to ask uncomfortable questions. Friends, family members, and colleagues are often the first line of defense. If someone opens up to you, don't dismiss their feelings. Instead, guide them to the resources that can help—whether that's professional counseling, a support group, or just a trusted ear willing to listen. And as for each of us personally, we have the responsibility to take care of ourselves. Seeking help is not a sign of weakness but a courageous step toward healing. Too often, people suffer in silence, feeling like there's no one to turn to. It's on all of us to change that narrative—to make seeking help the norm, not the exception.

The Call to Action

Are we doing enough? Perhaps not yet. But we can start today. Let's challenge the government to do more, ask corporations to prioritize mental wellness, and push our churches to offer more than just prayers. Let's make mental health a shared responsibility and take active steps to make sure no one suffers in silence. It's time to move from silence to support, from inaction to intervention. I urge you to consider policies that prioritize community-led initiatives and ensure that local voices are integral to land use decisions.


Why not partner with local bankers to work alongside our people or explore other financial routes to help our community? Such collaboration could foster sustainable development that truly benefits us all.























\$2.1 Million Leeward Highway Phase 1 Repairs to Begin on November 1, 2024

The Turks and Caicos Islands government has announced the long-awaited repairs to the Leeward Highway.

Minister of Physical Planning and Infrastructure Development, Hon. Jamell Robinson, confirmed that Phase 1 of the highway's repair work, a \$2.1 million project, will begin on November 1, 2024. This announcement was made during a press conference held on October 16, 2024, in Providenciales.

This phase of the project will address the section of the highway between Suzie Turn and the Scotia Bank intersection. Both the east-bound and westbound lanes are slated to be repaired as part of the initiative, which aims to improve one of the island's most deteriorated roadways. While these improvements are anticipated to cause significant traffic disruptions, the minister emphasized the necessity of the project and asked for public understanding.

Importance of the Repairs

The Leeward Highway is one of the busiest and most vital roadways in Providenciales, used daily by thousands of motorists. Years of wear and tear, compounded by the challenges posed by heavy traffic and weather, have led to extensive damage, especially in certain sections of the road. Cracks, potholes, and uneven surfaces at certain sections of the highway have made driving conditions difficult, and motorists have frequently complained about the hazards posed by those sections.

Minister Robinson highlighted the urgent need for these repairs, noting that the government had carefully evaluated the entirety of the highway to determine which sections required immediate attention. The stretch between Suzie Turn and Scotiabank was identified as a priority due to the severity of the damage.

"Clearly, motorists across Providenciales know the concerns we have with the Leeward Highway," the minister stated. "Phase 1, which is from Suzie Turn to Scotia Bank intersection, eastbound and westbound, is due to commence November 1st. Now, the roadway work will cause some disruption, maybe even significant disruption, but it is necessary. Either we allow it to continue to deteriorate and face increasing complaints about

potholes, or we address the issue now with some temporary inconvenience," he said. Expected Disruptions

Minister Robinson acknowledged the frustrations that residents and motorists will likely face during the repair work, particularly because the project will impact all four lanes of traffic around the intersection. However, he stressed that this short-term disruption is essential for the long-term benefit of the community.

The government is already planning to communicate extensively with the public through notices and updates from the Public Works Department, ensuring that residents are informed about detours, road closures, and changes to traffic patterns.

"We know it's going to be inconvenient for many of you, and we are sorry in advance. But these infrastructure upgrades are critical. We must either let it deteriorate further or give you a bit of disruption now so we can have improvements," the minister added.

The Leeward Highway project is part of a larger effort to revamp the road infrastructure across Providenciales and the wider Turks and Caicos Islands, improving safety, reducing long-term maintenance costs, and enhancing the overall driving experience for residents and tourists alike.

Additional Infrastructure Projects

In addition to the Leeward Highway repairs, Minister Robinson provided updates on several other critical capital projects that the government is undertaking. Among these is the long-awaited construction of a fire hall at the JAGS McCartney International Airport. Tenders for the project have been released, and work is expected to begin soon.

Similarly, the construction of a community center in Bottle Creek, North Caicos is also advancing. This project aims to provide a much-needed space for social gatherings, community activities, and events.

Other key projects mentioned by the minister include the second phase of the Norman B. Saunders International Airport development, which primarily focuses on expanding and upgrading the airport's parking lot. Furthermore, the redevelopment of Regatta Village and improvements to the South Caicos Sports Field are moving forward, with tenders closed and the review process underway.

The refurbishment of the Bambarra and Horse Stable beaches in Middle Caicos is also under review as part of the government's commitment to enhancing public recreational spaces and tourism infrastructure.

Minister Robinson reiterated that these projects represent a significant investment in the country's future and reflect the government's commitment to addressing critical infrastructure needs.

How exercise can help in breast cancer treatment



Regular exercise is an important part of being as healthy as you can be. In fact, being physically active can reduce your risk of developing breast cancer.

If you have been diagnosed with breast cancer, exercise can reduce the risk of a recurrence of the disease, and also help ease the treatment's troubling side effects, such as fatigue, pain, depression, and lymphedema.

Experts say that exercise is safe during and after all breast cancer treatments, as long as you take any needed precautions and keep the intensity low.

Breast medical oncologist Dr Jennifer Griggs says exercise improves mood, energy level, and overall health during breast cancer treatment. "Many people believe that during treatment for breast cancer you should take it easy.

That is obviously true, because you do not want to exert your energy in doing things that are not important. However, being inactive is not going to help you. You will lose muscle mass, strength and flexibility. Stay as active as you can, within the limits of your energy level," Griggs said.

She says exercise can help you reduce fatigue, especially during treatment with chemotherapy and after surgery, when a patient's energy is depleted. In addition, exercising in natural light, she said, is recommended. 'You will find that some days you are more tired than others, so you have to be kind to yourself and to your body," she said.

The key, she said, is that you do not have to exercise all at once. You can break it up into 10-minute segments and fit it into you daily life. "If you have been inactive before breast cancer, now is a great time to start. You should stay as active as you can during treatment. Beneficial exercises you can do include aerobic and flexibility exercises, strength training, and balance exercise," Griggs said. Exercise can help you maintain or build muscle mass and be stronger. As most people age, they tend to lose muscle and gain fat. Chemotherapy and hormonal therapy medicines can suddenly throw you into early menopause. The decrease in oestrogen that comes with menopause is linked to decreased muscle mass. Strength training exercises can help make sure you increase lean muscle mass and reduce body fat.

Exercise can help improve mobility. Scar tissue that forms after breast cancer surgery, reconstruction, or radiation can make your arm and shoulder muscles feel tight. If

you do not use your arm and shoulder as much after treatment, the muscles in those areas also can lose flexibility. Over time, careful stretching exercises can improve the range of motion in the arm and shoulder.

For many people, the hardest part of exercising is sticking to a steady routine. Once the initial enthusiasm wears off, you may find yourself making excuses not to exercise. However, Griggs recommends that even after surgery, people should continue to exercise.

"How soon you start, what type and how much physical activity you do after surgery will depend on the type of surgery you have had, your recovery, and your fitness level before your surgery.

Many people feel well enough to go for a short walk a few days after surgery, but others need longer to rest. Build your physical activity levels up gradually, and remember, it may take time to return to the level of activity you were doing before your surgery," Griggs cautioned. Chemotherapy affects people in different ways. Some people have very few side effects and are able to continue with their usual activities. Others feel extremely tired or unwell and unable to carry on as usual. This can be frustrating if you want to be physically active.

There will be times when you do feel able to do some type of activity. Gentle exercise, such as walking, can boost your energy, help make you feel less tired, and improve your mood. It may be possible to continue with other types of physical activity, such as yoga.

Talk to your doctor about any activities you would like to do while you are having treatment. They can tell you which of them are suitable.

Why Do We Sneeze?



Some sneezes are meant to clear irritants from our nasal passages. However, some people sneeze for more unusual reasons.

We all know the feeling: It usually starts with a peculiar tickle in your nose, quickly building to an explosive and satisfying blast out of your mouth and nose. But why do we sneeze?

As it turns out, sneezing is your body's way of getting rid of visible or microscopic allergens, viruses, and irritants, says Matthew Purkey, MD, an ear, nose, and throat doctor practicing in Hoffman Estates, Illinois for Duly Health and Care.

"When our upper airway, especially our nose, senses a foreign substance that is potentially harmful, we sneeze in response to expel the substance back out," he tells Health.

So sneezing is a protective mechanism. But how come it can feel so satisfying, and why do sneezes often happen in a row? And is there any way to

prevent a full-blown sneeze when you sense one is coming? Here's what you need to know.

What happens when we sneeze?

A sneeze starts when an irritant enters your nose, says Dr. Purkey. There, the invader becomes entangled in nose hair, stimulating nerve endings, which sends a message to a part of the brain stem called the medulla. The medulla controls important yet involuntary functions like breathing, digestion, and heart rate.

Once the nerve signals reach the medulla, the brain initiates a physical response that involves closing your eyes, taking a deep breath, relaxing the muscles in your throat, and then forcing air, saliva, and mucus out your nose and mouth—all in a few seconds

All sneezes begin and end the same way, but everyone has their own signature sneeze; a person's sneeze is almost as unique as their voice. Why? It

has to do with individual differences in lung capacity and the unique structure of your nose, throat, and mouth, Hascalovici says.

What causes sneezing?

Sneezes happen for many reasons—and not all of them make sense. In general, when we feel a tickle in our nose it's likely due to a foreign body entering our sinuses. According to the National Library of Medicine, common triggers for sneezing include, environmental irritants, like smoke, perfumes, and air pollution; allergies, caused by pet dander, pollen, or dust mites; infections like the common cold, COVID-19, and the flu; dry air, which irritates mucous membranes in the nose; peppers-including black pepper and chilli pepper—which contain a substance called piperine that irritates nasal passages. (It's also what gives pepper its pungent taste.) Beyond the sneeze triggers listed above, there are more peculiar ones, too. Some people sneeze after sex, according to the Sexual Medicine Society of North America.

While it's not entirely known why this happens, it may be because both sneezing and sexual arousal are controlled by the autonomic nervous system, which controls involuntary reactions, per the National Library of Medicine.

Additionally, in a fairly rare phenomenon coined "snatiation"—a combo of "sneeze" and "satiation"—some people sneeze after a large meal, Heather Moday, MD, an immunologist in private practice in Maine, tells Health.

People can also sneeze when suddenly exposed to bright light or while looking directly at the sun. Called photic sneeze reflex, this reaction is somewhat of a mystery. Research does indicate that it is at least partially genetic, Jacob Hascalovici, MD, a neuroscientist and chief medical officer at digital health care platform Clearing, tells Health.

Liam Payne's family await post-mortem reports to take body home from Argentina



Following the One Direction star's tragic death in Buenos Aires on October 16, at age 31, Argentinian newspaper Clarín, claims his body could remain in Argentina for 10 to 15 days. Once toxicological tests have been performed, Payne's remains will be available to his family for return to the UK.

The British Embassy said: "We are supporting Liam Payne's family and are in contact with local authorities." The Strip That Down singer died from "multiple traumas" that caused "internal and external bleeding".

The singer plunged from a third-floor balcony at the Casa

Sur Hotel in Buenos Aires, and preliminary autopsy findings reported by the Daily Mirror newspaper found the result was consistent with his 10-metre fall.

Toxicological and anatomical-pathological studies of blood and urine will determine any traces of drugs.

Police found a bottle of whiskey, a lighter, and a white powder in the room, as well as medications, including clonazepam, which is used to treat epilepsy, panic disorders or involuntary muscle spasms, and energy pills.

A notebook and Payne's passport were seized and handed over to investigators, as well as a phone that may have

belonged to the former boy band member and will be checked for messages.

Police described "total disorder" in the room, with various things broken. They earlier said they had been called to reports of an "aggressive man who could be under the influence of drugs or alcohol".

Emergency services previously said Payne had died instantly. Buenos Aires emergency services chief Alberto Crescenti told The Sun: "Our role was to head there quickly, give medical attention, and try to resuscitate him, but his injuries were incompatible with life.

"Based on what the team saw, there was apparently a cranial fracture and extremely serious injuries that led to his immediate death."

Audio from the two calls made by the hotel's head of reception to emergency services also circulated online, with the employee admitting that staff were "worried" a guest would put their life at risk.

In the first call, he said: "We have a guest drunk with drugs and alcohol. When he [them, gender not clear in conversation] is conscious, he is breaking everything in the room...

"We have a guest who is destroying everything in his room. We need someone to come."


After the line went dead, he called back and said: "We need you to send someone urgently because I don't know if the guest's life is in danger.

"They must be in a room that has a balcony. And, well, we're a little bit worried he'll do something, that he'll put his life at risk."

Payne's body was found in the hotel's inner courtyard at around 5 p.m. local time.

TMZ.com reported that witnesses stated Payne had been "acting erratic" in the lobby of the hotel, with the outlet publishing statements suggesting the singer had smashed his laptop and had to be taken back to his room.

'Warriors' album features Lauryn Hill, Shenseea, Busta Rhymes



The perilous journey home — it's a tale as old as The Iliad. Now it's a dynamic concept album starring hip-hop legends, Broadway belters and, of all things, the New York subway system.

Warriors, built on the 1979 cult classic movie, is an inventive song cycle by Hamilton mastermind Lin-Manuel Miranda and Pulitzer finalist Eisa Davis, an album that has deployed musical talent brilliantly to tell another story of going home, at the intersection of musical theatre

and popular music.

The movie – born from a book by Sol Yurick – follows the street gang the Warriors as they make their way from The Bronx to their home turf of Coney Island in Brooklyn while being hunted by rivals gangs and cops. The subway is almost a character, the main mode of transport, acting as the city's artery.

Miranda and Davis have kept the bones of the story but made strategic changes in genders, like making the Warriors all women, played by theatre vets Kenita Miller, Sasha Hutchings, Phillipa Soo, Aneesa Folds, Amber Gray, Gizel Jiménez, Jasmine Cephas Jones and Julia Harriman. They all give it an extra buzz, beautifully emotional in just a few words.

Surrounding them is an astonishing list of artistes playing various parts — Lauryn Hill, Nas, Busta Rhymes, Billy Porter, Ghostface Killah, RZA, Marc Anthony, Colman Domingo, Cam'ron, Shenseea and Joshua Henry, among them. In some inspired casting, James Remar and David Patrick Kelly — both veterans of the movie — are recast here as cops.

"This is the sound of something being born," Chris Rivers thrillingly raps at the top of the album and he has the honour of representing The Bronx. Don't you want to hear Nas repping Queens and Busta Rhymes as Brooklyn? The album is worth streaming alone just for that. Or for the chance to hear Hill sing "Can you dig it?" Miranda and Davis offer a musical journey along


with their narrative one – the sounds of salsa, ska, agro-rock, boy band, pop, old-school rap and even K-pop. Spanish and Korean mixes with the English. It's a diverse buffet, reflecting New York.

Some of the 26 tracks are fragments, some hushed, others fully formed and some hysterical, as with We Got You, a seductive love song delivered by a male gang wearing cardigans. Quiet Girls – featuring a fierce Porter – is a feminist anthem and A Light or Somethin' is a gorgeous love song for our times. The three part finale is a gloriously messy, eight-minute ride through a eulogy, a struggle and then grace.

Warriors is a portrait of a mean, tough city with determined residents bound together by frustration with their transit system. "Takin' a train to a boat to another train?!" the gangs sing in unison and astonishment on I Survive the Night, an electric opening number that's a theatrical setting of the table.

Trains rattle, doors close —we even hear underground announcements from Bernie Wagenblast, who voices the city's real subway system — across a rich soundscape that includes the rattling of spray paint cans and the crackling of fire. It shares with Miranda's previous stage works — In the Heights and Hamilton — an unabashed love of New York (There's even mentions of hot dog joint Gray's Papaya). The creators have said they have no plans for a stage version and you can hear why: It's all on the album already.

Another certification for Omi, as 'Hula Hoop' is certified silver in the UK



Hula Hoop, the second single issued from Omi's gold-selling debut album Me 4 U, has reached a new milestone.

On Friday, October 11, the song became his second silver-certified single in the United Kingdom by the British Phonographic Industry, after it exceeded 200,000 units in sales and streaming figures.

"Hula Hoop was a collaborative effort between myself and the record label (Ultra Music) at the time. So big up to Jenson Vaughan, he's the producer," Omi told Observer Online on Saturday in an interview. He added, "Hula Hoop is kind of similar in texture, a similar vibe to Cheerleader. It's identifiable. Once you hear the vocals, you know that its Omi."

Hula Hoop was a commercial success in Europe. Even though it didn't chart in the United States, it made the top 10 on major charts in Austria, Belgium, Denmark, Germany, Hungary, Slovakia, South Africa, Spain and Sweden.

In the United Kingdom, Hula Hoop raced to #75.

The song has been certified multiple times including 2x platinum in Sweden and Canada, platinum in Australia and Denmark, and gold in Italy, Germany, Mexico and New Zealand.

Omi's previous silver certification was for the collaboration I Found a Girl which features British boy band The Vamps. That song peaked at #30 in the UK in 2016.

Jamaicans in US pulling out the stops for a Harris victory over Trump



While admitting to some nervousness about the tightness of the presidential race, Jamaicans in the United States are going all out to help Democratic candidate and Vice-President Kamala Harris across the finish line ahead of Republican Donald Trump

Many Jamaicans are travelling outside their home state to campaign for Harris in the so-called battleground states where Americans say the election is historically won. These include Pennsylvania, Michigan, Wisconsin, Georgia, Arizona, North Carolina, and Nevada.

Roy Davidson, head of the Caribbean American Cricket Club of Los Angeles and former head of the National Association of Jamaican and Supportive Organizations, said many people from within the Jamaican and Caribbean communities in California "have been deployed in the states of Georgia and North Carolina to help the Harris campaign".

Jamaicans have also left from New York and other states to assist the campaign elsewhere. Most notably Pennsylvania, considered as the most crucial state, where get out the vote, knocking on doors, and raising money for Harris have been the main activities.

Stafford Grant, a Pennsylvania-based former member of the Jamaica Defence Force said, "I have no qualms she is going to win. We have the numbers and the votes, the important thing now is for us to execute our ground game with the use of technology to help her achieve victory."

Grant is among a number of Jamaicans and Caribbean nationals who formed Caribbean American United in Support of Harris, who is of Jamaican heritage, soon after she became the presumptive Democratic nominee for president in July this year

He said that although it was a tough race in Pennsylvania, "the contest here is very close, but with the level of the ground work that is being undertaken, there is a strong feeling she will prevail".
"There is even evidence that some Republi-

"There is even evidence that some Republican-leaning voters are leaning towards and have already voted for her, as early voting has started in the state," he said. "The enthusiasm remains high and I am confident that the vice-president is going to win, though I do acknowledge that it is real tight, and is getting tougher.

"However, we [Jamaicans] are pulling out all the stops. The emphasis now is getting out the votes and we are working hard in this regard," said Grant.

Joan Edghill who hosts a weekly programme on CRR FM radio in Florida said that while she "is a little nervous, the enthusiasm among Democrats seems to be even higher now as we get closer to the November 5 election".

She said other Jamaicans and herself "have been encouraging large scale mail-in and early voting and are using technology to reach people to get to the polls. A lot of emphasis is also being placed on younger first-time voters to help them understand what is at stake".

Edghill noted, too, that some among the Jamaican community are showing a preference for Donald Trump, but that even then the enthusiasm towards this election and for getting the vice-president elected "is more than has been shown in the recent past".

A handful of Jamaicans who the Jamaica Observer identified as Republicans declined to comment.

In Florida, retired real estate broker Juliet Mattadeen is among those who remain optimistic that Harris will win, saying, "She is working hard and I think her policies are resonating with the voters."

Former officer with the Department of Correctional Services (DCS) Clarence Brown said he believes Harris has performed and continues to perform well and thinks that she can win.

He worries, though, that she is being affected by too much sexism, classism, and even racism, a concern he had expressed shortly before she was formally nominated as the Democratic Party's standard-bearer.

Covington resident and former educator Hyacinth Davis said she continues to see a high level of support for Vice-President Harris within the African and other ethnic communities here. "There is also an increase intensity in early voting and an engagement at all levels; such as on the streets and in grocery stores," she added.

While acknowledging that there were some unfavourable issues facing the vice-president, such as less than full support among black males, Davis said she still remains confident of a Harris victory.

Retired Adjunct Professor Raymond Rhoden told the Observer that while he is "cautiously nervous", he thinks Harris will defeat Trump. "She has shown that she is capable of leading the country and I think she has put forward a series of policy initiatives that will benefit all Americans," he argued.

Sadie Campbell, the long-standing president of the Jamaica Progressive League (JPL), is among those who are cautiously optimistic of a win by Harris, though she, too, has expressed some level of nervousness, causing her to not "watch the TV news and the polls too much".

Patrick Williams who heads the Jamaica Awareness Association of California noted that "there is a strong possibility she will pull [it] off as hope remains strong amid a strong level of enthusiasm".

He said the Jamaican and Caribbean communities on the West Coast are very active. Two New York-based Jamaican residents — former Jamaica Constabulary Force member Dwight P Bailey and a secretary, Carlene McIntosh — have both expressed confidence that Harris will prevail in the election.

New Indonesia President Subianto swears in 109-member Cabinet

Newly inaugurated President Prabowo Subianto swore in Indonesia's largest Cabinet since 1966 on Monday, with 109 members representing his pledge for a strong government.

He announced the lineup late Sunday and named his Cabinet of ministers, vice ministers and head of national agencies the "Red and White Cabinet," referring to the colours of Indonesia's flag.

Subianto became the eighth president of Southeast Asia's largest economy on Sunday.

The Cabinet of Subianto's predecessor, Joko Widodo, had 34 ministers and head of government agencies.

Subianto's Cabinet is the largest since 1966 when Indonesia's first President Sukarno formed a lineup of 132 ministers in an extremely tense political situation after a failed 1965 coup. The so-called Dwikora Cabinet 2 was dismissed a month later.

Subianto has said earlier that he needs a strong administration, even though analysts said that his "fat" Cabinet would bloat the bureaucracy.

"I want to create a strong government that would unite

our multicultural society and diverse political interests," Subianto said before inviting more than 100 people for interviews at his residence last week. "It must be a big coalition, and some will say my Cabinet is fat."

The Cabinet features politicians from a coalition of seven parties who supported his victory in the February election, and figures allied with Widodo's Cabinet, who were reappointed to continue their jobs under Subianto's presidency. Analysts said the move was a political reward to Widodo for the latter's tacit support in the election.

Subianto was sworn in with his new vice president, 37-year-old Surakarta ex-Mayor Gibran Rakabuming Raka. He chose Raka, who is Widodo's son, as his running mate, with Widodo favoring Subianto over the candidate of his own former party. The former rivals became tacit allies, even though Indonesian presidents don't typically endorse candidates.

Subianto was a longtime rival of the Widodo, who ran against him for the presidency twice and refused to accept his defeat on both occasions, in 2014 and 2019.

But Widodo appointed Subianto as defense chief after his

reelection, paving the way for an alliance despite their rival political parties. During the campaign, Subianto ran as the popular outgoing president's heir, vowing to continue signature policies like the construction of a multibillion-dollar new capital city and limits on exporting raw materials intended to boost domestic industry.

Backed by Widodo, Subianto swept to a landslide victory in February's direct presidential election on promises of policy continuity.

Subianto reappointed nearly half of Widodo's Cabinet members, including Finance Minister Sri Mulyani Indrawati, making her the first person to hold the ministry under three different presidents.

Indrawati, 62, who has served as the executive director of the International Monetary Fund and managing director of the World Bank, is one of Indonesia's longest-serving finance ministers, having held the post for long stretches under Presidents Susilo Bambang Yudhoyono and Joko Widodo.

She has earned considerable respect in international circles, particularly for her reforms of the chaotic Indonesian taxation system and her role in steering Indonesia through the global financial crisis and the COVID-19 pandemic.

"We regularly consulted with each other to discuss strategies for strengthening the Finance Ministry and the state finances to support his programs," Indrawati told reporters after meeting with Subianto last week.

Other ministers from Widodo's Cabinet include Interior Minister Tito Karnavian, Trade Minister Zulkifli Hasan, Energy Minister Bahlil Lahadalia and State-Owned Enterprises Minister Erick Thohir.

Subianto has announced an ambitious goal of increasing annual economic growth to 8 per cent by the end of his five-year term, and embarking on an ambitious spending program, including an increase in defense spending, hikes in civil servants' salaries, and a program to give 83 million children free meals.

Coleby-Davis files criminal libel complaint against woman over Facebook claims



Minister of Energy and Transport JoBeth Coleby-Davis has filed a complaint with police accusing a wom-

an of criminal libel over comments she made about the Elizabeth MP on Facebook.

Coleby-Davis told The Nassau Guardian that she has also instructed her attorney to file a civil suit against the woman.

In a letter sent to Commissioner of Police Clayton Fernander this week, Coleby-Davis wrote that the allegations posted on social media are an attempt to smear her public image. She asked for police action to be taken against the Facebook user.

The individual runs a Facebook page where she streams video content. In a video posted to Facebook, the woman made several allegations against Coleby-Davis and others.

Coleby-Davis' attorney, Owen Wells of McKinney, Turner & Co, also wrote to Fernander requesting action against the woman on his client's behalf.

"We write to formally request an investigation into and the commencement of criminal libel charges pursuant to the Penal Code against [the woman] for the malicious publication of defamatory statements concerning our client on social media," Wells wrote in a letter dated October 15, 2024.

"We trust the necessary action will be taken to ensure that the individual is held accountable under the laws of the Commonwealth of The Bahamas."

In 2021, a private investigator was arrested and charged with criminal libel over messages he allegedly shared on social media making serious allegations about Prime Minister Philip Brave Davis, who was leader of the Official Opposition at the time.

However, that case was dismissed in August 2021 for want of prosecution after Davis failed to show up to court for a second time.

According to the Penal Code, a person convicted of intentional libel is liable to two years behind bars.



New Zealand win Women's T20 World Cup for first time

New Zealand won the Women's T20 World Cup for the first time, beating South Africa by 32 runs on Sunday after a standout performance from Amelia Kerr with bat and ball.

South Africa's chase was held to 126-9 in 20 overs at the Dubai International Cricket Stadium in reply to New Zealand's 158-5 in the final of the 18-day tournament.

The White Ferns added to their one-day title at the 2000 Cricket World Cup and became the first New Zealand team to win a T20 World Cup, with the men's team – the Black Caps – yet to achieve this feat

South Africa were also seeking to become a first-time T20 champions. It was a second successive heartbreak for South Africa, after they had lost the 2023 final on home soil to six-time champions Australia

After South Africa captain Laura Wolvaardt won the toss on Sunday and opted to bowl, Kerr top scored for New Zealand with a 38-ball 43. Brooke Halliday hit 38 runs in 28 deliveries and opener Suzie Bates scored 32 in 31. Nonkululeko Mlaba took 2-31 in four overs for South Africa.

South Africa made a strong start to its chase, reaching 51-1 in 6.5 overs but never really threatened afterwards, reaching the halfway stage of their innings at 64-3.

Wolvaardt top scored for South Africa with a 27-ball

33.

Kerr took 3-24 in her four overs, including Wolvaardt's wicket.

Kerr was named player of the match and also player of the tournament, finishing with a record 15 wickets in six games.

"I am a little bit speechless and so stoked to get the win, considering what this team has been through. It's what dreams are made of," the all-rounder said. "The wicket was pretty good and I thought 140-plus would get us in the game. It was an outstanding contribution from everyone to finish the job."

Both teams fielded an unchanged side from their semifinal wins where South Africa stunned defending champions Australia in the first semi by eight wickets on Thursday, while New Zealand beat West Indies in the second semifinal by eight runs on Friday.

New Zealand had previously finished runners-up, losing to England in 2009 and Australia in 2010.

The White Ferns were on a losing 10-match run prior to this World Cup, but showed a brilliant turn of form to reach the final for the first time in 14 years, with only one league stage loss through the tournament.

Power-packed batting

New Zealand rode on a power-packed batting performance. Despite losing Georgia Plimmer for nine runs, Bates and Kerr played attacking cricket to defy the Proteas bowling. New Zealand scored 43-1 in the power play.

Bates hit three fours and Kerr struck four boundaries as they put on 37 off 35 balls for the second wicket. Mlaba provided the breakthrough, bowling Bates in the eighth over with the score just past 50. Nadine de Klerk further pegged New Zealand back by trapping skipper Sophie Devine leg before wicket for six. Kerr, however, kept the momentum going with her highest individual score of the tournament as the 100 came up in the 15th over.

Halliday then stepped on the accelerator, smacking three fours, while Maddy Green (12 not out in six balls) also hit her team's only six as New Zealand finished with a par-plus score.

Runs dry up

In reply, Wolvaardt started well – she hit five fours – and put on 51 off 41 balls with Tazmin Brits for the first wicket.

South Africa's chase seemed to be on track when Fran Jonas (1-28) got the first breakthrough as Brits was caught at long on for 17.

The runs dried up immediately as South Africa scored eight off the next 14 balls and the pressure told. Wolvaardt tried to hit a boundary off Kerr's first ball and was out caught at mid-off instead, sparking huge celebrations in the Kiwi camp.

South Africa lost regular wickets afterwards. Kerr also sent back big-hitting Anneke Bosch for nine runs.

Marizanne Kapp was out caught for eight, as New Zealand didn't miss anything in the field. The middle order didn't come through for South Africa at all, reduced to 97-6 in 15.1 overs.

Rosemary Mair picked up 3-25 in her four overs, while Eden Carson finished off proceedings with the last over to crown the tournament's new champions

"I let myself dream last night about what it would be like to hold the trophy. It is hard to put in words what it means to this group of players, including myself, and for New Zealand cricket as well," Devine said. "The great thing about this group is we have known what we have been trying to achieve for the past 18 months.

"Results didn't go our way but we knew we were building in the right direction."

Mason Greenwood to speak with England boss before making Reggae Boyz switch— reports



Mason Greenwood starts process to switch allegiance to Jamaica

Mason Greenwood plans to speak to England head coach Thomas Tuchel to ascertain his chances of

being a part of the national team, before making a decision about switching his allegiance to Jamaica, according to media reports.

The Sun reported that while Tuchel will not take over the England team until January 1, Greenwood is hoping that a change of bosses could see him representing the team on a senior level.

However, according to reports, if this is not possible, the Olympique Marseille star plans to accept Reggae Boyz coach Steve McClaren's invitation to play for Jamaica.

It was reported in August that Greenwood began the process of switching allegiances to the Reggae Boyz; however, it was not confirmed that this was completed.

According to The Sun, the 22-year-old's international future has been in limbo following the attempt-

ed rape, assault and coercive behaviour charges he faced in January 2022. The charges have since been dropped.

The Sun reported that a source told them that Mason is aware of his chances of playing for England but his hope is to play in the World Cup.

"Mason knows his chances of playing for England again are very slim. But he wants to check with the FA and Tuchel now he has been appointed, to see what they think. He is determined to play at the highest level and that means the World Cup. So if England don't want him, he'll switch to Jamaica and try and get to the 2026 World Cup that way," the source reportedly told SunSport.

Greenwood qualifies to play for the Reggae Boyz through his Jamaican-born father.

Jamaica last qualified for the World Cup in 1998.

Coach Glen Mills calls for strong intervention after Paris letdown



Boxing is set to return to The Bahamas. The "Courtyard Brawl" featuring some of the top young up-and-coming boxers in the country going up against each other, is set for Friday, November 22 at Fusion Superplex.

After witnessing a less-than-expected medal haul at the Paris Olympics in the summer, Racers Track Club Head Coach Glen Mills believes track and field in Jamaica could decline significantly if the Jamaica Athletics Administrative Association (JAAA) does not improve how it governs the sport.

The island took home six medals during the games in the French capital with four coming from field events. It was Jamaica's lowest medal tally since the 2004 Athens Games and the first time since the 2000 Sydney Olympics in which no Jamaican finished with a gold medal in the sprints.

Mills, who guided the career of sprint legend Usain Bolt, says he wasn't surprised by many of the outcomes and says the JAAA needs to act quickly.

"We have to pay attention to what happened in Paris and what happened in the recent World [Under 20] because they are showing the cracks and symptoms that exist that need urgent attention if we do not intend to fall into the quagmire that West Indies cricket has gotten itself into," he said at a UWI-led symposium.

"I remember, as a youngster when I used to listen to cricket, it was as if West Indies was unbeatable in any form of the sport and they had a tremendously long reign but I don't think any attention was being paid to the weaknesses of what was needed for the continuity to perform at a high level," he added.

Mills, now, is concerned that a comprehensive review hasn't been done by the JAAA.

"I have not heard any attempt to have a commission of inquiry, or whatever you want to call it, into what were the problems and the causes of such a dramatic drop in our medal earnings. The standard that we have been able to maintain for several decades means this sudden drop requires attention," he said

"If we listen to Stephen Francis, myself and a number of players in the game, we have been pointing out and crying out for things to be attended to, but it has been falling on deaf ears. Especially a couple of interviews I've listened [to] with Stephen Francis, a number of things he pointed out years ago is now beginning to affect us significantly."

Mills says the leadership of the JAAA doesn't seem

to value the opinions of those involved in the sport. "I can't recall us being summoned to any kind of forum where all the top coaches of the clubs are involved in a frank and clear discussion with the administration. Most of it has been through interviews and informal talks and discussions, so we find very little attention has been given to the points raised, so we continue to have the divide between what we think is in the best interest of the sport and the athletes, as against what the association thinks"

Mills says the coaches and leaders of the track clubs locally must have a greater say in the track and field programme.

"There needs to be a greater interworking relationship or connectivity between the coaches, the club administrators who are the persons on the ground involved in working with the athletes and whatever campaign or programme to earn additional medals or increased performance; they have to be a major part in whatever planning and programme that is going to be developed.

"Too often, the executives of these associations do not involve the membership in their day-to-day work and planning. Yes, they're the executive body and must lead but you cannot have that disconnect because you will not have the kind of cooperation and unity of purpose that is necessary for success." He also believes the JAAA needs a drastic overhaul with the growth of the athletics globally," he said.
