2025 Long Lunch Major Raffle & Auction

1. General Terms & Conditions

- 1.1. Promoted by The Women's College within The University of Queensland (College Road, St Lucia, QLD 4067). Referred to in this document as The Women's College.
- 1.2. Funds raised from the 2025 Long Lunch Major Raffle & Auction will go to the Alumnae Awards Fund to support the Alumnae Awards Scholarship and the Mary Wooza Scholarship.
- 1.3. Residents/Associates and staff of The Women's College are eligible to enter.
- 1.4. Online sales for raffle tickets and auction bids open at 11:30am on Monday 7 July 2025 and close at 1:00pm on Thursday 21 August 2025.
- 1.5. In person sales for raffle tickets will close at 3:30pm on Saturday 23 August 2025. Auction bids can be made onsite at The Women's College until 4:00pm on Saturday 23 August 2025.
- 1.6. To enter the major raffle and/or auction, you must purchase at least one (1) raffle ticket or make one (1) bid online or in person.
- 1.7. One winner for each prize in the major raffle and auction will be drawn and/or announced at the Long Lunch (the event) on Saturday 23 August 2025. You do not need to attend the Long Lunch to enter the major raffle or auction.
- 1.8. Winners not in attendance at the event will be notified via email from The Women's College.
- 1.9. Collection of prizes:
 - a) If a winner attends the event when the prize is drawn and/or announced, they will collect their prize in person.
 - b) If a winner is not in attendance at the event, the prize will need to be collected from The Women's College. This is at the discretion of The Women's College.
- 1.10. Additional Terms & Conditions related to each prize may apply and are provided by the donor/business; please refer to the prize details for further information.
- 1.11. By purchasing a raffle ticket and/or making an auction bid, you agree to be bound by these Terms & Conditions, as well as the conditions and compliance with Queensland Law. Your details, entered in the Humanitix platform or provided in person, will be saved and retained by The Women's College. Your details will include (but not be limited to) your first name and surname, email address, mobile number, and postal address.
- 1.12. Entries which, in the opinion of The Women's College, are incomplete, incorrect or incomprehensible, and/or contain defamatory or offensive content are not eligible to win and may be removed from the promotion and the relevant entrant will be disqualified.
- 1.13. The Women's College may, in its absolute discretion, disqualify you if, in the opinion of The Women's College, you breach these Terms & Conditions, engage in dishonest or unethical conduct in relation to the promotion, manipulate, tamper or interfere with the conduct of the promotion, do not comply with the entry process, or conspire with others to gain an unfair advantage. The Women's College may investigate the matter if it suspects you of having engaged in such breach or conduct.
- 1.14. To the extent permitted by law, The Women's College is not liable for any loss, damage or injury whatsoever (including, but not limited to, indirect or consequential loss) resulting from this Major Raffle & Auction, including the taking of prizes.
- 1.15. If, for any reason, the Long Lunch event and/or Major Raffle & Auction is not capable of running as planned, including war, terrorism, state of emergency or disaster, infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures, or any other causes beyond the control of The Women's College which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Major Raffle & Auction, The Women's College reserves the right in its sole discretion to cancel, terminate, modify or suspend the Major Raffle & Auction.

2. Major Raffle Terms & Conditions

- 2.1 The major raffle ticket costs are one (1) ticket for \$20; three (3) tickets for \$50; and six (6) tickets for \$100. These costs apply to online and in-person sales. Online raffle ticket sales are conducted through our third-party supplier, 'Humanitix'. Online sales will incur an additional transaction fee that is charged by Humanitix. This transaction fee is donated to a charity at the discretion of Humanitix.
- 2.3 The Major Raffle prizes are as follows. All values are correct as at when the major raffle commenced. Values have been provided by the donor of each prize.
 - a) First prize: "A three-night luxury stay in an Ocean Superior Room at Halcyon House" valued at \$5,000. This prize includes accommodation in an Ocean Superior Room; daily breakfast and lunch; 3 three-course dinners at Paper Daisy; and one 60-minute spa treatment for two. The prize will also include a Welcome Drink on arrival, complimentary bike hire and use of surfboards, complimentary non-alcoholic mini bar, access to the onsite steam room, turn down service and pillow menu.
 - b) Second prize: "A \$2,000 Carla Zampatti gift card" valued at \$2,000.
 - c) Third prize: "A \$1,000 Zoe Kratzmann gift voucher" valued at \$1,000.
 - d) Fourth prize: "A \$500 MECCA gift card" valued at \$500.
 - e) Fifth prize: "A \$250 Soak Bathhouse gift voucher" valued at \$250.
 - f) Sixth prize: "A Louenhide gift pack including the Alexis Stripe Weekender Travel Bag in blush, Maggie Cosmetic Case, and Baby Simpson Tote Bag in fuchsia" valued at \$250.
 - g) Seventh prize: "A Louenhide gift pack including the Boston Tan Weekender Bag, Joey Sling Bag in tan, and Baby Simpson Tote Bag in taupe." valued at \$240.
 - h) Eighth prize: "A GirlsTrek gift voucher" valued at \$200.
 - i) Ninth prize: "A Gip's Restaurant, Toowoomba gift voucher" valued at \$200.
 - j) Tenth prize: "A Halcyon Wellness spa voucher" valued at \$150.

3. Auction Terms & Conditions

- 3.1. This is an open auction, and all bids received for each prize will be shared at the Long Lunch. Bids will not be communicated any earlier to participants in any alternative way or form.
- 3.2. Participants are allowed to make multiple bids for individual auction prizes online through Humanitix. If a participant makes multiple bids, The Women's College will accept the highest bid.
- 3.3. The highest bid at the close of the auction will secure the prize. If the highest bid has been made by two or more individuals, the following process will be actioned:
 - a) For bids received online, all individuals who have made the highest bid will be contacted by phone for their next highest bid. Contact will be made on Friday 22 August. The Women's College will make best efforts to contact the individual via the phone number provided by the individual (see clause 1.11 of these Terms & Conditions).
 - b) For bids received in person, all individuals who have made the highest bid on the day of the event (Saturday 23 August) will be asked to provide their next highest bid.
 - c) The Women's College will then determine the highest bid received for the prize.
- 3.4. The Women's College's decision on disputes is final.
- 3.5. The winner of the winning bid must pay for their prize (donation) within five business days of being notified of their successful bid. No refunds will be made available.
- 2.4 The Auction prizes and their reserve prices are as follows:
 - a) "A Glass Ladder leadership course" valued at \$6,000 – reserve price is \$2,000
 - b) "A one-on-one session with Chris Gray, one of Australia's leading independent property experts" valued at \$2,000 – reserve price is \$850.
 - c) "An accommodation voucher for a weekend getaway at Water & Woods, Springbrook" valued at \$1,100 – reserve price is \$800.
 - d) "Receive \$500 off a purchase from Electric Bikes Brisbane" valued at \$500 – reserve price is \$300.
 - e) "Six bottles of Moët & Chandon Impérial Brut champagne (standard size, 750 ml each)" valued at \$500 – reserve price is \$420.
 - f) "A BIODROGA Indulgence Facial at Will And Peta Skin Clinic (located in Sydney)" valued at \$200 – reserve price is \$180.
 - g) "A Running Bare 'Into The Aster' gift pack" valued at \$200 – reserve price is \$180.
 - h) "A champagne and fruit hamper" valued at \$200 – reserve price is \$180. Two individual hampers are available in this auction; the two highest bids will each secure one hamper.
 - i) "A \$180 gift voucher to Patina" valued at \$180 – reserve price is \$150.
