Terms and Sales Conditions

1 Torms

Acceptance of these terms is signified and implied by the customer ordering the goods either by phone, SMS, WhatsApp, email, online or in writing. These terms and conditions of de Le Cuona Designs Ltd & de Le Cuona, Inc. both hereinafter referred to as de Le Cuona supersede any other terms.

2 Prices

Prices shown are the Retail Prices exclude VAT or Sales Taxes which will be added at the current rate applicable to the relevant Bill to and Ship To addresses at the time of despatch. All prices exclude freight, duties and other customs or carrier charges as applicable. Prices shown are per unit of measure, these are typically Yard, Metre and Each. The minimum order quantity is one accessory unit, one Yard of fabric in North America or one Metre of fabric in all other regions.

§ appended to a product name indicates that the product is due to be discontinued. Please confirm stock availability prior to order.

3. Payment terms

- 3.1 Accounts are due and payable not later than the due date defined by the payment terms stipulated on the invoice. Terms are strictly net.
- 3.2 de Le Cuona reserves the right to hold back any order pending if an account is overdue for payment.
- 3.3 Credit limits are subject to review and can be increased or decreased at de Le Cuona's discretion.
- 3.4 Credit terms can be terminated at de Le Cuona's discretion if the terms of payment are breached, or if the customer enters administration or undergoes a change of ownership.
- 3.5 de Le Cuona Sales invoices must be paid in the currency of the invoice.
- 3.6 All bank charges for payment of de Le Cuona sales invoices must be borne by the remitter.
- 3.7 The Client shall inform its customers (and potential customers) that it will monitor and record information relating to their trade performance and such records will be made available to credit reference agencies, who will share that information with other businesses in assessing applications for credit and fraud prevention.

4. Carriage and handling

The order confirmation will have the carriage charges in accordance with the quantity, weight and number of parcels and the delivery address(es). For current charges or express options, please contact our Client Liaison Team.

5. Lost or damaged in transit

Claims for non-arrival must be made within 10 days of our invoice date and confirmed in writing within 14 days.

Damaged goods or short deliveries must be signed for as such and de Le Cuona notified immediately, otherwise liability cannot be accepted for any lost or damaged goods.

6. Delivery

Any date or time mentioned in any quotation of acknowledgement of order is approximate only; no liability can be accepted in respect of any failure to deliver at any particular date or time. The Company will make all reasonable endeavours to meet any dates or times in any quotations or confirmations, but will not accept any liability for failure to meet quoted delivery dates/times. Every effort is made to ensure that all orders that are in stock are delivered within four working days

7. Title to goods

- 7.1 Title to goods remains the property of de Le Cuona until paid in full.
- 7.2 Responsibility for insurance passes to the Customer on acceptance of the delivery.
- 7.3 de Le Cuona reserves the right of immediate repossession to any goods to which it has retained title.

8. Product attributes, nuances and variance tolerances

- de Le Cuona collections embrace natural fibres with their sublime natural nuances and imperfections; therefore:-
 - 8.1 Colour fastness: Products are not guaranteed against colour fading. Whilst every effort is made to match the sampling, de Le Cuona cannot guarantee to match the shade exactly. If a match is required, always send a sample or request a stock cutting for approval (CFA).
 - 8.2 Widths are based on the full width of the fabric. Both widths and repeats are approximate and they may vary slightly with each batch. Repeats may vary as much as 3-5% +/- and this should be taken into account when calculating your requirements. For multiple width draperies woven or knitted fabric is not a completely stable substance and therefore it cannot be guaranteed that when it is printed or woven, the pattern will be 'square' on the cloth. Pattern matching width-to-width cannot be guaranteed. When planning multiple width draperies, please make certain BEFORE CUTTING that the pattern alignment will achieve the desired result.
 - 8.3 Extra Wide Fabrics: 300 330 cm or 118 130". The many advantages offered by extra-wide fabrics include: optimisation of use; versatility (they may be used in either direction); the total (or partial) elimination of seams that translates into a saving on costs when making up the finished item and a more pleasing aesthetic result when hung or upholstered, whether used for curtains, wall decoration, bedspreads or sofas. Not all extra-wide fabrics have the technical construction to support use in either direction. We recommend you check the direction required beforehand and calculate the resulting meterage needed for the project, bearing in mind the pattern direction and repeat.
 - 8.4 Fabrics used as draperies, when held against the light, cannot be guaranteed to be visibly flawless.
 - 8.5 Shrinkage: Products are not guaranteed against shrinkage. Stretching or shrinkage of up to 4% on any fabric is an accepted industry tolerance. This may be caused by atmospheric variables beyond our control. It is advisable to allow a considerable hem allowance to compensate for this.
 - 8.6 Test Results: Test results are correct at time of printing; de Le Cuona reserve the right to change these at our discretion.
 - 8.7 Care: Care instructions are correct at time of printing and we reserve the right to change these at our discretion.
- All of these factors will be taken into account when assessing individual claims. Claims or complaints should be made in person or writing.

9. Inspection before cutting or add-on treatments

- 9.1 All orders are supplied on the understanding that the goods will be carefully inspected by the Customer prior to cutting and prior to having add-on treatments applied.
- 9.2 Whilst every effort is made to ensure that the ordered goods arrive correct and in the best possible condition, errors can be made and damage may occur in transit. Please ALWAYS CHECK BEFORE CUTTING, ALTERING OR TREATING the fabric in any way to ensure you are totally satisfied that the product supplied is correct in all respects. No claims can be accepted or exchanges made once the product has been cut, altered or subjected to additional processes.
- 9.3 The Customers responsibility shall not be diminished in the case of the goods being delivered to a third party on the instructions of The Customer .

10 Cancellation

- 10.1 Where an order is placed for bespoke goods, no cancellation can be accepted.
- 10.2 All other orders, once cut and packed, will be treated as returns where cancellation or amendment is requested.

10.3 A 30% handling charge will apply for all cancelled orders. Carriage charges incurred will not be credited.

11 Returns

- 11.1 No returns can be accepted or will be credited without prior arrangement with the de Le Cuona Sales or Client Liaison Teams.
- 11.2 No returns can be accepted after 30 days from the invoice date (where returns are agreed, the goods will be credited less a 30% handling charge).
- 11.3 Unauthorised or unapproved returns will be returned to The Customer and costs charged to their account .

Accessories

- 11.4 No returns can be accepted after 30 days from the invoice date. Returned accessories will not be refunded, must either be exchanged or have a credit placed on account (if Trade customer). Retail customer goods can only be exchanged to at least the same value.
- 11.5 Bespoke, made-to-order or custom-made items and items identified as Limited Edition Collectables can be neither refunded nor exchanged
- 11.6 All accessories must be inspected immediately. Faulty goods must be returned to de Le Cuona within 7 days. Faulty accessories returned after 7 days will not be refunded.
- 11.7 Accessories, accents and furniture, identified in the price list as Limited Edition Collectable, are non-returnable.
- 11.8 Headers taken on loan should be returned in an 'as new' and resaleable condition within 7 days. Damaged or spoiled goods will be charged to the customer at the customer's normal buying price.
- 11.9 Bed linen items cannot be returned for hygiene reasons.

Fahrics

12. Liability

- 11.10 Goods must be inspected before they are cut or made up. Once the fabric is cut, altered or treated in any way it cannot "under any circumstances" be returned for credit or exchange.
- 11.11 All fabrics must be inspected immediately. Any faulty goods must be returned to us within seven days. Fabrics returned after seven days must either be replaced or have a credit placed on the customer's account (if Trade customer). Fabrics returned after seven days will not be refunded.

Our goods are supplied on the condition that our liability for any fault or defect in the quality, condition, description or suitability for any purpose is limited to an amount not exceeding the original purchase price of the particular goods.

13. Force Majeure/Delay

- 13.1 de Le Cuona shall have the right to cancel or delay delivery under the contract if it is prevented from or hindered or delayed in delivery through any circumstance beyond its reasonable control, including but not limited to:
 - Act of God, strike, lock-out, or other labour dispute, fire, flood, drought, adverse working conditions, accidents to machinery, delays enroute.
 - The effect of any statute, rule, regulation, order, directive or recommendation by any Government, Government Department or other competent authority including restrictions of export and other licenses.
 - The non-availability of suitable materials or labour or necessary power or other services.
 - 13.1.4 Any other contingency whatsoever beyond de Le Cuona's control.
- 13.2. If de Le Cuona delays an order, the Customer shall, upon prior written notice to de Le Cuona of its intention, have the right to purchase elsewhere at its own risk and cost, such quantities of goods as may be necessary to cover current requirements, and de Le Cuona shall be under no liability arising out of its failure to deliver.
- 13.3. The Customer shall pay extra charges to cover extra cost incurred by de Le Cuona in the event of:
 - The Customer or its agents failing or refusing to take immediate delivery of goods in accordance with the Contract, or delivery being abortive for any other reason not being due to the fault of de Le Cuona.
 - 13.3.2 Goods having to be stored by de Le Cuona beyond the date on which The Customer or its agents were notified of their readiness for delivery. or beyond the date when they were first tendered for delivery, whether at the request of The Customer or its agents, or by reason of lack of adequate instructions or information for the Buyer or its agents, or by reason of any other matters outside the control of de Le Cuona.
- 13.4. Where delivery of the goods has been prevented or delayed by reason of any of the matters referred to in condition 13.3, the price of the goods, or the balance due, shall become due and payable no later than 30 days following the date when the goods were first tendered for delivery or first notified to The Customer by de Le Cuona as being ready for delivery, whichever shall be the earlier.

de Le Cuona Reseller Criteria

In order to maintain the quality and image of the de Le Cuona Brand, all Buyers reselling de Le Cuona products must comply with the following criteria:-

- i Any physical premises from which de Le Cuona products are marketed must be in keeping with the quality & image of the de Le Cuona Brand, and this standard must be maintained at all times.
- ii All physical premises must have allocated sufficient space to properly display an adequate representation of the de Le Cuona sampling & marketing materials, to a high standard of presentation in keeping with the quality & image of these products.
- iii All Resellers must offer an interior design service including a make-up or upholstery service, where trained staff provide personal advice on the suitability & use of products, with a pre & post sales service to customers.
- iv All Resellers must provide the facility for home visits for the purposes of customer service & advice, pre & post-sale.
- v All Resellers must only trade from premises agreed with the Seller.
- vi All promotional materials & advertising media must be consistent with the quality & prestige of the de Le Cuona Brand & its luxury brand values.

Due to the service requirements & consumer experience standards required by de Le Cuona to maintain the quality & image of their Brand, it is not appropriate for de Le Cuona products to be sold solely using the internet. Where Resellers use the internet to promote de Le Cuona products, the Reseller must adhere to the following.

- Websites must provide equivalent service standards & consumer experience standards required to that of a Reseller showroom/studio.
- de Le Cuona will only authorise its images to be used to supplement marketing & not to create a website library of designs. Where websites display de Le Cuona's images, the Reseller must have purchased sampling representing the Goods in the images for display & use in the physical premises.
- iii Websites must display a portfolio of made up work.
- iv Website must clearly show that the Reseller provides a personal interior design service including a make -up or upholstery service, where trained staff provide personal advice on the suitability & use of products, with a pre & post sales service to customers. The Reseller must provide the facility for home visits for the purposes of customer service & advice, pre & post-sale.
- The Reseller's trading name & trading address must be clearly visible on their website and the Reseller must notify de Le Cuona of its website address.
- vi Website contents, domain names & the 'look & feel' must, in the opinion of de Le Cuona, be representative of the prestige, image & quality of the Seller's Brands & promote the products in a way consistent with these values.
- vii de Le Cuona reserves the right to cancel this agreement, if, in de Le Cuona's sole opinion, the quality of the website is deemed to be detrimentally damaging the brand or market opportunity of de Le Cuona's products or brands.
- viii No other goods must be advertised, or links provided to other goods, which, in the opinion of de Le Cuona, harm the image or prestige of de Le Cuona.
- ix The Reseller must not bid on any search engine keyword phrase containing de Le Cuona's Brand names, or any misspelling of these Brand names.
- x The Reseller must not use any of de Le Cuona's Brands in domain names or account registrations on social networking sites .
