WHAT IS PODIATRY?

PODIATRIST

Podiatrists specialise in foot, ankle and leg healthcare. They improve people's mobility, independence and quality of life. Imagine how amazing it would feel to have a career helping people to live pain-free lives.



They work in many sectors, with the majority found in the NHS and independent (private) practice. Podiatrists can be found in all kinds of places: legendry rock band Deep Purple even had a podiatrist as part of their global tour team!

Most professional sports clubs will have a team podiatrist, and elite events like Wimbledon and the Olympics rely on podiatrists as a key part of the medical team. Podiatrists are autonomous, which means they are able to assess, diagnose and treat a patient by themselves but they will also often work with teams of other clinicians, like doctors, nurses and physiotherapists to ensure the best outcomes for their patients.

WHAT MAKES PODIATRY DIFFERENT FROM OTHER HEALTH CAREERS?

Podiatry offers so many career pathways. A newly graduated podiatrist will already have the ability to carry out complex assessments, minor surgery, administer local anaesthetic and issue antibiotics. From there they can take their career wherever they wish, both at home and abroad.

There is a great amount of flexibility to the career and podiatrists will tell you its one of the best things about their job.

They can fit their working week around their family and their passions to get the right work/life balance for them. And best of all, no nightshifts! Some podiatrists will work with their patients for a short time to help their issues, while others may treat the same patients for many years and through multiple life stages.

WHAT YOU WILL EARN WHEN YOU QUALIFY?

£30-50K PER YEAR

This will increase with extra training and if you work in the private or specialist sporting sectors. Podiatrists are in high demand in the UK. Employment rates after qualifying are extremely high. All universities report:

90-100% EMPLOYMENT RATE WITHIN SIX MONTHS OF QUALIFYING.

The UK training allows you to work all over the world too, including Australia, New Zealand, Canada, Spain, Malta, the UAE, Dubai, Singapore and many more. It is important to remember that everyone's journey will vary. Podiatry has a wealth of opportunities that allows you to carve out your own path and lets you adapt your work as your life changes throughout the course of your career.

START YOUR CAREER IN PODIATRY

You've got options! Undergraduate degrees, apprenticeships and post graduate fast track routes. There are lots of ways to study, many of which come with significant funding support. Find out more about the routes on **page 6**

Getting into university is not all about exam grades - your existing skills are valued. The admissions tutors that work for each university can advise you if you are ready to start a course straight away or what access course you can take to get you there.

FUNDING

FINANCIAL ASSISTANCE FOR PODIATRY STUDENTS

The cost of attending university can hold many back from reaching their full potential. As podiatry is an essential part of the healthcare infrastructure, undergraduate podiatry students from the UK will generally receive financial assistance to study.

Funding for postgraduate qualification routes varies. Please check with your chosen university for more information. Those studying for an apprenticeship will also be funded differently. Visit our apprenticeship page, or check with your university of choice for more information.

Funding support for undergraduate podiatry degrees will vary depending on factors such as which part of the UK you study in and where you lived before to starting your degree.

STUDENT LOANS AND BURSARIES ARE AVAILABLE DEPENDING ON YOUR COUNTRY AND SITUATION. YOUR CHOSEN UNIVERSITIES CAN ADVISE YOU ON YOUR INDIVIDUAL CIRCUMSTANCES

ENGLAND

Most UK students studying in England will be eligible for the NHS Learning Support Fund (NHS LSF) which will provide eligible students with:

- £6,000 per academic year training grant
- Parental support of £2,000
 if you have at least one dependent
 child under 15 years, or under 17
 years if registered with special
 educational needs
- Practice placement support
 Money back for excess travel and temporary accommodation costs

(travel and dual accommodation expenses) while you're on your practice placement

 Students experiencing financial hardship (Exceptional Support Fund).

Where you choose to study via an apprenticeship route, additional funding towards your training is available via the government apprenticeship programmes. Find out more on our apprenticeship page.

SCOTLAND

- The Student Award Agency for Scotland (SAAS) will provide you with information relevant to your personal circumstances
- Tuition fees are usually free for Scottish residents studying at a Scottish University
- Additional bursaries are also available depending on your age and personal circumstances.

NORTHERN IRELAND

Funding for students studying healthcare courses differs from the arrangements for other courses in Northern Ireland. Funding to cover tuition fees is available in many cases, as are bursaries and special loans.

Universities look at your academic and work history as well as your transferable skills when applying for their courses. WHERE TO STUDY AND HOW

Studying podiatry has never been more accessible. The traditional undergraduate degree has now been complemented with a fast-track Masters programme, building on skills from previous qualifications; and the increasingly popular study programmes allowing you to earn a salary while you learn with the degree apprenticeship in England and the PREPARE study programme in Scotland. All of these routes will get you to the same destination, a pre-registration qualification in podiatry. From there you can apply for registration with the regulator, the Health and Care Professions Council (HCPC) and within weeks of your graduation, saving limbs and lives as a podiatrist at one of the many independent practices or NHS departments across the UK.

UNDERGRADUATE DEGREE

QUALIFY AS A PODIATRIST

One of the ways to qualify as a podiatrist in the UK is by completing an HCPC - approved undergraduate degree, typically lasting three to four years. These courses provide the essential knowledge and practical skills needed for the profession. You can find a list of universities offering accredited courses throughout this quide.

FRAN CAMPBELL

Fran Campbell, Lead in Podiatry and Biomechanics at Accelerate CIC, advises: "Embrace opportunities to shadow others and work in interdisciplinary teams, and be confident in your skills and value." Graduating from UEL in 2009, Fran's career began in an NHS Band 5 role where she gained MSK experience. She progressed to Band 6 and following mentoring then progressed to Band 7, overseeing MSK and Podopaediatric services. Her MSc in Clinical Biomechanics and experience in private practice enhanced her gait analysis skills. Fran now treats NHS patients with chronic conditions at Accelerate CIC

DANIEL BROADLEY

Daniel began his career as a locum before securing a Band 6 position, where he provided a wide range of services including MSK, diabetes, nail surgeries, and routine care. His interest in MSK led him to focus on this area, developing skills in biomechanical clinics and eventually transitioning to a hybrid role as both a staff and MSK podiatrist.

In his staff podiatrist role, Daniel handles initial surgical assessments, post-operative care, and assists in theatre. His MSK role involves advanced techniques like mobilization, acupuncture, and ultrasound-guided injections.

1 Research and choose a university

3 Meet the entry requirements

Universities have varying entry requirements, often needing A-levels or equivalent qualifications in subjects like biology and chemistry. Some may accept alternative qualifications or relevant experience.

4 Apply through UCAS

Identify your preferred universities and courses, then apply via the Universities and Colleges Admissions Service (UCAS). Ensure you meet application deadlines and submit all required documents, including personal statements and reference letters.

5 Start your course Once accepted, begin your studies, covering subjects like anatomy, physiology, biomechanics, pharmacology, and clinical skills. Gain practical experience through clinical placements where you

assess and treat patients under supervision.

Clinical placements and practical experience

These are critical for applying your theoretical knowledge in real-world settings.

HCPC registration

After completing your degree, register with the Health and Care Professions Council (HCPC) to practice as a podiatrist in the UK. This ensures you meet professional standards and codes of conduct.

Continuous professional development (CPD)

Stay updated with advancements in research, technology, and clinical practices through CPD activities such as courses, webinars, and conferences.

DEGREE APPRENTICESHIP

EQUIVALENT TO A FULL-TIME DEGREE

The Podiatry Degree Apprenticeship is the sole apprenticeship pathway in podiatry, offering a comprehensive and practical route into the profession. This apprenticeship, equivalent to a full-time degree, spans three years or can be extended to four and a half years part-time. One of the main benefits is the "earn while you learn" structure, where you:

SPEND 40% OF YOUR TIME WORKING AND 60% STUDYING AT A UNIVERSITY, WITH NO TUITION FEES AS THEY ARE COVERED BY YOUR EMPLOYER AND THE GOVERNMENT

ADDITIONALLY, YOU GAIN VALUABLE CLINICAL EXPERIENCE, WORK WITH DIVERSE PATIENTS, AND ENJOY A UNIVERSITY EXPERIENCE.

ENTRY REQUIREMENTS AND QUALIFICATIONS

To embark on a podiatry apprenticeship, you'll generally need three good A-Levels and GCSEs in Maths and English, with equivalent qualifications accepted in Scotland, Wales, and Northern Ireland.

Upon completion, you will earn a BSc degree in Podiatry. Making you eligible to apply for registration with the Health and Care Professions Council (HCPC), the regulatory body for the profession.

APPLICATION PROCESS

ADDITIONAL INFORMATION

To apply for a podiatry apprenticeship, you must first secure employment with an organisation willing to sponsor your apprenticeship, typically within the NHS or private podiatry practices. Universities offering this apprenticeship include the:

- UNIVERSITY OF BRIGHTON UNIVERSITY OF EAST LONDON UNIVERSITY OF HUDDERSFIELD

Many more are expected to join. For more information and current vacancies, visit the government's national apprenticeship website or the RCPod's jobs board. Remember, as a paid employee, you won't qualify for a student loan, so budgeting your salary is essential.

PHOEBE EDWARDS

A third-year apprentice with the South Bedfordshire Community Podiatry Service at East London NHS Foundation Trust. Phoebe works across clinics in Luton, Houghton Regis, Leighton Buzzard, and the Luton and Dunstable Hospital, as well as on home visits for wound care.

Her role includes providing foot care, supporting the team, managing her own clinics under supervision, and organising Diabetic Foot Training for other healthcare professionals. Phoebe chose an apprenticeship in podiatry after discovering the field through her work with a community diabetes service, finding it rewarding and impactful.

Her advice for future apprentices includes effective time management, asking questions, and maintaining enthusiasm.

POSTGRADUATE PRE-REGISTRATION

For individuals who already hold a degree and are interested in pursuing a career in podiatry, a Masters-level course offers a streamlined and intensive path into the profession. This route is particularly suited to those who have a background in a related field, such as health sciences, biology, or sports science, although graduates from other disciplines are also welcome.

COURSE DURATION AND STRUCTURE

This Masters course typically spans approximately two years, combining both theoretical and practical components to provide comprehensive training in podiatry.

The curriculum is designed to cover key areas such as lower limb anatomy, biomechanics, clinical skills, and the diagnosis and management of foot and lower limb conditions.

The program includes clinical placements, allowing students to gain hands-on experience in real healthcare settings under the supervision of experienced podiatrists.

UNIVERSITIES OFFERING THE COURSE

Currently, four universities in the UK offer this specialised Masters in Podiatry:

- HEALTH SCIENCES UNIVERSITY, BOURNEMOUTH
- UNIVERSITY OF BRIGHTON
- UNIVERSITY OF GALWAY
- UNIVERSITY OF PLYMOUTH
- QUEEN MARGARET UNIVERSITY, EDINBURGH
- UNIVERSITY OF SALFORD

SUPPORT WORKFORCE

WHAT IS A PODIATRY SUPPORT WORKER?

Podiatry support workers are healthcare professionals who assist podiatrists in providing care for patients with foot and lower limb issues. While they are not fully qualified podiatrists and typically lack a BSc in podiatry and HCPC registration, they play a vital role in ensuring the smooth operation of podiatry services.

RESPONSIBILITIES AS A SUPPORT WORKER

- Administrative tasks, such as scheduling appointments and maintaining patient records
- Clinical duties like preparing patients for treatment, sterilising equipment, and assisting during procedures
- Some types of support workers will be able to work without supervision.

WHERE DO PODIATRY SUPPORT WORKERS WORK?



Podiatry support workers are found in various healthcare settings, predominantly within the NHS or in independent practices.

They may be referred to by different titles, such as Podiatry Assistants or Foot Care Assistants. Additionally, Foot Health Practitioners, who have similar training levels and are likewise unregulated by the HCPC, are part of this support workforce.

They can be employed in both the NHS and the private sector.

HOW CAN SUPPORT WORKERS BECOME QUALIFIED PODIATRISTS?

Support workers aspiring to become qualified podiatrists have several pathways available.

- They can pursue a podiatry degree apprenticeship in England while continuing their work
- They can also consult with podiatry schools to determine if their current training can be credited towards a degree programme, potentially
- reducing the time needed to qualify
- If they already hold a degree in another subject, they can enrol in a pre-registration Masters programe, which allows them to become qualified podiatrists after two years of full-time study.

ADMISSION TIPS

- Find the nearest podiatry school to where you are by visiting https://rcpod.org.uk/careers/podiatry-schools. Get in touch with their admissions team to find out if they open their podiatry clinic to the public. Some universities may allow for work experience before starting your studies. If you can't get work experience in podiatry, other health disciplines are useful and often transferrable
- Contact the admissions tutors
 The admissions criteria will often have some built in flexibility.
 Get in touch with them to discuss your life story and your experience so far it may help

- Be mindful of the overall health landscape when preparing for interviews; for example, understand the 6 Cs in health and social care
- Find out if your local podiatry school offers the chance for you to shadow existing podiatry students or take part in a day of shadowing in the on-site podiatry clinic
- School leavers and undergraduate degree attend university open days, Websites: UCAS. Browse websites such as: Royal College of Podiatry, UniStat. Log on to thestudentroom.co.uk and ask questions there. Look at the National Student Survey (NSS). Research University League

tables. Listen to Podiatry Podcasts. Search Instagram/Tik Tok. Email University admission tutors. Shadow at university clinic or try private practice or NHS clinics for some experience. Read university guides

- Podiatry as a second career
 - Consider the location of universities and where you live – remembering you will have some travel. Go to university open days and talk to existing mature students about time commitments and support (universities will always put you in touch with students if they are not there on the day). If you haven't been in a classroom for a long time or you don't have a science background, consider an online level 3 Anatomy and Physiology course which will help vour understanding, consider salaries: research income in the NHS v. private practice
- Life after professional sport and Life after HM armed forces There are various specialised courses at post grad level that would support sport and exercise, choose

placements with sports specialists – this could be abroad. Dissertation topics are broad and could look at specific areas of interest- around sports, exercise, foot health in armed services. If you haven't been in a classroom for a long time or you don't have a science background, consider an online level 3 Anatomy and Physiology which will help your understanding, consider salaries: research income in the NHS v. Private Practice

 online level 3 Anatomy and
 Physiology course which will help
 your understanding
- Degree Apprenticeship

You need to be in a job where the employer who will support the programme. You must have access to a diverse range of placements and patients and An understanding of the commitment involved with completing a degree alongside working.

PATHWAYS

Thinking about a change of career? Would you like to move away from a desk job and into a role that places interacting with people at the heart of it? Are you currently working in healthcare, but hanker after a stable, nine to five job with decent work/life balance? A career in podiatry can offer you all that and more.

BENEFITS TO CHOOSING PODIATRY AS A SECOND CAREER

- Almost certain employment
 It's a healthcare profession with
 a growing demand due to the
 ageing population and increased
 prevalence of chronic conditions
- Great work/life balance Working anti-social hours is rare in podiatry; the profession is particularly appealing for those seeking a career change to spend more time with family or pursue other interests
- Work in different settings
 Podiatrists can work in various settings, including private practices, hospitals, clinics, or even in research and academia; your career path is flexible!
- Autonomy You will have a certain amount of autonomy in your practice, especially if you own a private practice

- Money With good starting salaries in the NHS, a career in the health service offers you plenty of scope to rise up the ranks and earn more as you take on more responsibility; owning a private practice, or specialising in sought-after clinical areas can increase your earning potential even more
- Working with people You have the chance to build real and meaningful clinical relationships with your patients, providing them with care and watching their quality of life improve because of you
- Fulfilment For some, it is about the meaning they derive from helping people; for others it is a single-minded mission to alleviate pain, prevent complications and improve mobility.

USEFUL TRANSFERABLE SKILLS

A podiatry career draws on the skills that you have amassed in your life so far. Those with previous experience in healthcare, professional sport and the armed forces are particularly drawn to the autonomy and flexibility that podiatry has to offer. People from any professional background can join the foot health workforce. Key skills that a podiatrist needs are:

- Good listening skills
