## About Stephanie Jones

Stephanie Jones is a visionary leader, transformative strategist, and seasoned executive. As the Founder and CEO of It Takes a Village Software & Services (iTAV), she is on a mission to revolutionize healthcare by simplifying complex systems and advocating for the often-overlooked workforce, particularly operations teams and vulnerable populations.

iTAV, a software solution that provides AI-powered predictive analytics, introduces a forward-looking, strategic approach to workforce optimization for government sponsored health plans. Stephanie founded the company after watching her aging mother struggle to navigate the complex Medicare system and realizing that “it takes a village” to improve a broken and inefficient healthcare system.



Stephanie's decades-long career in healthcare technology and operations began in Cigna's underwriting department, a job that prepared her for leadership and eventually executive roles at top healthcare organizations, including Vista Health Plan, Coventry Healthcare (now Aetna), and UnitedHealth Group.

As Vice President of Product Development for Vista Health Plan, Stephanie oversaw Medicare and Medicaid HMO product design and portfolio management. Under her leadership, the company expanded to 250,000 members and generated \$500 million in annual revenue.

At Convey Health Solutions, Stephanie played a pivotal role in scaling the company's business to business operating model from \$30 million in annual revenue to \$400 million over ten years – culminating in her being named Chief Operating Officer. She was instrumental in taking the company public, marking a career milestone as she rang the bell on the New York Stock Exchange.
