## WELKOM CARGO AIRPORT PROJECT TAKES FLIGHT WITH OFFICIAL SITE HANDOVER

The Welkom Cargo Airport project has reached a significant milestone with the ceremonial handover of the site, ushering in an ambitious R5 billion development aimed at transforming Welkom Airport into a major cargo hub. This pivotal event took place on Wednesday and was attended by prominent figures, including Thanduxolo Khalipa, the Mayor of Matjhabeng Local Municipality, and representatives from Sébastien Investissements and Logistique, the firm appointed to lead the transformation. During his address, Mayor Khalipa expressed his enthusiasm regarding the project, highlighting the potential economic opportunities it will bring to the region. "I am pleased to announce that plans surrounding the airport are taking shape. An impressive R5 billion will be invested in its development, which is expected to drive economic growth and create jobs in our community," stated Khalipa. The Mayor further underscored the government's dedication to infrastructure development, calling upon contractors and all stakeholders to ensure the project's successful execution. "The

airport is more than just a structure; it represents a promise of prosperity, and we must collaborate to turn this vision into reality," he affirmed. Mr Mark Brummer, CEO of Sébastien Investissements and Logistique, echoed the Mayor's sentiments, expressing enthusiasm for the project while outlining the significant milestones ahead. "After extensive planning, engineering, and discussions, we are poised to initiate the next phase. Formal site inspections are scheduled to commence on June 24," Brummer confirmed. The transformation of Welkom Airport will facilitate the establishment of an international cargo facility, complete with a 5 km runway designed to accommodate large cargo aircraft transporting gold and other valuable commodities. In addition, the facility will support passenger and private aircraft, providing versatile infrastructure catering to diverse aviation needs. Brummer emphasized the project's commitment to community development, noting that training

facilities would equip residents with the skills necessary to replace contract workers, fostering long-term employment and empowering the community. "We are dedicated to building a sustainable workforce from within the local population," he added. The ceremonial handover is particularly significant as it coincides with Youth Month, a period dedicated to celebrating the spirit of June 16, a day symbolising the struggle for youth empowerment. Mayor Khalipa utilized this occasion to reinforce the municipality's commitment to offering meaningful opportunities for young people. "In the spirit of June 16, we reaffirm the right of young individuals to a future defined by opportunity and purpose," he remarked. The Welkom Cargo Airport project represents more than just an enhancement of transportation infrastructure; it is an integral part of a broader vision for a Special Economic Zone (SEZ) in the area. This initiative aims to revitalize the local economy, promote clean energy industries, and foster sustainable employment

opportunities. As part of this project, the municipality will oversee essential Environmental Impact Assessments (EIAs), geotechnical studies, and regulatory compliance processes, ensuring adherence to South Africa's stringent environmental and developmental guidelines. The landmark event was attended by various dignitaries, including councillors, members of the Municipal Executive Committee (MAYCO), the acting Municipal Manager, municipal officials, business leaders, and other stakeholders. It signifies a clear commitment to transparency and sustainable growth, inviting further regional investment. As the project progresses through its implementation phases, additional announcements regarding stakeholder engagements and investment updates are anticipated.



Data Protection in Digital Age: POPIA's Growing Importance for Businesses

The Information Regulator took a methodical approach in the early years after the Protection of Personal Information Act No. 4 of 2013 (POPIA) went into effect, concentrating mostly on awareness-raising, education, and cooperative engagement with responsible parties. During this time, organisations were more eager to be guided towards conformity than to be punished for mistakes. However, in recent years, this strategy has changed dramatically, with the Information Regulator adopting a more assertive stance and enforcing the Act more aggressively. Businesses would do well to change their approach from considering POPIA as a compliance checkbox to considering compliance as a regulatory priority in light of the latest developments. The costs of complacency are increasing as POPIA changes, therefore it's imperative that companies stay current and review their policies and procedures as quickly as feasible. Below is a discussion of some of the most significant POPIA developments and their implications for South African companies:

1.The data subject owns the data.

POPIA imposes certain requirements on enterprises to manage such personal information responsibly by enforcing the idea that personal information belongs to the individual, not the company that processes it. Even information created by a corporation based on a person's involvement in a health or loyalty program is regarded as that person's property, as the Gauteng High Court affirmed in *Discovery Ltd v. Liberty Group* 2020 (4) SA 160 (GJ). Organisations must follow their obligations under POPIA and be mindful of the possible repercussions if personal information is not treated legally. They must not approach personal information as a commodity to be freely exploited.

2.Examining direct marketing

In February 2024, the Information Regulator sent out its first enforcement warning for noncompliance with direct marketing. Even though the data subject repeatedly opted out and asked to be taken off the company's mailing list, FT Rams Consulting was accused of sending unsolicited direct

marketing emails. By interfering with the protection of the data subject's personal information, the company violated the requirements for the lawful processing of personal information, according to the Information Regulator. Additionally, the company violated section 69 of POPIA, which governs direct marketing through unsolicited electronic communications. FT Rams Consulting was mandated to stop sending unsolicited emails, use the consent form provided by the Information Regulator, and create a database of data subjects who had previously opted out and not consented to direct marketing. If the enforcement notice is not followed, there could be fines of up to R10 million or a maximum ten-year jail sentence. The Information Regulator released a Guidance Note on Direct Marketing in December 2024, emphasising the need to get the informed, specific, and voluntary consent of the data subject before sending direct marketing using electronic channels (such as email, SMS, or automated calls). Furthermore, according to the Guidance Note, a single unsolicited communication may be sent to get such consent, and if no response is obtained, no more messages may be sent until the data subject opts in.

3.Cybersecurity and data breaches

An e-Services Portal for mandatory data breach notification was introduced by the Information Regulator in April 2025. Notifications of security breaches experienced by enterprises are now officially submitted through this internet portal. By facilitating quicker and more open regulatory scrutiny, it helps South Africa get closer to international best practices. The Department of Justice was fined R5 million in July 2023 for failing to renew critical cybersecurity software, which resulted in the exposure of sensitive personal data. This was the most serious enforcement action to date. POPIA compliance necessitates proactive investment in security measures to safeguard the integrity and confidentiality of personal information in a business's possession or under its control, as this case makes evident.

4.Information officers' new

responsibilities and powers

Changes to POPIA's regulations, which go into effect on April 17, 2025, make it easier for individuals to request the erasure of their personal data, object to its processing, or choose not to receive commercial communications. The reforms also acknowledge budgetary realities while upholding accountability by allowing administrative fines to be paid in instalments and imposing new duties on information officers.

5.Finding a balance between transparency and privacy

In *Arena Holdings (Pty) Ltd t/a Financial Mail and Others v. South African Revenue Service and Others* 2023 (5) SA 319 (CC), the Constitutional Court declared that some clauses restricting the public's access to tax records were unconstitutional. This ruling restates the need to weigh the public interest against the right to privacy, which is not unqualified. Because of this, businesses shouldn't trust that POPIA automatically protects all information from being disclosed.

6.Ethics, AI, and the limits of digital

The Information Regulator revealed plans to address automated decision-making and the ethical usage of AI in April 2025. This suggests that new technologies that use personal data in intricate, opaque ways are receiving more attention. Companies that use AI technologies for marketing, consumer profiling, or hiring should get ready for future compliance requirements unique to algorithmic data processing.

There is actual legal and reputational risk. A more proactive regulatory approach is indicated by recent developments, such as the introduction of formal breach reporting channels, the levying of administrative fines, and the issuance of enforcement warnings. Since ignorance or inaction is no longer accepted, the Information Regulator now requires that organisations actively and consistently comply.

Conclusion:

Given the Information Regulator's more proactive approach, POPIA compliance must be a top priority for South African enterprises. New rules, fines, and enforcement notices are just a few recent developments that highlight how crucial proactive compliance is. In a fast changing data privacy context, businesses must assess and update their data governance frameworks to guarantee accountability, openness, and protection of personal data, eventually promoting public trust.

This development shows how South Africa's data privacy laws are developing, with accountability and enforcement replacing support and education. It is essential for businesses' to evaluate, modernise, and future-proof their data governance frameworks in light of these developments. This is required not merely to satisfy legal requirements but also to foster public confidence in a market that is becoming more and more privacy-conscious.



She cautioned that these challenges could hinder the potential of young individuals, emphasizing the need for a collective commitment to overcoming these obstacles. The event provided young attendees with valuable career guidance, health services, and opportunities for direct engagement with government officials. It served as a potent reminder that youth development remains a central focus of the Municipality's agenda, underscoring the belief that the future relies on a proactive, innovative, and responsible generation.

Australians, the second-seeded Proteas delivered a remarkable performance. Bavuma reflected on the journey to this achievement, acknowledging the challenges the team has overcome. He expressed hope that their success would inspire young cricketers across the nation. "There was always that belief that at some point the harder we knock on that door, the harder it was going to happen," he said. Looking ahead, Bavuma emphasized the continuous pursuit of excellence, with upcoming tournaments on the horizon. Cricket South Africa's head of national teams, Enoch Nkwe, affirmed that this victory would inspire future generations. At the same time, the Minister of Sport, Arts and Culture, Gayton McKenzie, highlighted the unifying power of sport in South Africa. Head coach Shukri Conrad shared in the excitement of the team's warm reception, stating, "It makes this win even more special. The guys have been great, but the fans have been better." As the Proteas look to build on this success, the nation rejoices in a moment that could redefine the future of South African cricket.
