# **History of Inclusive Play**

Play has always been an innate part of the childhood experience. Long before there were playgrounds of any kind, children created their own using little more than their imaginations. Play is important for the cultivation of motor skills as well as physical strength and stamina. Children also learn social skills from playing together in groups. Play occurs in all cultures and is an essential part of healthy childhood development, even though playgrounds themselves are a relatively recent addition. The first public playground was built in San Francisco in the year 1887, and playgrounds as we know them gradually came into existence. However, it took over a century for the idea of inclusive playgrounds to even begin to make a dent in America's cultural landscape.

A 1991 study brought awareness to the lack of inclusive playgrounds in public places when it suggested that disabled children were experiencing "play deprivation," which has been found to seriously impact healthy childhood development. The Architectural and Transportation Barriers Compliance Board developed accessibility guidelines in the year 2000 that were enacted into federal law one decade later, giving play areas until March 15, 2011, to be in compliance. The ruling was specific to new construction and alterations of existing playgrounds.

However, differences exist between Americans with Disabilities Act (ADA)-accessible play areas and inclusive playgrounds. ADA requirements involve accessibility for children with physical disabilities, while inclusive playgrounds also take the specific needs of children with sensory processing disorders such as autism into consideration in their design plans. ADA-compliant facts include wheelchair ramps with double rails that provide superior grip, barrier-free travel routes, low-impact surfaces, and a variety of accessible play options such as wheelchair-height sandboxes and customized swings. Inclusive playgrounds feature sensory-rich options such as activity panels that provide children with the opportunity to express themselves in a variety of ways, including music, touch, and mental exploration. They also include areas where children who are prone to sensory overload can get some downtime, such as talking tubes and other safe spaces.

There are currently more than 2,500 inclusive playgrounds available to the general public in the U.S., and more are being built every day. Playgrounds all across the country will continue to make great strides in becoming both ADA-compliant and inclusive, and there will be an increased emphasis on innovative play equipment designed with input from child-development experts and physical therapists.

The Arc is so proud to be part of this list and bring accessibility and inclusivity to downtown Cedar Rapids!

# **Advocacy Corner**

## Did you Know?

A student diagnosed with a disability can remain in school till the age of 22. The Individuals with Disabilities Education Act (IDEA) is a federal law ensuring free appropriate public education (FAPE) to all students diagnosed with a disability ages 3 to 21. By law, students who turn 21 in the middle of the school year can remain in school for the duration of the year and receive their diploma or certificate. At the age of 22, a student is required to leave the school system and access available adult services.

While a student utilizes public education, schools are required to provide all students with the means to learn and progress through the school system with access to necessary services throughout the school day at no cost to the family.

# **Services Spotlight**

## **Day Habilitation**

The Arc started their Day Habilitation program on Monday April 1st, 2013. On the first day of programming The Arc provided service to 3 individuals. The program started to grow rather quickly, and 2 regular groups were formed with 8 participants. Starting in June 2013 another group was brought on to start with individuals that had graduated from school programs.

Over the last 10 years, we have continued to take on more individuals and create more groups of individuals. These 9 groups are made up of 51 individuals who have different schedules to make up their time at Day Hab. The program relies heavily on utilizing the city bus for transportation to and from activities. Daily activities are chosen by the individuals within the program daily. Groups have the opportunity to select recreational or to take part in volunteer jobs.

Groups enjoy going to the mall, going to parks, walking trails, going shopping, spending time at local coffee shops, and spending time at the library. Some of the volunteer opportunities that the groups get to participate in include delivering Meals On Wheels, delivering Breakfast Bags (similar to Meals On Wheels), cleaning at the daily meal sites for Salvation Army, cleaning at the library, cleaning at the Free Health Clinic, and delivering Tidbit newspapers to downtown businesses.

Day Hab is a great opportunity for individuals to grow in their social skills, safety skills, self-advocacy skills, and a great place to make new friends!
