## **Keeping Children Safe Online**

A 2021 Office for National Statistics (ONS) report found that nearly a third of children had accepted a friend request from someone they did not know and around 1 in 10 children (11%) aged 13 to 15 years reported receiving a sexual message, while 1 in 100 reported sending a sexual message. Barnardo's offer the following advice.

### What types of harms do I need to be aware of as a parent?


There are different types of inappropriate, concerning and illegal content online. From bullying, violent videos and 'sexting' to blackmail. We know that those that want to harm our children can use chat rooms, gaming and social media to befriend and groom children. Children report that they can be quickly exposed to content they didn't search out. Therefore, it's vital not to blame children and keep calm if you are faced with this as a parent. The responsibility always lies with those that want to harm. The risk of online harm differs by age and what they are doing online. So, finding age-appropriate ways to educate children is essential. The Child **Exploitation and Online Protection Command** (CEOP) have some great animations to show younger children. Plus, they're split into age brackets with key messages you can revisit as a parent.

### What age should you start to talk to your child about online safety?

For younger children, it's best to use technology together and use that time to discuss what to do if something unusual or scary pops up. As they get older, they will need more independence but keep those conversations about online safety going. Remind them to tell someone if they need help, are worried or something makes them feel uncomfortable. Children feel that conversations about the internet and online safety should be frequent and not a one-off. Regular dialogue allows children to lead the conversation and leaves space for them to ask questions and share concerns. For older children, it allows us to explore what they are doing online. These conversations will change as they grow and mature but started early, they get easier. You can find more information about having a conversation with your children at Barnardo's online safety hub.

As a parent, how can I stay up to date with platforms, such as TikTok, Snapchat, Instagram, and their safety and settings. What are the biggest dangers to children online right now?

The dangers that pose the most risk to your child will depend a lot on how they use the internet, what is already being done to keep them safe, and what they already know about using the internet safely and responsibly. A simple and effective way to hear about the latest online trends or what your child is getting up to is to talk with them about their life online.



# **Keeping Children Safe Online**

By maintaining an open dialogue and encouraging them to talk to you about their internet use, parents can help children access the amazing resources and opportunities the internet has to offer whilst keeping them safe. The risks to each child are different depending on what they are doing online and the everchanging tactics of those who want to harm. Therefore, it is most effective to equip your child with the skills to identify harmful or uncomfortable situations, seek support and offer them regular opportunities through conversation to talk with you.

#### Do you have advice on keeping children safe when they're using an Xbox or PlayStation?

The best way to keep your child safe when they are playing games or using games consoles is through discussion. Talk with your child about the games they enjoy playing and where possible, sit down and play these together. Speak to your child about what else they do on their consoles, aside from play games. For example, what else do they access? Who do they communicate with? Next, establish and support realistic boundaries with your child, whilst encouraging safe choices. For example, make sure young people know not to share their personal information or anyone else's when playing online games. You may also want to think about the amount of time your child spends on these devices or take control of in-app purchases. Childnet's family agreement has some great ideas for areas to focus on with your family. The UK Safer Internet Centre also has further information specifically relating to the use of games consoles. Internet Matters and Thinkuknow are excellent tools to explore parental controls available through games consoles.



- Equip yourself with some basic knowledge by using internet sites.
- Ask your child to show you what new apps there are.
- Speak with other parents or older teens to see what they are doing online.

### **App Safety**

### The apps every parent needs to know about!

For many parents, keeping up-to-date with the technology and apps kids are using can feel like just another chore. Digital Awareness UK, the online safety and digital wellbeing organisation, has shared what apps it thinks parents really ought to know about.

We know that parents find it difficult keeping upto-date with the risks, age ratings and features of the apps their kids might be using. For the vast majority, **Snapchat**, **Instagram** and **Facebook** are household names, but here are a few other suggestions that may be worth researching.

#### VSCO

If you hear your child talking about VSCO (or Visco), then they're probably talking about the image editing app. For a monthly subscription, the app allows users to edit and post pictures and videos using filters to make them social media ready.

VSCO has two million users, because in addition to its flashy filters, it doesn't allow users to comment on or 'like' posts, unlike similar apps.

The 'VSCO Girl trend' is where it gets interesting, and many young teenage girls aspire to be one. A VSCO Girl is said to be 'on trend' in terms of how they dress, act and post on social media. It is reported that the VSCO Girl is environmentally conscious and typically identified by messy buns, baggy t-shirts, scrunchies, shell necklaces and 'effortless beauty'.


You can't make your VSCO account private or see who's following you, so talk to your child about the consequences of sharing private information. Location-based information appears on shared images; however, location sharing features can be disabled. It may also be worth speaking to your child about how they present themselves online and the pressures that they may face to fit in with trends.

#### **Tellonym and YOLO**

Tellonym and YOLO are currently winning the race to be the most popular anonymous messaging apps used by teens, with millions using them to chat and voice their opinions without being tracked.

YOLO can be used in conjunction with your child's Snapchat account and Tellonym can be linked to their X, Snapchat and Instagram accounts. While we find that today many teens are aware of the downsides associated with anonymous apps (such as abuse), they still appeal to those who want to have honest conversations with others about anything from what they look like to how popular they are.

As with all anonymous apps, both Tellonym and YOLO come with the possibility of your child receiving abusive messages, so ensure your children know how to manage online bullying – not just through 'blocking' and 'reporting' but by talking about what's happened. It's important to discuss with your child the benefits and consequences of sharing opinions anonymously and to think about how they would respond to something upsetting.

#### TikTok

With more than 500 million monthly users, TikTok has young people dancing and lip-syncing across the world right now and it certainly doesn't seem to be getting any less popular. TikTok allows users to upload short videos of themselves set to popular music and audio. Videos tend to be humorous with fun filters provided by the app.

Like Instagrammers and YouTubers, TikTokers are users who can be extremely influential and earn large sums of money. Many students see them as celebrities and aspire to become successful TikTokers themselves.

The app offers endless creativity, self-expression and imagination, but comes with similar risks to other social media networks such as exposure to inappropriate content, grooming and bullying.

Your child must think carefully about what they share and with whom when using the app.

Discord



The social aspect of video gaming can be just as important as playing the games themselves, which is why it's important for parents to get to grips with how apps such as Discord are used by their children.

Like leading live-streaming platform Twitch, Discord allows users to chat to other users publicly and privately while playing their favourite video games.

Students say that connecting with other players through chats adds a bit of competition or even mentorship. There are features within the app that allow users to make new friends over common interests and be part of huge communities.

As with any app that provides one-to-one or group chat features, Discord can lead to bullies or groomers interacting online with your child, or the possibility of them seeing inappropriate content. Have a good play around with the app's Privacy & Safety settings to ensure you and your child are happy with them, as well as discussing the benefits.

### **Warwickshire Attendance Service**

Please be aware that The Polesworth School will make a referral to Warwickshire Attendance Service when a child has been taken on a holiday during term time. Below is a article that we have been asked to publicise to parents by Warwickshire County Council.

The Supreme Court has clarified the law on unauthorised leave, including holidays, during term time (Platt v Isle of Wright 2017). The Supreme Court has made clear that attending school 'regularly' means that the children must attend school on every day that they are required to do so. As such, the parents of any child who is absent from school without authorisation for any length of time are likely to be considered as committing an offence under S444 of the Education Act 1996.

The law states a leave of absence may only be granted by a school if an application is made in advance and if it considers there are exceptional circumstances relating to the application.

Schools must judge each application individually considering the specific facts and circumstances and relevant background context behind each request.

A leave of absence is granted entirely at the school's discretion. Generally, a need or desire for a holiday or other absence for the purpose of leisure and recreation would not constitute an exceptional circumstance. Where a leave of absence is granted, the school will determine the number of days a pupil can be absent from school.

When making an application for Leave of Absence parents are advised to give sufficient information and time to allow the Head teacher the opportunity to consider all the exceptional circumstances and to notify parents of their decision. The school may also request further information on the application and supporting documentation where appropriate.

It is advised that if the resident parent has not received notification or a response regarding the leave of absence application, it is the parents' responsibility to ascertain if the leave is authorised prior to the start of the leave.

The school can only consider Leave of Absence requests which are made by the 'resident' parent ie the parent with whom the child normally resides.

Where applications for leave of absence are made in advance and refused, the child is expected to be in school on the dates set out in the application. If the child is absent during that period, it will be recorded as an unauthorised absence. Where a leave of absence is requested, but additional days taken either prior to or after the request may be considered as part of the leave of absence.

Leave of Absences which are not made in advance cannot be authorised in line with legislation. This will result in the absence being recorded as 'unauthorised'.

All matters of unauthorised absence relating to a Leave of Absence will be referred to the Warwickshire Attendance Service, part of Warwickshire County Council. Penalty Notices are issued in accordance with Warwickshire County Council's Code of Conduct for Penalty Notices and in the first instance, as an alternative to prosecution proceedings.

### **Warwickshire Attendance Service**

Leave of Absence taken in the academic year 2024-25-

The law relating to Penalty Notices changed with effect from 19 August 2024. Therefore, Penalty Notices issued for Leave of Absence taken from September 2024 will be issued in accordance with the updated legislation.

- Penalty Notices are issued to <u>each</u> <u>parent of each absent child</u>, (for example 2 children and 2 parents, means each parent will receive 2 invoices – 4 in total).
- <u>First Leave of Absence offence:</u> The Penalty Notice amount of £160 to be paid within 28 days, this is reduced to £80 for each child if paid within 21 days.
- <u>Second Leave of Absence offence</u> within a 3 year period (from the date of issue of the first penalty notice): The amount of £160 paid within 28 days. No reduced amount.
- Payment plans will not be offered and/or payments received outside of the 28 day period will not be accepted. Where a penalty notice expires unpaid the matter will be referred to Warwickshire County Council's Legal Services to consider criminal prosecution.
- Third Leave of Absence offence within a 3 year period <u>(from the date of issue of the first penalty notice)</u>: A penalty notice will be not be issued and the matter will be referred to Warwickshire County Council's Legal Services to consider instigating criminal prosecution proceedings under S444 of Education Act 1996.

### **Mental Health Support, Anxiety & EBSA**

We live in a time where 'mental health' is thankfully something we're becoming more and more aware of. Whilst this is undoubtedly brilliant that mental health is becoming less 'taboo', it does present new problems. Mainly, how do we support each other?

We are, of course, a school, not a health care provider. However, we take mental health incredibly seriously. Our priority is for children to leave us as successful young adults – they've learnt the value of hardwork and kindness. In order for us to meet this goal it's important that we all work together to support each other in times of need and to teach the children how they can reach out for support when they will undoubtedly need it.

#### But how?

Firstly, it's important to acknowledge that we all have 'mental health', just like we all have 'physical health'. Just like 'physical health' we all need to look after our 'mental health' and at times it needs additional 'care'.

As a school we have invested a huge amount of time (and money) in supporting children with their mental health. We have dedicated members of staff and regularly talk to the children about how they can help themselves and seek additional support if needed. This is vital so that students know what to do in any future situations.

- All students have a personal tutor. Their primary aim is to provide front-line pastoral care. An ear to listen and a voice to guide.

- Pastoral Team- Children often make excellent use of their Head of Year and Pastoral Support Officer. The team are highly trained and experienced in supporting students when they are having difficulties and working with them to find resolutions.

- Our Designated Safeguarding Team support students that have emotional difficulties.

- We are very proud of our partnership with the Mental Health in Schools Team (MHST). We regularly share their advice 'posters' via Polesworth Matters. When a student needs additional external support we refer them to MHST who triage the 'need' and potentially assign a highly trained specialist to meet with the student and give support/advice/techniques. We are about to offer all staff the opportunity to have a small amount of training on how they can support anxious children within their current role.

- We have our own, full-time, fully qualified School Counsellor.





### **Mental Health Support, Anxiety & EBSA**

#### EBSA (Emotionally Based School Avoidance)

Let's be honest, a lot of teenagers, from time to time, find getting to school difficult. They are often very tired and learning isn't easy.

EBSA is more than this.

EBSA is when children have long-term difficulty attending school due to 'push' (negative feelings about school) or 'pull' (home is 'comfortable' and they can do the nice things normally reserved for holidays or weekends).

Sometimes students experience EBSA because of something which has happened in school; someone has upset them, they are finding something difficult, they feel lonely etc. When these things happen we work tirelessly as a team to support the children to overcome these temporary barriers. Please reach out using the contacts below if you feel this is happening. It could be that they dislike school because there are rules they disagree with – if this is the case, unfortunately they need to accept that sometimes they might disagree with the rules, but that won't change anything.

If the problem is more long-term and a more 'specialist' approach is required, we have a designated member of staff to help. Please contact Mrs Grigg: (J.Grigg@ThePolesworthSchool.com). She can coordinate a whole school response and also, where suitable, involve external agencies to support your child to not only attend school, but to

begin to enjoy school again.
