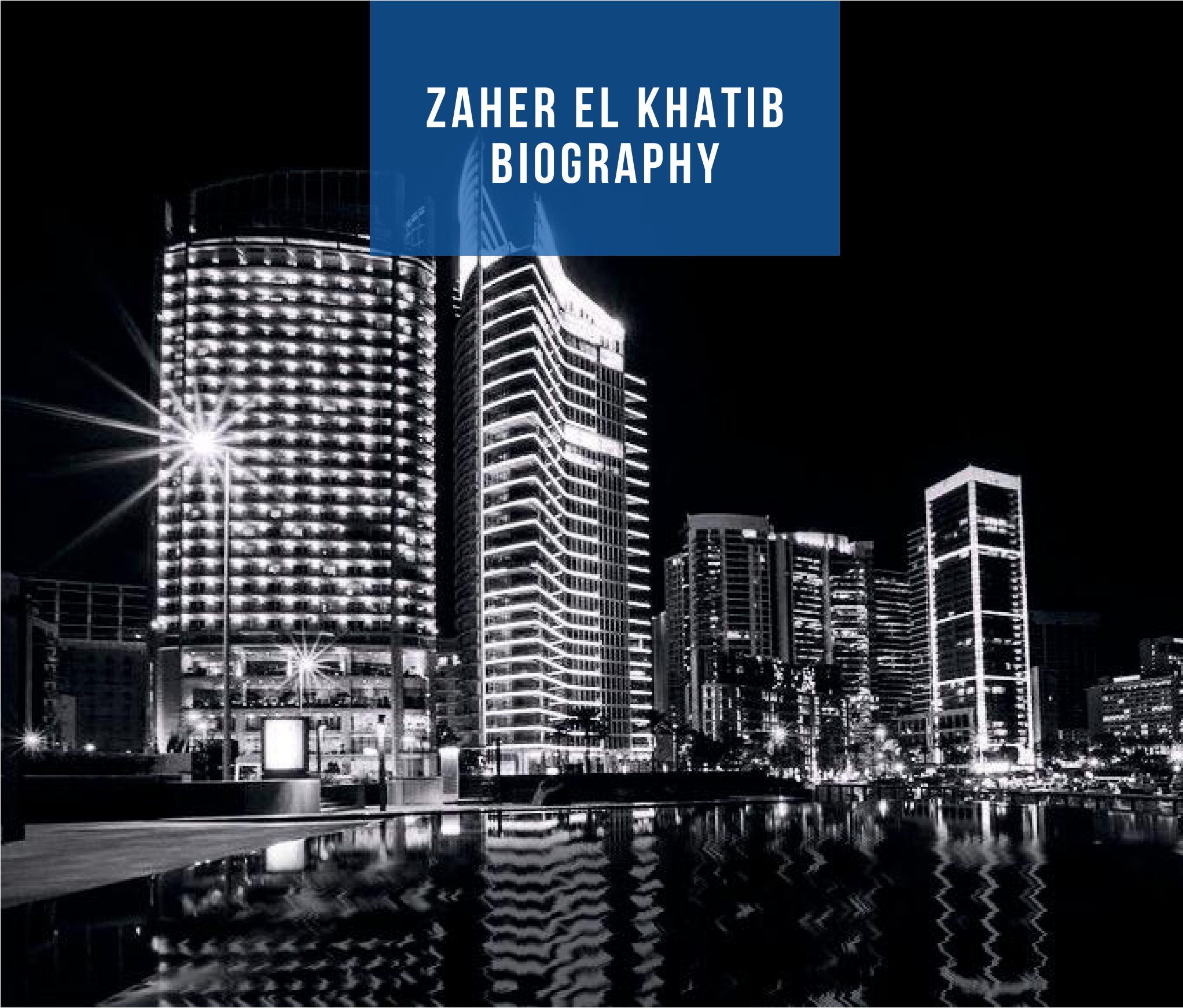

On 6 February 1990, he moved to Kuwait to join his uncle's FMCG trading company. He was only 19 at the time. Working from 6 am to 11 pm 7 days a week, even on holidays, he amassed significant experience as his uncle's assistant, gaining full exposure to warehousing, sales, HR, accounting, and other facets of the business.

Over the years, he assumed more responsibilities until he was in charge of running the entire company for his uncle. In 2002, he officially took over when his uncle passed away.

A risk-taker with strong determination, from 2003 to 2015 Zaher Fouad El-Khatib established 40 companies by diversifying within Kuwait and by expanding to new markets including Iraq, Libya, the UAE, Qatar, KSA, Turkey and Lebanon. 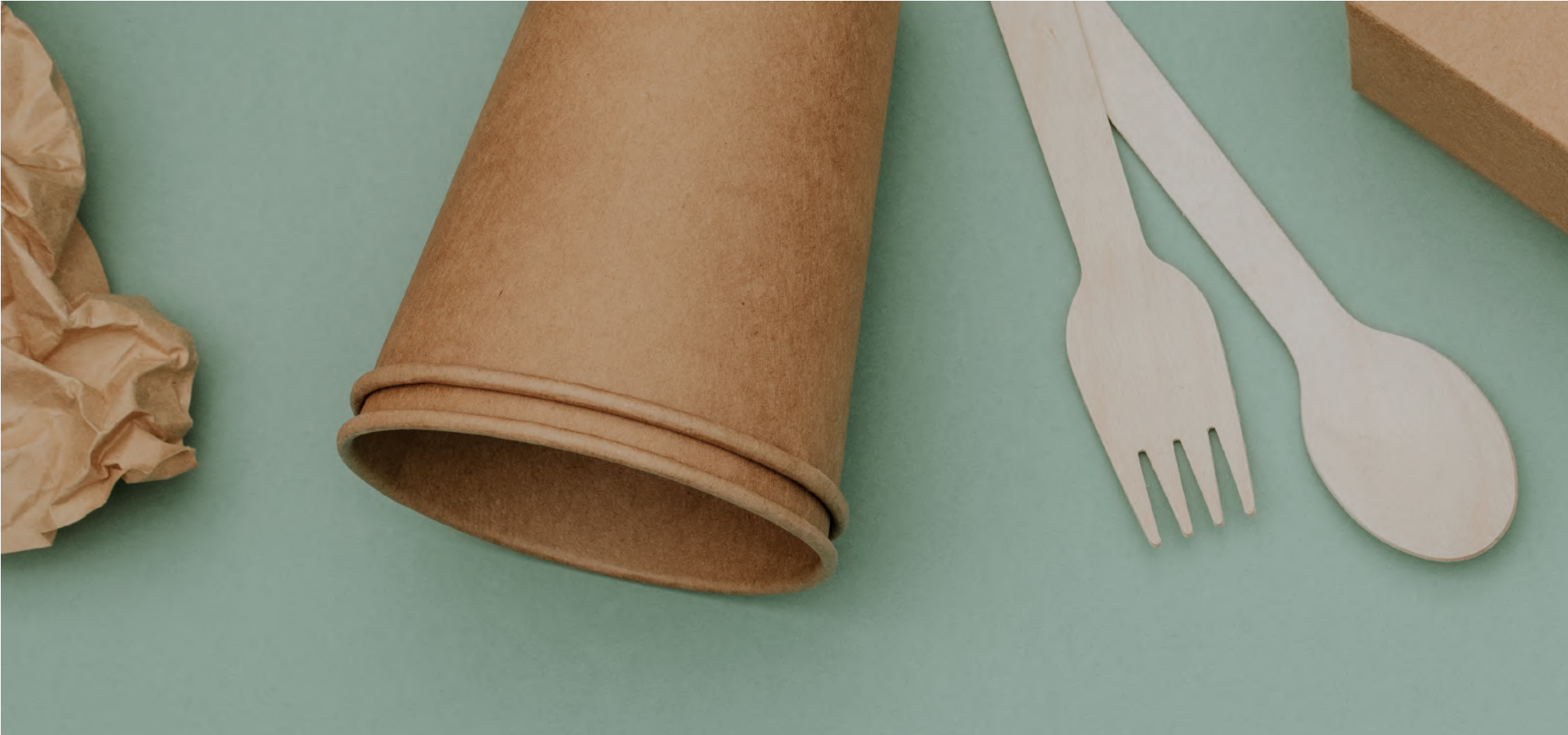
