

# A few 'David v Goliath' stories

- The modern environment movement grew out of the bushwalking clubs active in the first half of the 20th century. It's still important to visit the forests and wilderness we are trying to save and let their beauty speak to decision makers. Total Environment Centre hosted several Premiers on overnight trips, which led to new national parks being declared.
- Not all government ministers are as sympathetic. In one infamous episode, a Forests Minister accused us of translocating Koalas into an old growth forest that was set to be wood chipped. It was a ridiculous claim, but it shows how far some opponents will go, to try to discredit your campaign.
- One of many actions in the Cash for Containers push involved our director, Jeff Angel, along with the CEOs of Greenpeace and Cleanup Australia, delivering waste drink bottles and cans outside the corporate HQ of Coca-Cola. Coca-Cola, who opposed 10c refund schemes, called the police — an overreaction that produced excellent media coverage!
- In the early 1980s, the plight of an injured white ibis spurred a conversation at Total Environment Centre about the need for better wildlife rescue efforts. With the support of the Fund for Animals, WIRES NSW was born, and now it rescues and rehabilitates thousands of native animals for release back into the wild.

- With the balance of power held by progressive crossbenchers, a lot can be achieved. In one instance, we worked with three independent MPs and the Minister in charge of Sydney Water to reform the organisation from a water wasting and polluting agency largely disinterested in environment protection, by rewriting its legislation to incorporate water efficiency targets, ecologically sustainable development and recycling.
- A gas company mistakenly allowed access on their website to a confidential plan to drill in a pristine water catchment. A local informed us and, despite threats from the company, we released it to the public. The controversial plan was eventually dropped.
- Recently, when we took an Environment Minister on a tour of a threatened Koala colony near the city. He took the opportunity, there and then, to ring his senior colleague about a protection plan and immediately announced it to the waiting media, as the Koalas looked on.
- The operator of a major toxic waste dump was insistent it was safe and not leaching hazardous chemicals into the groundwater and neighbouring properties. Our volunteer hydrologist examined the geology and water flows. He found that pollution would most likely be occurring. The government ordered a review, resulting in closure of the site.

Supporting avoidance, reuse and recycling

Total Environment Centre was one of the first groups to start campaigning on plastic pollution. Plastic, in particular microplastics, are being found everywhere, including in our bodies. The evidence keeps growing about the impact on wildlife, the food chain and, potentially, human health.

"We played a major role in the banning of billions of plastic bags and the inception of container refund schemes that have now spread across the nation. We host and continue to work closely with the Boomerang Alliance and with its 55 NGO allies to stop plastic pollution," says Jeff.

The Container Refund Schemes in Australia have reduced litter volume by 57% and doubled recycling to 65% — but more needs to be done — expanding the number of eligible containers; greater refund point convenience; raising the refund to 20c to maintain the financial incentive; and setting a target of 90+% recovery.

"We are also seeking a national microplastic reduction strategy and preventing microfibre and rubber crumb pollution," says Michelle.

## Healthy Cities, Healthy Planet

"Most people live in the city. Total Environment Centre has and continues to be a key voice in making our cities liveable and sustainable. A green city also conserves the homes of our unique plants and animals," says Saul.

TEC saves green spaces and works for sustainable cities

Reducing greenhouse gas emissions (caused by energy use, construction materials and transport) from our urban areas is a vital task. It's also compatible with healthier lifestyles and decreasing the cost of living.


Total Environment Centre produced the first *Greenprint for Sydney* in 1999 and was a leading participant in the making of Sydney's green Olympic Games. We have persistently pursued the protection of remnant biodiversity; the creation of new green spaces; and supported campaigns and new laws to stop park sell-offs.

In 2023, we released *the Blue-Green Grid* – a vision for hundreds of hectares of interconnected and protected green spaces, river, and creek foreshores and tree canopy in Sydney, extending from the Koala greenbelt in the west to the coast.

The benefits are enormous – improved air quality and mental health, biodiversity conservation, creation of active and passive recreational areas and urban heat mitigation.



## Circular Economy – for everything

Once fierce opponents, many in the waste industry now support our push for a circular economy

After years of failed voluntary programs, it is time for genuine efforts to avoid landfilling and incineration, and instead reuse resources, again and again.

We have achieved new waste recovery, recycling and producer responsibility laws ; the closure of toxic dumps that were leaching into the environment; winning the national TV and computer recycling and container refund schemes. "I've only recently joined Total Environment Centre and it's a great pleasure to be part of helping make environmental change. My first campaign on end-oflife batteries has been an eye-opener and we are getting traction with decision makers and stakeholders," says Mark.

Our plan for a federal scheme for small ewaste and solar panels is being seriously considered by the government. With projections revealing batteries reaching end of life will increase to more than 230,000 tonnes by 2030, and double by 2050 – we are currently advocating a comprehensive end-of-life battery recycling and collection program.

## Save Sydney Basin Koalas

"Damaging developments are being opposed through the successful establishment of our Sydney Basin Koala Network (funded by WIRES and working with 20 groups). Based on benchmark legal and ecological research, we have the tools to advocate for a better future at local and state levels and will be also be issuing annual progress reports holding government and developers to account," says Stephanie.

Extinction is the next stop for our treasured Koala, unless we save their habitat and migratory corridors. We are highlighting the plight of the species near urban areas and have worked over the last four years to give them a future.

The Sydney Basin bioregion was once home to many healthy Koala populations – but **now just five small colonies are left and heading for extinction.** 



This is due to the massive 2019/2020 bushfires, ongoing mining, logging and urban sprawl.

The koala is an icon species and saving its habitat saves many other species. This campaign builds on TEC's our record of producing Australia's first listing of endangered animals and successfully campaigning for protection and recovery laws.

## Taking Action Against Global Warming

Commonwealth and state governments have legislated useful emission reduction targets for the next 25 years that are a 'minimum' and subject to independent review. A wide range of new policies across the economy need to be implemented.

A core challenge is converting our energy mix and preventing new coal and gas mining. We actively participate in the NSW Government's Climate Roundtable and recommended amendments to the founding legislation of the Net Zero Commission.

Total Environment Centre was one of the first groups to appoint a Greenhouse Campaigner in the 1990s; and the only NGO pursing reforms to the key framework rules -National Electricity Market - to remove barriers to renewables and energy efficiency. This ten year campaign has recently succeeded.

The Green Energy Guide helps consumers navigate the complexities of renewable energy options, offering advice on selecting green energy providers and understanding the benefits of solar, wind, and other renewable sources.

These guides empower individuals to make sustainable choices.


