### Post-Secondary Rental Assistance

The HHCDA offers rental aid to qualified households with an adult member pursuing higher education. This program supports low to moderate-income AIAN households with their rent, as outlined in the Indian Housing Plan.



## The inside scoop Recertification/Income Update made easier.

You can use Form 1040 as proof of income instead of getting separate verifications.

Instead of individual income verifications for anyone listed on the form.



 For example, a married couple with two full-time jobs, two gig jobs, child support, va disability, and asset income who filed jointly can turn in 1 page rather than verify each income stream.

If they filed separately, it would still be beneficial for them to each turn in page 1 of 1040; we would need one from each of them.

### UNDERSTANDING THE RENTAL UNIT TURNOVER PROCESS.

When a housing unit appears unoccupied, or a family moves out of a unit, you may wonder why nobody has moved in yet. However, it's important to note that HHCDA must take specific safety and quality assurance measures before a new family can move in.

- Regardless of the previous tenant,
   HHCDA must ensure a high standard of cleanliness with a deep clean for safety purposes.
- As we go through the rehabilitation and repair process, it's crucial to take care of maintenance tasks like fixing minor leaks, patching drywall holes, and replacing appliances.
- Once these steps are completed, the units are subject to inspection and must pass to be approved for occupancy.

HHCDA Rental Management checks the occupancy "waitlist."

To be eligible for immediate housing when units are available, you must keep your application information up-to-date.



### FOUR SEASONS OF HOME MAINTENANCE

As part of the renting process, we ask the tenant to think about the four seasons' maintenance needs of your home.

Regular maintenance is important in protecting our homes and families from natural and unnatural elements.

### Here are suggestions:

- Change Furnace/AC Filter
- Check Exterior wood trim including windows
- Put exterior fan filter (over stove) in sink and clean
- Clean out gutters use a work order if needed
- Have air conditioner checked
- Cut Grass
- Lawn Sprinkling and landscaping needs
- Clean Shower Heads
