Cadet Corps Gifted With \$40,000 Van By Premier's Cup Tournament

the Premier's Golf Tournament has donated a van valued at \$40,000 to the Turks and Caicos Islands Cadet Corps.

The handover ceremony took place on Tuesday, September 19, at the Downtown Ball Park in Providenciales.

Mervin Cox, Head of the Premier's Cup Tournament, emphasized the event's commitment to sponsoring the cadets. Recognizing their need for proper transportation to various events, he said the tournament committee decided to gift them the van.

Major Nimrol Beckles, Head of the TCI Cadet Corps, expressed his joy at accepting the van on behalf of the organization and extended his gratitude to everyone involved.

"Sometimes training finishes late, and there are definitely concerns about the cadets' safety in terms of getting them home. So, this would come in very handy in ensuring that we actually get things done," Beckles said.

Beckles also acknowledged the efforts of former Premier Hon. Sharlene Cartwright Robinson, who facilitated the clearance of the van through customs and Camco Enterprises, which made a generous financial contribution to cover landing and clearing costs.

Lorne Robinson, General Manager for the Oasis at Grace Bay, a subsidiary company of Camco Enterprise, shared that Camco underwrote the landing cost for the van.

"We recognize that the youths are our future, and we are actually happy to assist. We are still available to offer any assistance to the cadet corps, and to any organization that attempts to help the youth in this country," Robinson said.

Jasmine Thomas, Director for the Department of Youth Affairs, expressed her excitement about the partnership between the Premier's Cup Tournament and the Department of Youth Affairs. She highlighted the financial burden of transporting cadets to different locations and mentioned the importance of ensuring their safety during late-night events and early morning travel.

The Premier's Cup Gold Tournament donates to two entities whenever it is held. They are the Cadet Corps and the Duke of Edinburgh Programme, which is also a youth-oriented programme, which supports the Youth Department.

Thomas mentioned that the funds received from the Duke of Edinburgh programme would be used to purchase camp items such as tents and backpacks for the youth's adventurous journeys.

Edith Skippings, General Secretary for the Premier's Cup Gold Tournament, revealed that this was the second time the tournament had donated a van to the Cadet Corps. The first van was donated during the Rufus Ewing Administration, while the latest donation came from proceeds generated during the previous administration led by Cartwright Robinson.

Skippings added that the Premier's Cup had also donated more than \$10,000 worth of music equipment to the cadet corps.

Meanwhile, Beckles mentioned that the cadet corps had nearly 200 members spread across the Turks and Caicos Islands.

He said this generous gift from the Premier's Cup Tournament would undoubtedly enhance the mobility and safety of the cadets, enabling them to continue their valuable work in the community.

Cox and his team were appointed by Cartwright Robinson during her tenure. She served from 2016 until 2020. Each premier appoints their own Premier's Cup Committee, as each committee serves at the premier's pleasure. Despite the administration changing hands, the tenure of Cox and his team has been called.

Clean Record Over Popularity

Premier Hon. Washington Misick made it clear that he values his clean political record above all else and is not concerned with whether people like him or not.

Directing a portion of his speech towards Opposition Leader Hon. Edwin Astwood, with whom he clashed over political matters, Premier Misick acknowledged that some individuals in the community might prefer a government that adopts shady practices to fulfill hidden agendas. However, he firmly stated that he would not venture down that path. He emphasized his commitment to ethical governance and maintaining a spotless track record throughout his long tenure as a legislator.

"I have been a legislator for many, many years... totally untarnished, and by the help of God, I intend to take that to the end," Premier Misick affirmed. While acknowledging that he is not perfect and may make mistakes, he stressed the importance of making decisions based on available evidence and seeking wise counsel.

"As a leader, I am expected to be committed, not to comply with every uninformed, impractical, and even morally wrong advice," he explained. Premier Misick made it clear that he believes in ethical leadership and upholding the law, ordinances, regulations, morality, natural justice, and fair treatment of people.

"There are those who would shy away from doing the right thing in the interest of political

expediency. I get criticize for that a lot. That is not who I am. I am going to do, with the help of God, the right thing, he said.

He also dismissed the notion of succumbing to political or religious pressures, stating, "I am not that kind of person. And if Turks and Caicos is looking for that kind of leader, maybe they should elect the leader of the opposition because I am just not that kind of person. I believe in ethics."

Premier Misick spoke about his dedication to serving the people who elected him and his commitment to doing what is right, even in the face of controversy. He emphasized that he doesn't need to know who supports him; he is obligated to do the right thing, as expected by God and his constituents.

The Premier said he welcomed challenges and controversy, citing Martin Luther King Jr.'s words: "The ultimate measure of a man is not where he stands in moments of comfort, but where he stands in times of challenges and controversy." He noted that the opposition's criticism of his leadership is seen as a sign that he is doing well. Responding to what he termed as personal attacks on his character and age from the Opposition Leader, Premier Misick affirmed his vigor and energy, stating that he is as energetic as an 18-year-old. He humorously referred to his recent medical checkup, where his blood pressure was compared to that of an 18-year-old. He ex-

pressed his intention to live to the fullest and fulfill his God-given promise of 120 years.

"The Lord has been good to me. I am energetic as any 18-year-old. The last time I had my blood pressure taken (the doctor) said I had the pressure of an 18-year-old," the premier said, to thunderous applause from his governmental colleagues. "So, I don't want any body to set the sun on me before its time. That is God's business and Him alone."

He added: "I did not rise to be critical of the leader, but somewhere it says, 'to know better is to do better'. But unfortunately, it doesn't appear as if the Hon. Leader of the Opposition knows any better. I was somewhat disappointed that the leader of the opposition would make Ad Hominem or personal attack on my character and my age in diversionary tactics instead of addressing the issues raised in the Throne Speech...relevant issues that are affecting the country. But I hope he remembers what happened to the last persons who attacked me because of my age."

In the meantime, Premier Misick said he remains steadfast in his commitment to clean, ethical governance, even in the face of opposition and personal attacks. He told the House of Assembly that his priority is to serve the best interests of the people of the Turks and Caicos Islands, regardless of his personal popularity.

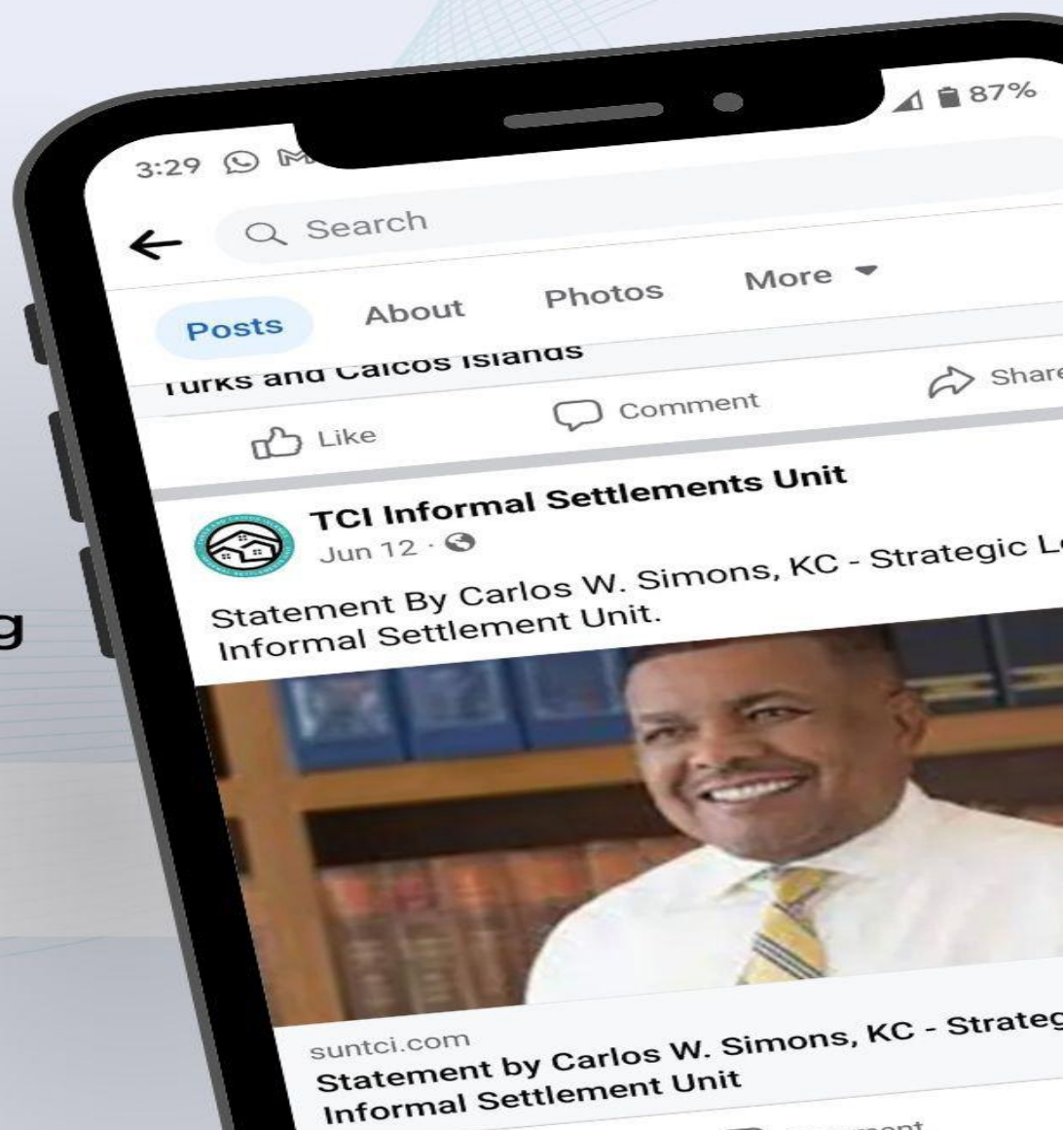

The hyper-disruptive force of the Middle East and the growth of the Global South

There have been greater explorations in creating alliances for trade in the Middle East.

In case you missed it, the G20 League of Nations met in New Delhi recently and there were several takeaways from the summit we should all keep at the forefront of our minds as a developing nation.

First, the 55-member African Union was formally made a permanent member of the G20, on par with the European Union, to make the grouping more representative. It is such a colossal move as, up until now, only South Africa was a member of the G20.

The entry of the African Union will also provides a more robust voice to the Global South within the G20, where it was always the G7 countries that have, for so long, leveraged their dominance. This move has come after the BRICs (Brazil, Russia, India, China, and South Africa), the League of Nations (dominated by China and Russia) expanded to include Argentina, Egypt, Ethiopia, Iran, Saudi Arabia, and the United Arab Emirates — also a step in the right direction for developing nations with emerging economies.

Moreover, at the summit, nations agreed that sovereign states should not and cannot forcibly seize other territories. Host country India, in tandem with Brazil, Indonesia, and South Africa, played a crucial role in ensuring that the summit did not splinter around condemnations of Russia, which, to some analysts, is another clear demonstration of the growing power of the Global South to direct diplomacy and trade negotiations forward.

Noticeably missing from the summit was China's Leader Xi Jinping. However, his absence never prevented unveiling some of the current dynamic geopolitical trade shifts. Indeed, it was a clear awakening to us that the West has decided to abide by the adage, "If you can't beat them" join them.

Enter India, Saudi Arabia, and the United Arab Emirates (UAE): At the summit, US President Joe Biden, along with leaders Narendra Modi, Crown Prince Mohammed bin Salman, and Sheikh Mohamed bin Zayed, announced the launch of a new trade route connecting India to the Middle East and Europe through railways and ports in what seems an unmistakable response to China's US\$3-trillion Belt and Road Initiative for trade and commerce.

According to President Biden, the plan also includes the European Union, France, Italy, and Germany, and will comprise two separate routes — "an east corridor link-

ing India to the Gulf Arab states and a northern corridor connecting the Gulf states to Europe". Goods and services would transit through the UAE, Saudi Arabia, Jordan, Israel, and Europe. The route will also enable electricity, digital connectivity, and pipes for clean hydrogen export. From all predictions, including those from the International Monetary Fund, India will grow by over 6 per cent in the next few years and is on track to be the world's third-largest economy. So, the US partnership with India is not surprising. But this announcement is a departure from President Biden's previous specific declarations on the Kingdom of Saudi Arabia (KSA), and our memory of his awkward fist bump with Saudi Arabia's prime minister, Crown Prince Mohammed bin Salman, when he visited the Gulf.

Clearly something has changed, and the KSA and the UAE are now strategically seen as titanic economic and politically independent forces amid some of the world's most powerful countries. They know you cannot disregard the Middle East any more. It would be best if you came to their table.

Furthermore, despite pressure to choose sides, Gulf states have insisted and maintained a balanced position involving political and economic cooperation across the board, which analysts say makes Gulf states strategically, diplomatically, and economically vital.

Their self-reliant foreign policy also upholds an unbroken friendship with China against others trying to create distance and tensions. As a result, "Gulf countries are using this multipolarity and this new world order to try to put themselves at the heart of global trade, trying to invest even more in connectivity and globalization." (Cinzia Bianco, The European Council)

The Middle East's stealthy strategy has definitely softened the United States' influence in the eyes of the world, and President Biden accepted at the summit that: "The world stands at an inflection point in history," as he graciously thanked the UAE leader for bringing them all to this point. The White House said the project would usher in a "new era of connectivity".

However, these geopolitical agreements are no surprise to me, especially since I was not only following the economic pursuits of Dubai and the UAE, but I also went to the KSA last February after the royal family announced its bold Vision 2030 to use KSA's strategic location as an integral driver of international trade through Africa, Asia,

and Europe is on target.

The Saudi Government spent US\$950 billion on mega projects; will complete its first phase of reconstruction — some 1700 acres of land — to boast a diverse selection of new leisure, entertainment, housing, education, and religious facilities with 38 unique hotels, 100 new restaurants (including Michelin Star restaurants), nine museums, over 100 retail shops, two grand mosques, two state-of-the-art universities, over 20,000 new residences, 14,000 underground parking spaces, and the rejuvenation of the landscape with 1 million plants, scrubs, and palm trees with tourism's annual GDP contribution to the Saudi economy of US\$30 billion in 2023, and tripling their tourism sector employment to 1.6 million jobs by 2030.

A critical component of this ambitious goal is the creation of 2,000 entertainment, cultural, and sporting events to attract millions of non-religious tourists annually, with the renewal of the birthplace of the Arabian peninsula — Driyah and At'Taurif.

Already, Saudi Arabia has forcefully disrupted the global golf, soccer, and Formula One space, unnerving what used to be traditional notions of where these sports should take place.

In June, the PGA tour agreed to merge with KSA's LIV Golf, which reportedly committed over US\$2 billion to grow the sport.

In soccer, Saudi Arabia's club Al Nassr signed a contract with Cristiano Ronaldo worth over US\$220 million. Plus, they have already built their own Formula One track in Riyadh.

They also plan to transform their public investment fund — with assets that are expected to reach US\$1.86 trillion by 2030 — into one of the largest sovereign wealth funds in the world and consolidate its position in shaping the global economy.

As the economic epicentre continues to shift away from the United States, the Caribbean needs to plan for where global opportunities will be in the next five to 10 years. Since our leading foreign exchange earner is remittances, and we have extensive knowledge in tourism, perhaps we need to consider how we export labour to the Middle East in addition to the US and Canada.

Turks and Caicos Has 45 Informal Settlements

Government has identified 45 informal settlements occupying 500 acres of land across the Turks and Caicos Islands.

The finding was revealed recently by the Informal Settlement Unit – a body set-up by government with its sole focus to halt informal settlement in the country and to get rid of existing ones.

Tito Lightbourne, Permanent Secretary in the National Security Council, and in whose office the Informal Settlements Unit falls, told reporters that the unit has identified 45 settlements that did not get the greenlight from the Physical Planning Department, with most of them being on Providenciales.

"We have identified 45 informal settlements nationally, 35 in Provo, nine in Grand Turk and one potentially in North Caicos. These settlements make up just about 500 acres of land and about 700 parcels of land. To put that into context, that is two percent of our land mass. Dock Yard is 21 acres essentially of a 500-acre challenge," Lightbourne said.

Dock Yard, which is in Providenciales is the country's biggest informal settlement, and on which government has given a great deal of attention, including running a survey in the community to get a true feel of what makes that community ticks. Lightbourne stated however, that the demolition process would not begin in Dock Yard, but other less problematic areas across the country.

"Some of these settlements, for lack of a better term, are low-hanging fruits, less contentious areas whether it be incomplete or uninhabited structures, so those are the ones that you would see us targeting the most before starting the expansion...targeting those unfinished, those inhabited structures, reclaiming that land particularly if it is Crown Land. If it is private land, we have to engage the private landowner," Lightbourne explained, noting that a great deal of the land occupied by informal settlers

are private properties.

For his part, Carlos Simons, Head of the Informal Settlements Unit, private landowner, for the most part, are willing establish low-cost housing, to ease formal homeownership crisis. "Let me also say this, that some of the land that has been occupied by the informal settlers is private land, and private landowners want low-cost housing," Simons explained, noting that government, under the new Housing Policy, would be willing to assist private landowners in developing low-cost housing, by, among other things, reduction of import duties. He pointed out that some informal settlers could likely become beneficiaries of that programme.

Simons pointed out that providing basic amenities in Dock Yard is not off the cards, but there would be much work to be done before getting to that stage.

"We understand that Dock Yard is private land... all private land. There is no Crown Land there. And so, until we understand and resolve some of the land concerns in Dock Yard, it would be difficult for government to go in and cut roads. "But government is anxious and ready to develop and improve the facilities and infrastructure, but to do so at the moment in appropriate. Not trying to provide basic amenities that people in communities need, but they are larger issues that first must be addressed," Simons further stated.

Lightbourne pointed out that the dense nature of Dock Yard makes it virtually impossible to provide certain amenities.

"You would have seen the Dock Yard Report, and here in Turks and Caicos the minimum parcel of the size of piece of land is .21 of an acre for one structure. We have .21 parcel in that area that has 11 structures. That is part of the issues that we want to get to the bottom of... who legally and legitimately owns each parcel of land," Lightbourne noted.

In the meantime, Simons pointed out that it has

taken 25 years for Dock Yard to develop to its current point, and so, the problem would not disappear in short order.

"Dock Yard is privately-owned land...that doesn't mean that government does not have a role to play, because I have seen the area and the aerial photographs...and none of the houses there could achieve Planning approval.

"And if the person builds on his own land outside of the planning laws, the Planning Department could go to court, get a court order for the structure to be pushed down," he explained.

He said however, that the Informal Settlement Unit would not readily go into Dock Yard and begin bulldozing structures but would approach it from a case-by-case standpoint.

"We are not saying that that is going to be our approach in Dock Yard because we know that there are people who are law-abiding people... majority of them are law-abiding," Simons further stated.

He added: "But in the meantime, the community should know that the Unit is not going to permit further developments of the informal settlements. And so, as the foundations are laid, and blocks are put up, we will push it down. When we said we will contain the further development of informal settlements, that is what we mean. We will not permit areas in Five Cays and Blue Hills to be developed in that way any longer.

"We have drone technology, and the Unit, once it is fully staffed, will have the manpower to monitor and know that two weeks after a site has been cleared there is activity there. And so, we know we have to keep that monitored.

"What we are inviting private landowners to do is, once we have assisted in clearing lands, they must undertake to monitor it whether by fencing or regularly visiting, or whatever. But it makes no sense for resources to be spent on land clearance and then three weeks later, its back to where we were," Simons noted.

Government Plans Big Development at Clement Howell and Louise Garland Thomas High Schools



TAYLOR:The Comfort Suite one-story building will become two stories

The Washington Misick government has announced ambitious plans for the redevelopment of the Clement Howell and Louise Garland

Thomas High Schools on Providenciales. The initiative aims to modernize educational infrastructure and enhance the learning environ-

ment for students. One of the central components of this redevelopment project involves the demolition of the dilapidated ‘Comfort Suite’ building located on the Clement Howell High School property. This announcement was made by the Minister of Education, Youth, Sport, and Social Services, Hon. Rachel Taylor, during her address at the commissioning of the OutoCAD Lab earlier this week. The Comfort Suite building had initially been included in the previous year’s budget for refurbishment. However, Minister Taylor revealed that funding for this project had been withdrawn to allow for a more comprehensive redevelopment plan. In the revised proposal, the one-story Comfort Suite building is slated for demolition, and in its place, a modern two-story structure will be constructed. Minister Taylor explained, “The Comfort Suite building was budgeted for last year, but we took it out for a reason. But it is going to go back into this year’s budget. So, the Comfort Suite one-story building will become two stories. One two-story building will be here at Clement Howell, and the other will be located at Long Bay High School.” She said the initiative underscores the government’s commitment to providing students with state-of-the-art facilities conducive to learning and development. Minister Taylor further noted that the government had recently completed a significant project at the Enid Capron Primary School, where she once served as the principal. The education minister pointed out that the redevelopment of the Clement Howell and Louise Garland Thomas High Schools is expected to have further positive impact on the quality of education in the Turks and Caicos Islands, offering students access to modern facilities and resources for their academic growth. The specific details of the project timeline and budget allocation was not immediately available as the government finalizes its plans for this ambitious educational infrastructure upgrade.

Minister of Education Hon. Rachel Taylor commended Rubis for its dedication to the development of young people in the Turks and Caicos Islands, emphasizing that Rubis is not only in the region for profit but also to contribute to education and nation-building.

"Your efforts here today is indicative of your commitment and the interest that you have for the young people of these 'Beautiful By Nature' Turks and Caicos Islands," she said. "You were resilient in your effort that you deliver on this AutoCAD project."

Taylor highlighted the need for engineering and architectural skills in the country, as identified in a recent skills gap audit, and expressed her enthusiasm for the emphasis on AutoCAD education at Clement Howell High School.

She revealed that the AutoCAD programme would provide students with valuable skills and an easy transition path to the Turks and Caicos Islands Community College, where admission is free. She also mentioned the government's commitment to expanding technical and vocational education through the Technical and Vocational Education and Training Programme (TVET).

The inauguration of the Rubis-sponsored AutoCAD Lab has been seen as a significant step forward in advancing educational opportunities and filling critical skills gaps in the Turks and Caicos Islands.

Honey may not be good for scarring caused by burns and deep cuts.

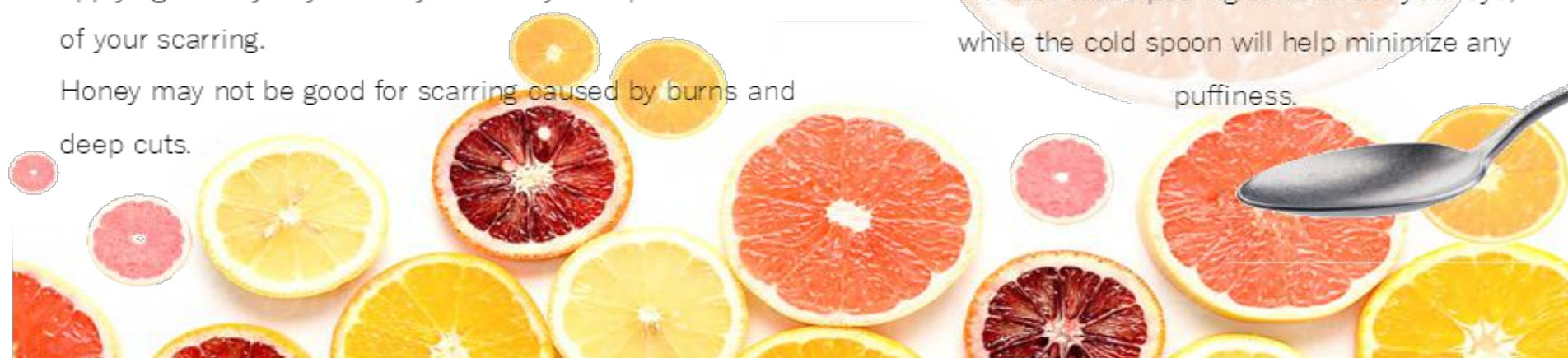
Coconut Oil as Shaving Cream

The training covered a range of topics, including:

- Legionella Disease Overview: Understanding the causes, symptoms, and transmission of Legionnaires’ disease.

- Water System Assessment: Identifying potential sources of Legionella contamination in public and private water systems.
- Risk Assessment: Evaluating and prioritising potential Legionella hazards in our community.
- Control Measures: Implementing preventive measures and remediation strategies to minimize the risk of Legionella growth and exposure to the bacteria.

Regulatory Compliance: Ensuring adherence to local and national regulations related to Legionella management.

The Environmental Health Department extends its gratitude to PAHO, Dr. Eldonna Boisson, PAHO/WHO Representative for The Bahamas and Turks and Caicos Islands and facilitators, Leonard Smith and Michael Williams for the exceptional training program and sharing their expertise in the field of Legionella disease prevention. Commenting on the training, Honourable Shaun D. Malcolm, Minister of Health and Human Services stated, “As stewards of public health, our Environmental Health Officers play a crucial role in safeguarding our community from environmental hazards. This Legionella disease training course equips our team with the expertise needed to effectively address emerging public health concerns. 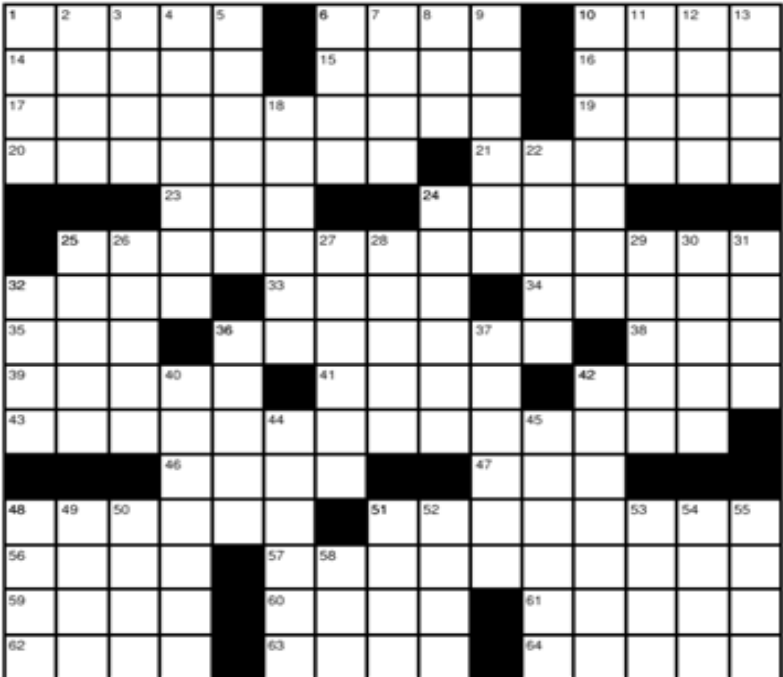

diseases and contribute to antimicrobial resistance.

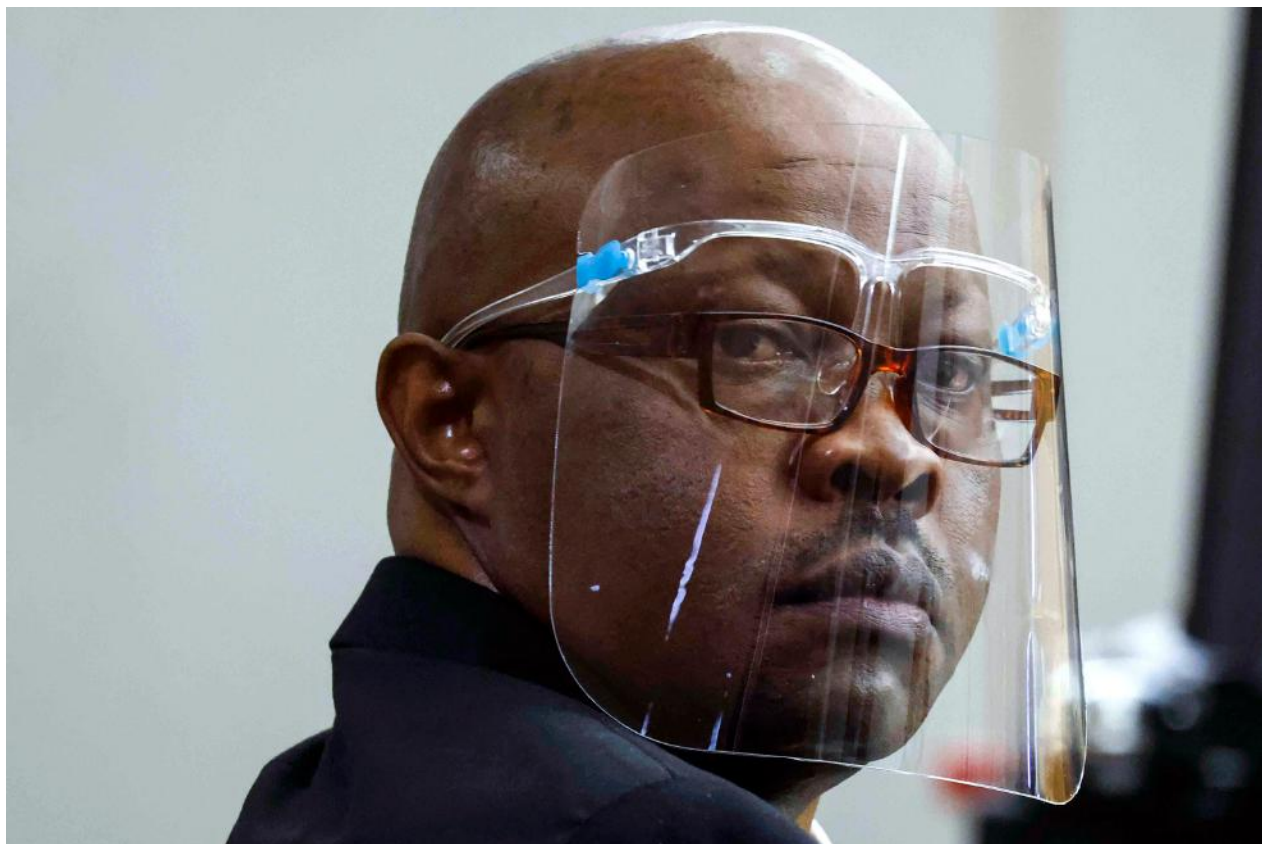

Man accused in deaths of 22 elderly women killed in prison



A man accused of killing nearly two dozen older women and who was convicted last year in the slayings of two was killed Tuesday morning by his cellmate at a Texas prison, an official said. Billy Chemirmir, 50, was found dead in his cell, said Texas Department of Criminal Justice

spokesperson Hannah Haney. She said that Chemirmir's cellmate, who is serving a sentence for murder, was identified as the assailant, but said she couldn't release the cellmate's identity or how Chemirmir was killed. Family members of the victims who gathered at

a news conference expressed shock and relief at the news.

"My mother died in fear. This man did not have a peaceful passing. There's some relief in feeling that he didn't get off easily," said Shannon Dion, whose 92-year-old mother, Doris Gleason, was among those Chemirmir was charged with killing.

The authorities said Chemirmir preyed on older women in the Dallas area over a two-year span, killing them and stealing their valuables. Time after time, their deaths were initially determined to be from natural causes, even as family members raised alarm about missing jewellery. Chemirmir was caught after a 91-year-old woman survived a 2018 attack and told police a man had forced his way into her apartment at an independent living community for seniors, tried to smother her with a pillow and took her jewellery.

Police said they found Chemirmir the following day in the parking lot of his apartment complex holding jewellery and cash, having just thrown away a large red jewellery box. Documents in the jewellery box led them to the home of Lu Thi Harris, 81, who was found dead in her bedroom.

After Chemirmir's arrest, police across the area re-examined deaths, and the charges against him grew. Many of the victims' children have said they were left perplexed by the deaths at the time, as their mothers, though older, were still healthy and active.

Biden's Democratic allies intensify pressure for asylum-seekers to get work permits



As more than 100,000 migrants arrived in New York City over the past year after crossing the border from Mexico, Mayor Eric Adams and Governor Kathy Hochul have begged President Joe Biden for one thing, above all others, to ease the crisis. "Let them work," both Democrats have said repeatedly in speeches and interviews. Increasingly impatient leaders of Biden's party in oth-

er cities and states have hammered the same message over the last month, saying the administration must make it easier for migrants to get work authorisation quickly, which would allow them to pay for food and housing. But expediting work permits isn't so easy, either legally or bureaucratically, experts in the process say.

Politically, it may be impossible.

It would take an act of Congress to shorten a mandatory, six-month waiting period before asylum-seekers can apply for work permits. Some Democratic leaders say the Biden administration could take steps that wouldn't require congressional approval. But neither action seems likely.

Biden already faces attacks from Republicans who say he is too soft on immigration, and his administration has pointed to Congress' inability to reach agreement on comprehensive changes to the US immigration system as justification for other steps it has taken.

The Homeland Security Department has sent more than one million text messages urging those eligible to apply for work permits, but it has shown no inclination to speed the process. A backlog of applications means the wait for a work permit is almost always longer than six months.

As frustrations have mounted, Hochul has said her office is considering whether the state could offer work permits, though such a move would almost certainly draw legal challenges. The White House has dismissed the idea.

Immigrants are frustrated as well. Gilberto Pozo Ortiz, a 45-year-old from Cuba, has been living, at taxpayer expense, in a hotel in upstate New York for the last three months. He says his work authorisation is not yet in sight as social workers navigate him through a complex asylum application system.

"I want to depend on no one," Ortiz said. "I want to work."

Venezuela mounts protest against Guyana's oil auction



The Venezuelan Government has mounted a protest against Guyana's recently concluded oil blocks auction. In a statement issued by its Ministry of Foreign Affairs, the administration said, "The Bolivarian Republic of Venezuela strongly rejects the illegal bidding round for oil blocks currently being carried out by the Government of the Cooperative Republic of Guyana since it intends to have maritime areas pending delimitation between both countries."

It further noted that the Government of Guyana does not have sovereign rights over these maritime areas and consequently any action within their limits is a violation of international law, as long as they are not carried out through an agreement with Venezuela.

The missive added, "The Bolivarian Republic of Venezuela reiterates that any illicit and arbitrary concession that Guyana grants, has granted or intends to grant in the areas in question is unacceptable and violates its sovereign rights, and warns that these actions do not generate any type of rights for third parties to participate in this pro-

cess."

Guyana's Head of State, Dr. Irfaan Ali categorically stated however that his administration is entitled to pursue economic development within the nation's maritime borders. The President said, "The Government of Guyana reserves the right to pursue economic development activities in any portion of its sovereign or any appurtenant maritime territories. Any unilateral attempt by Venezuela to restrict the exercise by Guyana of its sovereignty and sovereign rights will be wholly in consistent with the Geneva Agreement and the rule of international law."

Guyana and Venezuela are currently before the International Court of Justice (ICJ) to address the latter's spurious claims over the former's sovereign territory. Such aspersions were raised by Venezuela after an ExxonMobil-led consortium marked its first discovery in the Stabroek Block, following which it blazed a trail of over 33 significant discoveries.

The exploration success has not only catapulted Guyana to international stardom in the oil and gas arena but was

responsible for generating significant interest in the country's first oil blocks auction that featured 11 shallow water blocks and three deepwater concessions.

Vice President, Bharrat Jagdeo and chief policymaker for Guyana's oil sector said last week that eight of the 14 blocks received bids from six groups of companies.

The companies that submitted bids include: Total Energies EP Guyana B.V, Qatar Energy International E&P LLC, & Petronas E&P Overseas Ventures SDN BHD (Malaysia); Delcorp Inc – Guyana, Watad Energy, Arabian Drillers (Saudia Arabia); Exxon Mobil Guyana Limited, HESS New Ventures Exploration Limited, and CNOOC Petroleum Guyana Limited; Liberty Petroleum Corporation (USA) and , Cybele Energy Limited (Ghana); Sispro Inc. (Guyana); and lastly International Group Investment Inc. (Guyana), in joint venture with Montego Energy SA (London). The Vice President did not state which companies made bids for certain blocks. Be that as it may, the official said, "We are very pleased with the offers that we had from the bid round (which closed September 12, 2023). The blocks that we did not receive bids for are D3, S1, S2, S6, S9, and S11. So that means some of the blocks are very competitive. A number of people are questioning whether this was a successful bid round or not but we are pleased with how the round has gone."

He said the government is satisfied with the outcome, especially since the auction was held after the modernization of the legislative and regulatory framework. The chief policy maker for Guyana's oil sector was pleased with the fact that authorities kept its promise to not conclude the bid round without new model Production Sharing Agreements (PSAs) in place to govern deepwater and shallow water blocks. He also lauded the passage of the Petroleum Activities Law.

Along with having a more robust regime in place, Jagdeo said one needs to appreciate the global context within which the new system was implemented. He noted in this regard that there is a push for oil companies and the world over to reduce their reliance on fossil fuels. As a result, oil companies he said are finding it more challenging to raise financing for petroleum related activities.

With those factors considered, Jagdeo said the interest for eight of the 14 blocks on offer was commendable. He said the next stage is for authorities to review the bids received, following which, more details would be released. Jagdeo also anticipates that awards will be made before the year's end.

Girl falls into uncovered water tank, dies

Residents looking at an open concrete tank in which the child is suspected to have drowned on Tuesday.



Residents of Comfort district, a few miles south of Mandeville, were left in shock and disbelief after a little girl, said to be about seven years old, is suspected to have drowned in an open concrete tank on Tuesday.

The child was identified only as Kimmy, a grade-one student at a nearby school.

Residents told the Jamaica Observer that about midday the child was attempting to retrieve a

slipper from the tank when she lost her balance and fell in.

They said firefighters who responded to their calls later removed the child's body from the tank.

One resident, who identified himself as Val, pointed to the danger in having open concrete tanks

"As a father, I feel it to know that a child lost her life like this. We need to take some steps to deal with safety because even adults can make a wrong step and fall in it. I don't even know the little girl, but I feel it, like my own child, it is just sad," he said.

"From now on we have to take things more seriously. This tank, it has to be covered now, whether [water in] it is used for feeding animals or plants," he added.

Another resident who asked not to be named said she knew the child well.

"She is just seven. She just graduated from basic school and started grade one," the woman said.

"She [mother] is always around her four chil-

dren no matter if it is day or night. She just got a job and had to leave the children in the care of somebody else," one resident said.

"If me did know seh she wanted somebody to keep the children, I would have done so," added the resident.

Residents claimed the children were left by their mother in the care of her spouse. But it was unclear if the little girl and her siblings were being supervised in the moments leading up to the suspected drowning.

Workers from the Child Protection and Family Services Agency visited the community on Tuesday following the incident.

On September 18, 2020 there was the suspected drowning of Nardesha Smith, 19, a pregnant woman in the neighbouring community of Settlement.

Smith, who was visiting her boyfriend in the community, fell into an open concrete water tank while seeking cover in bushes during an attack by gunmen. Aljay Green, 20, was killed by gunmen in the attack.

School sports Season Officially Opens
