QUIZABLED FOUNDATION LAUNCHED

Quizabled is a unique platform specifically designed for children and youth with disabilities which has changed landscape of quizzing events in India. As the brainchild of Seva-in-Action & LTIMindtree, Quizabled has flourished under their joint stewardship, spanning over 400 + schools and reaching more than 8,000 participants across the country. Recognizing the paramount importance of ensuring the sustainability and autonomy of this impactful project, it has been decided to transition Quizabled into a separate entity called "Quizabled Foundation".

It is for the first time that a Corporate foundation and NGO has come together to form an organization in the disability space. The Quizabled Foundation was launched on 11th June 2024 by the first board of Directors Mr. Paneesh Rao, LTIMF and Mr. Anirudh Biligeri Govindaya, SiA in the presence of board members of Seva-in-Action Assn, Dr. Girimaji, Chairperson, Mrs. Ruma Banerjee, Vice Chairperson and Mr. Rajasekhara Reddy, Secretary with other board members and Quizabled team.

QUIZABLED STEPS INTO 10TH EDITION

Quizabled with its new format will reach out to rural, aspirational & tribal districts of India. The 10th Edition of Quizabled will be conducted under the new entity Quizabled foundation. It will be a nationwide program, reaching out to 13 states across India in collaboration with NGO partners in Karnataka with Seva-in-Action, Bangalore, Tamil Nadu with SPASTN, Chennai, Maharashtra with Sujaya Foundation, Mumbai, Delhi with Special Olympics Bharat (SOB), Delhi, Kerala with Raksha Society, Kochi, Andhra Pradesh with Uma Educational & Technical Society, Kakinada, Telangana with Helen Keller's Institute of Research & Rehabilitation of Disabled Children, Hyderabad, Uttar Pradesh with SPARC India, Lucknow, Odisha with Open Learning Systems, Bhubaneswar, Madhya Pradesh with SOB, MP, Gujarat with SOB, Gujarat, Himachal Pradesh with Chetna Society, Bilaspur and West Bengal.



ELIGIBILITY CRITERIA:

- 1. Children & Youth with Intellectual Disability (Junior) 13 to 18 years.
- 2. Children & Youth with Intellectual Disability (Senior) 18 to 25 years.
- 3. Children & Youth with Autism Spectrum Disorder 13 to 21 years.
- 4. Children & Youth with Cerebral Palsy (CP) 13 to 21 years.

This year, the focus is on children and youth with Intellectual and Developmental Disabilities, including those with intellectual disability, cerebral palsy, and autism spectrum disorder. The competition from the state has been brought to the zonal level.



The Zonal Quiz competition will be held in across East, West, North & South in collaboration with NGO partners in Chennai, Hyderabad, Delhi, Bhubaneswar & Ahmedabad
