



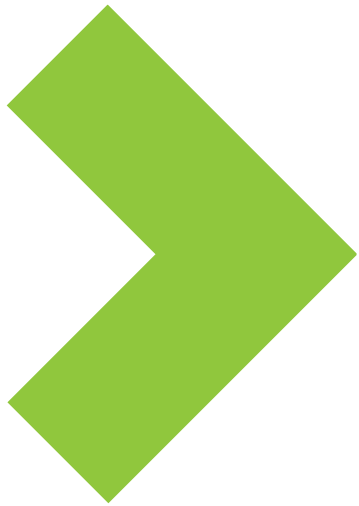

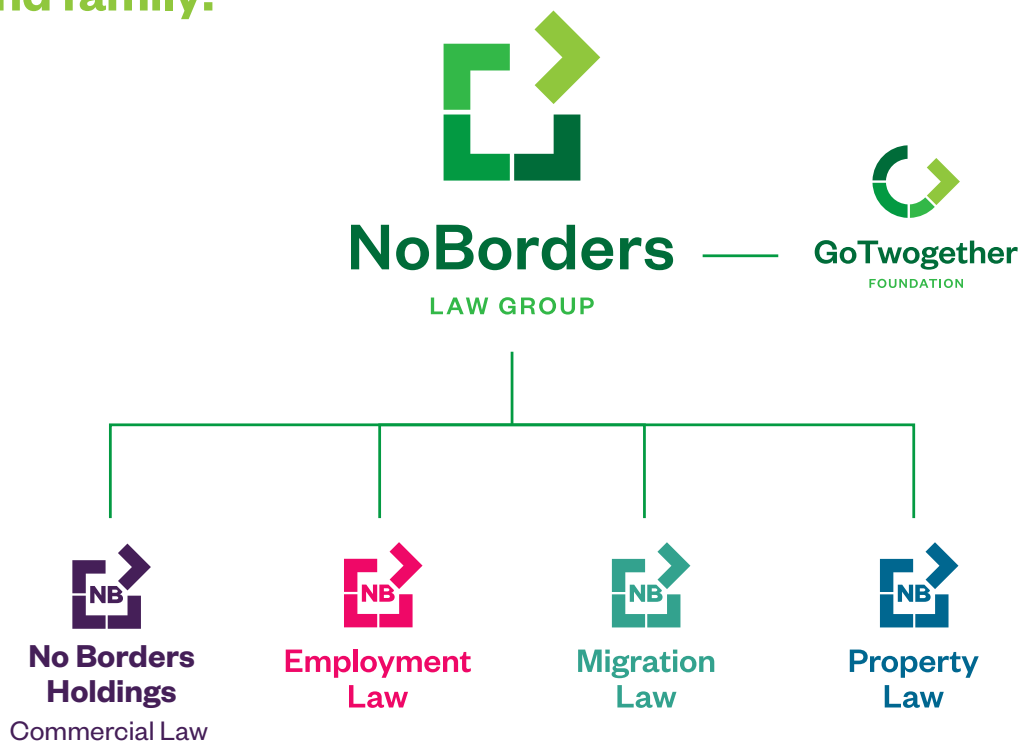

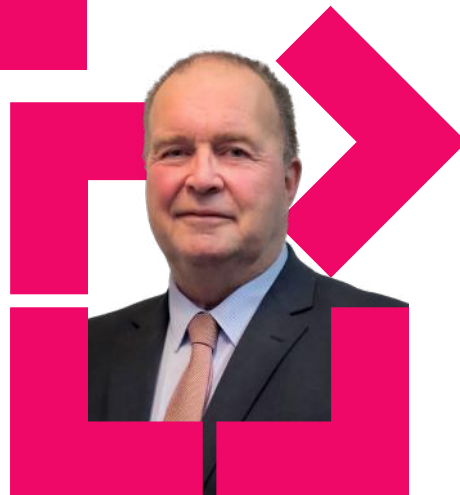

› VISA APPLICATION

We'll establish your eligibility for an Australian visa before handling every aspect of your application, providing clear guidance and examples of how to lodge a successful application. You'll have regular consults (in person or virtual) with our dedicated team through each stage; and we'll handle the direct liaison with the Department of Immigration on your behalf.

› CITIZENSHIP APPLICATION

Comparable to the Full Visa Application service, our team will see you through the citizenship application process every step of the way. To qualify to apply for citizenship by grant, you must be an Australian permanent resident, meet several different criteria and score 75pc or more on the 20 question Australian citizenship test. We'll work towards your goals.

› SKILLS ASSESSMENT

Skills assessment is an important part of the visa process for those seeking the General Skilled Migration (GSM) visa, Employer Sponsored visa, Temporary Skill Shortage visa (TSS) or the Temporary Graduate visa (subclass 485). Our migration agents will help manage and explain every step of the assessment process to you.

› APPLICATION REVIEW

If you think you're on the right track with your visa, but would like some professional advice, our application review service is for you. Our expert team will review your application, and provide a report of what needs to be amended, plus a final review before the application is submitted.

› ADMINISTRATIVE APPEALS

Having a refusal on your migration application can be an incredibly disheartening and distressing situation. Our team will review your case, and provide guidance and representation moving forward should you wish to appeal the decision with the Administrative Review Tribunal.

› PAID LEGAL CONSULTATION

› FEDERAL COURT REVIEW
