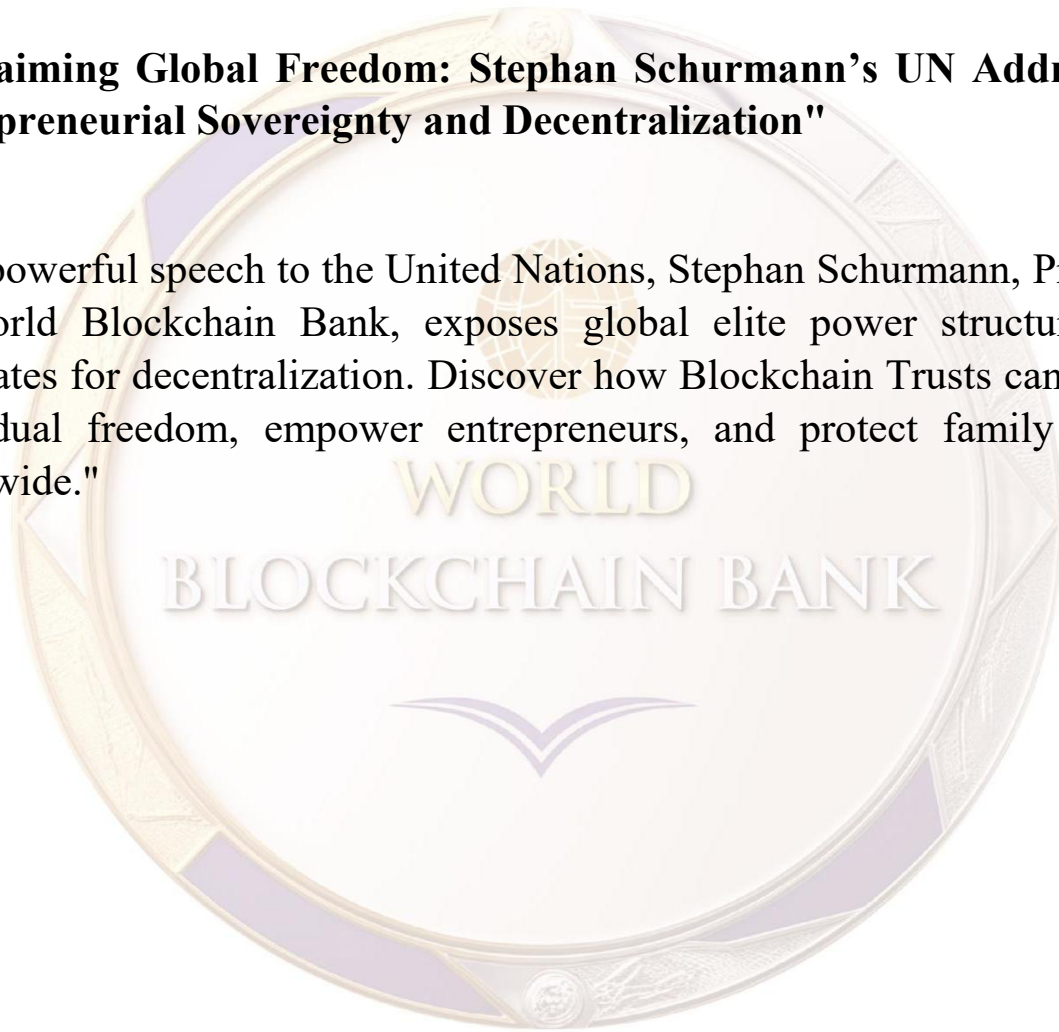




"Reclaiming Global Freedom: Stephan Schurmann's UN Address for Entrepreneurial Sovereignty and Decentralization"
